Aloha Maria Cristina Valenzuela:

Congratulations on your nomination to the State Council on Developmental Disabilities. To assist the Hawaii State Senate with its confirmation process, we request that you submit the following information to our office no later than February 21st, 2025, to ensure that we proceed in a timely manner:

- 1. Why do you wish to be a member of the State Council on Developmental Disabilities. As a member of the State Council on Developmental Disabilities I would represent the Executive Office on Aging and fill the mandated seat as Representative of State Entities that Administer Funds Provided Under the Older Americans Act of 1965. According to Public Law 106-402 (Developmental and Disabilities Assistance and Bill of Rights Act of 2000), the DD Council in its membership shall include representatives of relevant State entities including the Older Americans Act. [Section. 125 (C)(4)(A)(III)].
- 2. What do you perceive are the roles and responsibilities of a member of the State Council on Developmental Disabilities.
 As a board member of the State Council on Developmental Disabilities my primary role is to support and advocate for the agency to achieve its mission to "empower, advocate, and support individuals with intellectual and developmental disabilities statewide to control their destiny and determine the quality of life they desire". I have a responsibility as a member to also support the Council on DD to meet the goals and strategies/objectives as identified in their state plan. Specific responsibilities include attendance and participation at the annual retreat and monthly/quarterly meetings, including committee meetings, share ideas and provide information on policies, laws and issues that impact individuals with ID/DD and their families.
- 3. Given your understanding of the roles and responsibilities as a member of the State Council on Developmental Disabilities, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

Most of my professional experience includes program coordination and management, program and policy development, direct service work, and advocacy for vulnerable and underserved populations. From working with and serving older adults, individuals recovering from neurotrauma (e.g. traumatic brain injury, stroke, and spinal cord injuries), adjudicated youth, teen moms, and domestic violence survivors I've had the opportunity to learn from individuals and families about the challenges and successes that they face, which impact their health and social and economic. My approach in these roles has always been to listen, empathize, learn, and provide the information and resources/tools that will assist the individual to make decisions about their own life.

I am currently the Legal Assistance Developer with the Executive Office of Aging. The Executive Office of Aging is the lead agency in the coordination and oversight of a statewide system of aging and caregiver services and supports for the State of Hawai'i. As the Legal Services Developer I provide leadership and oversight of legal assistance services for older individuals. From advocating for resources critical to legal providers to helping older adults find an attorney with the proper expertise I work to maintain the rights of older individuals and individuals with disabilities under the Older Americans Act.

Additionally, as a representative of the Executive Office of Aging I can provide information, resources, and insights on aging issues that impact individuals with ID/DD. I can also learn from the State Council on DD and the ID/DD community on the gaps in services and supports that are still needed and identify resources that may be helpful. I would also share this information and ideas with the Aging Network and work to change/improve current policies and programming.

4. What do you hope to accomplish during your term of service?

As a first time board member my goal is to listen and learn more about the State Council on DD by attending the board meetings and committee meetings. I currently participate in the Bridging ID/DD and Alzheimer's Committee and the Transportation, Housing, and Employment Committee of the Council on DD and will contribute to the efforts of the committees in meeting its objectives. I've attended and will continue to attend trainings to better understand how EOA can improve the quality of life for individuals with ID/DD and have or are at risk of Alzheimer's disease or related dementia. I also hope to continue to support the committee in how to address the needs of these individuals and their families.

In consultation with the Council on DD I will work with EOA to update and refresh the Aging and Disability Resources Center website to include and list all the pertinent and necessary resources on disability. I am also participating on the Guardianship Work Group that is trying to address issues with the States guardianship and conservatorship procedures.

5. Name three qualities that best describe you and how these qualities will the State Council on Developmental Disabilities.

Three qualities:

Person centered approach- I believe in providing the information and assistance needed for individuals to determine what is best for them and what type of life they want/choose. I also respect one's dignity and the ability to choose and make good and bad choices. I will take this same approach in advocating for individuals with ID/DD. In working with the agency, I can provide information and help with efforts, particularly in how it relates to aging and disability.

Determined- when I set my mind to something I work to get it done. I will apply this same approach in assisting the Council on DD to achieve its mission and meet the goals/objectives set in their state plan.

Collaboration- We don't exist in silos and are part of a community. As a board member I would work with, share ideas and coordinate efforts to ensure that the Council on DD achieves its goals.

- 6. Name a previous experience you've had that will be beneficial as a member. From 2017-2018 I worked at the Dept. of Health Developmental Disabilities Division with the Neurotrauma program. The Neurotrauma program provides education on neurotrauma, assistance to individuals and families to identify and obtain access to services, and the creation of a neurotrauma registry through the Neurotrauma Special Fund. Additionally, I worked for 14 years with older adults and their family caregivers at Catholic Charities Hawaii and at my current position at the Executive Office on Aging. In my professional experience working with individuals recovering from neurotrauma and with older adults I gained a better understanding of the challenges and successes that these vulnerable populations face and how this impacts their wellbeing and quality of life. My understanding of the Older Americans Act and how the services and supports under OAA can assist individuals with ID/DD and their families and will also benefit the agency.
- 7. Can you foresee any possible conflicts of interest that could arise during your service on the State Council on Developmental Disabilities. How would you overcome conflicts of interest?
 - I don't foresee any possible conflicts of interest. To address/avoid any conflicts of interest it's important to identify any conflicts, be transparent about the conflict and lessen any risks that might arise.
