1. Why do you wish to be a member of the Commission on Fatherhood.

I seek to become a member of the **Commission on Fatherhood** because I believe in being part of the solution—not just in words, but through action on a **statewide**, **influential platform**. Fathers play a critical role in the strength and stability of families, yet too many feel unheard, unseen, and unsupported.

I want to **bridge that gap**, ensuring that fathers who may not believe they have a voice are empowered to find one. I will stand as their advocate, championing their needs, concerns, and contributions—both in legislative spaces and within our communities.

Fatherhood is not just a personal responsibility; it is a societal foundation. When we uplift fathers, we strengthen families, and when we strengthen families, we build a brighter future for all. I am ready to serve, to listen, and to lead in this mission.

2. What do you perceive are the roles and responsibilities of a member of the Commission on Fatherhood?

3. Given your understanding of the roles and responsibilities as a member of the Commission on Fatherhood, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

I believe I am well-qualified for this position because of my firsthand experience as a father and my dedication to supporting families. Being a father of four for the past fourteen years has given me a deep understanding of the challenges fathers face—whether in navigating parental responsibilities, strengthening family bonds, or seeking guidance during difficult times.

One of my mentors taught me the importance of service: to truly help others, you must first understand their needs and then find ways to meet them. I have carried this principle throughout my work, including my time at the Service League in San Mateo, CA, where I assisted men in transitional housing from county jail. There, I advocated for fathers by making calls on their behalf, particularly those dealing with child support issues who were unable to advocate for themselves.

Currently, I work with Maui Family Support Services, where I help families build stronger relationships by identifying risk factors and reinforcing protective factors for children. Through this work, I have gained experience in non-violent mediation, a needs-based approach that requires deep listening, empathy, and conflict-resolution skills. This practice has been instrumental in helping families navigate difficult situations and develop healthier dynamics.

My ability to listen, understand, and advocate for fathers makes me a strong candidate for this position. I am committed to ensuring that fathers in our community have the resources and support they need to thrive.

4. What do you hope to accomplish during your term of service?

Supporting Fathers, Strengthening Families

In Maui County, fathers deserve access to resources—both time-honored and newly available—that empower them to reunite with their children and families when needed. Every father facing this journey should know that support exists to help them navigate the path toward healing and reconnection.

For solo fathers, maintaining stability and fulfilling their responsibilities is vital. They should never feel like they have to shoulder this burden alone. That's why we must encourage fathers to come together, to meet at least four times a year, to stand side by side in solidarity, and to remind one another that fatherhood is not a road meant to be traveled alone.

Above all, we must guide and uplift fathers—teaching them not just through words, but through action—how to be respectful, responsible, and accountable. To have integrity, to be honest, and nurturing partners, and to serve as role models within our communities. When fathers thrive, families grow stronger, and our entire community benefits.

Reimagining Fatherhood: A Space for Strength and Renewal

I want to bring self-care awareness to fathers because too many are carrying the weight of the world on their shoulders, stressed to the max with nowhere to release it. But what if their greatest outlet wasn't just a solo escape—but their own families? What if, instead of feeling isolated, fathers had a dedicated space to recharge, reconnect, and grow stronger alongside their loved ones?

Imagine a free county gym on every island—a place where fathers and families could go not just to exercise, but to access resources, find support, and channel stress and anger into something productive and healing. A space built not just for physical strength, but for emotional and mental well-being. A place where fatherhood is honored, where families bond, and where the cycle of stress is replaced with resilience, connection, and empowerment.

It may sound ambitious—but why not? Strong fathers create strong families. Strong families build strong communities. And when we invest in spaces for fathers to thrive, we invest in a future where no father has to struggle alone.

Let's dream boldly—because this is possible. This is our/my mission. This is our/my commitment. Together, we will ensure that no father feels unseen, unheard, or unsupported.

Resilient. Steadfast. Dedicated. These are not just words; they are the qualities I believe every leader in this role must embody. I fully understand the complexities and challenges that come with this position, as well as the aspirations I hold for it.

That is why I must remain steadfast in my commitment, ready to face opposition and navigate obstacles with unwavering resolve. I must be resilient, undeterred by closed doors or the word "no." And above all, I must be dedicated—through every challenge, in the face of any storm—because fathers deserve to be heard, to be seen, and to be recognized as vital pillars of their families. This is the mission. This is the responsibility. And I am ready to carry it forward.

The Power of Working Together: A Lesson from the Imu

A few months ago, I had the privilege of standing alongside fathers and families at an **Imu** during a one-night campout. We had a shared purpose—to prepare food to raise money for a paddling club. But as the night unfolded, it became clear that this experience was about much more than just cooking.

From the moment I arrived, I saw fathers stepping up in different ways—some in the kitchen, carefully preparing and wrapping the pork, while others were outside, digging and building the fire pit, placing large stones to create the foundation for the Imu. Each of us had a role to play, a **Kuleana**, to ensure everything was ready. When it was time, we covered the pit, making sure no smoke escaped, and working in unison toward a common goal.

As we waited through the night and into the early morning, something even more meaningful happened. We talked story. Fathers shared how they build bonds with their children, and how they create a culture of strength and connection within their families and communities. The fire wasn't just cooking the food—it was igniting conversations about fatherhood, responsibility, and the power of working together.

I know our chair would like to see more events like this—opportunities for fathers and families to come together, strengthen their ties, and support one another. I can help make that happen. I love bringing people together, rallying the troops, and staying connected to what our community needs. Because when families stand together, when fathers lead with purpose, we create something far greater than a meal—we build a legacy of strength, unity, and resilience.

Letter of Interest



Growing up without my biological mother or father had its challenges, to say the least. I remember being a bitter and angry child. It was like I was in a dream state, lost without guidance and direction. I felt ashamed and embarrassed about not having a father. These challenges shaped my ideas about fatherhood.

When I was young, my father would write and send gifts on holidays and birthdays. The letters and gifts were precious to me and I remember them to this day. To me, it meant he did at least think about me. I longed and looked forward to the letters and gifts each and every birthday and holiday. It was the only link I had with my father. It was a way I could feel connected to him and get his attention. Tragically, my father died when I was 10 years old. His death brought an end to the letters and gifts, as well as the connection I felt to him. Although I was sad that my father had passed away, I also felt a sense of relief. I no longer had to feel ashamed and embarrassed about not having a father. He wasn't around because he was dead not because he didn't want me.

Growing up without my father in my life warped my mindset of what a father was and left me with little to no guidance for when I was to be a father. I had a lot of fear about being a good father. Could I be the father I never had? Could I stick around instead of leaving like my father did? My desire to be a father wavered between not doing it out of fear and doing it even though I was afraid.

I sought out father figures and role models to learn from. I found them in my sports, school, and church communities. I learned a lot of amazing things. The values and lessons I learned gave me the ability to forgive my father for not being there for me. Once I was truly able to forgive my father, I was ready to get married and start a family. Being born into this situation I decided I had two options. I could follow in his footsteps or I could use this as an opportunity to be a better father.

Today, I am married to an amazing woman. I get to know and love each day. I am a father of five, two daughters, two sons, and one baby in heaven.

Being a father has allowed me to understand my father a bit more. He did not have the support he needed in order to successfully be my father. Men need support in order to properly lead a family. They need guidance and opportunities to grow.

I want to advocate for fathers here on Maui that need support. I want to be a voice where they don't have a voice. I stand on the foundation that fathers are extremely important in the family unit.

Becoming a commissioner aligns with my purpose and passion to help fathers be their best. It will allow me to support programs to guide them to their full potential as they navigate their 'Ohana.

I'm currently working at Maui Family Support Services with the Pōhai Kākoʻo ʻOhana parent skills-building workshop, as the program supervisor. I work with parents with children ages 9-17 to help build their parent/child relationship as well as prevent the children from using drugs and alcohol.
