SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND  
BURIAL COUNCIL, ISLANDS OF KAUA'I AND NI'HAU, GUBERNATORIAL NOMINEE,  
CHADLEY SCHIMMELFENNIG, FOR A TERM TO EXPIRE 06-30-2029.**

**The Department of Land and Natural Resources (Department) supports Governor's Message 763, nominating Mr. Chadley Schimmelfennig to the Island Burial Council, Islands of Kauai and Niihau, expiring June 30, 2029.**

The Island Burial Councils are established under Section 6E-43.5, Hawai'i Revised Statutes. The Councils determine whether to preserve in place or relocate previously identified native Hawaiian burials site, recognize lineal and cultural descendants, and provide counsel and advise to the Department. With the exception of the Moloka'i Island Burial Council, the island burial councils consist of no more than nine members, of which six representatives shall represent a specific geographic area, and no more than three shall be representatives of development and large landowner interests. Mr. Schimmelfennig is seeking to represent the Koloa geographic area.

Mr. Schimmelfennig has direct genealogical connections to the Koloa region through his family lines, tracing his lineage in the area back to the 1400s, and his 'ohana have remained a part of that community for generations and many of his kūpuna are buried in the region, reflecting his relationship with the 'āina and its ancestral places. He has served as a caretaker of heiau and other sacred sites throughout the Koloa Po'ipū area. Mr. Schimmelfennig was raised with the knowledge of traditional burial practices, and has been taught to identify and care for iwi kūpuna, actively engaging in the kuleana of site protection and reinterment. His understanding of protocol and his humility in seeking guidance from kupuna and cultural practitioners further exemplifies his connection to the community.

In addition to his cultural and genealogical qualifications, Mr. Schimmelfennig has experience working within Native Hawaiian organizations in leadership roles. He served as Executive Director of Kawaikini New Century Public Charter School, where he oversaw educational programming rooted in Hawaiian culture and values. He has also worked as a teacher and vice principal in the DOE system, integrating culturally responsive learning, and partnered with the Office of Hawaiian Education to implement the Nā Hopena A‘o (HĀ) framework.

Mr. Schimmelfennig’s affiliations also include longstanding membership in the Royal Order of Kamehameha I, Kaumuali‘i Chapter, where he serves as a Kahuna Kuhikuhi pu‘uone, and he chairs the Kamalo‘ula Heiau Restoration Project. His participation in various hui like Hui Mālama o Kaneioulouma and Hui Mālama Loko I‘a demonstrate his sustained commitment to mālama ‘āina and community-based cultural restoration work.

Senate confirmation will ensure that Mr. Schimmelfennig’s lived experiences, cultural foundation, and leadership capacity will serve as a voice of descendants to protect iwi kupuna with dignity and contribute culturally appropriate decisions to the Kauai Niihau Islands Burial Council until June 30, 2029.
