## Re: GM767 – Confirmation as Circuit Court Judge of the Circuit Court of the Third Circuit (Island of Hawai'i), Gubernatorial Appointee, KAUANOE A.D. JACKSON

Honorable Chair Rhoads, Honorable Vice Chair Gabbard, and Members of the Senate Committee on Judiciary:

Please accept this testimony from the West Hawai'i Bar Association regarding the nomination of Kauanoe A.D. Jackson as Circuit Court Judge of the Third Circuit Court. The West Hawai'i Bar Association represents 113 attorneys practicing in the Third Circuit. Our Association serves the West side of the Island of Hawai'i—an area stretching from the district of North Kohala in the far north, all the way through the south of the island to the district of Ka'ū.

The Third Circuit Court, Division Three, has been without a permanent judge since July of 2024. This has placed a serious strain on the court's ability to provide justice in a consistent, fair, and efficient manner. The West Hawai'i community will be served by the confirmation of a permanent judge on the Circuit Court bench.

We, the Executive Board of the West Hawai'i Bar Association, believe it is in the public interest to provide insight into the collective observations and experiences of those who regularly work within the justice system. We undertook a survey of West Hawai'i Bar Association members regarding Ms. Jackson's nomination, and, of the responses received, the consensus was substantially positive and reflects a high level of professional regard for Ms. Jackson.

We requested our members evaluate Ms. Jackson as to the following criteria: integrity, diligence, legal knowledge and ability, professional experience, judicial temperament, public service, and the ability to fulfill the responsibilities and duties of the position. The responses from our members reflect a recognition of Ms. Jackson's ability to serve the community with respect and dedication. Respondents consistently recognized her commitment to the legal profession, thoughtful demeanor, and consistent demonstration of fairness and ethical conduct.

A concern was raised regarding Ms. Jackson's lack of civil litigation experience, however members indicated that they believed she had the legal knowledge and ability to take on that challenge. These results reflect the regard in which Ms. Jackson is held by members of the legal community—individuals who have had an opportunity to observe her work firsthand in courtrooms and in practice.

We appreciate the opportunity to comment on matters affecting the interests of the West Hawai'i bar and look forward to the stability that the appointment of a permanent Circuit Court judge will provide to our legal community.

I write in SUPPORT of the confirmation of Kauanoe A.D. Jackson to the Circuit Court of the Third Circuit, the State of Hawai'i, for a 10-year term as Circuit Court Judge.

I have known Ms. Jackson since 2012, and worked with her from 2012-2015. During that time, I found her to be a diligent, hard-working, and crazy smart deputy prosecuting attorney and an excellent colleague.

After I left the Office of the Prosecuting Attorney in 2015, I litigated against Ms. Jackson on numerous occasions, including several jury trials—mostly losing to her! From my perspective as a defense attorney, I saw how Ms. Jackson is not only an aggressive advocate for the office, but also aggressive in promoting the rule of law and ensuring due process to criminal defendants.

One notable example comes from a preliminary hearing, in which Ms. Jackson represented the State, and I was court-appointed counsel for the defendant in a drug case. In that prelim, the arresting officer testified to the recovery of the drugs at issue and, in doing so, testified to facts demonstrating that the warrantless search and seizure had been without probable cause under both state and federal law. Ms. Jackson completed the hearing professionally and without displaying agitation, anger, or frustration expressed toward any of the witnesses, the court or counsel. I made a note to myself to seek an expedited transcript and to file an immediate motion to suppress the evidence and dismiss the charges. After the court found probable cause for the offense, and Ms. Jackson and I were leaving the courtroom, she pulled me aside and indicated that she would file a dismissal when she returned to the office, which she did.

The reason this is notable is that many—perhaps most—DPAs would have put me to the time and trouble of preparing and litigating a motion; put the State (which was paying my

fees) to the expense of providing expedited transcripts and paying me to brief, file, and argue the motion; and would have wasted our extremely limited judicial resources by insisting on a hearing that could have but one outcome (whether at the trial or appellate level). Not only did she do the right and efficient thing with respect to that case but, based on my earlier work with her at the OPA, I am confident that the dismissal was followed by her taking the time to ensure that the individual officer and our local HPD office was trained on why that particular search and seizure was impermissible and how to conduct the investigation properly next time.

I could not be more delighted about Ms. Jackson's selection by Governor Green, she is smart, unflappable, fair, honest, and truly seeks every day to do justice in our community. Accordingly, I humbly request that Ms. Jackson's appointment to the vacant position as Circuit Court Judge for the Third Circuit, State of Hawai'i be enthusiastically CONFIRMED.

Re: Kauanoe Jackson, Third Circuit Judicial Nominee

It is with great pleasure that I recommend Kauanoe Jackson for this position. I am a retired prosecutor, who had worked at the Kona Prosecutor's Office for approximately 16 years, when Kaua joined the office. She was inexperienced but eager to learn and diligent about both factual investigation and legal research for her cases.

I clearly remember when Kaua had her first felony trial. This was a difficult sex assault case which many prosecutors might have declined. The victims were two young women who came here from the mainland, went on a cruise with a local company and decided they would like to work for that company on the boat. They discussed this with an employee on the cruise and were advised that they must be very physically fit to get a job. He told them he would do a physical exam and invited them to his residence. There after testing them for qualities one might expect on a sports fitness exam, he told them to remove their pants and began to "examine" them in their private areas. When he was later reported, his defense was consent. Although many people might find it hard to believe the girls could be so gullible that they submitted to this, believing it to be a pre-employment physical, Kaua carefully interviewed the girls demonstrating real empathy and willingness to listen, and researched the law regarding invalid consent. She got convictions on this case before a jury. It was at that time that I realized Kaua would be a future star at the prosecutor's office. Of all the young prosecutors, I have seen in 34 years as a prosecutor, she was the best.

Since that time, she has prosecuted countless drug cases, for which extensive foundation must be laid to get the results of drug tests into evidence. She also learned all about DNA, in order to present expert witnesses in several trials. In addition, she prosecuted many negligent homicide/ vehicular manslaughter cases for which it is necessary to learn about engineering principles and to carefully differentiate simple negligence, gross negligence and recklessness. These skills would be readily applicable to civil tort cases. Her knowledge of foundation requirements for expert testimony would also assist her in trying civil cases.

As a person who switched from doing mostly civil cases in Alaska to becoming a prosecutor in Hawai'i, I can state that there is a learning curve, but I am sure Kaua will readily master that curve with her typical diligence and hard work. It is my experience that doing frequent criminal trials, as Kaua has done teaches one to be more knowledgeable about courtroom requirements and thinking quickly, an ability which many civil attorneys lack the opportunity to develop. Both

Kaua and I had the invaluable experience of developing evidence skills under the thumb of Judge Ronald Ibarra who was very strict about not allowing speaking objections and imposed requirements of objecting only by stating the rule number or a one- or two-word description, i.e. hearsay, or foundation.

- has always shown respect for all judges and opposing counsel without giving in easily when there was a basis for disagreement. She is very conscientious about the need for a judge to give everyone a fair opportunity to argue before making a decision. One example of this was her successful application for certiorari and eventually obtaining a reversal of a suppression decision in State v Vega NO. CAAP-18-0000715, Decided: June 17, 2020. There the appellate court ruled that a trial court cannot rule on theory in support of suppression, (staleness), not raised by opposing counsel without allowing chance for the opponent to brief the new theory. I am sure she would apply that principle of fairness and willingness to listen, without deciding cases based on prior experience as a prosecutor.
- 2. has always been forthright about discovery obligations, and I am sure she would expect that of litigants before her. She also repeatedly demonstrated a desire to improve the legal system, by politely explaining the significance of errors made by police to those police and providing continuing education for other police.

In conclusion I would say that I would trust Kaua to be fair and impartial, as well as empathetic to litigants in any case which came before her.
