

As Kaua'i County's Administrator for the Office of Boards and Commission, I have worked closely with Shaylyn for the past six (6) years. Currently, Shaylyn is the Chair of Kaua'i's Public Access, Open Space, Natural Resources Preservation Fund Commission. Every year, one-half of one percent (0.5%) of real property tax revenues are placed in a fund. The Commission reviews proposals and recommends the purchase of land or property entitlements to be acquired via the fund. The purpose of the acquisition must be for:

- Public recreation and education,
- Beach and mountain access
- Preservation of
 - ♦ Historic or cultural lands and sites
 - ♦ Habitats and ecosystems
 - ♦ Forests, beaches, coastal areas, and agricultural lands
- Protecting watershed lands
- Conserving land
 - ♦ For open space and scenic values
 - ♦ To reduce erosion, floods, landslides, and runoff.

Shaylyn has served as Chair on multiple occasions. During her tenure, she advocated for and spearheaded a number of initiatives, and several properties were acquired. She is passionate, committed, and she does her homework. She's a proven leader and a valuable member of the Commission and in the community. 



Sorry, I accidentally sent you the letter below before it was completed. I would love to complete our testimony. One of the activities she has been involved in is through Open Spaces. She has diligently researched and reviewed the loss of cultural practices of limu collecting here on Kauai. Many of the homeowners have blocked off access to our beaches by growing plants to block public access to the beach. Some of them have even built stonewalls and fences to keep the Hawaiians from accessing the ocean. There are practitioners who spend their time teaching our students here on Kauai to keep the knowledge of limu harvesting and growth. This is a cherished tradition to her as her aunt was a limu collector and taught others the Hawaiian tradition of preserving limu. Another of her concerns has been access to open up and preserve designated trails used for hunting from Moloa'a to Hanalei. As outsiders swallow up land on the north shore, they too build, fence and plant obstacles for our hunters to keep them from feeding their families and others in the community. Shaylyn comes from a generation, past and present, of hunters and gatherers. I believe she and others who share her dreams will slowly regain access to our mountains which is rich in food both pigs and other kinds of food that are abundant on our island. I would appreciate your support as I feel her knowledge and experience will assist our state, especially our Hawaiian community, in getting the native people to acquire a piece of land to call their own.
