i previously submitted highly favorable testimony on behalf of Karen Nakasone for each of her prior judicial appointments, circuit court judge and as an associate judge to the Intermediate Court of Appeals. My strong commendation is based upon my personal first-hand observation when Ms. Nakasone initially appeared in my criminal court in the late 1990's, early 2000's, arguing with precision, clarity and conciseness, demonstrating a professionalism far beyond her youth. Her verbal dexterity was equally matched by her excellent writings. I next became reacquainted with Ms. Nakasone upon her appointment to the circuit court in 2011, assigned to the civil division. Although Ms. Nakasone's entire legal career was with the Public Defender's Office, to avoid the appearance of any conflict of interest, she was initially placed within the civil trial division. There is no playbook or benchbook on how to handle hundreds of cases in the civil division, ranging from products liability, auto accidents, contracts, complex litigation, and the list goes on. Prior to her appointment to the Circuit Court in 2011, Ms. Nakasone built a strong record of community service, advocacy, and leadership, exhibiting principled commitment and courage by speaking out for justice for even unpopular marginalized minorities.

Judge Nakasone's thirteen years on the bench, nine years in the Circuit Court and four years on the Intermediate Court of Appeals, have prepared her and will serve her well if she is elevated to serve as Chief Judge of the ICA. Her excellent research and writing skills are a reflection of her clarity of thought and firm grasp of legal analysis. As a judge she is deliberate but not indecisive. Judge Nakasone has a remarkable disposition and temperament – she is humble, engaging, and collegial.

I always feel a sense of gratefulness when I'm asked to recommend someone whom I respect and value both professionally and personally for high office. That my evaluation is thought of in a positive light by the person seeking my support is gratifying.

But, in this instance, where Judge Karen Nakasone is making the request of me, I cannot think of an occasion when I was more enthusiastically motivated.

Her Judicial legal record is outstanding and recognized as such by her nomination. A glance at her resume regarding her background as a Circuit Court Judge -a post for which I nominated her in 2011 in both criminal and civil trials and litigation is second to none.

It is with great pleasure and pride, as her Zen teacher and Abbot of Chozen-ji, International Zen Dojo, that I recommend Karen Nakasone to you for the position of Chief Judge of the Hawai'i Intermediate Court of Appeals (ICA).

1. has trained at Chozen-ji for many years, and despite the demands on her as a judge and mother of two girls, practices Kendo, and teaches Karate. She underwent *sesshin*, a six day intensive meditation training designed to make a person transcend their self-imposed limits. The hours of sitting in meditation are long; the time to sleep is short; and the concentration required in acts of daily living is relentless. 1. incident is illustrative of Karen's kindness. A plum tree at the temple was withering away. Karen's mother suggested that the dirt around the roots of the tree be replaced with new, fertile soil. Karen brought her two daughters to dig out the old dirt, put several bags of soil in, and build a cute circle around the tree with pieces of brick. The tree is thriving and even flowers in season. Karen is one of the few students who come up to weed the grounds regularly despite it being an impossible task.

I don't want to talk about myself, but perhaps knowing my background might lend more credibility to my recommendation of Karen. I am third generation in Hawai'i, graduated as a United States Presidential Scholar from Punahou despite my father never owning a car, graduated from Yale summa cum laude, have a PhD from the University of Michigan in clinical psychology, authored several books, served on the boards of City Bank and Central Pacific Bank, and worked in executive positions in healthcare for over 30 years. From my perspective, Karen is exceptional in the values, integrity, conscientiousness, and wisdom she will bring to this position.

Presiding over the courtroom, seeing 180 degrees, judging from her heart according to the Aloha Spirit and judging from her intellect with an intuition which transcends the dualism of rationality, Karen is the kind of judge who will help keep Hawai'i the kind of place we grew up in and love.

I first met Judge Nakasone (of course, Karen, then), when I was a 2L law student interning for the summer at the State Public Defender's Office. I had the opportunity to write the opening brief on an appeal of a trial she had done. I was able to discuss with Karen her trial strategy, appellate issues, and pick her brain about what the appeal should focus on. That was more than 20 years ago, in approximately 2001. I still recall that case because Karen was a respected trial attorney in the office, and even though I was just a law student intern, she treated me with respect and talked to me as if I were an attorney.

I am a civil litigator at the law firm of Damon Key Leong Kupchak Hastert, located in Honolulu. I write to express my strong **SUPPORT** for Governor Green's appointment of the Honorable Karen T. Nakasone to serve as Chief Judge of the Intermediate Court of Appeals (ICA).

I fully support the confirmation of the Honorable Karen T. Nakasone as Chief Judge to the Intermediate Court of Appeals (ICA).

I have known Judge Nakasone since 1996 when she joined the Office of the Public Defender, and I had the opportunity to work closely with Judge Nakasone when she was assigned to the appellate division. I was immediately impressed with not only her intellect but also with her work ethic and her commitment to and her compassion for the those in the community who needed the most help. Her contributions as an appellate attorney have led to several precedent-setting Hawai'i Supreme Court cases.

Judge Nakasone has also proven herself as an outstanding jurist during her five years as an associate judge in the ICA and her nine years as a circuit court judge. As a circuit court judge, she presided over ninety trials (seventy of which were jury trials) countless of evidentiary hearings, motions, settlement conferences, and sentencing hearings. Fortunately, for the people of the State of Hawai'i, when the U.S. Supreme Court's interpretation of a provision that is present in both the U.S. and Hawai'i Constitutions does not adequately preserve the rights and interests sought to be protected, the Hawai'i appellate courts have not hesitated to recognize the appropriate protections as a matter of state constitutional law. Therefore, to ensure that the State Constitution continues to adequately preserve the broader rights and interests of the people of Hawai'i, it is imperative that the chief judge is someone who is courageous and willing to recognize that the Hawai'i Constitution bestows broader rights and protections than the U.S. Constitution. Associate Judge Nakasone is that someone.

Thank you for the opportunity to share the Hawaii State Bar Association (HSBA) Board of Directors' comments on GM 790, Nomination of Judge Karen T. Nakasone for Chief Judge of the Intermediate Court of Appeals (ICA).

After a rigorous process, described below, the HSBA Board of Directors concluded that Judge Nakasone is **QUALIFIED**. Judge Nakasone has dedicated much of her public service to the law, social justice efforts, and to examining the rights of indigent defendants. As a Judge, she has been afforded significant civil experience and has broadened the depth of her legal experience across various areas of the law. Judge Nakasone is well respected in and out of the courtroom, and will continue to bring her strong work ethic, leadership skills, dedication to public service, and respect for the law to the ICA.

The HSBA Board of Directors followed its multi-step process to arrive at its conclusion, which included:

- The nominee was notified of the HSBA appointment review process, which includes a questionnaire requesting educational credentials, legal and other professional work experiences, and personal references; a resume; a copy of the Judicial Selection Commission (JSC) application; a form authorizing disclosure from the Office of Disciplinary Counsel of any disciplinary action; and an interview with the HSBA Board of Directors.
