**I. OVERVIEW OF PROPOSED LEGISLATION**

The **DLIR offers comments** to this proposal to effectuate the recommendations of the "Phase 3" forward-looking report and transfers the Office of State Fire Marshal from the DLIR to the Office of the Governor.

**II. CURRENT LAW**

Act 209 (SLH, 2024) established the Office State Fire Marshal within the DLIR. The State Fire Council has been administratively attached to the DLIR since Act 241 (SLH, 1978).

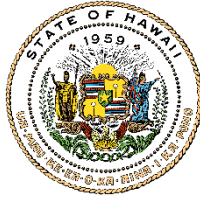
**III. COMMENTS ON THE HOUSE BILL**

The DLIR supports the previous versions of this bill wherein the permanent placement of the State Fire Council and State Fire Marshal is transferred to the Department of Defense (DOD) and defers to other agencies on the other substantive revisions involving fire safety.

The DLIR focuses on labor-related issues, such as worker well-being and labor-management relations, which are distinct from disaster preparedness and emergency response. The DOD has a mission centered on disaster readiness, response coordination, and public safety, making it a more appropriate home for fire protection and emergency management functions. Moreover, housing fire protection efforts in the DOD aligns fire safety responsibilities with the state's broader emergency response framework.

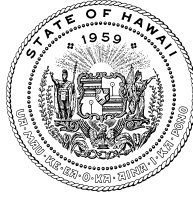

House Bill 1064, House Draft 2 proposes amending the laws concerning the Office of the State Fire Marshal to effectuate the recommendations of the "Phase 3" Forward-Looking Report prepared by the Fire Safety Research Institute regarding the August 2023 Maui wildfires, further clarifies the role of the State Fire Marshal, and appropriates funds. **The Department of Land and Natural Resources offers comments.**

The Department appreciates the intent of this measure, which defines and expands the roles of the State Fire Marshal and redefines the roles of the State Fire Council. By combining the Fire Marshal's enforcement power with the State Fire Council's advisory expertise, Hawai'i will establish a more proactive and effective fire safety framework that aligns with national best practices.

The Department supports the amendments in House Draft 2, stating that the Office of the State Fire Marshal (OSFM) reports directly to the Governor. The OSFM must function as a centralized authority, independent of local jurisdictions but in close collaboration with county and state fire and emergency management departments. Centralized oversight is essential to address systemic risks and ensure consistency across all islands. Reporting directly to the Governor's Office will provide the OSFM with the executive support needed to fulfill its statewide mandate, oversight, and coordination.

**H.B. No. 1064 H.D. 2 Relating to Fire Protection**

Chair Elefante, Chair Aquino, and members of the Senate Committee on Public Safety and Military Affairs and Senate Committee on Labor and Technology

The Office of the Governor provides the following **comments** for H.B.1064 H.D. 2, Relating to Fire Protection. This bill amends the laws concerning the Office of the State Fire Marshal to best effectuate the recommendations of the "Phase 3" Forward-Looking Report by Fire Safety Research Institute on the August 2023 Maui wildfires.

The Maui wildfire resulted in unbearable loss of lives, homes, infrastructure, and businesses. This tragic event is a wake-up call that due to climate changes, the risk of catastrophic wildfires, along with other natural disasters in Hawaii has increased.

Currently, the State Fire Council is administratively attached to the Department of Labor and Industrial Relations (DLIR). However, the evolving nature of fire-related emergencies, including wildfires and other large-scale incidents, necessitates a more integrated approach with the state's emergency management and response infrastructure. The Department of Defense (DOD), which encompasses the Hawaii Emergency Management Agency, is better positioned to provide the necessary support and coordination for statewide fire prevention and response efforts.

In the committee report for H.B.1064 H.D. 2 there are several amendments we find problematic.

Referenced below:

***(1) Deleting language that would have established the Office of the State Fire Marshal in the Department of Defense and instead temporarily establishing the Office in the Office of the Governor;***

***(2) Deleting language that would have required the State Fire Council to appoint the State Fire Marshal and instead requiring the Governor to appoint the State Fire Marshal from a list of three names submitted by the State Fire Council;***

These two amendments compromise the original framework of H.B. 1064 by shifting authority from specialized oversight to a more politically influenced structure. Originally, the bill intended for the Office of the State Fire Marshal to be housed within the Department of Defense, where technical expertise and disciplined management would ensure robust fire safety oversight. Additionally, allowing the State Fire Council to appoint the State Fire Marshal was designed to keep the process in the hands of experts. Changing these provisions to temporarily place the office in the Governor's office and vesting the appointment power in the Governor—even if limited to a selection from a list—risks infusing the process with greater political influence, thereby diluting the technical integrity that was central to the bill's intent.

***(7) Deleting language that would have transferred the State Fire Council from the Department of Labor and Industrial Relations to the Department of Defense;***

This amendment, which blocks the transfer of the State Fire Council to the Department of Defense, further deviates from the original design by maintaining the Council under the Department of Labor and Industrial Relations. This decision undermines the prospect of aligning the Council with the more structured and specialized environment of the Department of Defense, potentially limiting its effectiveness in overseeing fire safety and mitigation matters.

Together, these amendments disrupt the careful balance of resources and expert oversight envisioned in H.B. 1064, replacing a system designed to safeguard fire safety standards with one that may be more susceptible to external influence and less capable of upholding the rigorous standards originally proposed.

We respectfully request this Committee amend H.B.1064 H.D. 2 to reflect the original intent of the bill.

The proposed transfer of the State Fire Marshal and State Fire Council to the Department of Defense represents a strategic enhancement of Hawaii's fire protection and mitigation capabilities. By aligning these entities with the state's primary emergency management agency, we can ensure a more coordinated, efficient, and effective approach to safeguarding our communities from fire-related hazards.

Aloha Chair Elefante, Chair Aquino, Vice-Chair Wakai, Vice-Chair Lee, and members of the committees:

I am Major General Stephen Logan, Adjutant General and Director of the Hawaii Emergency Management Agency, State of Hawaii, Department of Defense.

The Department of Defense provides written testimony in **SUPPORT of HB 1064 HD2.**

The purpose of this bill is to amend the laws concerning the Office of the State Fire Marshal (OSFM) to best effectuate the recommendations of the "Phase 3" Forward-Looking Report by the Fire Safety Research Institute on the August 2023 Maui wildfires.

In the aftermath of the August 2023 Lahaina wildfires, the Department of the Attorney General initiated an investigation and retained the independent, third-party Fire Safety Research Institute, part of UL Research Institutes, to assess the performance of state and county agencies in preparing for and responding to the August 2023 Maui wildfires. The investigation led to three reports — a "Phase 1" Comprehensive Timeline report, a "Phase 2" Incident Analysis Report, and a "Phase 3" Forward-Looking Report.

The "Phase 3" Forward-Looking Report organized these findings and provided a prioritized list of action items for the State and all counties for changes to be made to improve Hawaii's response to wildfires. The report calls for changes and improvements to the OSFM, which was established by Act 209, Session Laws of Hawaii 2024. Changes included bolstering the statutory authority of the OSFM to address the wide spectrum of fire safety issues and delineating responsibilities and reporting structures between the State Fire Marshal and the State Fire Council; creating an organizational structure to immediately address the State's fire-safety priorities effectively; and substantially increasing the budget for the staffing of the OSFM.

The department supports the Governor's direction in aligning the OSFM's mission and responsibilities under the Department of Defense. The State Fire Marshal is currently located in the Department of Labor and Industrial Relations (DLIR). DLIR's focus on labor related issues is distinctly different from disaster preparedness and emergency response. The Department of Defense mission aligns with disaster readiness, response coordination and public safety making it a more appropriate location for fire protection and emergency management functions. It further co-locates the State Fire Council (SFC) and the OSFM.

This bill seeks to improve consistency with National Best Practices, such as those of California, Florida and New York, which all house their oversight of fire safety under their emergency management or emergency services divisions. Additionally, it will enhance resource allocation and administrative synergy. The Department of Defense already provides logistical and administrative support for emergency response entities, allowing the SFC and OSFM to leverage existing infrastructure.

The one concern the department has at this time is a relative lack of experience and technical expertise in fire management until the OSFM organizational structure can be established.

Wildfires are a growing threat and Hawaii's vulnerability to wildfires, as seen in recent events, necessitates a change. Passage of this bill would clarify the role of the State Fire Marshal and facilitate unity of effort with the State Fire Council thereby increasing the readiness and resilience of the State against fire related disasters.

Aloha Chairs Elefante and Aquino, Vice Chairs Wakai and Lee, and Members of the Committees,

Mahalo for the opportunity to testify **in support** of HB1064, HD2 relating to fire protection. The Climate Advisory Team (CAT) believes it is critical to support the Office of the State Fire Marshal in fulfilling its mission of protecting Hawai'i's residents and improving how the state responds to wildfires.

The CAT is a volunteer group, convened by Governor Green to develop community-informed policy recommendations to help make Hawai'i more resilient to natural disasters. The CAT published its findings and recommendations in a [policy paper](#) in January 2025, which provides detailed context for the measures we are supporting this legislative session.

The devastating 2023 Maui wildfires exposed significant vulnerabilities and inadequacies in our state's ability to prepare for and respond to wildfires. One of our greatest vulnerabilities is that the state does not have a State Fire Marshal. While the Legislature created a fire marshal position in 2024, as of this writing, that person has not yet been hired and has no staff, budget, or office. Establishing a fully functional Hawai'i State Fire Marshal Office was named the second highest priority in the Fire Safety Research Institute's (FSRI) "Phase 3" forward-looking report of actions to improve Hawai'i's response to wildfires.

The magnitude of work required by the Office of the State Fire Marshal cannot be overstated. This office must be supported, expanded, and appropriately resourced to ensure its stability and efficacy. This bill would appropriately clarify the role and duties of the Office of the State Fire Marshal, bolster its ability to address fire safety issues across the state and address the organizational structure of the Office of the State Fire Marshal. Additionally, the CAT supports further discussion between legislators and key

stakeholders on the most strategic organizational placement for the Office of the State Fire Marshal and the selection process for the role of the State Fire Marshal.

The CAT underscores the urgent need for more funding for the Office of the State Fire Marshal. The amount currently allocated for the office is \$172,000; the CAT recommends annual funding of at least \$2 million for the office. The annual funding for the state fire marshal position and the staffed office should be increased substantially in the 2025 legislative session with appropriate long-term funding commitments made. These steps are necessary to fully execute the recommendations made by FSRI and the attorney general and ensure our state is better equipped to respond to wildfires. Chairs Elefante and Aquino and Members of the Committees:

The Department of the Attorney General (Department) supports this bill and provides proposed amendments for clarity and consistency.

On Friday, August 11, 2023, the Department initiated an independent, third-party investigation to assess the performance of state and county agencies' preparation and response to the August 2023 Maui wildfires, including the Lahaina wildfire-initiated urban conflagration that killed 102 people. The Department retained the Fire Safety Research Institute (FSRI), a part of UL Research Institutes, to conduct the investigation, which was completed in approximately one year. Based upon this investigation, FSRI published three reports, which were released in phases: the Lahaina Fire Comprehensive Timeline Report (Phase One), the Lahaina Fire Incident Analysis Report (Phase Two), and the Lahaina Fire Forward-Looking Report (Phase Three).<sup>1</sup> The Phase Three report outlined specific actions that the State and counties should take to improve future wildfire preparedness and response.

This bill is in accord with the Phase Three report,<sup>2</sup> and would effectuate the priorities in the report that require legislative action, including: Priority 2 (Office of the State Fire Marshal), Priority 3 (Wildfire Education Programming), Priority 7 (Evacuation), Priority 8 (Codes and Standards), Priority 9 (Wildfire Response Preparedness), and Priority 10 (Vegetation and Land Management).

### **Recommended Amendments**

The Department offers the following amendments for clarity and consistency:

1. Add the following definition of “structure hardening” to section 132-A after page 2, line 19 (the term is used in section 132-Q(b)(3) (page 17, line 15)):  

"Structure hardening" means the installation, replacement, or retrofitting of building materials, systems, or assemblies used in the exterior design and construction of existing structures with the primary purpose of reducing risk to structures from wildfire and in compliance with the provisions of the state fire code relating to structure or home hardening.
2. Add three items to the enumerated directives of the OSFM as additional paragraphs to section 132-C(a) (page 3, line 14, to page 5, line 6) to be consistent with certain amendments added to H.D. 2:
  - a. "Prepare a statewide wildfire hazard map on a biennial basis" to be consistent with section 132-Q(a) (page 17, lines 3-6);
  - b. "Administer the community risk reduction program" to be consistent with sections 132-L and -M (page 11, line 4, to page 12, line 15); and
  - c. "Establish state-wide minimum defensible space requirements" to be consistent with section 132-P (page 14, line 10, to page 17, line 2)
3. Rename the title of section 132-G (page 9, lines 1-2) to “Utilization of firefighting resources,” as the current title does not align with the amended content of the section.

4. Amend section 132-M (page 12, lines 1-14) to:
  - a. Identify the OSFM as the agency responsible for administering the Community Risk Reduction Special Fund created in section 132-M(a) (page 12, lines 1-4).
  - b. Delete "continuously" on page 12, line 9, as the continuous appropriation may be deemed to violate article VII, section 5 ("[n]o public money shall be expended except pursuant to appropriations made by law"), or article VII, section 11 ("all appropriations for which the source is general obligation bond funds or general funds shall be for specified periods"), of the State Constitution.
5. Delete section 132-Q(g)(4) (page 20, lines 5-7), as it appears to essentially duplicate section 132-Q(g)(1) (page 19, lines 16-19).
6. Add the word "fire" between the words "state" and "marshal" in the title of section 132-R (page 22, line 10).
7. Make further amendments to section 132-16 (section 13 of this bill—page 50, line 12, to page 52, line 12), as follows:
  - a. Amend subsection (b)(4) (page 52, line 12) to read: "Coordinate with the state building code council on matters pertaining to fire safety"; and
  - b. Add subsection (c)(4) to read: "Review any conflicts that may arise in the adoption, amendment, or implementation of the state fire codes at the state and county levels or in the adoption, amendment, or implementation of rules proposed or adopted by the office or the counties pursuant to this chapter."
8. Add separate appropriation sections to specifically appropriate funds into and out of the Community Risk Reduction Special Fund, which is created under section 132-M (page 12, lines 1-14).

Thank you for the opportunity to provide comments on this important bill. We respectfully ask that it be passed.

My name is James Abraham and I am testifying on behalf of Hawaiian Electric in support of HB 1064, HD2, Relating to Fire Protection.

Hawaiian Electric supports this bill, which aims to implement safety priorities from the Fire Safety Research Institute Phase 3 Forward-Looking Report. Wildfires and other climate change impacts are whole-of-society issues that must be addressed collectively with a holistic approach by the State, counties, and private sector.

Hawaiian Electric recently submitted its 2025-2027 Wildfire Safety Strategy to the Hawai'i Public Utilities Commission, which details Hawaiian Electric's plans to deploy new technology, fortify infrastructure, minimize fire hazards and expand community partnerships to significantly reduce the risk of a wildfire started by its equipment. One aspect of this comprehensive bill is that it would give the State Fire Marshal's office discretionary power to explore additional opportunities to reduce wildfire risk, including engaging with electric utilities regarding further actions to protect public

safety, reduce risk to electric company customers, and promote electrical system resilience to wildfire damage. Hawaiian Electric would welcome the opportunity to work with the State Fire Marshal's office and as a member of the advisory board, as we continue our work with many State, county, and local stakeholders to create a safer and more resilient Hawai'i.

Accordingly, Hawaiian Electric supports HB 1064, HD2. Thank you for this opportunity to testify.

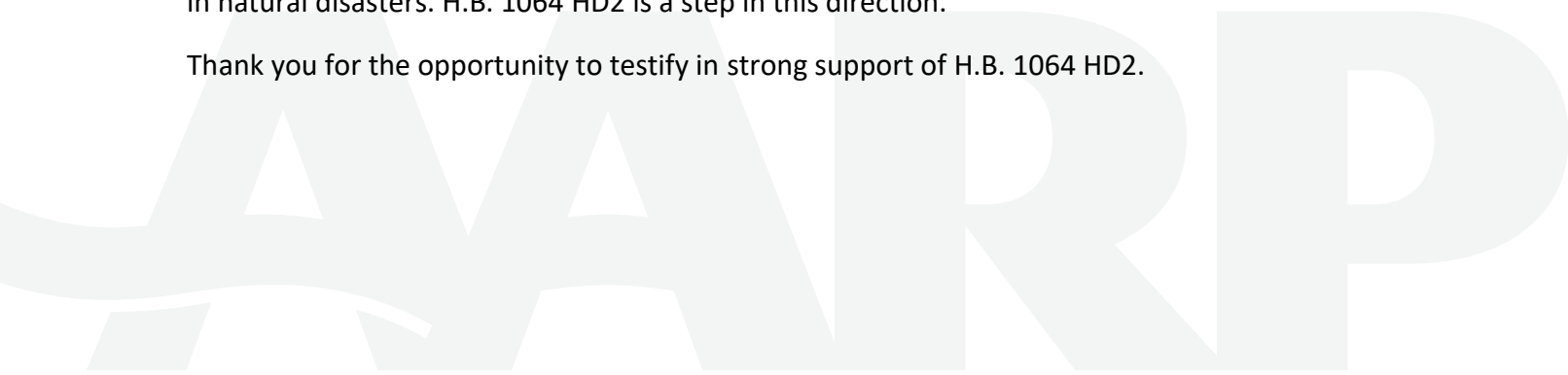

As you know, more than two-thirds of the victims in the Maui wildfire were 60 and older. Kūpuna are the most vulnerable population in every kind of natural disaster from wildfires to hurricanes to tsunami.

AARP believes policymakers should create and implement plans to address the needs of vulnerable populations like kupuna and people with disabilities. The State Fire Marshall's Office is one of the agencies that is in the best position to regularly conduct specific, comprehensive and evidence-based planning to address the needs of older adults, people with disabilities, and their caregivers in wildfires. They should be given the authority and tools to do this.

Hawaii's leaders need to encourage disaster resilience and reduce the number of kupuna deaths in natural disasters. H.B. 1064 HD2 is a step in this direction.

Chair Elefante, Vice Chair Wakai, and members of the Committee on Public Safety and Military Affairs and Chair Aquino, Vice Chair Lee and members of the Committee on Labor and Technology, my name is Leslie Door, Director of Product, Risk & Regulatory Compliance for Zephyr Insurance Company and Chair of the Property Policy Committee for Hawaii Insurers Council. The Hawaii Insurers Council is a non-profit trade association of property and casualty insurance companies licensed to do business in Hawaii. Member companies underwrite approximately forty percent of all property and casualty insurance premiums in the state.

Hawaii Insurers Council (HIC) **supports** this bill with one friendly amendment. HB 1064, HD2 implements Phase 3, a forward-looking report, from the Fire Safety Research Institute, which conducted a study after the Lahaina Wildfires in 2023. We believe this bill adopts measures that will reduce fire risk to our community. Defensible space, assistance for vulnerable persons, and a statewide building code all contribute to a community that is safer from fire.

HIC respectfully requests the language contained in proposed section 132-D(8)(A) on page 6, lines 18-20 through page 7, lines 1-2, be amended to read as follows, so that coordination with the insurance industry is done through the State Insurance Commissioner. The language we suggest would read as follows:

“(8)(A) The insurance commissioner, as defined in Section 431:2-102, regarding insurance policy coverage provisions, underwriting standards, insurance rates, and any other insurance-related topic relevant to enhancing the protection of property from wildfire at a reasonable cost; ...”
