#### In consideration of HOUSE BILL 1064, HOUSE DRAFT 2, SENATE DRAFT 1 RELATING TO FIRE PROTECTION

House Bill 1064, House Draft 2, Senate Draft 1 proposes amending the laws concerning the Office of the State Fire Marshal to effectuate the recommendations of the "Phase 3" Forward-Looking Report prepared by the Fire Safety Research Institute regarding the August 2023 Maui wildfires, further clarifies the role of the State Fire Marshal, and appropriates funds. Establishes the Office of the State Fire Marshal in the Department of Defense. Establishes the State Fire Marshal Selection Commission. The Department of Land and Natural Resources opposes this measure as written.

The Department appreciates the intent of this measure, which defines and expands the roles of the State Fire Marshal and redefines the roles of the State Fire Council. However, The Department does not support language in HB 1064, HD 2, SD 1, related to the establishment of the State Fire Marshal Selection Commission. On March 24, the State Fire Council (SFC), of which the Department's representative is a voting member, interviewed candidates for the State Fire Marshal (SFM) position as required by Act 209, Session Laws of Hawai'i 2024. The SFC identified a well-qualified, knowledgeable, and articulate candidate to fill the SFM position. The SFC intends to offer the SFM position to the selected candidate. The selection of this candidate culminated nine months and hundreds of manhours of effort by SFC members since Act 209 was enacted in July 2024. The amendments proposed in SD1 could potentially nullify the work of SFC in the selection of the SFM and delay the hiring of the SFM for many months.

The Department supports the amendment in House Draft 2, that states that the Office of the State Fire Marshal (OFSM) report directly to the Governor. The OSFM must function as a centralized authority, independent of local jurisdictions but in close collaboration with county and state fire and emergency management departments. Reporting directly to the Governor's Office will provide the OSFM with the executive support needed to fulfill its statewide mandate, oversight, and coordination.

The Department also recommends a minimum funding of \$2,000,000 to adequately support the reestablishment of the OFSM as specified in the SFC's 2024 Report to the Legislature. The Department urges your committees to pass legislation that will provide clarity, consistency, and continuity in consideration of the work and effort performed by the SFC to fill the SFM position.

#### I. OVERVIEW OF PROPOSED LEGISLATION

The **DLIR supports the intent** of this proposal to effectuate the recommendations of the "Phase 3" Forward-Looking Report. The department respectfully requests transferring the State Fire Council along with the Office of State Fire Marshal to the Department of Defense (DOD) to reflect the original intent of the Governor's proposal to align these entities with the state's primary emergency management agency.

#### **II. CURRENT LAW**

Act 209 (SLH, 2024) established the Office State Fire Marshal within the DLIR. The State Fire Council has been administratively attached to the DLIR since Act 241 (SLH, 1978).

#### III. COMMENTS ON THE HOUSE BILL

The DLIR strongly supports efforts to improve Hawaii's response to wildfires by delineating responsibilities and reporting structures and fostering an organizational structure to address fire safety priorities effectively. The DLIR's primary roles in response to the Maui wildfires included administering Disaster Unemployment Assistance and a National Dislocated Workers Grant. The department focuses on labor-related issues, which are distinct from disaster preparedness and emergency

response. The DOD has a mission centered on disaster readiness, response coordination, and public safety, making it a more appropriate home for fire protection and emergency management functions. The DOD, which encompasses the Hawaii Emergency Management Agency, is better positioned to provide the necessary support and coordination for statewide fire prevention and response efforts.

I am Major General Stephen Logan, Adjutant General and Director of the Hawaii Emergency Management Agency, State of Hawaii, Department of Defense.

The Department of Defense provides written testimony in **SUPPORT of HB 1064 HD2 SD1**.

The purpose of this bill is to amend the laws concerning the Office of the State Fire Marshal (OSFM) to best effectuate the recommendations of the "Phase 3" Forward-Looking Report by the Fire Safety Research Institution on the August 2023 Maui wildfires.

In the aftermath of the August 2023 Lahaina wildfires, the Department of the Attorney General initiated an investigation and retained the independent, third-party Fire Safety Research Institute, part of UL Research Institutes, to assess the performance of state and county agencies in preparing for and responding to the August 2023 Maui wildfires.

The investigation led to three reports — a "Phase 1" Comprehensive Timeline report, a "Phase 2" Incident Analysis Report, and a "Phase 3" Forward-Looking Report.

The "Phase 3" Forward-Looking Report organized these findings and provided a prioritized list of action items for the State and all counties for changes to be made to improve Hawaii's response to wildfires. The report calls for changes and improvements to the OSFM, which was established by Act 209, Session Laws of Hawaii 2024. Changes included bolstering the statutory authority of the OSFM to address the wide spectrum of fire safety issues and delineating responsibilities and reporting structures between the State Fire Marshal and the State Fire Council; creating an organizational structure to immediately address the State's fire-safety priorities effectively; and substantially increasing the budget for the staffing of the OSFM.

The department supports the Governor's direction in aligning the OSFM's mission and responsibilities under the Department of Defense. The State Fire Marshal is currently located in the Department of Labor and Industrial Relations (DLIR). DLIR's focus on labor related issues is distinctly different from disaster preparedness and emergency response. The Department of Defense mission aligns with disaster readiness, response coordination and public safety making it a more appropriate location for fire protection and emergency management functions. It further co-locates the State Fire Council (SFC) and the OSFM.

The bill will improve consistency with National Best Practices, such as those of other states, who house their oversight of fire safety under their emergency management or emergency services divisions. Additionally, it will enhance resource allocation and administrative synergy. The Department of Defense already provides logistical and administrative support for emergency response entities, allowing the SFC and OSFM to leverage existing infrastructure.

The one concern the department has at this time is a relative lack of experience and technical expertise in fire management until the OSFM organizational structure can be established.

Wildfires are a growing threat and Hawaii's vulnerability to wildfires, as seen in recent events, necessitates a change. Passage of this bill would clarify the role of the State Fire Marshal and facilitate unity of effort with the State Fire Council thereby increasing the readiness and resilience of the State against fire related disasters.

The Department of the Attorney General supports this bill and provides the following comments and recommended amendments.

This bill effectuates the recommendations of the "Phase 3" Forward-Looking Report by the Fire Safety Research Institute on the 2023 Maui wildfires and clarifies the role of the State Fire Marshal. It also relocates the Office of the State Fire Marshal from the Department of Labor and Industrial Relations to the Department of Defense, and establishes a new State Fire Marshal Selection Commission to appoint the State Fire Marshal beginning January 1, 2026. Until that day, the bill authorizes the Governor to appoint the State Fire Marshal from a list of three nominees submitted by the State Fire Council.

Act 209, Session Laws of Hawaii 2024 (Act 209), established the Office of the State Fire Marshal, effective July 1, 2024, and authorized the State Fire Council to appoint the State Fire Marshal for a five-year term.

The bill changes the appointment procedure established by Act 209. Under the proposed section 132-H(a), HRS (page 10, lines 1-11), any State Fire Marshall appointed by the State Fire Council under Act 209 would be replaced on this bill's effective date by the Governor's appointee, potentially a different person. If the

Legislature intends for the State Fire Marshal appointed under Act 209 to serve a fiveyear term, we recommend amending page 10, lines 2-5, as follows:

Until January 1, 2026,[the state fire marshal shall be the administrator of the office and] if a state fire marshal has not already been appointed by the state fire council as set forth in Act 209, Session Laws of Hawaii 2024, the state fire marshal shall be appointed by the governor from a list of three names submitted by the state fire council. (Wording to be deleted is bracketed and stricken; new wording is underscored).

In addition, we recommend adding a new subsection (g) to the new section to be added to chapter 132 establishing the State Fire Marshal Selection Commission after page 26, line 4, to read:

(g) Notwithstanding the provisions as set forth in this section, if a state fire marshal has already been appointed by the state fire council as set forth in Act 209, Session Laws of Hawaii 2024, the state fire marshal selection commission's authority to appoint the state fire marshal will begin upon the expiration of the appointed state fire marshal's term.

The State Fire Marshal Selection Commission, once created, would retain the authority to remove the State Fire Marshal, as provided in section 132- (b)(1), HRS, on page 23, lines 16-17.

Additionally, we note that section 132-J, HRS, on page 11, lines 7-10, provides that salaries and expenses of the Office of the State Fire Marshal "shall be paid in the same manner as the expenses of other offices of the office of the governor." This is inconsistent with the rest of the bill, which places the Office of the State Fire Marshal within the Department of Defense and appropriates funding for its operations to be expended by the Department of Defense as stated on page 59, lines 1-8. To address this inconsistency, we recommend deleting section 132-J (page 11, lines 7-10) and renumbering the subsequent sections accordingly.

We respectfully ask the Committees to consider these recommended revisions and pass this bill. Thank you for the opportunity to provide comments on this bill.

Aloha Chairs Dela Cruz and Rhoads, Vice Chairs Moriwaki and Gabbard, and Members of the Committees,

Mahalo for the opportunity to testify **in support** of HB1064, HD2, SD1, relating to fire protection. The Climate Advisory Team (CAT) believes it is critical to support the Office of the State Fire Marshal in fulfilling its mission of protecting Hawai'i's residents and improving how the state responds to wildfires.

The CAT is a volunteer group, convened by Governor Green to develop community-informed policy recommendations to help make Hawai'i more resilient to natural disasters. The CAT published its findings and recommendations in a <u>policy paper</u> in January 2025, which provides detailed context for the measures we are supporting this legislative session.

The devastating 2023 Maui wildfires exposed significant vulnerabilities and inadequacies in our state's ability to prepare for and respond to wildfires. One of our greatest vulnerabilities is that the state does not have a State Fire Marshal. While the Legislature created a fire marshal position in 2024, as of this writing, that person has not yet been hired and has no staff, budget, or office. Establishing a fully functional Hawai'i State Fire Marshal Office was named the second highest priority in the Fire Safety Research Institute's (FSRI) "Phase 3" forward-looking report of actions to improve Hawai'i's response to wildfires.

The magnitude of work required by the Office of the State Fire Marshal cannot be overstated. This office must be supported, expanded, and appropriately resourced to ensure its stability and efficacy. This bill would appropriately clarify the role and duties of the Office of the State Fire Marshal, bolster its ability to address fire safety issues across the state, and address the organizational structure of the Office of the State Fire Marshal.



The CAT underscores the urgent need for more funding for the Office of the State Fire Marshal. The amount currently allocated for the office is \$172,000; the CAT recommends annual funding of at least \$2 million for the office. The annual budget for the state fire marshal position and the staffed office should be increased substantially in the 2025 legislative session with appropriate long-term funding commitments made. These steps are necessary to fully execute the recommendations made by FSRI and the attorney general and ensure our state is better equipped to respond to wildfires. Please see <a href="Section3.2.3">Section 3.2.3</a> of our Policy Recommendation on Climate Disaster Resilience, Recovery and Funding for more information.

I am Kazuo Todd, Chair of the Hawaii State Fire Council (SFC). The SFC does not support language in HB 1064, HD 2, SD 1, related to the establishment of the State Fire Marshal Selection Commission.

On March 24, the SFC interviewed candidates for the State Fire Marshal (SFM) position as required by Act 209, Session Laws of Hawaii 2024. The SFC identified a well-qualified, knowledgeable, and articulate candidate to fill the SFM position. The SFC intends to offer the SFM position to the selected candidate.

The selection of this candidate culminated 9 months and hundreds of manhours of effort by SFC members since Act 209 was enacted in July 2024. The timeline, actions, and due diligence performed by the SFC to fill the SFM position is summarized:

5/3/24	House Bill 2085 to reestablish the Office of the State Fire Marshal (OSFM) passed Final Reading and was enrolled to the governor.
7/5/24	Act 209 to reestablish the OSFM was signed by Governor Green.
7/11/24	The SFC & DLIR start initial discussions and work on the SFM position description (PD) and other documents required by Act 209.
8/12/24	The SFC discussed its requirements to comply with Act 209 at its FY25 First Quarter Meeting.
9/18/24	The SFM position description was finalized by DLIR & SFC.
9/27/24	DLIR requests release of \$172,000 in general funds as appropriated by Act 209, SLH 2024.

9/27/24	The SFC conducted a special meeting & approved the SFM PD and 89-day hires for the position.
11/7/24	\$172,000 in general funds as requested by DLIR on 9/27/2024 was released by Governor Green.
11/8/24	The SFC approved the Report to the Legislature (required by Act 209) regarding the OSFM at its FY25 Second Quarter Meeting.
11/15/24	The SFM position description was posted on the DLIR & DHRD websites
1/14/25	The SFC approved establishment of a Permitted Interaction Group to review SFM application received and create a list of qualified applicants.
1/15/25	2025 Legislative session opens and several bills are introduced to place the OSFM within Hawaii State DoD.
1/23/25	The SFM position was removed from the DLIR & DHRD websites. 14 applications for the position were received.
2/3/25	The SFC conducted a special meeting on the presentation of findings and recommendations of the Permitted Interaction Group that was formed on 1/14/2025.
2/25/25	The SFC conducted a special meeting to accept presentation of findings and recommendations of the Permitted Interaction Group that was formed on 1/14/2025.
3/24/25	The SFC interviewed 4 applicants for the SFM position. Six candidates were initially scheduled for interviews but 2 withdrew.
3/27/25	The SFC chair met with the DLIR Deputy Director, HR specialist, and Deputy Attorneys General to obtain clarity on the SFM hiring process.

On March 27 a discussion with Department of Labor and Industrial Relations personnel, Deputy Attorneys General, and myself was conducted to agree upon the process to offer the position to the candidate selected by the SFC. All involved in the discussion agreed the current path forward to hire the selected candidate is unclear and language in HB 1064, HD2, SD1, certainly obfuscates the onboarding process.

The SFC strongly recommends amendments to HB 1064, HD 2, SD 1 which aligns with the SFC's 2024 Report to the Legislature, available at <a href="https://labor.hawaii.gov/wp-content/uploads/2024/11/State-Fire-Marshal-Report-ACT209-part-1-signed.pdf">https://labor.hawaii.gov/wp-content/uploads/2024/11/State-Fire-Marshal-Report-ACT209-part-1-signed.pdf</a>. The Personnel Plan section of the report states:

Posting of the SFM position shall follow established processes within the DLIR. The SFM shall be appointed by the SFC to serve a term of five years. If necessary, the SFC may fill the position of the SFM with a temporary (89-day hire). The appointment of the SFM shall be made without regard to chapters 76 and 89, and shall not be subject to the advice and consent of the senate. The SFM position was posted on the DLIR website. The SFM will be annually evaluated by the SFC in accordance with performance objectives (under development at the time of this report). The SFC may recommend or take corrective actions in the case of suboptimal performance by the SFM. At the time of this report, Act 209 specifies an appropriation to establish one full time equivalent permanent position to support the SFM. The SFM shall follow established processes

within the DLIR to fill the support position from a pool of qualified applicants. Additionally, Act 209 states the SFM may hire staff as necessary.

The SFC also recommends a minimum funding of \$2,000,000 to adequately support reestablishment the Office of the SFM as specified in the SFC's 2024 Report to the Legislature. The SFC urges your committees to pass legislation that will provide clarity, consistency, and continuity in consideration of the work and effort performed to fill the SFM position.

The Office of the Governor supports H.B.1064 H.D. 2, S.D 1, Relating to Fire Protection. This bill amends the laws concerning the Office of the State Fire Marshal to best effectuate the recommendations of the "Phase 3" Forward-Looking Report by Fire Safety Research Institute on the August 2023 Maui wildfires.

The Maui wildfire resulted in unbearable loss of lives, homes, infrastructure, and businesses. This tragic event is a wake-up call that due to climate changes, the risk of catastrophic wildfires, along with other natural disasters in Hawaii has increased.

Currently, the State Fire Council is administratively attached to the Department of Labor and Industrial Relations (DLIR). However, the evolving nature of fire-related emergencies, including wildfires and other large-scale incidents, necessitates a more integrated approach with the state's emergency management and response infrastructure. The Department of Defense (DOD), which encompasses the Hawaii Emergency Management Agency, is better positioned to provide the necessary support and coordination for statewide fire prevention and response efforts.

#### **Specific Reasons for the Proposed Transfer:**

- Enhanced Emergency Coordination: DOD's existing role in disaster preparedness
  and response aligns seamlessly with the objectives of the State Fire Marshal and State
  Fire Council. This alignment will facilitate more efficient mobilization of resources during
  fire emergencies.
- 2. **Improved Resource Allocation:** Integrating fire mitigation and coordinated services within the DOD allows for better allocation of federal and state resources, ensuring that fire prevention and response initiatives are adequately funded and supported.

3. **Streamlined Communication:** Housing the State Fire Marshal and State Fire Council within the DOD will enhance communication channels among various emergency response agencies, leading to more cohesive and effective operations during crises.

#### Additional Provisions in HB 1064 H.D. 2, S.D.1:

- Establishment of the Office of the State Fire Marshal: The bill placing the Office of the State Fire Marshal permanently to DOD for administrative purposes. The State Fire Marshal, appointed by the Governor from a list of three names submitted by the State Fire Council for a five-year term, and shall not be subject to the advice and consent of the Senate, will oversee statewide fire protection efforts, including coordinating with local agencies, reviewing fire risks, and conducting inspections of state buildings.
- **Duties of the State Fire Marshal:** The State Fire Marshal's responsibilities will encompass a broad range of activities aimed at enhancing fire safety, such as:
  - Coordinating fire protection efforts between local agencies.
  - Working with the State Fire Council on matters related to fire services.
  - Reviewing and proposing amendments to the state fire code.
  - Conducting inspections of state buildings to ensure fire safety compliance.
  - o Providing public education and awareness on fire safety.

#### Amendments to the Hawaii Revised Statutes (HRS):

- Amendment to HRS §132-16: The bill proposes amending HRS §132-16 to reflect the
  transfer of the State Fire Council to the DOD for administrative purposes. This change
  aligns the council's administrative support with its operational needs in fire prevention
  and response.
- Addition of New Section (§132-NEW): A new section is proposed to establish the state fire marshal selection commission, which shall be placed within the DOD for administrative purposes.

The proposed transfer of the State Fire Marshal and State Fire Council to the Department of Defense represents a strategic enhancement of Hawaii's fire protection and emergency response capabilities. By aligning these entities with the state's primary emergency management agency, we can ensure a more coordinated, efficient, and effective approach to safeguarding our communities from fire-related hazards.

I respectfully urge the committee to pass HB 1064, H.D. 2, S.D. 1 to strengthen our state's fire protection framework.

Subject: House Bill (HB) 1064, House Draft (HD) 2, Senate Draft (SD) 1 Relating to Fire Protection

I am Sheldon K. Hao, Fire Chief of the Honolulu Fire Department (HFD). The HFD opposes language in HB 1064, HD 2, SD 1, which proposes to establish a State Fire Marshal (SFM) Selection Commission.

On March 24, the State Fire Council (SFC) interviewed candidates for the SFM position, as required by Act 209, Session Laws of Hawaii (SLH) 2024. The SFC identified a well-qualified, knowledgeable, and articulate candidate to fill the SFM position. The SFC intends to offer the SFM position to the selected candidate.

The selection of this candidate culminated nine months of manhours and effort by SFC members since Act 209 was enacted in July 2024. The timeline, actions, and due diligence performed by the SFC to fill the SFM position is herewith summarized:

05/03/24 House Bill 2085 to reestablish the Office of the State Fire Marshall passed its final reading and was enrolled to Governor Josh Green.

- 07/05/24 Act 209 to reestablish the Office of the SFM was signed by Governor Green.
- 07/11/24 The SFC and the State of Hawai'i's (State) Department of Labor and Industrial Relations (DLIR) start initial discussions and work on the SFM position description (PD) and other documents required by Act 209.
- 08/12/24 The SFC discussed its requirements to comply with Act 209 at its fiscal year (FY) 2025 First Quarter Meeting.
- 09/18/24 The SFM PD was finalized by the DLIR and the SFC.
- 09/27/24 The DLIR requested release of \$172,000 in general funds, as appropriated by Act 209, SLH 2024.
- 09/27/24 The SFC conducted a special meeting and approved the SFM PD and 89-day hires for the position.
- 11/07/24 On September 27, 2024, \$172,000 in general funds were released by Governor Green as requested by the DLIR.
- 11/08/24 The SFC approved the Report to the Legislature (required by Act 209) regarding the Office of the SFM at its FY 2025 Second Quarter Meeting.
- 11/15/24 The SFM position description was posted on the DLIR and the State's Department of Human Resources Development (DHRD) websites.
- 01/14/25 The SFC conducted a special meeting and approved the establishment of a Permitted Interaction Group (PIG) to review SFM applications received and created a list of qualified applicants.
- 01/15/25 The 2025 Legislative Session opened, and several bills are introduced to place the Office of the SFM within the State's Department of Defense.
- 01/23/25 The SFM position was removed from the DLIR and the DHRD websites. There were 14 applications that were received for the position.
- 02/03/25 The SFC conducted a special meeting on the presentation of findings and recommendations of the PIG that was formed on January 14, 2025.
- 02/25/25 The SFC conducted a special meeting to accept the presentation of findings and recommendations of the PIG that was formed on January 14, 2025.

- 03/24/25 The SFC interviewed four applicants for the SFM position. Six candidates were initially scheduled for an interview, but two withdrew.
- 03/27/25 The SFC Chair met with the DLIR Deputy Director, Human Resource Specialist, and Deputy Attorneys General to obtain clarity on the SFM hiring process.

On March 27, 2025, a discussion with DLIR personnel, Deputy Attorneys General, and the SFC Chair was conducted to agree upon the process to offer the position to the candidate selected by the SFC. All involved in the discussion agreed the current path forward to hire the selected candidate is unclear and language in HB 1064, HD2, SD1 certainly obfuscates the onboarding process.

The SFC strongly recommends amendments to HB 1064, HD 2, SD 1, which aligns with the SFC's 2024 Report to the Legislature and is available at <a href="https://labor.hawaii.gov/wp-content/uploads/2024/11/State-Fire-Marshal-Report-ACT209-part-1-signed.pdf">https://labor.hawaii.gov/wp-content/uploads/2024/11/State-Fire-Marshal-Report-ACT209-part-1-signed.pdf</a>. The Personnel Plan section of the report states:

Posting of the SFM position shall follow established processes within the DLIR. The SFM shall be appointed by the SFC to serve a term of five years. If necessary, the SFC may fill the position of the SFM with a temporary (89-day) hire. The appointment of the SFM shall be made without regard to chapters 76 and 89, and shall not be subject to the advice and consent of the senate. The SFM position was posted on the DLIR website. The SFM will be annually evaluated by the SFC in accordance with performance objectives (under development at the time of this report). The SFC may recommend or take corrective actions in the case of suboptimal performance by the SFM. At the time of this report, Act 209 specifies an appropriation to establish one full time equivalent permanent position to support the SFM. The SFM shall follow established processes within the DLIR to fill the support position from a pool of qualified applicants. Additionally, Act 209 states the SFM may hire staff as necessary.

The SFC also recommends a minimum funding of \$2,000,000 to adequately support reestablishment of the Office of the SFM, as specified in the SFC's 2024 Report to the Legislature.

The SFC urges your committees to pass legislation that will provide clarity, consistency, and continuity in consideration of the work and effort performed to fill the SFM position.

HB1064 HD2 SD1 addresses key gaps in coordination and preparedness, reflecting many of the concerns raised since the tragedy. I am Roberta Chun, a concerned citizen strongly **opposed** to H.B. 1064. The absence of a State Fire Council (SFC) representative as a <u>voting member</u> on the State Fire Marshal Selection Commission (SFMSC) is a gross oversight. The State Fire Council is made up of the most skilled and up-to-date personnel with firsthand knowledge of fire prevention in the State.

This bill is in response to the "Phase 3" Forward Looking Report by the Fire Safety Research Institute on the 2023 Maui wildfires. This report lists its first priority on the State and County levels as action planning and accountability. This bill does not identify the National Incident Management System (NIMS) and Incident Command System (ICS) that centers around planning, training and accountability. All Hawaii fire departments have been following NIMS for more than twenty years when the President directed the Secretary of Homeland Security to develop and administer NIMS on February 28, 2003. Yet communication was lost at the NIMS level due to the lack of preparedness and training.

The "Phase 3" report follows the NIMS framework identifying the major components: preparedness, communications and information management, resource management, command and management, and ongoing management and maintenance, including electronic mapping.

NIMS represents a core set of doctrine, concepts, principles, terminology, and organizational processes that enables effective, efficient and collaborative incident management. All Federal departments and agencies are required to adopt and use NIMS as they carry out their responsibilities in response to incidents, as does the State of Hawaii. NIMS adoption and compliance is also a condition of Federal preparedness assistance. ICS is one component of the larger NIMS framework.

Hawaii county fire departments are the backbone with expertise of fire incident management in similar but unique jurisdictions. Preparedness planning as described in NIMS between the public and private sector would have made a significant impact in the outcome of the destruction that took place by the Lahaina fire.

HRS Chapter 46, Section 4, grants counties the power to designate and define zoning districts and specifically outlines the powers of counties regarding zoning, including the ability to prescribe rules, regulations, and administrative procedures for enforcing zoning ordinances. Counties are responsible for enforcing the use classification districts adopted by the Land Use Commission

(LUC) and the restrictions on use and conditions relating to agricultural districts. The counties' responsibility for enforcement includes taking necessary actions against violators of land use district classifications and land use district regulations, except those relating to conservation districts.

As it stands, county fire departments have no jurisdiction to enforce the fire code on State or other public real property. In 2024, 22 public schools were holding classes with inoperable fire alarm systems. Over 60% of Hawaii public schools have fire alarm issues. Other State buildings are no different. The State is the owner and responsible party in enforcing the fire code on publicly owned lands. The SFM must have enforcement powers to sanction State departments who fail to comply with the fire code, and the counties must have enforcement powers to sanction State departments who fail to comply with the fire code.

H.B. 1064 is a poorly formulated cumbersome bill outlining duties to the OSFM that conflict with existing required policies and procedures and are redundant in others. This bill in and of itself is its own best testimony showing gross oversight by not including representatives of the SFC on the SFMSC. The SFMSC would best carry out its duty to the people of Hawaii by consisting of five voting members: two representatives of the SFC appointed by the SFC; one appointed by the governor and approved by the Senate; one by the Senate and one by the House. Failing to recognize the SFC members as the experts in fire safety is not acceptable.
