
Honorable Chair, Vice-Chair and Committee Members,

Thank you for the opportunity to submit testimony in **Support of HB1176.** 

Research and development facilitates innovation which is essential for economic growth in Hawai'i. The Hawai'i Economic Diversification Program will encourage technology companies to conduct business in Hawai'i and will allow Hawai'i companies to compete with other states to recruit and retain more local talent.

This program will provide grants to qualified Hawai'i technology businesses that do research in strategic high growth industries such as artificial intelligence, biotechnology, nanotechnology, therapeutics, etc.

Oceanit is one of the largest local science and technology companies in the State and has been around for over 39 years. We strongly support HB1176 as one of the few state policies to support our local industry.

Makai Ocean Engineering, Inc. (Makai) **SUPPORTS HB1176** and respectfully requests the removal of the first-come, first-served provision in favor of a fairer distribution method..

We ask the committee to consider removing the first come, first served basis from the grant. Many of the Qualified High Technology Business (QHTB) were not able to receive the credits in prior years, because all of the funding was allocated in the first 23 seconds. Makai believes that including a provision allowing all businesses that submit their applications within the first 24 hours to receive a prorated share of the \$10,000,000 would provide broader support for Hawaii's QHTB community.

This approach ensures that both startups and established businesses have an equal opportunity to access funding, rather than favoring only those who can submit within seconds.

# Makai supports this bill's efforts to address key issues with the current research credit, including:

- Ensuring that grants are directed to truly qualified technology companies, aligning with the bill's intent.
- Removing the reference to the base amount in IRS Section 41, which currently limits eligibility for many innovative tech firms.

## **About Makai Ocean Engineering**

Makai is a locally-owned and operated technology company that has been based in Hawai`i for over 50 years. We are currently performing R&D on a variety of exciting ocean technology projects, including Machine Learning software, autonomous underwater vehicles, ocean thermal energy conversion (OTEC), seawater air conditioning (SWAC), and subsea cable systems.

Makai has been successful in bringing in tens of millions of dollars in R&D funds from federal and international sponsors to Hawai`i, helping to stem the tide of "brain drain" of talented kama`aina kids going to the mainland. Makai is not unique among Hawaii technology companies in this. There is a tech community here that has made a strong economic impact in terms of high

paying jobs, and demonstrated success in <u>commercializing R&D</u>, which has increased taxable revenue for the state, and brought home kama'aina scientists and engineers.

My name is Sherry Menor, President and CEO of the Chamber of Commerce Hawaii ("The Chamber"). The Chamber supports House Bill 1176 (HB1176), which establishes a public policy framework that addresses state goals related to economic diversification and appropriates funds to the Hawaii Technology and Development Corporation to implement specific programs that address these goals.

HB1176 aligns with our 2030 Blueprint for Hawaii: An Economic Action Plan, specifically under the policy pillar for Small Business. This bill promotes policies that drive economic growth, enhance workforce opportunities, and improve the quality of life for Hawaii's residents.

Hawaii's economy faces challenges due to its reliance on tourism and limited diversification in highgrowth industries. To encourage innovation and economic resilience, this bill establishes the Hawaii Economic Diversification Grant Program, which supports qualified high technology businesses engaged in research and development (R&D). Modeled after the federal R&D tax credit, this program provides grants equal to the federal research credit for businesses conducting qualified research in Hawaii.

The bill allocates funding to the Hawaii Technology Development Corporation to administer the program, with a \$10 million cap on total annual grants. Participating businesses must report on expenditures, job creation, intellectual property, and economic impact, ensuring accountability and effectiveness. By incentivizing R&D in biotechnology, renewable energy, artificial intelligence, and other high-tech industries, this measure diversifies Hawaii's economy, fosters innovation, and creates high-paying jobs. The Chamber supports this bill as a key investment in Hawaii's long-term economic growth and sustainability.
