DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the bill's intent and offers comments. DHS respectfully requests that this program and appropriation not conflict with, reduce, or replace priorities identified in the executive budget. Additionally, DHS prefers that any increase appropriation be included in the executive budget bill as a recurring appropriation so that the coverage could be ongoing.

PURPOSE: Appropriates funds to the Department of Human Services to authorize Medicaid coverage through the Children's Health Insurance Program to income-qualified pregnant persons and children regardless of immigration status.

The House Committee on Human Services and Homelessness amended the measure by:

- (1) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

DHS believes there is a clear benefit to the state to ensure all residents, regardless of immigration status, have access to health care. Per [Senate Concurrent Resolution 183 SD1 \(2023\)](#), DHS completed its [report](#) on this matter. The general fund appropriations in the bill are

based on cost estimates in the report to provide coverage for 500 pregnant women and 4,000 children.

The House Committee on Human Services and Homelessness Committee Report cited the DHS legislative report regarding the state funds needed to provide health insurance coverage for children regardless of their immigration status if DHS were able to get permission to use the CHIP State Plan Option or the CHIP Health Services Initiative (HSI) option. The amounts cited are (1) \$744,000 for pregnant persons (CHIP State Plan Option); (2) \$620,000 for pregnant persons, including ten months post-partum care (HSI); and (3) \$2,976,000 for children under the (HSI) option. Given the current federal administration's stance on immigration status and the Medicaid/CHIP program, it may be unlikely that DHS would be allowed to use the HSI option. If only state funds could be used for the populations in (2) and (3), the amounts are (2) \$2,000,000 for pregnant persons' post-partum care (HSI) and (3) \$9,600,000 for children.

DHS notes that any reductions to federal funding levels will impact our ability to execute programs at current levels and may make execution of the changes proposed in this bill difficult or impossible to accomplish.

The Legal Clinic (TLC) supports HB1349, HD1, which appropriates funds to the Department of Human Services to authorize Medicaid coverage through the Children's Health Insurance Program to income-qualified pregnant persons and children regardless of immigration status. This is a much needed social safety net measure.

TLC is a Hawai'i nonprofit, nonpartisan organization. TLC is a direct legal services provider, representing those in Hawai'i who meet income eligibility guidelines without regard to immigration status, national origin, ethnic background, race, religion, ideology, gender identity, sexual orientation, age, or disability. TLC works alongside immigrants so they can attain authorization to work and live with dignity, reunite with their families after years of separation and escape horrific violence to find refuge in the United States. TLC recognizes that every person needs and deserves to feel a sense of trust, welcome, and belonging.

According to the 2020 U.S. Census, Hawai'i is the most diverse state in the nation.¹ In 2023, Hawai'i had about 256,000 immigrants, which is approx. 18% of the State population.² The top countries of origin for immigrants were the Philippines (45 percent of immigrants), China (9 percent), Japan (8 percent), Korea (6 percent), and the Pacific Island Nations (4 percent).³

There are between 41,000 -50,500 undocumented immigrants in Hawai'i.⁴ Hawaii is the only state where undocumented women (55%) outnumber men.⁵

Approximately 500 pregnant persons and 4,000 income qualified children in Hawaii are denied access to affordable health care through Medicaid, the children's health insurance program, and health insurance exchanges established under Affordable Care Act, solely due to their immigration status.

Low-income immigrants without prenatal care are 7 times more likely to give birth prematurely and 5 times more likely to experience neonatal death, demonstrating that limited access to health care for pregnant persons and their newborn children significantly increases risk of exposure to life-threatening situations. Providing access to health insurance coverage for income-qualified pregnant persons will help lower barriers and increase access to health care for resident immigrant populations in the State. It will also increase health outcomes.

Low-income immigrant children without access to health care services experience a higher rate of preventable hospitalizations during childhood. Without appropriate medical management, chronic conditions such as asthma and diabetes may lead to life-threatening medical emergencies. Inadequate access to preventative care such as immunizations and well-being and well-child visits may aggravate various health conditions increasing the occurrence of acute and chronic conditions and can leave developmental health conditions undiagnosed and untreated.

As of June 2024, 24 states and the District of Columbia provide Medicaid coverage to income-eligible children regardless of immigration status. A 2024 report by the Department of Human Services found that the state may "leverage the Unborn Children Children's Health Insurance Program (CHIP) State Plan option. This Medicaid option allows states to cover the unborn child of pregnant persons who are not traditionally eligible for coverage due to their immigration status. This option is supported with a federal matching rate of just over 69%."⁶

As for children, "[s]tates do have the option to cover immigrant children who do not meet the immigration criteria for Medicaid or CHIP using state-only funds. This option does not require CMS approval or reporting but is a larger financial commitment from the state to fund the benefits. Several states, like Illinois, California, New York, and Oregon, use state-only funds to cover all children regardless of immigration status."⁷

TLC understands that it may be more fiscally feasible at this time to only provide coverage to pregnant persons through HB1349, HD1 and will support a clarifying amendment to this bill stating that HB1349, HD1 appropriates funds to the Department of Human Services to authorize Medicaid coverage through the Children's Health Insurance Program to income-qualified pregnant persons, omitting children, regardless of immigration status.

This bill will ensure that people are afforded some measure of medical care for health and welfare for themselves, their families and their communities, and for our basic human rights and dignity.

TESTIMONY IN STRONG SUPPORT OF HB 1349

Submitted by The Hawai'i Friends of Civil Rights

The Hawai'i Friends of Civil Rights works to achieve equity, justice, inclusion, uphold civil rights, and eliminate discrimination. We stand in **Strong Support of H.B. 1349**

Long-established medical consensus holds that prenatal care is fundamental to reproductive and infant health. The lack of access to prenatal care increases the risk of premature birth and low birth weight and is a factor in a range of poor health outcomes experienced by undocumented pregnant women and their babies, including higher rates of labor and delivery complications and premature births. Many of these negative outcomes pose long-term development risks to newborn U.S. citizen children and could be avoided with full access to prenatal care.

A recently released report, the Hawai'i Department of Health reported that from 2018 to 2021, the maternal death rate in the United States increased from 17.4 to 32.9 per 100,000 live births and that disadvantaged populations including Native Hawaiians and other Pacific Islanders, Black, and American Indian and Alaska Native persons have the highest rates of pregnancy-related deaths. The report further noted that approximately 80% of pregnancy-related deaths are preventable requiring a multilevel approach that includes ensuring quality care for all pregnant and postpartum persons. Additionally, the Kaiser Family Foundation (KFF) noted that expanding Medicaid coverage regardless of immigration status resulted in improved outcomes including increases in average gestation and birth weight among newborns. Med-Quest's estimate for providing Medicaid coverage for an estimated cohort of 500 undocumented pregnant persons is \$744,000 in state funds for pregnancy-related services and 2 months of postpartum care. Extending postpartum care an additional 10 months would increase state-funded costs to \$1,364,000.

With one of the lowest national rates of uninsured persons and a leader in healthcare, Hawai'i has the opportunity to reaffirm its commitment to healthcare through this measure and to recognize the substantial federal and state tax contributions made by Hawai'i's undocumented residents.

AlohaCare appreciates the opportunity to provide testimony in **strong support of HB1349 HD1**. This measure appropriates funds to the Department of Human Services to authorize Medicaid coverage through the Children's Health Insurance Program to income-qualified pregnant persons and children regardless of immigration status.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

Consistent with our mission and our values, AlohaCare is committed to promoting access to quality, whole-person healthcare for all of Hawai'i's residents, regardless of immigration status. An estimated 45,000 undocumented immigrants live in Hawai'i, making up 3% of the State's total population. Expanding coverage will contribute to our State's health equity and social determinants of health (SDOH) priorities at large by increasing healthcare access.¹ Under the SDOH framework, a person's social and community context are key factors that affect health outcomes. AlohaCare understands expanding coverage may improve our current member's health and well-being, specifically those that are family of undocumented immigrants, as they are often subject to trauma and various social and environmental stressors.² In 2014, approximately 60,202 people in Hawai'i lived with at least one undocumented family member.

Our neighbors, friends, and ‘ohana who are undocumented immigrants are working, contributing to Hawai‘i’s economy, and should not be subject to the risks of living without health insurance. The American Immigration Council estimates that undocumented workers are overrepresented in the State’s labor force at 4.5%, primarily in the leisure/hospitality and agriculture industries.³ In 2024, undocumented immigrants paid an estimated \$157 million in State and local tax contributions, and across the nation undocumented immigrants paid an estimated \$59.4 billion to the federal government.⁴

According to Hawai‘i Friends of Civil Rights testimony on the 2023 bill SB842, many of the 45,000 undocumented persons in Hawai‘i secure health insurance through the Hawai‘i Prepaid Health Care Act, while approximately 11,000 undocumented immigrants are uninsured—with 43% of these households reporting incomes below 200% of the federal poverty level—unable to access the care they need until they have a medical illness or condition that becomes an emergency.⁵

Expanding coverage will allow undocumented immigrants to access primary and preventative care and may decrease emergency room visits. Hawai‘i’s Medicaid program currently provides coverage of emergency medical services to individuals who are ineligible for Medicaid due to immigration status. This emergency coverage is provided to stabilize the emergency medical condition, but Medicaid does not cover any follow-up visits resulting from the emergency visit.

Dear Chairs, Vice Chairs, and Members of the Committees,

The Hawai‘i Coalition for Immigrant Rights (HCIR) submits this testimony in **strong support of HB1349 HD1**, which seeks to expand Medicaid coverage through the Children’s Health Insurance Program (CHIP) to income-qualified pregnant persons and children, regardless of immigration status.

HCIR is committed to advancing the rights and well-being of immigrants in Hawai‘i by advocating for policies that promote equity, healthcare access, and full participation in society. A key part of our mission is ensuring that all individuals—regardless of where they were born—have the opportunity to live healthy lives and become productive members of our community. However, many immigrant families in Hawai‘i lack access to basic healthcare due to their immigration status, putting them and their children at serious risk.

Hawai‘i is home to a significant immigrant population, many of whom contribute to our economy in essential industries such as agriculture, healthcare, construction, and hospitality. Yet, despite their contributions, many immigrant families are excluded from critical healthcare programs. This is especially harmful to pregnant individuals and children, who require consistent, quality medical care to thrive. Without access to affordable healthcare, many forego necessary prenatal checkups, vaccinations, and routine pediatric care, leading to severe and preventable health complications.

States such as California, Illinois, New York, and Oregon have already recognized this inequity and expanded Medicaid-like coverage to all income-eligible pregnant persons and children, regardless of immigration status. Hawai‘i must follow suit and reaffirm its values of inclusion, equity, and compassion.

The public health and economic benefits of passing HB1349 are undeniable:

- **Reducing premature births and neonatal deaths:** Lack of prenatal care is one of the leading causes of low birth weight, complications during delivery, and long-term health issues for infants. These preventable outcomes place a heavy emotional and financial burden on families and increase costs for the state’s healthcare system.

- **Lowering emergency healthcare costs:** When families cannot access routine care, they are forced to rely on emergency rooms for preventable conditions, which is far more expensive and places additional strain on Hawai'i's hospitals and public health resources.
- **Improving economic stability for families:** Ensuring that children and expecting parents have medical coverage allows families to focus on work, education, and their future, rather than living in fear of a medical crisis they cannot afford.

At HCIR, we believe that no child and no expecting parent should be denied healthcare simply because of their immigration status. HB1349 is a common-sense, compassionate, and cost-effective solution that will improve health outcomes, reduce disparities, and strengthen Hawai'i's communities.

We strongly urge the committee to pass this bill and ensure that every child and every pregnant person in Hawai'i has access to the healthcare they need to thrive.

The purpose of this bill is to appropriate funds to the Hawaii Department of Human Services to authorize Medicaid coverage to income-qualified pregnant persons and children regardless of immigration status.

Approximately 500 pregnant persons and 4,000 income qualified children in Hawaii are denied access to affordable health care through Medicaid, the children's health insurance program, and health insurance exchanges established under Affordable Care Act, solely due to their immigration status.

Low-income immigrants without prenatal care are 7 times more likely to give birth prematurely and 5 times more likely to experience neonatal death, demonstrating that limited access to health care for pregnant persons and their newborn children significantly increases risk of exposure to life-threatening situations.

In Hawaii the current cost of an average neonatal intensive care unit stay is between \$7,000 and \$8,000 a day.

Hawaii DHS estimates the cost of providing income-qualified pregnant persons with health insurance coverage and twelve months of post-partum care at \$1,364,000 annually.

Providing access to health insurance coverage for income-qualified pregnant persons will help lower barriers and increase access to health care for resident immigrant populations in the State. It will also increase health outcomes.

Low-income immigrant children without access to health care services experience a higher rate of preventable hospitalizations during childhood. Without appropriate medical management, chronic conditions such as asthma and diabetes may lead to life-threatening medical emergencies. Inadequate access to preventative care such as immunizations and well-being and well-child visits may aggravate various health conditions increasing the occurrence of acute and chronic conditions and can leave developmental health conditions undiagnosed and untreated.

As of June 2024, 12 states and the District of Columbia provide Medicaid coverage to income-eligible children regardless of immigration status. Hawaii DHS estimates the cost of providing income-qualified children with health insurance coverage under the federal health services

initiative program at \$2,976,000, with a wholly funded state program estimated at \$9,600,000. Increasing access to health insurance coverage for income-qualified children will improve health care outcomes for all keiki, regardless of immigration status.

A 2024 report by the Department of Human Services found that the state may “leverage the Unborn Children Children's Health Insurance Program (CHIP) State Plan option. This Medicaid option allows states to cover the unborn child of pregnant persons who are not traditionally eligible for coverage due to their immigration status. This option is supported with a federal matching rate of just over 69%.” [DC202 .PDF](#) (retrieved 1/16/2025).

As for children, “States do have the option to cover immigrant children who do not meet the immigration criteria

for Medicaid or CHIP using state-only funds. This option does not require CMS approval or reporting but is a larger financial commitment from the state to fund the benefits. Several states, like Illinois, California, New York, and Oregon, use state-only funds to cover all children regardless of immigration status.” [DC202 .PDF](#) (retrieved 1/16/2025).

Aloha Chair Yamashita, Vice Chair Takenouchi, and Members of the Committee,

My name is Christine Andrews, and I submit this testimony today in SUPPORT of HB 1349, HD1 - Relating to Medicaid.

Every year, approximately five hundred pregnant persons in Hawai`i are denied access to affordable health care through Medicaid, the Children's Health Insurance Program, and health insurance exchanges established under the Patient Protection and Affordable Care Act, P.L. 111—148, because of their immigration status. Evidence-based studies show that low-income immigrants without access to prenatal care are seven times more likely to give birth prematurely and five times more likely to experience neonatal death. Improving maternal and neonatal outcomes is not only a highly-desirable public health goal, it is also a cost-saving measure, as providing health coverage to improve outcomes avoids the costs of avoidable intensive medical interventions.

While providing health coverage to low-income pregnant persons regardless of immigrant status provides public health benefits and save costs, as of May 2024, Hawai`i was not among the community of twenty-four states plus the District of Columbia to provide medicaid coverage to all income-qualified pregnant residents regardless of their immigrant status. The Department of Human Services estimates the cost of providing income-qualified pregnant persons with health insurance coverage and twelve months of postpartum care at \$1,364,000 annually.

Increasing access to health insurance coverage to include income-qualified pregnant persons will reduce barriers and increase access to health care for resident immigrant populations in the State. To estimate the potential cost savings of the proposal, I will discuss the financial benefits of avoiding costs associated with preterm births. According to the CDC's National Center for Health Statistics, in 2022, Hawai`i ranked 18th nationwide for preterm births, with a preterm birth rate of 9.82%. For the approximate five hundred pregnant persons in Hawai`i currently denied access to affordable health care, that comes to approximately 49 preterm births. According to "Preterm birth lifetime costs in the United States in 2016: An update", the annual societal economic cost (medical, educational, and lost productivity) associated with preterm birth in Hawaii was an estimated \$73,000, or over \$97,200 in today's dollars. So, while the cost of the proposed bill, which is the cost of providing income-qualified pregnant persons with health

insurance coverage and twelve months of postpartum care, is cost-effective when considering potential avoided preterm birth costs alone, which could be as much as 49 preterm births times \$97,200, or \$4,762,800. Health care provided to income-qualified pregnant persons ultimately avoids greater public health care costs.

I SUPPORT HB 1349, HD1 as both a financially prudent public health care investment as well as a moral imperative to support our community members regardless of immigrant status.

****Testimony in Opposition to HB1349 – Relating to Medicaid****

Aloha Honorable Members of the House of Representatives,

I am writing to express my opposition to HB1349, a bill that seeks to appropriate funds to the Department of Human Services to provide Medicaid coverage through the Children’s Health Insurance Program (CHIP) to income-qualified pregnant persons and children, regardless of their immigration status. While I share the Legislature’s commitment to public health and compassion for vulnerable populations, I believe this proposal raises significant fiscal, legal, and policy concerns that outweigh its intended benefits. Below, I outline my objections to this legislation.

First, extending Medicaid and CHIP benefits to individuals regardless of immigration status places an unsustainable financial burden on Hawaii’s taxpayers. The bill estimates an annual cost of \$1,364,000 to cover approximately 500 pregnant persons and an unspecified number of children, yet it does not account for potential increases in demand or administrative costs as awareness of the program spreads. Hawaii’s budget is already strained by high living costs, housing shortages, and the need to support existing residents. Allocating scarce general revenue funds to expand coverage for non-citizens risks diverting resources from citizens and legal residents who rely on these programs, potentially leading to reduced services or increased taxes for all.

Second, this legislation undermines federal immigration policy and creates a precedent that could incentivize illegal immigration to Hawaii. Federal law currently restricts Medicaid eligibility to citizens and certain qualified immigrants, reflecting a balanced approach to resource allocation and national sovereignty. By bypassing these restrictions, HB1349 could signal that Hawaii offers generous benefits without regard to legal status, potentially attracting more undocumented individuals to the state. This could strain not only healthcare systems but also housing, education, and social services, further compounding the challenges faced by our communities.

Third, the bill’s reliance on state funding rather than federal matching funds exacerbates its fiscal impact. Unlike standard Medicaid expenditures, which benefit from significant federal contributions, the costs of covering undocumented individuals fall entirely on the state. The cited daily cost of neonatal intensive care unit stays (\$7,000–\$8,000) highlights the expense of untreated conditions, but proactive prenatal care for this population does not guarantee cost

savings if complications persist or if utilization exceeds projections. Without a clear cost-benefit analysis or federal support, this proposal risks becoming an inefficient use of state resources.

Finally, while the effective date of July 1, 3000, suggests this bill is a long-term proposal, its introduction now reflects a policy direction that merits scrutiny. Hawaii should prioritize healthcare access for its legal residents and work within federal frameworks to address gaps in coverage, rather than creating a state-specific entitlement that duplicates existing efforts like community health centers, which already serve underserved populations regardless of status. Alternative solutions—such as partnerships with nonprofits or federal advocacy for broader reforms—could achieve similar outcomes without the risks posed by HB1349.

In conclusion, HB1349's expansion of Medicaid and CHIP coverage to undocumented pregnant persons and children, while well-intentioned, threatens Hawaii's fiscal stability, legal consistency, and resource equity. I respectfully urge you to vote against this bill and focus on sustainable, federally aligned strategies to improve healthcare access for all legal residents of our state. 
