Dear Members of the House Finance Committee,

I am writing to express my **strong opposition** to House Bill 1391, which proposes the establishment of a Hawaii-Ireland Trade Commission within the Department of Business, Economic Development, and Tourism. While fostering international relations is generally beneficial, this particular initiative raises several concerns regarding its fiscal responsibility and relevance to Hawaii's economic interests.

**Fiscal Responsibility:** The creation of a new commission entails administrative costs, including staffing, operational expenses, and potential travel between Hawaii and Ireland. Given our state's current budget constraints, allocating taxpayer dollars to a commission with questionable return on investment is imprudent. These funds could be more effectively utilized in areas directly impacting Hawaii residents, such as education, healthcare, or infrastructure.

Geographical and Economic Relevance: Ireland, located in the Atlantic Ocean, is geographically distant from Hawaii. Our state's primary trade partners are typically within the Pacific Rim, where logistical considerations and existing economic ties make trade more feasible and beneficial. Focusing on a trade relationship with Ireland does not align with Hawaii's strategic economic interests and may divert attention from more pertinent opportunities.

**Timing and Legislative Priorities:** The introduction of this bill appears to be a last-minute attempt by the current administration to allocate funds before potential policy changes. Such hasty legislative actions can lead to poorly conceived programs that lack thorough vetting and long-term planning. It is crucial that our government prioritizes initiatives that offer clear, immediate benefits to our community.

**Alternative Considerations:** Rather than establishing a new commission, Hawaii could explore strengthening existing trade relationships within the Asia-Pacific region, where cultural, economic, and logistical factors are more closely aligned with our state's interests. Additionally, investing in local businesses and industries would have a more direct and positive impact on Hawaii's economy.

In conclusion, while international trade is an important aspect of economic development, **House**Bill 1391 does not represent a fiscally responsible or strategically sound approach for

<b>Hawaii. I urge you to oppose this bill and consider more effective avenues</b> for promoting our state's economic well-being.
