RELATING TO TRADE.

Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee. The Department of Business, Economic Development, and Tourism (DBEDT) offers the following comments to H.B. No.1391 which establishes the Hawaii-Ireland trade commission within DBEDT.

While such a commission may help identify trade opportunities and provide a pathway to bring these opportunities with Ireland to fruition, establishing a commission requires compliance with sunshine laws and confirmation of commissioners, and funding for research. Funding in the amount of \$25,000 is requested to adequately address this bill.

Aloha e Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee:

My name is Sherry Menor, President and CEO of the Chamber of Commerce Hawaii ("The Chamber"). The Chamber supports House Bill 1391 House Draft 1 Senate Draft 1 (HB1391 HD1 SD1), which establishes the Hawai'i-Ireland Trade Commission within the Department of Business, Economic Development, and Tourism for administrative purposes. Requires annual reports to the Legislature and Governor.

HB1391 HD1 SD1 aligns with our 2030 Blueprint for Hawaii: An Economic Action Plan, specifically under the policy pillar for Small Business. This bill promotes policies that drive economic growth, enhance workforce opportunities, and improve the quality of life for Hawaii's reside

Hawaii aims to diversify its economy and strengthen international ties through collaboration with global partners, and Ireland presents a unique opportunity in this regard.
