My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS® ("HAR"), the voice of real estate in Hawaii and its over 10,000 members. HAR supports House Bill 1406, HD1, SD1, which establishes the Intergovernmental Task Force for Permit Simplification to identify actions taken, challenges encountered, and legislative measures necessary to facilitate, expedite, and coordinate state and intergovernmental development permit processes. Appropriates funds.

Housing is impacted by numerous state-level permits, such as Special Management Area permits, Land Use Commission district boundary amendments, individual wastewater system permits from the Department of Health, State Historic Preservation Division reviews for historic properties, approvals from the Hawaii Housing Finance and Development Corporation for affordable housing projects, and permits from the Hawaii Community Development Authority.

At the county level, according to the 2024 UHERO's Hawaii Housing Factbook<sup>1</sup>, Hawaii's permitting process takes nearly three times longer than in other states, despite efforts by counties to improve efficiency. Processing times for single-family home permits on average range from 141 days in Hawaii County to 315 days in Kauai County. For multifamily housing projects, approvals take even longer—318 days in Hawaii County and up to 427 days in Kauai County. In addition, the City & County of Honolulu faces a significant backlog, further delaying both residential and commercial projects.<sup>2</sup> These delays can significantly increase project costs, create uncertainty, and slow or disincentivizes the construction of much needed housing. As time passes, rising interest

The Grassroot Institute **supports** <u>HB1406 HD1 SD1</u>, which would establish the Intergovernmental Task Force for Permit Simplification with the goal of identifying and analyzing ways to streamline and coordinate state and intergovernmental permit processes.

This bill deserves praise for encouraging thoughtful permitting reform.

In addition to slowing housing growth, Hawaii's notorious permit delays add significantly to the price of housing in our state. According to "The Hawai'i Housing Factbook," produced by The Economic Research Organization at the University of Hawai'i, the median permit processing time between mid-2018 and mid-2023 across the state was 161 days.<sup>1</sup>

A recent report from the Grassroot Institute, "Seven low cost ways to speed up permitting in Hawaii," provides a potential road map for commonsense permit reform.<sup>2</sup> In particular, it suggests that the task force consider increasing permit exemptions, utilizing third-party approvals and adopting a meaningful "shot clock."

The task force should also consider implementing a program that would grandfather existing dwellings that were built without permits.

It might be possible to reduce permitting delays with more staff or better software, but ultimately, only reform of the permitting regulations themselves will make lasting inroads into resolving our housing crisis.



Thank you for the opportunity to provide testimony in support of HB1406, HD1, SD1, which aims to streamline the state and intergovernmental development permitting process.

Hawaiian Telcom supports the intent of this measure, as Hawai'i's state and county permitting processes are more challenging, time-consuming, and costly than those in other states, causing significant delays to essential projects. This bill seeks to address these onerous procedures by establishing a task force within the House of Representatives to streamline permitting and propose legislative initiatives for a more efficient, transparent, and user-friendly experience, ultimately boosting economic development for our state.

Since Congress approved \$65 billion in 2021 to provide states and U.S. territories with federal grants to close the digital divide through the Infrastructure Investment and Jobs Act (IIJA) and Broadband Equity, Access, and Deployment (BEAD) programs, the State of Hawai'i has been awarded over \$300 million in federal funding. This funding will be matched with state and private sector investments to build broadband infrastructure and deliver high-speed internet services across the state. Additionally, Hawaiian Telcom was one of 36 projects awarded a highly competitive federal Middle Mile Grant to build a new interisland broadband fiber cable connecting Kaua'i, O'ahu, Moloka'i, Mau'i, and Hawai'i. These federal projects share a highly defined timeline for delivering services, which must contend with the complexities of our state and intergovernmental permitting processes. Streamlining regulations, including permitting, will help stimulate and maximize private and public sector investments in constructing fiber-enabled broadband networks.

While these federal dollars provide a temporary infusion of funding for broadband infrastructure and services, the investments will yield significant economic and technological benefits for our state for generations. They will enhance the capacity and resiliency of our broadband networks and extend broadband connectivity throughout the state.

Hawaiian Telcom supports initiatives like this to improve state and intergovernmental development permitting processes. We stand ready to work with your committee, other state and county agencies, and stakeholders to solve long-standing issues and enable greater economic competitiveness.

My name is Dan Haire, President and CEO of Navian Hawaii. Navian appreciates the opportunity to provide testimony **in support** of HB1406, HD1, SD1 Relating to Government Procedures. HB1406 establishes the Intergovernmental Task Force for Permit Simplification to identify actions taken, challenges encountered, and legislative measures necessary to facilitate, expedite, and coordinate state and intergovernmental development permit processes.

Hawai'i is undergoing a major demographic shift, with a rapidly aging population that will have profound implications for our healthcare infrastructure. In 2023, over 21% of Hawai'i's residents were aged 65 and older – a proportion that has been increasing and is projected to reach one in four by 2035. The fastest-growing segment includes those over 80 years old, a group that will require intensive levels of care, including skilled nursing, palliative, and hospice services.

As this trend continues, Hawai'i will face a dramatic rise in demand for inpatient and residential care facilities. Yet at present, constructing such facilities is exceptionally difficult due in large part to delays in the permitting process. One of our projects, at 1221 Gulick Ave, is expected to be stuck around two years in Honolulu's Department of Planning and Permitting, critically delaying potentially dozens of beds from servicing our kūpuna. As our industry works to significantly increase the availability of beds, the problem will only worsen.

This measure is a critical first step in addressing systemic inefficiencies. By convening stakeholders and beginning a focused conversation on how to streamline permitting, this task force can help lay the groundwork for meaningful reforms. If Hawai'i is to meet the needs of its aging population with compassion and foresight, improving the efficiency of our permitting system must be part of the solution.

Navian Hawaii is a nonprofit organization supporting the needs of Hawai'i's aging population, including through hospice, palliative care, and integrated support services. The name "Navian" blends "Navigator" and "Guardian," reflecting our mission to guide individuals and their families through the physical and emotional challenges that often accompany aging and serious illness.

## In consideration of HOUSE BILL 1406, HOUSE DRAFT 1, SENATE DRAFT 1 RELATING TO GOVERNMENT PROCEDURES

House Bill 1406, House Draft 1, Senate Draft 1 establishes an Intergovernmental Task Force for Permit Simplification within the House of Representatives, to include a representative from the State Historic Preservation Division (Division). **The Department of Land and Natural Resources (Department) strongly supports this measure and offers the following comments.** 

The framework for a comprehensive statewide historic preservation program in Hawai'i is established under Chapter 6E, HRS. The historic preservation program requirements identified at 6E-42, HRS, address the Division's responsibilities when completing historic preservation reviews for projects that require permits. These historic preservation reviews can add time to the permit approval process; in many cases because submittals are incomplete or include inaccurate information. The proposed task force within this measure may help to better identify such issues as well as how to resolve them in such a way that expedites the permit process. To that end, the Department and Division are happy to participate in such a task force. Furthermore, the Division recommends that if such a task force is established, that the County representatives reach out to their respective Certified Local Government program staff and the county Cultural Resource Commission members in order to benefit from their local knowledge and expertise in both historic preservation and 6E, HRS relate permitting issues within their communities.
