In consideration of HOUSE BILL 1421 RELATING TO FINANCING

House Bill 1421 establishes and appropriates funds for a cesspool conversion on-bill financing program to be administered by the Hawaii Green Infrastructure Authority to provide low-interest loans to eligible homeowners for the upgrade, conversion, or connection of cesspools. The Hawai'i Climate Change Mitigation and Adaptation Commission (Commission) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.

The Commission consists of a multi-jurisdictional effort between 20 different departments, committees, and counties. Removal of cesspools for all properties within the Sea Level Rise Exposure Area (SLR-XA), is imperative to the health of nearshore waters and for members of the public accessing coastal resources. Removal may not be achievable by 2050 as directed by Act 125, Session Laws of Hawai'i 2017, without financing support for replacement. The Commission's 2022 update to the *Sea Level Rise Vulnerability and Adaptation Report* Recommended Action 6.4 counsels that the State should expand policy directives beyond the existing income tax credits and requirement for removal by 2050. Specifically, policy must address existing cesspools in the coastal zone in relation to enforcement of existing laws and regulations.

This bill addresses equity issues around cesspool conversion by providing financing for those that may not have the funding to make this significant investment. Cesspools on the shoreline and in the coastal zone will be an increasing source of nonpoint source pollution as groundwater rises and coastal erosion accelerates. This bill addresses the challenges many homes will have

with converting cesspools by providing on bill financing so that cesspool conversion can begin sooner and more equitably.

Chair Lowen, Vice Chair Perruso and Members of the Committee:

Thank you for the opportunity to testify on HB1421 relating to financing. The Hawai'i Green Infrastructure Authority (HGIA) **supports** this bill which establishes a cesspool conversion on-bill financing program to provide low-interest loans to eligible homeowners.

While the majority of property owners required to convert or upgrade their existing cesspools may be able to qualify for bank or credit union financing, access to capital barriers exists for approximately 20,000¹ homeowners. It is imperative that in addition to grants, tax credits and other incentives, the State also provide these low and moderate-income² (LMI) homeowners with a low-cost financing <u>option</u>, which eliminates credit barriers by leveraging innovative on-bill repayment mechanisms, while still being prudent stewards of public funds.

In order to appease our local financial institutions, the design of this financing program can include the following:

- If there is an existing mortgage(s) on the property, the LMI property owner must seek financing from the local³ bank, credit union or finance company that holds or services said mortgage(s).
- In addition to meeting the LMI threshold, the property owner must provide two adverse action notices when applying for this financing program. If there is an existing mortgage on the property, one of the adverse action notices must

be from the local bank, credit union or finance company that holds or services said mortgage⁴.

• A portion of the funds can be used to co-create a credit enhancement for our local financial institutions to finance "near-bankable" homeowners with cesspool conversion loans.

Protecting our environment and ensuring clean water is important. Providing LMI homeowners with credit barriers a low-cost financing option to comply with the state's mandate is equally important.

Thank you for this opportunity to provide comments and testify in support of HB1421.

Therefore, the SPO recommends the following revisions to Section 3, page 12, lines 18 to 20:

(7) Enter into contracts for the administration of the cesspool conversion on-bill financing program exempt from in accordance with chapter 103D;

RELATING TO FINANCING

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 1421: 1) establishes the Cesspool Conversion Loan Special Fund (CCLSF) to be administered by the Hawai'i Green Infrastructure Authority (HGIA) for the purpose of providing low-interest loans to eligible households to upgrade or convert existing cesspools; 2) sets allowable sources of funding for the CCLSF, including legislative appropriations, funds from governmental or private entities, repayment of loans and interest payments, and fees; 3) appropriates an unspecified amount of general funds in FY 26 and FY 27 for deposit into the CCLSF; and 4) appropriates an unspecified amount of special funds out of the CCLSF in FY 26 and FY 27 to provide loan funding, to reprogram and automate the counties' billing systems, and to hire 1.00 program manager position to administer the CCLSF.

As a matter of general policy, B&F does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 1421, it is difficult to determine whether the proposed CCLSF would be self-sustaining.

MEMORANDUM FOR HEADS OF EXECUTIVE DEPARTMENTS AND AGENCIES

FROM: Matthew J. Vaeth, Acting Director, Office of Management and Budget

SUBJECT: Temporary Pause of Agency Grant, Loan, and Other Financial Assistance Programs

The American people elected Donald J. Trump to be President of the United States and gave him a mandate to increase the impact of every federal taxpayer dollar. In Fiscal Year 2024, of the nearly \$10 trillion that the Federal Government spent, more than \$3 trillion was Federal financial assistance, such as grants and loans. Career and political appointees in the Executive Branch have a duty to align Federal spending and action with the will of the American people as expressed through Presidential priorities. Financial assistance should be dedicated to advancing Administration priorities, focusing taxpayer dollars to advance a stronger and safer America, eliminating the financial burden of inflation for citizens, unleashing American energy and manufacturing, ending "wokeness" and the weaponization of government, promoting efficiency in government, and Making America Healthy Again. The use of Federal resources to advance Marxist equity, transgenderism, and green new deal social engineering policies is a waste of taxpayer dollars that does not improve the day-to-day lives of those we serve.

This memorandum requires Federal agencies to identify and review all Federal financial assistance¹ programs and supporting activities consistent with the President's policies and requirements.² For example, during the initial days of his Administration, President Donald J. Trump issued a series of executive orders to protect the American people and safeguard valuable taxpayer resources, including *Protecting the American People Against Invasion* (Jan. 20, 2025), *Reevaluating and Realigning United States Foreign Aid* (Jan. 20, 2025), *Putting America First in International Environmental Agreements* (Jan. 20, 2025), *Unleashing American Energy* (Jan. 20, 2025), *Ending Radical and Wasteful Government DEI Programs and Preferencing* (Jan. 20, 2025),

2025), Defending Women from Gender Ideology Extremism and Restoring Biological Truth to the Federal Government (Jan. 20, 2025), and Enforcing the Hyde Amendment (Jan. 24, 2025). These executive orders ensure that Federal funds are used to support hardworking American families.

To implement these orders, each agency must complete a comprehensive analysis of all of their Federal financial assistance programs to identify programs, projects, and activities that may be implicated by any of the President's executive orders. In the interim, to the extent permissible under applicable law, Federal agencies **must temporarily pause** all activities related to obligation or disbursement of all Federal financial assistance, and other relevant agency activities that may be implicated by the executive orders, including, but not limited to, financial assistance for foreign aid, nongovernmental organizations, DEI, woke gender ideology, and the green new deal.

This temporary pause will provide the Administration time to review agency programs and determine the best uses of the funding for those programs consistent with the law and the President's priorities. The temporary pause will become effective on January 28, 2025, at 5:00 PM. Even before completing their comprehensive analysis, Federal agencies must immediately identify any legally mandated actions or deadlines for assistance programs arising while the pause remains in effect. Federal agencies must report this information to OMB along with an analysis of the requirement. OMB also directs Federal agencies to pause all activities associated with open NOFOs, such as conducting merit review panels.

No later than February 10, 2025, agencies shall submit to OMB detailed information on any programs, projects or activities subject to this pause. Each agency must pause: (i) issuance of new awards; (ii) disbursement of Federal funds under all open awards; and (iii) other relevant agency actions that may be implicated by the executive orders, to the extent permissible by law, until OMB has reviewed and provided guidance to your agency with respect to the information submitted.

OMB may grant exceptions allowing Federal agencies to issue new awards or take other actions on a case-by-case basis. To the extent required by law, Federal agencies may continue taking certain administrative actions, such as closeout of Federal awards (2 CFR 200.344), or recording obligations expressly required by law.

Additionally, agencies must, for each Federal financial assistance program: (i) assign responsibility and oversight to a senior political appointee to ensure Federal financial assistance conforms to Administration priorities; (ii) review currently pending Federal financial assistance announcements to ensure Administration priorities are addressed, and, subject to program statutory authority, modify unpublished Federal financial assistance announcements, withdraw any announcements already published, and, to the extent permissible by law, cancel awards already awarded that are in conflict with Administration priorities, and; (iii) ensure adequate oversight of Federal financial assistance programs and initiate investigations when warranted to identify underperforming recipients, and address identified issues up to and including cancellation of awards.

Aloha Chair Lowen, Vice Chair Perruso, and Energy and Environmental Protection Committee Members:

The Hawai'i Reef and Ocean Coalition (HIROC) is a group of scientists, educators, filmmakers and environmental advocates who have been working since 2017 to protect Hawaii's coral reefs and ocean.

The Hawai'i Reef and Ocean Coalition STRONGLY SUPPORTS HB1421!

There are about 83,000 cesspools in Hawai'i that are dumping about 50 million gallons **every day** into Hawaii's groundwater, drinking water, streams, and ocean and harming our coral reefs. By law (the mandate of section 342D-72, Hawaii Revised Statutes), all 83,000 cesspools must be upgraded to a system approved by the Department by 2050.

Cesspool upgrades are expensive. The cost depends on site-specific conditions, but the cost to convert a cesspool to a septic system or an aerobic treatment unit system is often over \$30,000. We need to try to find ways to make upgrades more **affordable** to homeowners and governments.

At a time when many residents of Hawai'i are struggling to make ends meet, our State has an excellent opportunity to **save our people money** by providing low interest loans for those unable to access financing.

This bill directs the Hawai'i Green Infrastructure Authority to create a non-traditional cesspool conversion on-bill financing of low interest loans for those unable to access financing at reasonable rates and terms, including eligible low and moderate income homeowners. On-bill financing has worked for renewable energy and water measures, while mitigating risks to providers of capital, which can reduce costs to borrowers. On-bill low interest loan financing spreads the costs to homeowners over time to make them more affordable.

Recoveries would be through the county water bills.

This bill provides a more affordable way for cesspool owners to pay the costs of upgrading their cesspools.

I am testifying in Support of HB 1421 relating to financing on behalf of the Coral Reef Alliance (CORAL)and a concerned citizen of Moku o Keawe. This bill establishes and appropriates funds for a cesspool conversion on-bill financing program to be administered by the Hawai'i Green Infrastructure Authority to provide low-interest loans to eligible homeowners for the upgrade, conversion, or connection of cesspools. CORAL and The Ocean Legislative Task Force advocate for cesspool conversion as part of our kuleana to care for the oceans that sustain us.

Cesspool upgrades are expensive. We need to try to find ways to make them affordable to homeowners and governments. CORAL has been working to remove cesspools across Hawaii for over ten years. We watch as communities and homeowners invest millions of dollars and countless hours to identify solutions for these outdated systems only to be stalled due to lack of funding and gov capacity. With more than 80,000 cesspools across the state, contributing millions of gallons per day of raw sewage to our groundwater and ocean, cesspools pose a severe threat to coral reefs, human health, and our economy. Coral reefs are essential to shoreline protection for sea level rise, cultural practices, and community well-being.



HB 1421 directs the Hawaii Green Infrastructure Authority to create a non-traditional cesspool conversion on-bill financing of low interest loans for those unable to access financing at reasonable rates and terms, including eligible low and moderate income homeowners. On-bill financing has worked for renewable energy measures and water, while mitigating risks to providers of capital.

Since recovery of funds would be through the county water bills, this will not benefit homeowners of Hawaii County who are not supplied by County water infrastructure, it can assist those households that are.

CORAL is an international coral reef conservation organization that works with communities, businesses, and governments to save coral reefs. With field offices on Maui and Hawai'i Island, and projects throughout the Main Hawaiian Islands, CORAL uses a science-based approach to improve coastal water quality. Throughout the state, CORAL's programs mitigate land-based sources of pollution, such as wastewater discharge and stormwater runoff. We are a member of The Ocean Legislative Task Force, a group of over 100 individuals from diverse environmental organizations, working together to safeguard marine ecosystems. Our collective expertise allows us to craft impactful strategies to protect Hawaii's waters.

On behalf of the non-profit WAI: Wastewater Alternatives & Innovations, I am writing in **strong support of HB1421.** This bill directs the Hawai'i Green Infrastructure Authority (HGIA) to use on-bill financing to create low-interest loans for homeowners to convert their cesspools. These loans are a needed and valuable resource for those people unable to access financing at reasonable rates and terms, including low and moderate income homeowners.

Cesspool conversions can be costly, and we need to try to find ways to make upgrades more **affordable**. On-bill financing has worked for renewable energy and water measures, and it mitigates risks to providers of capital, which can reduce costs to borrowers. On-bill low interest loan financing spreads the costs to homeowners over time to make them more affordable. Recoveries would be through the county water bills.

Hawaii has more than 83,000 cesspools across the state, discharging 52 million gallons of raw sewage each day into Hawaii's waters. <u>Along with threats to public health and drinking water</u> resources, new research shows that polluted wastewater poses significant harm to coral reefs and the near-shore environment. The people of Hawaii need this law to make sure their wastewater systems aren't polluting the groundwater or nearby surface waters.

WAI is an environmental non-profit dedicated to protecting our water resources by reducing sewage pollution from cesspools. We support more innovative, affordable, and eco-friendly solutions to wastewater management. Better sanitation systems protect public health and valuable natural resources like groundwater, streams, coral reefs and coastal areas.

Hawaii is struggling with serious sewage pollution, and the state has a mandate to make sure all cesspools are converted in the next two decades. <u>This bill provides a more affordable way for cesspool owners to pay the costs of upgrading their cesspools</u>. Mahalo for your leadership on this issue and support of this bill.

Testimony of The Nature Conservancy Supporting HB 1421, Relating to Financing. Committee on Energy and Environmental Protection January 30, 2025, 9:00 am

Dear Chair Lowen, Vice Chair Perruso, and Members of the Committee:

The Nature Conservancy (TNC), Hawai'i and Palmyra would like to provide comments HB 1421 which would establish and appropriate funds for a cesspool conversion on-bill financing program to be administered by the Hawai'i Green Infrastructure Authority to provide low-interest loans to eligible homeowners for the upgrade, conversion, or connection of cesspools.

Science conducted by TNC and partners has shown that wastewater, particularly cesspools, are detrimental to the coral reefs which protect our coastlines and underpin our economy. Without clean coastal waters are reef ecosystems are put at even greater risk in the face of growing global stressors including climate change.

Cesspools cause harm to water quality within adjacent groundwater, anchialine, coral reef systems and fisheries by introducing elevated amounts of organic nitrogen and phosphorus, pathogens, and other contaminants. Contaminants emitted from cesspools can harm aquatic ecosystems by encouraging excess algal and bacterial growth and can also pose a threat to human health. Our research in He'eia, Maunalua, Olowalu, Hana and South Kohala has shown direct evidence of cesspool contamination in streams and coastal waters using a variety of bioindicators and chemical signatures.

One of the primary limitations for cesspool upgrade, conversion or connection at scale is the high-cost of conversion to private homeowners. HB 1421 is one possible avenue to provide valuable financing options. Similar to investments in clean energy, on-bill financing provides low interest loans that can allow for smaller payments over long periods of time. This could encourage homeowners to comply with conversion requirements sooner and reduce environmental stressors more quickly.

Mahalo again for the opportunity to provide comments on HB 1421.

Guided by science, TNC is a non-profit organization dedicated to the preservation of the lands and waters upon which all life depends. The Conservancy has helped protect more than 200,000 acres of natural lands in Hawai'i and Palmyra Atoll.
