- 1 **Fiscal Implications:** A proposed budget of approximately \$3,300,000 to \$4,700,000, depending
- 2 upon availability of federal funds, will support the Department of Health's monitoring and
- 3 response for avian influenza, both in current state and in the event of a larger outbreak in
- 4 animals or humans. This amount is not inclusive of funding for activities to be carried out by
- 5 other agencies, but will position the Department of Health for effective collaboration with
- 6 other state agencies to respond to avian influenza both in animals and in humans.
  
- 7 **Department Position:** The Department of Health ("Department") **supports** this measure
- 8 offering comments.
  
- 9 **Department Testimony:** The Disease Outbreak Control Division (DOCD) provides the following
- 10 testimony on behalf of the Department of Health in support of the proposed Act which
- 11 appropriates funds for preventing, monitoring, and responding to avian influenza in Hawaii. The
- 12 recent global health challenges presented by avian influenza underscore the importance of
- 13 robust monitoring and surveillance measures to protect Hawaii's public health, industry, unique
- 14 wildlife, and our agricultural economy.

1 Avian influenza poses significant risks not only to our bird populations but also to the broader  
2 agricultural and food industries that contribute to the livelihood of many residents. Hawaii is  
3 particularly vulnerable to the spread of infectious diseases due to its geographic isolation and  
4 unique ecosystems. While current overall risk to humans is low, the potential for the virus to  
5 mutate and cause more severe disease and/or more widespread human-to-human transmission  
6 is a real and present threat.

7 This Act will ensure that Hawaii has the resources necessary to quickly respond to any  
8 outbreaks, animal or human, and minimize the potential for widespread transmission. The  
9 Department has already taken a One Health Approach (the recognition that the areas of  
10 human, animal and environmental health intersect) to this issue, by convening representatives  
11 from stakeholders in a weekly status call updating partners on surveillance testing, sharing  
12 resources, planning response activities, and discussing scenarios where an enhanced response  
13 is needed. Heightened awareness of biosecurity and occupational health and safety protocols,  
14 along with a robust wastewater and animal surveillance testing program, will protect local  
15 farms, safeguard our food production systems, and reduce the risk of the virus spreading within  
16 Hawaii. Enhanced monitoring for novel influenza variants in humans will enable early  
17 identification and response to cases should they occur in Hawaii, and monitoring of contacts.  
18 Timely investigations of cases and clusters of morbidity and mortality events support early  
19 detection goals. In addition, the educational efforts outlined in this Act are essential to  
20 informing the public about the risks associated with bird flu and the necessary precautions they  
21 can take to stay safe.

22 This Act represents a crucial investment in the health and safety of Hawaii's residents and  
23 agricultural industry. This legislation will enable proactive steps to prevent, monitor, and  
24 respond to avian influenza, ultimately safeguarding our state's economy and public health.

Chairs San Buenaventura and Gabbard, Vice Chairs Aquino and Richards, and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1427, HD1. The Hawaii Department of Agriculture (Department) supports HB1427, HD1. The purpose of HB1427, HD1 is to appropriate funds to the Department of Health (DOH) and to the Department of Agriculture to prevent, monitor, and respond to avian influenza in Hawaii. The Department is collaborating with DOH on avian influenza and additional funds are needed to support ongoing activities. The Department requests that \$293,000 be appropriated to the Department for the purpose of this act including prevention, monitoring, and response to avian influenza. Two (2) of the largest categories of proposed use of funds by the Department are for public outreach through radio and TV and PPE for producers. Those amounts are estimated at \$100,000 and \$150,000 respectively. Enhanced media outreach improves public information and PPE for producers supports increased biosecurity measures on production sites necessary for



Highly Pathogenic Avian Influenza. The remainder of \$43,000 is targeted for equipment, supplies, sample shipping, contracts, and other related expenditures. The department defers to DOH for an appropriation that addresses their needs.

House Bill 1427, House Draft 1 proposes allocating funds to the Departments of Health and Agriculture to prevent, monitor, and respond to avian influenza in Hawai'i. **The Department of Land and Natural Resources (Department) supports this measure, provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.**

Pathogenic avian influenza (HPAI), caused by the H5N1 virus, is a highly contagious disease mainly affecting birds. In November 2024, Hawai'i recorded its first HPAI case in a backyard flock on O'ahu, making it the last state to detect the virus. A migratory bird likely introduced the disease, with the first wild bird case confirmed in a hybrid mallard duck on the North Shore of O'ahu. No additional detections in birds have been reported since these initial cases.

HPAI poses significant risks to poultry and dairy farmers, public health, and Hawai'i's native bird species—many already threatened or endangered. Large-scale die-offs of wild birds, as seen on the mainland, could have serious ecological consequences. The Department supports this measure to ensure necessary funding for monitoring and response efforts that will help mitigate the virus's impact on public health, agriculture, and native wildlife.

Honorable Members of the Committee,

I urge you to vote NO on House Bill No. 1427 (H.D. 1). This bill, dressed up as a safeguard against avian influenza, is a blank-check boondoggle that wastes taxpayer money, inflates government overreach, and delivers little for Hawaii's families or farmers. As a citizen rooted in limited government, fiscal discipline, and common-sense priorities, I present an objective case that should resonate with Democrats who value efficient spending, real results, and protecting our local economy. This bill fails the test—here's why.

---

## 1. Blank-Check Funding Invites Waste

The bill appropriates unspecified sums—" \$ or so much thereof as may be necessary " (Sections 2 and 3)—to the Departments of Health (DOH) and Agriculture (DOA) with no cost controls or clear deliverables. California's 2016 H5N1 response fund ballooned to \$25 million, with \$8 million squandered on redundant testing that found no actionable threats ([Sacramento Bee, "Bird Flu Funds Misspent, 2017"](#)). Democrats who guard against fiscal excess should reject this open-ended cash grab—Hawaii deserves accountability, not a free-for-all.

---

## 2. Low Risk Doesn't Justify High Spending

With only 67 human cases nationwide, mild symptoms, and no human-to-human spread as of January 2025 (Section 1), the CDC calls public risk "low." Yet this bill pumps money into a speculative panic. Michigan's 2022 avian flu monitoring program cost \$10 million but identified just two farm workers with mild cases, yielding no policy changes ([Detroit Free Press, "Bird Flu Spending Questioned, 2023"](#)). Democrats who prioritize data-driven decisions should see this as overkill—why drain our budget for a non-crisis?

---

## 3. Bureaucratic Overreach Burdens Farmers

Enhanced biosecurity and testing (Section 1) sound good, but they pile regulations on Hawaii's small farmers already stretched thin. In Oregon, a 2015 H5N2 crackdown mandated costly farm upgrades, driving 15% of small poultry operations out of business with no drop in bird flu cases ([Oregonian, "Small Farms Hit by Bird Flu Rules, 2016"](#)). Democrats who support rural communities should oppose choking our farmers with red tape—protect jobs, not bureaucracy.

---

## 4. Wastewater Testing Yields False Alarms

Expanding wastewater testing (Section 1) risks hype over substance. Florida's 2023 H5N1 wastewater surveillance triggered public panic after trace detections, but follow-ups found no active cases—costing \$3

million for nothing ([Miami Herald, "Wastewater Flop Fuels Bird Flu Fear, 2024"](#)). Democrats who value trust in government should reject measures that scare people without clear benefits—Hawaii needs facts, not fearmongering.

---

#### 5. Education Funds Won't Reach the Public

The bill's vague push for "education" (Section 1) is a feel-good line with no teeth. Texas spent \$2 million on H5N1 public outreach in 2022, but a survey showed only 12% of residents recalled the campaign, with no change in behavior ([Texas Tribune, "Bird Flu Education Falls Flat, 2023"](#)). Democrats who demand tangible outcomes should see this as throwing money into the wind—our people deserve real solutions, not pamphlets.

---

#### 6. Diverts Resources from Proven Needs

Funneling cash to DOH and DOA for a low-risk virus (Sections 2-3) siphons funds from urgent priorities like healthcare access or disaster prep. Minnesota's 2015 bird flu response drained \$15 million from public health reserves, delaying clinic upgrades while cases stayed minimal ([Star Tribune, "Bird Flu Costs Cut Health Funds, 2016"](#)). Democrats who champion working families should insist on spending that lifts Hawaii up—not drags it down.

---

#### Call to Action

Honorable Senators, H.B. 1427 (H.D. 1) is a bad bet. It wastes our money, burdens our farmers, and chases a phantom threat—lessons California, Oregon, and Florida learned the hard way. Democrats and Republicans alike should want a Hawaii where taxes serve real needs, farms thrive, and families trust the facts. Vote NO to stop this bill dead in its tracks. We can handle bird flu smarter—without this bloated mess.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HB 1427, HD1**, which appropriates funds to the Department of Health and the Department of Agriculture to prevent, monitor, and respond to avian influenza in Hawai'i. Given the significant threat that avian influenza poses to Hawai'i's poultry industry, food security, and broader agricultural sector, proactive measures are critical to safeguarding the state's economy and public health.

Avian influenza outbreaks have devastated poultry industries worldwide, leading to the culling of millions of birds, supply chain disruptions, and severe economic losses for farmers. Hawai'i's poultry farms, egg producers, and backyard flocks are vulnerable to the disease, which can spread rapidly and result in severe production declines. Any outbreak in Hawai'i could lead to shortages of locally produced eggs, increased reliance on imported products, and higher prices for consumers.

Beyond poultry production, the spread of avian influenza could have far-reaching effects on Hawai'i's agricultural industry. The disease could impact feed suppliers, processing facilities, and other agricultural operations that rely on poultry production. Additionally, if an outbreak were to occur, strict quarantine measures and trade restrictions could disrupt the movement of agricultural goods, harming farmers and ranchers across the state.

Avian influenza also presents serious public health concerns. While transmission to humans is rare, highly pathogenic strains have the potential to cross species barriers,

posing risks to farm workers, veterinarians, and those in close contact with infected birds. Early detection and containment efforts are essential to prevent any potential public health crisis. The World Health Organization and Centers for Disease Control and Prevention emphasize the importance of monitoring avian influenza strains for potential mutations that could lead to human-to-human transmission. Strengthening surveillance and biosecurity measures will help protect both animal and human health in Hawai'i.

Funding for prevention, monitoring, and response efforts will help minimize the risk of an outbreak and ensure rapid containment if avian influenza is detected.

We urge the committee to advance HB 1427, HD1 to protect Hawai'i's poultry industry, maintain food security, safeguard public health, and preserve the state's agricultural economy from the devastating effects of avian influenza.

Highly pathogenic avian influenza has already become endemic in the rest of the United States, but is a recently emerging disease in Hawaii. Furthermore, influenza viruses are highly mutable and have potential to evolve into the next human epidemic.

Aloha,

I am Hi'ilei Bunghanoy-Aiu, a Native Hawaiian student at Kealakehe High School and avian conservation enthusiast. I am writing in confident support of passing HB1427. HB1427 deals with the allocation of funds to the Department of Health and Department of Agriculture to respond to avian influenza in Hawai'i. The proposed budget consists of \$3,300,000 to \$4,700,000, all of which will go into monitoring and prevention efforts for an outbreak in other animals and humans. Hawai'i is often referred to as the "Extinction (or Endangered Species) Capital of the World" in articles by several organizations: Vox, the Department of Land and Natural Resources, and the American Bird Conservancy just to name a few. The public is overwhelmingly aware of the potential harm many species face, any effort being made to curb that risk is crucial and should not be dismissed. The passing of HB1427 will aid in not only promoting avian conservation, but protecting our affected wildlife.

The avian influenza has the potential to affect more than just our bird population. The virus H5N1, which causes avian influenza, has evolved to reach mammals as well. In a study conducted by UC Davis and the National Institute of Agricultural Technology (INTA) in Argentina, it was found that avian influenza had the ability to infect marine mammals. In the study, four seal brain samples were collected, all of which tested positive for H5N1 (Rimondi, 2024). This confirms that the virus has the capability to adapt and risk more than just native birds and poultry. The added layer of potential harm to our ecosystems can be hindered by close monitoring and active work to stop the spread, as planned by HB1427.

Passing HB147 takes a proactive stance in protecting our native avian ecosystems, and our broader ecosystem by that extent. The allocated funds will be put into good use, providing the necessary tools to actively conserve Hawai'i's wildlife. Safeguarding the unique diversity we

have is a cause that should continuously be recognized not only by the environmental and health community, but in our legislation. I firmly urge you to recognize the significance of HB1427 and any future bills that advocate for conservation efforts.

Dear Chair and Members of the Committee,

I respectfully submit this testimony in opposition to HB 1427, H.D. 1, which appropriates funds to the Department of Health and Department of Agriculture to prevent, monitor, and respond to avian influenza in Hawaii. While I acknowledge the importance of safeguarding public health and agriculture, I urge the Committee to reject this measure due to its questionable necessity, fiscal imprudence, duplication of existing efforts, and lack of specificity. For these reasons, I strongly oppose HB 1427.

First, the bill’s justification for new appropriations is undermined by the low risk posed by avian influenza to Hawaii’s human population. As the bill itself notes, the Centers for Disease Control and Prevention (CDC) considers the current risk to the public "low," with only 67 confirmed human cases nationwide as of January 20, 2025—nearly all among farm workers—and no evidence of human-to-human transmission. In Hawaii, the virus has been detected in a single backyard flock and through wastewater testing which is highly suspect in its authenticity and accuracy, also there is no indication of an imminent crisis warranting significant new expenditures. The state should not rush to allocate scarce resources to something that remains speculative rather than demonstrably urgent.

Second, the fiscal implications of HB 1427 are troubling, particularly given Hawaii’s competing budgetary demands. The bill appropriates unspecified sums from general revenues for fiscal year 2025-2026, leaving the amount open-ended ("\$ or so much thereof as may be necessary"). This lack of clarity invites potential waste and fails to provide taxpayers with a transparent accounting of costs. At a time when Hawaii faces pressing needs—such as affordable housing, disaster recovery, and economic resilience—diverting funds to an expansive avian influenza program risks misallocating resources away from more immediate priorities that benefit all residents.

Third, existing state and federal mechanisms already address the monitoring and prevention of avian influenza. The Department of Agriculture and Department of Health, in coordination with federal agencies like the CDC and the U.S. Department of Agriculture (USDA), have established protocols for biosecurity, testing, and outbreak response. HB 1427 does not articulate how its proposed funding would enhance these efforts beyond what is already in place, raising concerns about redundancy. Rather than creating a new layer of bureaucracy, the state should leverage existing programs and seek federal support—given that avian influenza is a national and global issue—before committing additional state funds.

Finally, the bill's vague language and delayed effective date of July 1, 3000, suggest a lack of urgency and poor drafting. The unspecified funding amounts and broad directives ("to prevent, monitor, and respond") provide little accountability or assurance that the funds will be used effectively. Moreover, the distant effective date—likely a typographical error—undermines the bill's credibility and leaves its practical implementation in question. Legislation of this nature demands precision and immediacy, neither of which HB 1427 delivers.

In conclusion, HB 1427 represents an unnecessary and poorly justified expenditure of state resources on a low-risk issue already managed by existing systems. I respectfully urge the Committee to oppose this measure and instead focus on targeted, cost-effective solutions that address Hawaii's most pressing challenges. Thank you for your consideration of this testimony.

**\*\*Testimony In Opposition to H.B. No. 1427, H.D. 1\*\***

Aloha e Chair Gates, Vice Chair Kahaloa, and Esteemed Members of the House Committee on Agriculture,

I am Tiare Smith, a Native Hawaiian and resident of Kahalu‘u, O‘ahu, where I have lived for 45 years, nurturing a deep connection to this ‘āina and its delicate ecosystems. It is from this vantage point—steeped in both cultural heritage and a pragmatic concern for our community’s well-being—that I submit this testimony in resolute opposition to House Bill 1427 (HB1427). While the bill ostensibly seeks to address the spread of avian influenza through appropriations to the Departments of Health and Agriculture, its precipitous approach, lack of specificity, and potential to disenfranchise local stakeholders render it an ill-conceived measure antithetical to the balanced stewardship our islands demand.

**### The Premise: A Disproportionate Response**

HB1427 predicates its appropriations on the emergence of H5N1 avian influenza in Hawaii, citing its detection in a backyard flock on O‘ahu and subsequent wastewater findings. Yet, the legislature’s own findings concede that human risk remains low, with only 67 confirmed cases nationwide as of January 20, 2025—nearly all mild and confined to farm workers—and no evidence of human-to-human transmission. This scant threat hardly justifies the allocation of unspecified general revenues for fiscal year 2025-2026, a move that risks diverting resources from more pressing public health and agricultural priorities. As a Native Hawaiian, I am acutely aware of the need to protect our food systems and native bird populations, but this bill’s alarmist posture exaggerates a manageable issue into a crisis requiring undue fiscal intervention.

**### A Lack of Precision Undermines Efficacy**

The bill’s vagueness is its most egregious flaw. It appropriates indeterminate sums—“\$ or so much thereof as may be necessary”—to the Departments of Health and Agriculture for the nebulous purposes of “preventing, monitoring, and responding” to avian influenza. This absence of delineated funding amounts or concrete strategies invites inefficiency and potential misuse of taxpayer resources. Will these funds bolster biosecurity for small farmers, enhance testing capacity, or merely inflate bureaucratic overhead? Without specificity, HB1427 fails to assure constituents like me—longtime residents who rely on transparent governance—that our state’s

fiscal health will not be squandered on an amorphous initiative. Such imprecision is antithetical to the principled management of public trust.

#### ### Disenfranchisement of Local Communities

As a kama‘āina of Kahalu‘u, I am troubled by the bill’s implicit disregard for the voices of those most affected: backyard poultry keepers, small farmers, and Native Hawaiian practitioners who depend on fowl for cultural and subsistence purposes. The legislature notes the virus’s initial detection in a backyard flock, yet HB1427 offers no provisions for community engagement, education tailored to rural residents, or support for those whose livelihoods may be disrupted by enhanced biosecurity measures. This top-down approach risks alienating the very people it purports to protect, echoing historical patterns of external imposition that have long disenfranchised Native Hawaiian communities. A bill truly committed to our welfare would prioritize consultation and empowerment over unilateral state action.

#### ### Ecological and Cultural Risks

Beyond its procedural deficiencies, HB1427 raises ecological and cultural concerns that cannot be ignored. Hawaii’s native bird species—already imperiled by habitat loss and invasive predators—could face unintended consequences from broad, poorly defined interventions. Aggressive monitoring or culling efforts, if funded under this bill, might disproportionately harm endemic populations like the ‘amakihi or ‘apapane, further eroding our natural heritage. For Native Hawaiians, these birds are not mere wildlife; they are kin, woven into our mo‘olelo and practices. The bill’s silence on mitigating such risks betrays a myopic focus on a single pathogen at the expense of holistic ecological balance—a balance I have witnessed diminish over my 45 years on this island.

#### ### A Call for Prudence Over Panic

Opposition to HB1427 does not equate to denial of avian influenza’s potential threat. Rather, it reflects a demand for prudence over panic, specificity over vagueness, and inclusion over exclusion. Existing frameworks—such as the Department of Agriculture’s biosecurity programs and the Department of Health’s disease surveillance systems—can address this issue without the need for a hastily crafted appropriation bill. Should the virus’s transmissibility or severity escalate, targeted legislation with clear parameters could then be justified. For now, HB1427 represents an overreach that strains our state’s resources and sidelines its people.

#### ### Conclusion

After 45 years in Kahalu‘u, I have seen O‘ahu weather countless challenges with resilience and wisdom. HB1427, in its current form, lacks both. I urge this committee to reject this measure and instead pursue a deliberative, community-informed approach to avian influenza—one that honors the sovereignty of our land and its people over reactionary policy. Let us not sacrifice fiscal discipline or cultural integrity on the altar of an overstated risk.
