H.B. 226 H.D. 1 RELATING TO MOTOR VEHICLES

House Committee on Consumer Protection & Commerce

The Hawaii Department of Transportation (HDOT) **supports H.B. 226 H.D. 1**, which prohibits a person from installing, mounting, adhering, affixing, or using any sun screening device in conjunction with the glazing material of a motor vehicle with mirrored, metallic, red, yellow, amber, or blue tint. Requires all drivers and passengers of motor vehicles with applied tint to roll down their windows when stopped by a law enforcement officer at a traffic stop. Lowers the minimum light transmittance levels for sun screening devices on certain motor vehicles. Exempts side windows to the rear of the driver and rear windows on sedans from sun screening device requirements. Increase the minimum and maximum fines for violating sun screening device requirements.

The HDOT supports keeping the 35 percent light transmittance requirement for the front side wing vents and windows and not require sedans to have 35 percent light transmittance for side windows that are to the rear of the driver and rear windows, similar to vans, minivans, trucks, and buses. Additionally, the windows to which the tint has been applied to shall be rolled down when the motor vehicle is stopped by a law enforcement officer at a traffic stop.

The Hawaii County Police Department (HPD) strongly believes this Bill presents significant safety concerns for motorists, pedestrians, and law enforcement personnel. HPD **opposes** this proposal because deeply tinted windows can impair a motorist's vision, particularly in low-light conditions such as nighttime driving, inclement weather, and poorly lit roadways. Reduced outward visibility increases the risk of collisions and creates hazards not only for the driver but also for surrounding motorists and pedestrians.

Furthermore, allowing darker window tint presents a serious concern for law enforcement officers conducting traffic stops and other roadside operations. Limited visibility into a vehicle makes it more difficult to assess potential threats, compromising officer safety. It also hinders the ability to properly identify suspects who may attempt to evade law enforcement by fleeing in a vehicle. While this bill includes a requirement for drivers to roll down their windows during law enforcement-initiated stops, this provision does not fully address the core issue. In situations involving inclement weather or driver noncompliance, the risk remains.

Current regulations, which require a minimum of 35% light transmittance, serve an important role in ensuring adequate visibility while balancing the benefits of window tint for glare and heat reduction. Lowering this standard would create unnecessary dangers on our roadways.

For these reasons, we respectfully urge the committee to reject House Bill 226, H.D. 1 in the interest of public safety.

Thank you for the opportunity to provide testimony. We urge the committee to reconsider or amend this bill to address these concerns.
