Chair Lee, Vice Chair Inouye, and members of the Committee:

The Department of Law Enforcement (DLE) supports House Bill 228, House Draft 1. This bill authorizes counties to adopt rules for the use of electronic license plates and regulations concerning the intentional obscuring of license plates with covers or shields. Additionally, the bill prohibits the use of license plate flipping devices and establishes appropriate minimum and maximum fines for violations.

The DLE believes this legislation is necessary for enhancing public safety and law enforcement capabilities. License plates serve as critical identifiers for vehicles involved in criminal activities, traffic violations, and other public safety matters. Devices or methods that obscure or alter license plates are often employed specifically to evade identification by law enforcement and automated systems like traffic cameras and toll collection devices.

The prohibition on license plate flipping devices addresses a concerning technology that allows drivers to instantly switch between different license plates, which has no

legitimate purpose and exists primarily to facilitate criminal activity and evade law enforcement. The established minimum fine of \$750 for these devices appropriately reflects the serious nature of this violation.

Similarly, intentionally obscuring license plates with covers or shields undermines the fundamental purpose of vehicle registration and identification. The minimum fine of \$500 for such violations serves as an appropriate deterrent.

By authorizing counties to establish rules for electronic license plates, this legislation appropriately prepares our state for emerging technology while ensuring proper regulatory oversight. Electronic license plates offer potential benefits including streamlined registration processes and enhanced vehicle tracking capabilities in cases of theft.

The DLE views this legislation as directly supporting our mission to protect public safety by ensuring that vehicles on our roadways remain properly and clearly identifiable.

The City and County of Honolulu, Department of Customer Services (CSD), Division of Motor Vehicles (DMV), respectfully offers comments to H.B. No. 228, H.D. 1, Relating to License Plates. CSD DMV appreciates the intent of the proposed legislation and the opportunity to offer the following comments for your committee's consideration.

Section 1 of the bill proposes to allow the counties to adopt rules authorizing the use of an electronic license plate in lieu of one or both physical license plates currently issued in the City and County of Honolulu by CSD DMV. While CSD DMV appreciates the intent to allow each county to adopt rules relating to electronic license plates, if the CSD DMV is delegated administrative rulemaking authority, CSD DMV will require adequate time to research and consider implementation requirements in order to proceed to promulgate such administrative rules. CSD DMV would not be prepared to immediately implement the usage of electronic license plates in the City and County of Honolulu. Therefore, CSD DMV appreciates the ability to promulgate administrative rules and implement the usage of electronic license plates in a manner and time to be determined by CSD DMV in its discretion.

Sections 2 and 3 of the bill propose to prohibit the operation of a motor vehicle with a license plate flipping device and to prohibit intentionally obscuring a vehicle's license plate through the use of a cover or shield. CSD DMV appreciates the intent of the proposed legislation and supports the proposed sections regarding the prohibition of license plate flipping devices and prohibition of intentional obscuring of a vehicle's license plate.
