Aloha Chair Lee, Vice Chair Inouye, and Members of the Committee,

On behalf of our over 20,000 members and supporters, the Sierra Club of Hawai'i **SUPPORTS HB307 HD1**, which would create a special number plate in recognition of Kaho'olawe, thereby reminding us of the lessons the island has taught and continues to teach us about our kuleana to these islands we call home.

Fifty years ago, the "Kahoʻolawe 9" landed on Kahoʻolawe as it was being actively bombed as target practice by the United States Navy. Through their bravery and defiance, the "Kahoʻolawe 9" exemplified aloha ʻāina, and their stand not only led to the eventual relinquishment of Kahoʻolawe to the state of Hawaiʻi, but also catalyzed what is now referred to as the "Second Hawaiian Renaissance," resulting in transformative changes to our legal, cultural, and social landscape.

The story of Kahoʻolawe holds many lessons of continued and particular relevance today. Its long history of mismanagement and abuse, the sacrifices made by the "Kahoʻolawe 9" to stop its desecration, and the damage it continues to suffer from all remind us of the costs we and our future generations must bear when we do not uphold our responsibilities of reciprocity and care for the 'āina that sustains and nurtures us. The successes of the "Kahoʻolawe 9" and the Protect Kahoʻolawe 'Ohana against the United States Navy in securing the return of Kahoʻolawe also gives us inspiration and hope - that a deep and steadfast love for our islands can, in fact, triumph over the greatest of odds. The community-led actions and efforts that ended the bombing of Kahoʻolawe, and that continue to clean-up and heal the land, also remind us of the importance of grassroots voices and leadership in ensuring the proper stewardship of our Hawaiʻi nei – a lesson that we must continue to hold close, as we navigate the ongoing Red Hill water crisis, and as we contemplate the true costs of military live fire training and other activities from Kaʻula, to Puʻuloa, to Mākua, to Pōhakuloa.

Accordingly, the Sierra Club of Hawai'i supports this bill as a means of not only recognizing Kaho'olawe and sustaining the work of the Protect Kaho'olawe 'Ohana, but as a way to also remind our communities of the critical lessons that Kaho'olawe taught



and continues to teach us – lessons that we must remember now perhaps more than ever before.

Therefore, the Sierra Club of Hawai'i respectfully urges the Committee to **PASS** this measure. Mahalo nui for the opportunity to testify.

We are Olan Leimomi Fisher and Kevin Chang, Kuaʻāina Advocate and Executive Director, respectively, testifying on behalf of Kuaʻāina Ulu 'Auamo (or KUA). "Kuaʻāina Ulu 'Auamo" stands for "grassroots growing through shared responsibility," and our acronym "KUA" means "backbone." Our mission is to connect and empower communities to improve their quality of life through the collective care for their biocultural (natural and cultural) heritage, serving as a "backbone organization" that supports creative and community-driven solutions to problems stemming from environmental degradation. Hawaiʻi's biocultural resources continue to be negatively impacted by political, economic, and social changes, and the increasing dangers of climate change make fostering and empowering resilient communities acutely critical.

Currently KUA supports three major networks of: (1) over 40 mālama 'āina (caring for our 'āina or "that which feeds") community groups collectively referred to as E Alu Pū (moving forward together); (2) over 60 loko i'a (fishpond aquaculture systems unique to Hawai'i) and wai 'ōpae (anchialine pool systems) sites in varying stages of restoration and development, with numerous caretakers, stakeholders, and volunteers known as the Hui Mālama Loko I'a ("caretakers of fishponds"); and (3) the Limu Hui made up of over 50 loea (traditional experts) and practitioners in all things "limu" or locally-grown "seaweed." Our shared vision is to once again experience what our kūpuna (ancestors) referred to as 'ĀINA MOMONA – abundant and healthy ecological systems that sustain our community resilience and well-being.

KUA supports HB307 HD1 as an incremental step towards 'āina momona.

This bill would create a special license plate to recognize and raise funds needed to help our Hawai'i community fulfill the collective promise and obligation to heal Kahoʻolawe. Funds raised would go into the Kohe Mālamalama o Kanaloa Protect Kahoʻolawe Fund. A new and cherished member of our E Alu Pū network is the Protect Kahoʻolawe 'Ohana (PKO), long time champion and steward of Kahoʻolawe.

A primary function of KUA includes support for the development of an 'auwai, or a system of resources, tools, bridges, relationships, and networks that cultivate and elevate our communities' efforts to greater levels of collective impact in the care of our biocultural resources. A core catalyst for the flow in this 'auwai includes increasing necessary resources and pathways for community-led efforts helping to manage and regenerate the condition of the 'āina that sustains us. We trust that a share of the resources generated from this special license plate will go to support some of PKO's efforts which are core to connecting our broader community with understanding the importance and sacredness of Kaho'olawe.

The communities we work with are committed to ensuring the long-term health of our biocultural resources that they have cared for and depended on for generations since time immemorial. We believe our environment, the foundation of our very existence, is about long-term investment and a vision of 'āina momona. To get there requires taking the steps necessary for greater self-sufficiency, development of new and more innovative career pathways, mindsets, relationships, and resources for mālama 'āina efforts that encourage and build upon the time-tested techniques of our ancestors in Hawai'i. Passing this bill out of your committee will open an essential 'auwai system toward reaching this vision.

Aloha Chair Lee, Vice Chair Inouye, and members of the Committee on Transportation and Culture and the Arts. My name is Joshua Kaakua and I am testifying on behalf of the Protect Kahoʻolawe 'Ohana in strong support of HB 307 Relating to Special Number Plates to recognize the island of Kahoʻolawe and the Aloha 'Āina movement that it has inspired.

January 4, 2026 will mark the 50th year since nine individuals landed on the island of Kahoʻolawe to draw attention to the injustices and discrimination experienced by Native Hawaiians. Upon arrival, they were unexpectedly astounded and deeply moved by the abuse and destruction that they witnessed of a fragile, starkly beautiful, and spiritually powerful island. This gave rise to the organization of the Protect Kahoʻolawe ʻOhana and its fiscal non-profit charitable entity, Kohe Mālamalama o Kanaloa Protect Kahoʻolawe Fund (ʻOhana).

A civil suit, *Aluli v Brown*, filed by the 'Ohana in 1976 led to a court-mandated Consent Decree in 1980 under which the Protect Kaho'olawe 'Ohana was recognized as a steward working for the restoration of the island; was provided access, with volunteers, to engage in spiritual, cultural and educational activities; and began to jointly govern the island with the U.S. Navy. In 1977, two

'Ohana members, George Helm and Kimo Mitchell, were lost at sea in the waters off of Kaho'olawe during a protest of the bombing.

On October 22, 1990, U.S. President George H.W. Bush stopped all bombing exercises on the island. The U.S. Congress terminated all military use of the island in 1993 under Title X of the 1994 Department of Defense Appropriations Act (Title X). Title X further authorized the conveyance of Kahoʻolawe and its surrounding waters to the State of Hawaiʻi and authorized \$400 million for ordnance removal. The ordnance removal program ended in 2004. The State of Hawaiʻi manages the island through the Kahoʻolawe Island Reserve Commission under HRS 6K, codified in July 1993 in partnership with the Protect Kahoʻolawe ʻOhana and Kohe Mālamalama o Kanaloa Protect Kahoʻolawe Fund.

Kahoʻolawe has become a model of co-stewardship of Hawaiian ancestral lands by community groups working together with the Department of Land and Natural Resources. Kahoʻolawe is an iconic symbol of Aloha ʻĀina - the recognition and acceptance of generations of Native Hawaiians since 1976 of the kuleana (responsibility) to love, care for, and respect our precious islands and restore Hawaiʻi's sovereignty. Kahoʻolawe was the piko (catalyst) for the dynamic cultural renaissance of Hawaiian hula, language, arts, and national pride that prevails today, almost 50 years later.

Our 'Ohana recommends and supports special number plates for Kaho'olawe in order to:

- encourage awareness about the injustices endured by Kahoʻolawe and Native Hawaiians and how Kahoʻolawe's cultural and natural resources and Hawaiian cultural and spiritual practices were restored through longterm (50-years) commitment, sacrifice, dedication, and constancy by generations of Native Hawaiians and those who call Hawaiʻi home;
- educate the general public about how the sacred nature of the island of Kahoʻolawe as well as other sacred places in Hawai'i are able to be revived and protected through dedicated volunteer co-stewardship and the acknowledgement and revitalization of Native Hawaiian

ancestral knowledge and related cultural and spiritual practices, as protected under the article 12, section 7 of the Hawai'i Constitution;

- acknowledge the efforts, work, ingenuity, and lives that have been given in the pursuit of the protection of Native Hawaiian lands, people, and Hawai'i sovereignty; and
- connect the broader community with the mission of Kahoʻolawe's cultural and environmental recovery and serve as a reminder of the strength of collective action.

Having a Kahoʻolawe special number plate is a fitting tribute to the decades-long efforts of the Protect Kahoolawe 'Ohana and all those in the broader community who have contributed to and benefitted from this important Kahoʻolawe Aloha 'Āina movement. Importantly, the proceeds from the sale of these plates will directly benefit the Protect Kahoolawe 'Ohana, further supporting the important work collectively conducted in safeguarding and preserving the island for future generations. In celebration of 50 years since the first landings, this special number plate will provide a legacy of commitment to Kahoʻolawe's healing and stewardship. Here is a possible design for the plate:
