DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the intent of the bill, defers to the Office of the Governor, and provides comments. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget.

<u>PURPOSE</u>: The purpose of this bill is to appropriate funds to the Office of the Governor for a state child care facility for state employees and their families.

The number of licensed and registered family child care providers and center-based providers has been on the decline since prior to the COVID-19 pandemic. Establishing a state childcare facility for employees and their children would provide another childcare option for state employees and their families. It may contribute to improving workforce recruitment, retention, and continuity of employment.

DHS will work with the entity through the licensing process to ensure that the health and safety standards for the licensing of child care facilities per Hawaii Administrative Rules are met and maintained when children are in care.
