Bill Title: HB 0358 RELATING TO DISASTER PREPAREDNESS.

Purpose of Bill: Requires all public buildings, including public school buildings, constructed after

January 1, 2026, to be designed to withstand category five hurricanes and be

used as shelters in the event of an emergency.

#### **Department's Position:**

The Hawaii State Department of Education (Department) is providing comments on HB 0358.

The Department agrees that Hawaii is vulnerable to natural disasters and more shelters are needed; however, the proposed bill to require all public buildings to be constructed to withstand Category 5 hurricanes and to be used as shelters should consider the feasibility of this measure.

The current Hawaii State Building Code includes life safety design criteria for enhanced hurricane protection areas (EHPA) in high occupancy state- and county-owned buildings occupied during hurricanes of up to Category 3. High occupancy is defined as 300 or more occupants. To meet EHPA design requirements to withstand a Category 3 hurricane restrooms are required to be accessible from the interior, the facility must withstand projectiles, emergency generator power must be provided, a higher level of structural integrity is factored in, and other design considerations have to be met. The Department would have to overhaul the design requirements for school facilities and greatly increase the cost to design and construct any school building to withstand a higher Category 5 hurricane. In addition, the current Hawaii State Building Code does not include requirements for a building that can withstand a Category 5 hurricane in Appendix U, Hawaii Hurricane Sheltering Provisions for New Construction, Section 430 State- and County-Owned Public High Occupancy Buildings - Design Criteria for Enhanced Hurricane Protection Areas.

The Department would also request greater specificity on the type of public facilities impacted. For example, covered play court structures are not fully enclosed so it would not be a desirable shelter

during a hurricane but would still be required to meet the requirements under the proposed bill.

The Department of Accounting and General Services (DAGS) appreciates the intent of this measure, which requires all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

#### DAGS offers the following **comments**:

- Consideration should be given to exempting public building types for which the
  associated design and construction standards would be excessive, such as, but not
  limited to, carports and material storage sheds at corporation yards.
- It should be expected that adherence to the design and construction standards

required to withstand category five hurricanes will involve substantial increases in project costs. Projects currently under design and intended to begin construction on or after January 1, 2026, may not have sufficient appropriated funding to accommodate the increased costs of compliance. Therefore, consideration should be given to revising the measure's language to provide that such compliance will be required on projects for which appropriations were made in the legislative session of 2026.

Chair Au Belatti, Vice Chair Iwamoto, and Members of the Committee:

The Department of Corrections and Rehabilitation (DCR) supports the intent of House Bill (HB) 358, which seeks to require all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

Under DCR are eight (8) correctional institutions throughout the state that house justice involved individuals. We are currently in the planning phase for proposed relocations of the Oahu Community Correctional Center (OCCC), the Kauai Community Correctional Center (KCCC), and the Maui Community Correctional Center (MCCC). We support that design of these correctional facilities must withstand Category five hurricanes, however, because we are responsible for the care and custody of justice involved individuals, our capacity to provide shelter for others is very limited.

#### HB358

I am Dr. Kioni Dudley. Let's talk about our real situation. We've never had a hurricane hit O'ahu head-on. So we had come to believe that hurricanes never would. Then came climate change awareness, just a few years back. And we became aware that with warming seas, the spawning area for hurricanes over by Mexico had moved northward. And now Hawaii is in the path for hurricanes crossing the Pacific. We've had hurricanes brush the Big Island. Last year we had one pass just north of O'ahu. They're coming. So where will you go? The Oahu Dept. of Emergency Management tells us they have places of refuge for 100,000 people in a Cat 1 or 2 hurricane. But they expect 200,000 to need places to go. That means 100,000 people will have no place to go even in a Cat 1 or 2 hurricane. Will you be one of those 100,000 people? What about your kids? Where will they go? Will your family die?

Now I've only mentioned shelters for a Cat 1 or 2. When a Category 3, 4, or 5 hits, we don't have a single shelter that will hold up. There's **no place for anyone** to go. What will you do? How can you save your family?

This bill would require that all new schools and public buildings be built to withstand Category 5 hurricanes. Again, Cat 5s are coming. This is just a start. But at least it is a start.

There are a few additional words that I strongly recombined putting into the bill. The bill says that the new buildings would have to withstand a Category 5 hurricane. That should be "Category 5 hurricanes with winds of 200mph. Further, people stay in a hurricane shelter for a whole day or longer. They need to be able to reach bathrooms. So I would add "and have interior passages to bathrooms." Section II (d) should be amended to state that "All public buildings, including public school buildings constructed after January 1, 2026 shall be designed to withstand category five hurricanes with winds of 200 mph, and have interior passages to bathrooms, and be used as shelters in the event of an emergency.

Please think about not just yourself and your family. Think about future generations. We have a real obligation to them to start building now. Please vote for this bill.
