

COMMENTS ON HB 370_HD1 RELATING TO PARTIAL PUBLIC FINANCING OF ELECTIONS

The Office of Hawaiian Affairs (OHA) respectfully submits <u>COMMENTS</u> on HB370_HD1, which increases the amount of public funds available to candidates for public office who participate in the State's Partial Public Financing program under Hawai'i Revised Statutes (HRS) Chapter 11, Part J, and increases participating candidates' expenditure limits.

OHA generally supports public financing as a good government measure. The amendments to HRS Chapter 11 proposed in HB370_HD1 will make the public financing program a more viable option for candidates by increasing the funding available to candidates who participate in the partial public financing system. Increased access to publicly financed campaigns makes elections more accessible, open, and fair

At the same time, OHA objects to the continued disparity with which OHA is treated under the Partial Public Financing law. HRS § 11-423(d) sets forth the campaign expenditure limits under the partial public financing program by a formula that multiplies the "number of voters in the last preceding general election registered to vote" in the relevant voting district by a specific dollar amount. *See* HRS § 11-423(d). OHA trustees are the only candidates who run statewide election campaigns that are not explicitly listed in this subpart, and thus default to the lowest multiplier category with "other offices," or \$0.20 (20 cents). *See* HRS § 11-423(d)(5). As a point of comparison, the lieutenant governor who also runs a statewide campaign has a dollar multiplier of \$1.40. *See* HRS § 11-423(d)(2).

The total expenditure limits in HRS § 11-423(d) in turn affect the amount of public financing available to a candidate under HRS § 11-425, which sets public funding as a percentage of the total expenditure limits. While OHA appreciates that this measure will increase the maximum amount of public financing available to OHA candidates from

\$1,500 to \$17,200 (using the last general election voter registration data), this is still far below what comparable office holders will receive. Under the changes proposed in HB370_HD1, the lieutenant governor's maximum public funding will increase from \$180,782 to \$271,173.

As a matter of fairness and equity, OHA respectfully requests that OHA be treated comparably to other statewide office holders through necessary amendments to HRS §§ 11-423, -425. Specifically, the multiplier set in HRS § 11-423 should put OHA on parity with the lieutenant governor, another statewide office holder. Likewise, section 2 of HB370_HD1 should be amended to set the maximum amount of public funds available to OHA candidates at fifteen percent of the HRS § 11-423 limit, consistent with candidates of the position of lieutenant governor, another elected position that requires statewide elections.

Chair Yamashita, Vice Chair Takenouchi, and Committee Members: **The League of Women Voters of Hawaii supports HB370 HD1.** The League of Women Voters of the US believes that methods of financing political campaigns should enable candidates to compete equitably for public office and ensure that candidates have sufficient funds to communicate their messages to the public. Hawaii's Partial Public Funding Program (PPFP) is intended to support those goals.

Public financing of campaigns for political office is an investment in good governance, like budgeting for the Office of Elections or the Campaign Spending Commission or the Legislature itself. Public Financing can return the value invested in it by increasing the extent to which elected officials work for the benefit of all state residents, rather than wealthy businesses or individuals; increasing voter confidence in government; and encouraging more citizen participation in elections and communication with their representatives.

The cost of this investment is not large. Supporting HB370 HD1 would cost less than \$5million in the 2026 election year, even assuming an extremely large increase in the number of candidates seeking and qualified for public financing. That is a very small addition to the State budget, as this committee is well aware. It is also quite possible that legislative spending would be more effective and efficient when directed by the needs and values of the population, rather than being swayed by financial relationships with special interests. Please make this investment in helping a more diverse group of candidates consider running for elected office, decreasing corruption and enhancing the reputation of elected officials in Hawaii.

HOUSE BILL 370, HD1, RELATING TO PARTIAL PUBLIC FINANCING OF ELECTIONS

FEBRUARY 25, 2025 · FIN HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 370, HD1, relating to partial public financing of elections, which increases the amount of partial public campaign financing available for all elective offices; adjusts the minimum amount of qualifying contributions certain candidates must receive to participate in the program; and increases the matching fund payments for excess qualifying contributions.

Our democracy belongs to we, the people. At a time when our nation is experiencing extreme political turmoil and basic civil liberties are under assault, we must take steps in Hawai'i to safeguard democratic participation. In the 2024 primary election, for example, our state experienced its lowest turnout in 65 years, with only 32.1 percent of registered voters filling out a ballot. This is, in part, a reflection of the public's deep cynicism with our electoral processes.

Hawai'i continues to be embroiled in public corruption scandals, following the bribery allegations that were levied against former Senate Majority Leader Kalani English and former State Representative Ty Cullen. Other public officials, such as employees at local permitting offices, have also recently been ensnared in bribery scandals, in some cases with connections to Milton Choy, the lobbyist who was responsible for coordinating the bribery scheme that Sen. English and

Rep. Cullen became a part of. These cases show that we have a moral crisis in our public institutions and must do all we can to restore integrity to government.

When candidates for public office are forced to rely on private donations to build relationships, those transactions can cause corruption or create the perception of it. Put simply, legislators are responsive to donors because donors fund their campaigns. Money is crucial to winning. Roughly 91 percent of candidates who outspend their opponents win their elections.

Relatedly, many people choose not to run for public office because they can't afford the cost of a campaign, leaving many incumbents routinely uncontested in their reelection bids. The average winner of a State House seat in Hawai'i spends approximately \$40,000 on their campaign, compared to only \$16,000 for the losing candidate. Over half of all campaign donations in 2022 came from just 980 donors, each of whom contributed at least \$6,000 in candidate donations during that election cycle.

This bill moves our islands incrementally toward an election system that is fair. <u>We are especially</u> supportive of the proposed positional funding for the Hawai'i Campaign Spending Commission, which has not received additional staff since its inception decades ago. That said, we urge your committee to continue evaluating more robust public financing models, such as those being used in states like Maine. In the 2010 and 2012 election cycles, the Hawai'i Island County Council ran a pilot program for comprehensive public funding. Similarly, Connecticut and Maine have instituted comprehensive public financing programs, which have proven successful at increasing electoral participation and reducing candidates' reliance on private donations. Over 70 percent of Democratic legislators use public financing to fund their campaigns in Maine.

These models ensure that candidates no longer need to rely on contributions from wealthy donors. Instead, they can seek support from their constituents in the form of small donations that verify their credibility and subsequently obtain public funding in an amount sufficient to run effective campaigns. Legislators are, in turn, empowered to focus on engaging with their communities, rather than charming the donor class. Ultimately, this reorients our government toward the will of the people, not the wallets of the privileged. We believe that government should work for the public interest, not special interests. It is in that spirit that we support this and other reforms to uplift the transparency, accountability, and integrity of our state's election system.

Thank you for the opportunity to testify on this bill.¹ The Campaign Spending Commission ("Commission") supports this bill.

The purpose of this bill is to enhance Hawaii's partial public financing program by increasing the maximum amount of public funds available for all offices by 50%² (except for the Office of Hawaiian Affairs ("OHA") which will be significantly enhanced by over 1,000%) to qualified candidates. It also makes a downward adjustment of the minimum qualifying contributions for certain offices because it appears that publicly financed candidates for those offices were having a difficult time raising the minimum qualifying contributions. Respectfully, the Commission is submitting this bill as an attempt to boost an existing program that is mandated by the State Constitution which has not changed and whose maximum dollar amounts have not changed since 1995.

This bill amends Hawaii Revised Statutes ("HRS") sections as follows:

1) HRS §11-425 by increasing the maximum amount of public funds available for all offices (except for the offices of the Mayor of the County of Kauai, Mayor of the

County of Maui, and OHA trustee) by 50%. The bill also increases the maximum amount available for candidates for Mayor of the counties of Kauai and Maui by 125% by moving those offices from subsection (a) to subsection (b) <u>and</u> increasing the maximum amount of public funds available for a candidate for trustee of OHA from \$1,500 for the election period to 10% of the expenditure limit for each election established in HRS §11-423(d).

- HRS §11-429(a) by increasing the amount of qualifying contributions required for a candidate for trustee of OHA from more than \$1,500 in the aggregate to more than \$5,500 in the aggregate.
- 3) HRS §11-429(b) by increasing matching fund payments from \$1 for each \$1 of qualifying contributions in excess of the minimum qualifying contribution amounts to \$2 for each \$1 of excess qualifying contributions.

The bill also provides a downward adjustment of the minimum amounts of qualifying contributions for the office of prosecuting attorney for the city and county of Honolulu (from \$30,000 to \$25,000), and counties of Hawaii (from \$10,000 to \$5,000) and Kauai (from \$5,000 to \$3,000), and for the office of county council for the county of Maui (from \$5,000 to \$4,000). Lastly, the original bill established two full-time equivalent (2.0 FTE) positions in the Commission and appropriated \$200,000 to fund these positions.

For illustration, here is a comparison of the present partial public funding program in contrast to the enhanced partial public funding program set forth in this bill. For a qualified <u>Senate</u> candidate running in District 1 in the 2026 election, the maximum amount of public funds available is \$7,269 in the primary election and another \$7,269 in the general election. In contrast, under this bill, this same candidate would receive \$10,903 in the primary election and another \$10,903 in the general election. For a qualified <u>House</u> candidate running in District 1 in the 2026 election, the maximum amount of public funds available is \$3,562 in the primary election and another \$10,903 in the general election. For a qualified candidate running for <u>Kauai Mayor</u> in the 2026 election, the maximum amount of public funds available is \$9,635 in the primary election and another \$9,635 in the general election. In contrast, under this bill, this same candidate would receive \$21,679 in the primary election and \$21,679 in the general election. For a qualified candidate running for <u>Maui</u> <u>Mayor</u> in the 2026 election, the maximum amount of public funds available is \$23,002 in the primary election and another \$23,002 in the general election. In contrast, under this bill, this same candidate would receive \$51,754 in the primary election and \$51,754 in the general election. Lastly, for a qualified <u>OHA</u> candidate in the 2026 election, the maximum amount of public funds available is \$1,500 for the election period. In contrast, under this bill, this same candidate would receive \$17,217 in the primary election and \$17,217 in the general election.

Under the bill, assuming one qualified candidate for each elective office³ in the state, the maximum amount of public financing available would be **\$2,353,426** in the 2026 primary election and another **\$2,353,426** in the 2026 general election. As of October 31, 2024, the Hawaii Election Campaign Fund ("HECF") balance was **\$2,268,225.38**. An appropriation into the HECF is likely necessary if this bill is passed. As the following table shows, recent usage of the partial public financing program has been dwindling:

In regard to the additional two full-time equivalent (2.0 FTE) positions in the measure, the Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, inperson, and by email as well as a number of enforcement actions for violations. Under HRS \$11-314(7), one of the Commission's 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside agencies.⁴ In comparison to other State and county good government groups with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld and approve our request for

³ The Commission is aware that not all elective offices appear on the ballot in an election year.

⁴Act 10, Special Session 1995, was the single year that a sum of \$70,000 was appropriated for one investigator for the Commission for FY 1995-1996 and was then sunset. This request essentially restores this position and makes it permanent.

2 new full-time permanent exempt excluded positions (i.e., an Elections Assistant and an Investigator).⁵

The Commission requests that this committee pass this bill with the appropriation of \$200,000 for the two full-time equivalent (2 FTE) permanent positions to be placed within the Commission restored.

⁵ The Commission requested these 2 full-time permanent exempt excluded positions in its FY 2025-2027 budget to which the Governor has approved – specifically, the request was for \$200,000 for FY 2026 and \$180,000 for FY 2027-2029. Notably, the Commission is an administratively attached agency with the Department of Accounting and General Services.

As a citizen who values free markets, personal accountability, and the integrity of our elections, I submit this testimony in strong opposition to HB370. This bill increases public campaign funding—raising maximums from 10% to 15% for top offices and 15% to 22.5% for others, doubling matching funds to \$2 per \$1 raised, and appropriating taxpayer dollars for it all. Comments:

As a taxpayer and resident of Hawaii, I strongly oppose House Bill No. 370 (H.D. 1), which expands the partial public financing program for election candidates, because I believe it's deeply unfair, burdens me excessively, and destroys the free election system I value. I resent that my hard-earned tax dollars-already stretched thin by Hawaii's high living costs, where \$1 in 1995 is now worth \$2.07-will be tapped in unspecified amounts for fiscal year 2025-2026 to fund political campaigns and hire more Campaign Spending Commission staff, when I'd rather see that money fix roads or ease housing woes than subsidize candidates I might not even support, like a Honolulu mayor's race when I live on Kauai. I find it unjust that the bill hikes maximum public funds to 15% of the expenditure limit for governor or 22.5% for other offices and doubles matching funds to \$2 per \$1 of excess contributions, giving well-connected candidates a massive advantage—someone raising \$50,000 extra nets \$100,000 in public money, while I'd struggle as a grassroots hopeful to scrape together \$1,500 for state representative and get next to nothing. I'm baffled and frustrated by the inconsistent qualifying thresholds-why should I need \$5,500 to run for Office of Hawaiian Affairs while a Kauai prosecutor gets by with \$3,000 or a Maui councilor with \$4,000, when it feels arbitrary and uneven with no clear reason? I believe this bill obliterates free elections by flooding them with taxpayer cash—candidates can dodge engaging me directly, relying on my money instead of my vote, eroding the democratic freedom of choice and reducing their accountability, while the measly \$100 cap for small offices mocks their worth and leaves them sidelined. I'm also unsettled by the fiscal irresponsibilitythose vague appropriation sums could spiral out of control, draining state coffers without me knowing how much I'm on the hook for, which isn't right. Comments:

I am writing to express my strong opposition to House Bill HB370, which pertains to the partial public financing of elections in Hawai'i. While the intention behind this legislation may be to enhance the electoral process and promote greater participation, I believe it poses several significant issues that undermine the democratic principles we hold dear.

Firstly, the allocation of public funding to political campaigns raises concerns about the responsible use of taxpayer money. In a time when many residents are struggling with economic challenges, diverting public funds to finance political campaigns seems misaligned with the priorities of our community. It is essential that our government focuses on addressing pressing issues such as education, healthcare, and infrastructure, rather than subsidizing candidates' campaigns.

Additionally, HB370 may inadvertently favor certain candidates or parties over others. The criteria for eligibility and the distribution of funds could create an uneven playing field, leading to potential bias in the electoral process. This undermines the core principle of a fair and competitive democracy, where all candidates should have an equal opportunity to present their ideas and garner support.

Moreover, public financing could diminish the accountability of candidates to their constituents. When candidates rely on taxpayer money, there may be less incentive to engage with the community and address the specific needs and concerns of the electorate. True democracy flourishes when candidates are motivated to connect with voters and seek their support through genuine engagement rather than relying on public funds.

In conclusion, while the objective of enhancing electoral participation is commendable, I believe that House Bill HB370 is not the right approach. It risks misallocating taxpayer resources, creating an uneven electoral landscape, and diminishing the accountability of elected officials. I urge lawmakers to reconsider this bill and explore alternative methods to promote civic engagement and support for candidates that do not compromise the integrity of our electoral system.

- 1. Fiscal irresponsibility: As a taxpayer I don't want my tax dollars going to a candidate I don't support.
- 2. Effectiveness concerns: There is extremely limited evidence that increased public financing leads to significant improvements in electoral outcomes or reduces the influence of special interests. We already have partial public financing and less than 1% of 141 candidates in the 2024 election opted-in for partial public financing.
- 3. Potential for abuse: Expanding the program may create opportunities for candidates to exploit public funds for personal or political gain.
- 4. Complexity: The proposed changes to qualifying contributions and matching fund payments may further complicate an already complex system, potentially deterring participation.
- 5. Unintended consequences: Increased public financing could lead to a proliferation of fringe candidates, potentially confusing voters and fragmenting the political landscape.
- 6. Resource allocation: The funds appropriated for this program could be better utilized for pressing public needs such as education, healthcare, or infrastructure.

Instead of expanding the public financing program, I urge the committee to consider focusing on voter education initiatives to increase informed participation in the electoral process.

Dear Representatives,

I am writing to express my enthusiastic support for House Bill 370 (H.D. 1), which seeks to modernize and strengthen Hawaii's partial public financing program for elections. This bill represents a vital step toward ensuring that our electoral system remains equitable, accessible, and reflective of the voices of all Hawaii residents.

As the bill notes, the funding levels for the partial public financing program were last significantly updated in 1995. Since then, the value of the dollar has more than doubled, eroding the program's effectiveness in supporting candidates who rely on grassroots contributions rather than large private donations. By increasing the maximum amount of public funds available to qualifying candidates—including those running for governor, lieutenant governor, mayor, state legislature, county councils, prosecuting attorney, and the Office of Hawaiian Affairs—this bill ensures that candidates have the resources they need to compete fairly in today's elections.

I particularly commend the bill's provisions to raise the maximum public funding thresholds to 15% of the expenditure limit for top offices like governor and mayor of Honolulu and Hawaii counties, 22.5% for state senators, representatives, and other local offices, and 10% for Office of Hawaiian Affairs trustees. These adjustments reflect the realities of modern campaign costs and provide a lifeline to candidates who prioritize small-donor support over special interests. Additionally, the increase in matching fund payments from \$1 to \$2 for every dollar of excess qualifying contributions amplifies the impact of individual donations, empowering everyday residents to play a larger role in our democracy.

The bill's adjustments to minimum qualifying contribution amounts are equally critical. By recalibrating these thresholds—such as lowering the requirement for Honolulu prosecuting attorney from \$30,000 to \$25,000, or raising it for Office of Hawaiian Affairs candidates from \$1,500 to \$5,500—the legislation strikes a balance between encouraging participation and ensuring candidates demonstrate broad community support. These changes make the program more inclusive while maintaining its integrity, allowing a wider range of candidates to viably enter the electoral process.

Furthermore, I strongly support the appropriations outlined in Sections 4, 5, and 6 of the bill. Allocating general revenues to bolster the Hawaii Election Campaign Fund and providing resources for additional staff at the Campaign Spending Commission demonstrates a commitment to the program's success. With increased participation anticipated, these investments will ensure the commission can effectively administer the program and uphold transparency and accountability in our elections.

Hawaii has long been a leader in promoting fair and transparent elections, and H.B. 370 builds on that legacy. By reducing the influence of big money in politics and leveling the playing field for candidates who represent the interests of working families, Native Hawaiian communities, and underserved populations, this bill strengthens the democratic process for all. It sends a clear message: in Hawaii, elections should be about ideas and people, not just wealth and insider connections.
