In consideration of H.B. 431 HD2 SD1 RELATING TO HOUSING.

Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee.

HHFDC <u>supports</u> HB 431 HD2 SD1, which appropriates funds to the Office of the Governor for the continued implementation of the Kauhale Initiative and Ohana Zones Pilot Program. It also appropriates funds to the Hawaii Housing Finance and Development Corporation (HHFDC) for the development of supportive housing projects and provision of supportive services for certain households in the supportive housing projects. HHFDC supports the measure so long as it does not adversely impact priorities identified in the Executive Budget Request for FY 2026.

HHFDC recognizes the need for a dedicated funding source to assist individuals with special needs. The appropriation will allow us to develop, operate, and maintain affordable, supportive housing projects and provide supportive services for households with special needs who reside in such projects.

We request \$175,000 for one full-time equivalent (1.0 FTE) housing finance specialist I position to help administer the provisions in Section 5 of the bill.

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports this measure, which invests in the Kauhale initiative, the Ohana Zones Pilot program, and permanent supportive housing as strategies to reduce homelessness. DHS defers to the Statewide Office on Homelessness and Housing Solutions (SOHHS) and the Hawaii Housing Finance and Development Corporation (HHFDC). DHS respectfully requests that any appropriation align with the executive budget and not reduce or replace other budget priorities.

<u>PURPOSE</u>: The bill appropriates funds to the Office of the Governor for the continued implementation of the Kauhale Initiative and Ohana Zones Pilot Program. Appropriates funds to the Hawai'i Housing Finance and Development Corporation for the development of supportive housing projects and provision of supportive services for certain households in the supportive housing projects. Effective 6/29/3000. (SD1)

The House Committee on Human Services & Homelessness amended the measure by:

(1) Changing the appropriations to unspecified amounts;

- (2) Deleting language that attempted to prevent the proper lapse of a general fund appropriation at the end of the fiscal biennium for which the appropriation was made;
- (3) Deleting language that would have established the Kauhale Initiative Special Fund;
- (4) Inserting language that appropriates an unspecified amount to assist the Statewide Office on Homelessness and Housing Solutions in implementing the Kauhale Initiative;
- (5) Changing the effective dates to June 29, 3000, and July 1, 3000, respectively, to encourage further discussion; and
- (6) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Committee on Housing further amended the measure by:

- (1) Expanding the authorized uses of funds appropriated for the Kauhale Initiative;
- (2) Authorizing funds appropriated for the Kauhale Initiative to be used for the Ohana Zones Pilot Program established under Act 209, Session Laws of Hawaii 2018;
- (3) Requiring at least two bidders for any Kauhale project estimated to be over \$1,000,000 if appropriated funds are used to contract for the procurement of building services and projects related to the Kauhale Initiative;
- (4) Deleting the unspecified appropriation to the Statewide Office on Homelessness and Housing Solutions to implement the Kauhale Initiative; and
- (5) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Committees on Health and Human Services and housing substantially amended this measure by:

- Deleting language that would have allowed funds appropriated for the continued implementation of the Kauhale Initiative to be used for the Ohana Zones Pilot Program established under Act 209, Session Laws of Hawaii 2018;
- (2) Deleting language that would have allowed:
 - (A) The Governor to transfer all or a portion of the appropriations for the continued implementation of the Kauhale Initiative to the Governor's designated executive branch departments or agencies, including the Statewide Office on Homelessness and Housing Solutions, for expenditures incurred to implement the Kauhale Initiative; and
 - (B) The Governor's designated executive branch departments or agencies to expend the transferred appropriations for the performance of their duties under the Kauhale Initiative;
- (3) Deleting language that would have provided that if funds appropriated for the continued implementation of the Kauhale Initiative are used to contract for the

- procurement of building services and projects related to the Kauhale Initiative, there shall be at least two bidders for any kauhale project estimated to be over \$1,000,000;
- (4) Inserting a blank appropriation amount for the continued implementation of the Ohana Zones Pilot Program established under Act 209, Session Laws of Hawaii 2018;
- (5) Deleting language that would have established a Supportive Housing Special Fund to be administered by the Hawaii Housing Finance and Development Corporation;
- (6) Deleting language that would have made appropriations into and out of the Supportive Housing Special Fund;
- (7) Inserting a blank appropriation amount to be expended by the Hawaii Housing Finance and Development Corporation for the development, operation, and maintenance of affordable, supportive housing projects and the provision of supportive services for households with special needs who reside in the supportive housing projects;
- (8) Amending the legislative findings of part III to reflect its amended purpose;
- (9) Amending section 1 to reflect its amended purpose; and
- (10) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Hawaii State Council on Developmental Disabilities **STRONGLY SUPPORTS HB431 HD2 SD1**, appropriates funds to the Office of the Governor for the continued implementation of the Kauhale Initiative and Ohana Zones Pilot Program. Appropriates funds to the Hawaii Housing Finance and Development Corporation for the development of supportive housing projects and provision of supportive services for certain households in the supportive housing projects. Effective 6/29/3000.

This bill represents a critical step forward in meeting the housing needs of Hawaiʻi's most vulnerable populations, including individuals with intellectual and developmental disabilities (I/DD). Catholic Charities Hawai`i **strongly supports HB 431 HD2 SD1**, which appropriates funds for the Kauhale Initiative and Ohana Zone Pilot Program, and funding to the Hawai`i Housing Finance and Development Corporation (HHFDC) for the development, operation, and maintenance of affordable supportive housing projects and supportive services for the special need resident. (SD1 deleted the Supportive Housing Special Fund.)

Catholic Charities Hawai'i (CCH), a community-based organization, has provided social services in Hawai'i for over 77 years, assisting 40,000 people annually. Our services target the most vulnerable in Hawai'i, including elders, veterans, children, families, houseless individuals, and immigrants. We have a long history of addressing affordable housing and homelessness.

These initiatives are crucial to address Hawai'i's homelessness crisis. On Oahu, 62% of homeless persons are unsheltered. The **Kauhale Initiative** accelerates the development of diverse housing options, helping people move off the streets into much-needed transitional and bridge housing. Funding **Ohana Zone** projects keeps formerly homeless individuals in housing. However, deeply affordable permanent housing remains KEY to truly ending homelessness.

The development of ongoing **Supportive Housing** is particularly vital. This bill provides a transparent structured financial mechanism to integrate development, operations, and supportive services—ensuring that vulnerable populations receive not just shelter, but the assistance needed for long-term stability. By centralizing funding and coordination under the Hawai'i Housing Finance and Development Corporation (HHFDC), this initiative streamlines coordination, benefiting developers, service providers, and, most importantly, individuals in need.

We urge the legislature to add the language for a Supportive Housing Special Fund, which was deleted in this SD1. The special need residents in these homes require ongoing services to successfully live in the community. This Special Fund would create a process the ongoing funding, which is critical for developers to ensure long-term stability. We must prioritize chronically homeless individuals and those with special housing needs—veterans, individuals with addictions, aging-out foster youth, domestic violence survivors, developmentally disabled persons, and frail elders. Without supportive housing and supportive services, many face institutionalization, costly emergency interventions, or even premature death.

Catholic Charities Hawai`i urges your support for this bill. The Kauhale, Ohana Zones and Supportive Housing Initiatives are essential to tackling homelessness. <u>Please approve significant funding</u> to bring stability and hope to those who need ongoing supportive services. Hawaii Substance Abuse Coalition Supports HB431 HD2 SD1:

ALOHA CHAIR, VICE CHAIR, AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery-oriented services.

HSAC respectfully advocates for funding supportive services.

HSAC recognizes that **supportive housing with specialized funding** for services to help individuals with **disabilities**, **substance use disorders**, **cooccurring disorders** (mental health and substance abuse), severe mental health, justice-involved reentry, and more are needed

- 1. As a means for people to **become** functional while striving for self-sufficiency.
- 2. Having a means for transitioning residents to functionality through behavioral health services leads to permanent housing and
- 3. Is a key cost-effective strategy to not over utilize Kauhale building projects.

Residential and Outpatient Substance Use Disorder funding has been reduced at a time when studies indicate that housed homeless will need these critical services.

HSAC notes that formal treatment, such as residential and outpatient will be critically needed for Kauhale residents to achieve functionality and recovery.

Studies show that once housed, feeling safe and stable, many homeless voluntarily seek substance abuse treatment because they want improved functionality.

• For example, 50-60% of individuals in Housing First programs engaged in substance use disorders treatment when supportive services were offered. Programs offering integrated care (housing, food, medical care, and counseling) report higher engagement in substance abuse treatment, with rates often exceeding 50% in some cases.

- After safe housing, homeless still are at elevated risk for experiencing substance use disorders (SUDs), mental disorders, trauma, medical conditions, employment challenges, and incarceration. Both treatment and housing needs must be concurrently addressed.¹
- Substance use, mental health, medical care, and social supports services are critical for mitigating risks of SUDs and mental disorders and improving health outcomes.
- Programs using the "Housing First" model prioritize stable housing without requiring sobriety or participation in substance abuse treatment as a condition for housing. Once stabilized, motivational interviewing and harm-reduction strategies can encourage more people to pursue treatment.
- Many homeless individuals with substance use disorders also struggle with mental health conditions. Addressing these conditions alongside addiction increases the likelihood of seeking and remaining in treatment.

Residential and intensive outpatient treatment is vital for individuals who need intensive, round-the-clock care, particularly when addiction is severe or compounded by complex personal, social, or psychological challenges. It provides the stability and resources needed to build a strong foundation for lasting recovery.

Providing stable housing and basic necessities significantly increases the likelihood that individuals will consider and engage in substance abuse treatment. **Hawaii** needs to be prepared for large numbers of Kauhale residents asking for treatment just at the time when capacity is insufficient to meet this need.

That is why I am involved with **Kokua Kona**, a grassroots initiative dedicated to developing an **intentional living community** for individuals with disabilities in Kailua-Kona. I am writing on behalf of a planned Hawai'i Island housing community, Kokua Kona, which is highly aligned with Governor Green's Kauhale Initiative. We are very much in support of HB 431. We believe a village-like, integrated housing community like Kokua Kona would lead to a better sense of well-being for its' residents both in the present and in the years to come.

We are particularly aligned with the bill's intent to "build[ing] partnerships between government and community, providing affordable spaces for housing and healing, and fostering belonging and responsibility."

My son is profoundly autistic, non-speaking, and has seizure disorder. He has high support needs, and will likely require lifetime care. He also loves the water and is most at home in the pool or ocean. Because he is non-speaking, we very much want him to live in a safe community where his needs will be met, but he will not be in isolation. We intend Kokua Kona to be that place.

The overarching premise of our initiative is outlined below:

Housing that is Affordable:

There is an acute need for housing that is affordable across Hawai'i Island,

with an extra challenge for individuals and families with developmental

disabilities. Additionally, turnover in the caregiver community is high and

we hope to support stability in the availability of support/care services by

offering housing that is accessible and affordable.

Building Community:

The overall intention is to build community while also providing housing.

Nationwide, only 10% of adults with developmental disabilities have access to

support to live outside of their family home. About half of adults with

autism report feeling lonely and/or depressed.

Serving the Wider West Hawai'i Island Community:

The fully realized community will be an integrated community where individuals

with neurogenic differences, including those with intellectual / developmental

disabilities can live safely, but are not isolated. The intention is for the

community to be multi-generational. We believe the Kupuna can bring, but also

find, healing by being in a specialized, sensory friendly environment designed

to live peacefully with the keiki as one 'ohana. A portion of the community

will be adults or families without special needs, including care providers.

RE: HB 431 Relating to Housing

I'd first like to introduce my position - I've been a realtor for 8 years with Coldwell Banker Island Properties and have been raised in the family business of local real estate her in Kona for over 30 years. I am a 2005 graduate of Kamehameha Schools Kapālama and a Native Hawaiian woman. I am the mother of 3 children on the autism spectrum, one with a severe intellectual disability and the others with "level 1" autism and slight developmental delay. I am also the Founder of the Ava Sofia Foundation DBA Autism Moms of Kona, a 501(c)(3) nonprofit here in Kailua Kona.

I emphatically support the Kauhale initiative and the strategic coalescence of community partners with shared goals and needs for support, so that we can come together to incubate and nurture a collective healing and growth as a community.

Our nonprofit organization maintains a membership of 560 members, most of them representing an entire family unit. From this no cost membership, we have identified 150 keiki on the Kona side and 45 keiki on the Hilo side, and their families comprise our Qualified Members who have an official diagnosis of Autism or similar developmental delay or intellectual disability. The Kauhale initiative directly aligns with our our vision for housing that we call www.KokuaKona.org,, and we would love to participate in any way.

We have spent the past few years studying different housing models for those with intellectual disabilities across the nation, and we believe that there is an opportunity to provide housing solutions not only for those who are an adult with a disability, but also those families needing safe housing that are raising children with neurogenic conditions such as autism and other intellectual disabilities, as well as our kupuna who are suffering from neurological diseases such as dementia, alzheimers, parkinsons, etc. We believe that with the right collaboration, there may be more opportunity to extend housing to our service providers for adequate retention of professionals such as Speech and Language Pathologists, Occupational Therapists, Behavioral Therapists, Direct Support Workers through Waiver services, Pediatric Dentistry, Educators and Developmental Pediatricians – the list goes on. The communal space is an opportunity to build out the environment which these stakeholders heal together through cooperative play, art sessions, therapeutic horticulture, and so on, and there will be room to provide educational training to build independence and life skills.

The nuances of our business proposal might provide further solutions for the Kauhale movement in overcoming obstacles and barriers in realizing the first phases, because our business model is not so much Affordable Housing, yet housing that is affordable and which presents possibilities for subsidized housing, etc. It would provide economic reinforcement when it comes to working through the kinks with planning, permitting, water commitments, sustainable building, zoning, and a variety of other things that are unique to Hawai'i island. It would also delve into the implications of ensuring that communal housing is compliant with the Final Rule on Community Integration – the Home & Community Based Services (HCBS) Settings Rule

A little more about the Ava Sofia Foundation: We are a family-centered support network which is focused on supporting all members of a family that is raising a child on the Spectrum, so that they thrive in the home and integrate with their community. We individualize our relationship with families, identifying gaps in service provision and opportunities for care, and we work with them so that their family thrives in their home environment. We often assist with obtaining an official diagnosis, ensuring proper assessments are called for, advocating in the schools, and connecting with medical service providers such as ABA and Occupational therapists that can help. Our organizational culture is founded on Hawaiian cultural values - Kuleana, Hoʻokipa, and Aloha – and this has brought much healing and hope to many who would have otherwise struggled with this silent disability in shame and isolation (shared in the news).

We work with small businesses and other non-profit organizations to enable Private Therapeutic Alternatives - group activities focused on sensory & nervous system regulation that is curated to accommodate individuals with disabilities. We have sought Access and made experiences such as Paddleboarding Rock Climbing, Movie Going Experiences, Group Yoga, Horticulture Scavenger Hunts, Story Time, Sound Baths in the Cloud Forest, Seashell Art at the Peace Gardens, and Horse therapy among many other collaborations and have had much success in integrating our families into their community. In addition, our team advocates immensely to encourage access to community services and equal opportunity through family engagement and inclusion. Our network spans to include support for other educators, service providers, as well as families with similar developmental disabilities and needs for support.
