Bill No. and Title: House Bill No. 438, Relating to Due Process Protection

**Purpose:** Establishes the Due Process in Immigration Proceedings Program ("Immigration Program") within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court.

#### **Judiciary's Position:**

The Judiciary offers the following comments on House Bill No. 438:

We support the intent of this measure, which is to establish a program to provide legal representation to individuals in immigration-related proceedings in immigration court, but respectfully suggest the following amendments for clarification and to comport with how the Judiciary administers funds for other legal services.

The current language of the bill states, among other things, "*judiciary shall: (1) Provide legal representation to individuals in immigration-related proceedings in immigration court*..." The immigration court does not fall under the purview of the state courts, but rather the federal courts. As such, the Judiciary has no jurisdiction over immigration cases nor the immigration court, and the Judiciary, as an entity, and/or its staff are not qualified to provide legal representation in such matters.

In the alternative, should the legislature intend to appropriate funding for a non-profit organization or legal service provider to provide immigration services, the Judiciary, or other governmental department if deemed more appropriate, may serve as the administrator of the appropriated funds. This can be established similarly to the legislative funding for general civil legal services or mediation services under Act 202 (2024), which the Judiciary currently administers through a Request for Proposal process.

To this end, the Judiciary requests the following language in the bill to be modified, as follows:

#### "PART . DUE PROCESS IN IMMIGRATION PROCEEDINGS PROGRAM

**§601-** Due process in immigration proceedings program; establishment. (a) There is established the due process in immigration proceedings program within the judiciary. The program shall be administered by the judiciary. The judiciary shall administer funding for the program and contract with nonprofit organizations, legal service providers, and other entities to implement and operate the program and provide program services.

(b) The purpose of the due process in immigration proceedings program shall be to provide legal representation to individuals residing in the State who are facing immigration-related proceedings in immigration court, regardless of their ability to pay.

(c) The judiciary may shall issue requests for proposals to select and contract with nonprofit organizations, legal service providers, and other entities to implement and operate the due process in immigration proceedings program.

**§601- Powers and duties.** In the administration of the due process in immigration proceedings program, the judiciary shall <u>ensure that the entities contracted to implement and operate the program</u>:

(1) Provide legal representation to individuals in immigration-related proceedings in immigration court, including but not limited to deportation defense, asylum applications, and other immigration relief processes;

(2) Prioritize services for individuals who are detained, at risk of deportation, or otherwise vulnerable due to their immigration status;

(3) Partner with community-based organizations and legal service providers to ensure culturally and linguistically appropriate services;

(4) Conduct outreach and education to inform impacted communities about the availability of legal representation and related resources; and

(5) Collect and report data on the program's outcomes, including the number of individuals served, types of cases handled, length of time each

case has been pending, and success rates, while maintaining confidentiality and protecting sensitive information.

**§601- Annual report.** (a) <u>The entities contracted by The the</u> judiciary to implement and operate the program shall submit an annual report to the legislature no later than twenty days prior to the convening of each regular session.

(b) The annual report shall include:

(1) The number of individuals served by the due process in immigration proceedings program;

(2) The types of cases handled;

(3) The outcomes of the cases;

(4) The length of time each case has been pending; and

(5) Recommendations for improving access to legal representation for individuals in immigration-related proceedings in immigration court."

We respectfully request that any appropriation provided not supplant the Judiciary's existing funding or budget requests. Thank you for the opportunity to testify on this measure.

#### HB NO.438 RELATING TO DUE PROCESS PROTECTIONS

Chair Ilagan, Vice Chair Hussey, and Honorable Committee Members,

The Office of the Public Defender (OPD) SUPPORTS THIS BILL

We support the intent of the legislature to expand current legal representation of Hawaii residents, including for non-citizens in which rights enshrined in the state constitution and statute are implicated. We support the statutory expansion of due process rights in alignment with community expectations.

As noted in Section 1 of the bill, immigration proceedings are complex. These proceedings are ordinarily outside the purview of the OPD as they are civil and held in federal court. Public defenders in the federal system are similarly not utilized as these cases are not criminal in nature.

Costs for this immigration proceeding program can be minimized significantly utilizing existing legal service providers and the work of the OPD. The OPD will work with the Judiciary in its implementation and development of the program.

Aloha Chair Ilagan, Vice Chair Hussey, and members of the Committee,

I am writing in **support** of HB438. This bill establishes due process in the Immigration Proceedings Program within the judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court.

It is difficult to forget the stories from the first Trump Administration of <u>children in court on their own during</u> <u>immigration proceedings</u>, expected to mount a defense against their deportation without an adult by their side. Unfortunately, this happens all too often. Immigrants end up in immigration court alone, unable to understand the language, without any legal training, and facing an ICE prosecutor and judge. It is almost inconceivable that anyone would be successful in arguing their case in these circumstances.

Hawai'i continues to be a legal desert, with only a handful of pro bono immigration attorneys in the state, the majority of whom are on O'ahu. With additional funding more legal service organizations can staff additional attorneys and paralegals to ensure that more residents, many of whom have a viable pathway to lawful status, could fight their case in a fair and dignified way. Our overburdened courts and prosecuting attorney's office would greatly benefit from this additional support.

I urge you to support this bill. Families should not be ripped apart by our immigration court system simply because individuals do not have the thousands of dollars it would take to pay a private attorney to fight their case.

Having such protections builds trust in our judicial process and ensures that the outcomes, regardless of whether one is the plaintiff or defendant, are a result of a fair evaluation of facts and fair legal process.

#### Testimony in Support of HB22, HB73, HB438 and HB457 for hearings on January 29, 2025

Chair Ilagan, Vice Chair Hussey, and Members of the Committee,

UNITE HERE Local 5 represents 10,000 working people in the hotel, food service and health care industries across Hawaii.

The United States is founded on the ideas of freedom. Migration is freedom. The ability to move freely to pursue a better life is freedom. The ability to safely leave a place and safely arrive in a new place is freedom of movement. When that freedom is threatened, we must act on our values and protect those people from policies designed to restrict human freedoms.

Hawaii, as a melting pot of immigrants and their descendants, is a beneficiary of that freedom to migrate. Many of our union members are immigrants or children of immigrants, they are the working-class families, friends and neighbors that make up the fabric of our Hawaii communities.

**We support HB22** as it clarifies how Hawaii will treat non-judicial warrants. As noted in the preamble, there are legitimate concerns about the constitutionality of civil immigration detainers, as opposed to criminal warrants issued by a judge with probable cause. HB22 also provides reasonable and thoughtful exceptions in certain scenarios.

**We support HB73** as it protects our already limited state and county public lands from being developed into detention centers. We have far more pressing economic development needs in Hawaii, such as affordable housing.

**We support HB438** as it provides due process and legal representation for individuals facing proceedings in immigration court. Due process is a foundation of our court systems. If an individual has a viable claim for their immigration status, but is denied it for lack of representation, then that is a failure of our democratic system. HB438 provides eligibility requirements ensuring those with insufficient financial means are given fair trial at court.

**We support HB457** as it provides transparency, public access and public participation in immigration matters between federal agencies and Hawaii state law enforcement. HB457 also provides that people in custody of law enforcement are informed of their rights. Public access to information and informing people of their rights are basic democratic principles we support.

Dear Chair Ilagan, Vice-Chair Hussey, and Members of the House Committee on Economic Development & Technology:

On behalf of myself and my two immigration attorney colleagues at the William S. Richardson School of Law Refugee & Immigration Clinic ("RILC"), we submit testimony in our personal capacities in <u>support with a suggested amendment for HB 438</u>, which establishes the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in Immigration Court.

#### About RILC

**RILC** offers law students an opportunity to work on immigration law cases under the supervision of a licensed immigration attorney. Immigration law is a dynamic area of law that intersects with many issues in contemporary culture and politics. With a Director, two Law Fellows, and 6-10 law students each semester, we provide specialized and high-quality immigration legal services to income-eligible noncitizens in Hawai'i. We focus our efforts on income-eligible clients seeking asylum, removal defense, and other forms of humanitarian relief because these clients often have the most difficulty finding and paying for legal representation.

#### Our Position on HB 438

We support HB 438 because from our personal experience as immigration attorneys, we have observed a great need for public interest immigration attorneys to provide free or affordable, high-quality immigration legal services in immigration court. In Hawai'i, foreign-born residents comprise nearly a quarter of its population of 1.4 million and include an estimated 50,000 undocumented residents. Yet, only a dozen lawyers statewide provide free or low-cost immigration legal services to immigrant communities. With this new federal administration and their immigration priorities, we anticipate a dramatic increase in removal proceedings. To address this increase, we believe that this legislation will help build the capacity required to provide free or low-cost legal services to the immigration community in Hawai'i.

#### Suggested Amendment on HB 438

As the only immigration law clinic in the State of Hawai'i, we are in a unique position to train law students who are interested in practicing immigration law, especially in the areas of asylum and removal defense. HB 438 would build the current capacity for immigration removal defense in Hawai'i by allowing for the hiring of existing immigration lawyers as well as training law

Mahalo for the opportunity to submit testimony on behalf of the Hawai'i Coalition for Immigrant Rights (HCIR) in **strong support** of HB438, which establishes the Due Process in Immigration Proceedings Program within the Judiciary. This program is critical to ensuring fairness, protecting families, and fostering community stability by providing legal representation to income-qualified individuals facing immigration-related proceedings in immigration court.

As a coalition of over 30 immigrant-serving and immigrant-led organizations across Hawai'i, HCIR represents the voices of thousands of families who contribute to the fabric of our state. Hawai'i is the most diverse state in the nation, and immigrants make up 18% of our population. They are our neighbors, co-workers, and 'ohana, contributing significantly to Hawai'i's economy and vitality, especially in agriculture, tourism, and healthcare.

#### **Ensuring Due Process and Community Stability**

Immigration proceedings are complex and intimidating, and individuals—many of whom have limited English proficiency—are forced to navigate this system without legal representation unless they can afford costly private counsel. Without representation, the likelihood of achieving a fair and just outcome in immigration court is significantly diminished, leading to devastating consequences for individuals and their families.

HB438 addresses this inequity by ensuring that income-qualified individuals in Hawai'i are provided legal representation. This not only upholds the principle of due process but also promotes family unity and community stability. When families are torn apart by deportation, it destabilizes households, creates economic hardship, and sends ripple effects throughout our communities.

#### **Economic and Social Contributions of Immigrants**

Hawai'i's immigrants, both documented and undocumented, are vital contributors to our economy. In 2022, undocumented immigrants alone contributed \$157.2 million in state and local taxes. These contributions highlight the importance of policies that support immigrants, protect families, and ensure that individuals can continue to contribute to our collective prosperity.

By preventing unnecessary deportations and ensuring fair proceedings, HB438 helps preserve these contributions and strengthens the economic health of our state. Moreover, this bill aligns

The Legal Clinic (TLC) supports HB438, which establishes the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court and appropriates funds.

TLC is a Hawai'i nonprofit, nonpartisan organization. TLC is a direct legal services provider, representing those in Hawai'i who meet income eligibility guidelines without regard to immigration status, national origin, ethnic background, race, religion, ideology, gender identity, sexual orientation, age, or disability. TLC works alongside immigrants so they can attain authorization to work and live with dignity, reunite with their families after years of separation and escape horrific violence to find refuge in the United States. TLC recognizes that every person needs and deserves to feel a sense of trust, welcome, and belonging.

Immigrants (documented and undocumented alike) contribute to Hawaii's economic health and growth. Hawaii's "undocumented immigrants contributed \$157.2 million in state and local taxes in 2022. Their tax contributions could increase to as much as \$194.4 million if they were given official authorization to work. This is also true for the rest of the United States. If all undocumented immigrants in the U.S. had work permits, their tax contributions would rise by \$40.2 billion each year, reaching a total of \$136.9 billion." With the Trump Administration promising to deport immigrants at unprecedented levels, we are expecting a greater surge in Hawai'i immigration court cases. Hawaii's immigrant population is an integral part of Hawaii's community and are our neighbors, coworkers, and 'ohana. Targeting a significant portion of Hawaii's community in terms of both size and positive economic contributions for deportation or other immigration-related proceedings in immigration court severely destabilizes family units and economic security and results in community volatility and vulnerability.

Individuals in deportation proceedings face permanent separation from their families and their communities, and sometimes life-threatening risks in their countries of origin.

Individuals, some with language difficulty, appear before immigration court, including minors, and are not entitled to government-funded legal representation, leaving them to navigate complex legal systems alone, unless they are able to afford costly counsel or other assistance on their own. Those who are able to obtain costly counsel in immigration court are likely to achieve more favorable outcomes in immigration proceedings, such as relief from deportation or successful asylum applications.

Thus, HB438, establishing the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court and appropriating funding, is critical to assuring due process and promoting family unity, community stability, and economic security.

HB438 is about providing services to people in our communities because it will ensure that our communities are kept together and families are not separated, which will result in economic hardship. HB438 will provide legal representation to income qualified individuals residing in Hawai'i who are facing immigration-related proceedings in immigration court and is to be administered through the Judiciary.

HB438 is the fair, right, just thing to do to ensure that people are afforded the necessary protections under the law, families and communities are preserved, and our human rights and dignity are respected.



The US percentage of foreign born is 14%. According to U.S. Census figures for 2014-2018, over 18% of Hawai'i's population consists of first-generation immigrants or migrants (260,000 in total). That's one out of five residents in our state. Immigrants reside in all counties/islands: Oahu 75%, Maui 12%, Hawaii 7%, and Kauai 5%. Immigrants from the Philippines represent the largest country of origin group, making up nearly half—or 45.8 percent—of all immigrants in Hawai'i. However, more recent immigrant groups such as Mexicans, Vietnamese, and Micronesians also make up sizeable shares of the foreign-born population.

U.S. citizens are protected by many laws and practices . Without the rights and protections of full citizenship, non-citizens are vulnerable to potential abuse, discrimination, and uncertainty, particularly in the face of recent restrictions added to federal immigration policies and practices. Immigrants who seek legal status—to which they may be entitled—frequently lack the financial means or English language proficiency needed to secure legal status.

A majority (58%) of Hawai'i's foreign born residents are naturalized citizens. However, an estimated 54,000 are lawful permanent residents ("Green Card" holders) and eligible to apply for naturalized citizenship but may need assistance in doing so. Another estimated 45,000 or more are believed to be undocumented or under-documented. These include residents who are seeking asylum, individuals who have overstayed their visas, and those with so-called DACA (Deferred Action for Childhood Arrivals) status. Many of these individuals may be entitled to legal protections but are vulnerable and could be reluctant to seek help.

While a high majority of immigrants (77%) in Hawai'i report speaking English "well" or "very well," there remains a large number for whom English proficiency will present a potential obstacle. According to the Hawai'i Department of Business, Economic Development and Tourism (DBEDT), more than 130 different languages are spoken among Hawai'i's immigrants, and one in four residents of the State speak a language other than English at home. A 2016 Hawai'i State report found that speakers of a non-English language typically earn 10% to 34% less than English-only speakers for all proficiency levels (Hawai'i DBEDT, April 2016). Most commonly spoken statewide are Tagalog (>58,000), Japanese (>54,000), Ilocano (>45,000), Spanish (>25,000), and Hawai'i an (>18,000).

The new administrations Executive Orders and call for mass deportation of undocumented persons, terminating refugee and assylum application and other anti-immigrant policies makes legal representation needed more. There is an urgent need in Hawai'i for accessible and affordable legal counsel and related services for low-income immigrant residents seeking assistance on immigration matters. For those whose English proficiency is limited, lack of access to interpreters or translated documents can also be a barrier. Awareness of immigrant rights and protections is limited, and the need for public education is essential. [SEP] The process of applying for U.S. citizenship or for other changes to one's immigration status is extraordinarily complex, While some immigrants might require only brief service for routine matters, many have difficult, multi-layered cases that require extended advice and counsel. Immigrants need legal representation in deportation and asylum defense, sponsorship of family members to immigrate, naturalized citizenship or legal residency. Some have tried unsuccessfully in the past to secure their change in status but may have not been able to due to lack of expert legal advice and/or the complexity of their matters. <sup>[1]</sup><sub>SEP</sub>Complexities are staggering for those facing both criminal charges and immigration court issues, and some cases require lengthy and demanding involvement. Additionally, there is no presumptive right to defense counsel in immigration matters, meaning that individuals who cannot afford attorney fees may face detention, deportation, or denial of citizenship benefits without legal representation and assistance to tackle complex application procedures. Legal counsel is not only expensive, but also hard to come by, as there are few practicing immigration attorneys in Hawai'i.

Expert legal representation increases the chances of protecting immigrant rights and securing a positive outcome. Nationwide, according to the American Immigration Council, immigrants who are petitioning for U.S. legal status and who have an attorney are five times more likely to obtain relief from deportation than those without counsel. In 2016, 90% of those who were denied asylum had no legal representation, vs. 48% denied with legal counsel (Center for American Progress). In 2017, the Immigration Court in Honolulu completed 241 immigration cases with 83 resulting in removal or voluntary departure. Only 37% of all respondents had legal counsel. Other studies have shown that successful petitions for permanent residency or naturalization lead to immigrants being better able to secure good employment (including an increase in personal earnings of as much as 11%), and to become more civically engaged — significantly boosting economic and social opportunity for them and for our community as a whole.

HFCR stongly supports hb438 which establishes a due process Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration courts.

This is why we at Maui Roots Reborn strongly support HB 438. The looming threat of ICE agents arriving in Hawai'i to carry out arrests, detentions, and mass deportations is deeply alarming. Our immigrant families, already traumatized by the 2023 wildfires, now face the terrifying prospect of expedited removal without due process.

We have dedicated ourselves to earning the trust of our community and helping them rebuild their faith in institutions and organizations after the trauma of the wildfires. #### **Background**

It can happen here. And it did.

A detention camp. An Internment Camp. A concentration camp. Honouliuli Internment Camp, Sand Island Detention Camp, U.S. Immigration Station, Waiakea Prison Camp, Kilauea Military Camp, Maui County Jail, Haiku Military Camp, Lana'i City Jail, Kaunakakai County Jail, Kaunakakai County Courthouse, Wailua County Jail, Kalaheo Stockade, Waimea Jail, Lihue Plantation Gymnasium.

After the Empire of Japan attacked Pearl Harbor on December 7, 1941, FDR ordered the internment of the Japanese Americans, regardless of their citizenship two months later. Executive Order 9066. The War Relocation Authority (WRA) was established on March 18th to organize their removal. "These prisoners were never even charged with a crime, let alone convicted. Two-thirds of them were U.S. citizens, born in the U.S.—the remainder could not have become citizens because at that time people of Asian origin were prohibited from naturalization." *https://www.hawaiiinternment.org/untold-story/resources* [Emphasis added]. *See also* Michi Weglyn's landmark <u>Years of Infamy, The Untold Story of America's Concentration Camps</u>, and the NBC-produced documentary "Guilty by Reason of Race."

- Fueled by suspicions of disloyalty with military personnel and local authorities collaborating on arrests, the U.S. government interned 2,270 people of Japanese ancestry in Hawai'i. The "internees" were at first confined to the local internment camps, with most being sent to O'ahu's U.S. Immigration station before being transferred to internment camps on the mainland.
- Thus, more than 2,000 of the 120,000 or so Americans of Japanese ancestry who were interned during the war came from Hawai'i. "Surrounded by barbed wire and armed sentries, they were held for the duration of the war allegedly to prevent any attack on U.S. strategic installations, although not a single incident of a Japanese American attempting to aid the enemy was ever documented."

#### What was it like?

As the round-up proceeded, the [Dorothea Lange] photographs show people ripped from their lives on short notice, forced to sell property at great losses, to give up homes & furnishings, leave jobs and schools; lined up, registered, tagged like packages; waiting, waiting, often guarded by armed soldiers; allowed to bring only what they could carry.

- The greatest injury was often the humiliation. . . At the **Tanforan** assembly center in San Bruno, a former racetrack, the internees lived in horse stables. They are surrounded by prison regulations: no cameras, no books or magazines in Japanese, meals in large mess halls with food often ladled out from garbage cans, collective toilets, whole families sleeping in one "room" barely partitioned off from adjoining families, singles sleeping in huge wards with long rows of cots.
- The snow-covered Sierras looking down from the east did nothing to cool the 100-degree-plus heat, and there were neither trees nor hills to break the fierce winds, whether icy or hot. Lange was awed by the hostile environment: "meanest dust storms ... and not a blade of grass. And the springs are so cruel; when those people arrived there they couldn't keep the tarpaper on the shacks." . . .Unlike the other camps, Manzanar needed no high barbed fence or guards—as with Alcatraz, geography formed the prison walls.

Catholic Charities Hawai'i **Supports HB 438, Relating to Due Process Protections,** to establish the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court, with funding.

Catholic Charities Hawai`i (CCH) is a tax exempt, non-profit agency that has been providing social services in Hawai`i for over 75 years. CCH has programs serving elders, children, families, homeless and immigrants. Our mission is to provide services and advocacy to the most vulnerable of the people in Hawai`i. We service over 113,000 people each year throughout the state. We are a Department of Justice (DOJ) Recognized Organization and our General Immigration Service Program provides legal immigration services with staff who are accredited through the DOJ.<sup>i</sup> Our staff are *partially* accredited, allowing them to represent immigrant clients before the U.S. Citizenship and Immigration Services (USCIS) but does not allow them to represent immigrant clients in immigration court. There are situations where we must refer our low-income immigrant clients to attorneys who are able to represent them in immigration court and are concerned that the available pro bono resources are limited and are likely to be stretched due to anticipated increase in demand.

Immigrants can end up in immigration court alone, unable to understand the language, without any legal training, and facing an ICE prosecutor and judge, because they are not able to afford costly legal representation. Pro Bono immigration attorneys are limited in Hawai'i and the majority are on the island of Oahu. With this proposed funding, more legal immigration service organizations can staff additional attorneys and paralegals across the islands to ensure that more Hawaii residents, many of whom have a viable pathway to lawful status, can be represented in a fair and dignified way.

Catholic Charities Hawai`i urges your support for this bill. Please provide significant funding to support family unity and social justice.

# HB 438, RELATING TO RELATING TO DUE PROCESS PROTECTIONS

JANUARY 29, 2025 · ECD HEARING

POSITION: Support.

**RATIONALE:** Imua Alliance <u>supports</u> HB 438, relating to due process protections, which establishes the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court.

Imua Alliance is a victim service provider for survivors of sex trafficking, <u>including numerous</u> <u>migrant survivors</u>. Over the past 15 years, we have provided comprehensive direct intervention (victim rescue) services to over 200 victims, successfully emancipating them from slavery and assisting in their restoration, while providing a range of targeted services to over 1,000 victims and individuals at risk of sexual exploitation. During the pandemic, demand for services to our organization skyrocketed by 330 percent, driven in part by a fivefold increase in direct crisis calls.

Many of the victims we have assisted have suffered from complex and overlapping trauma, including post-traumatic stress disorder, depression and anxiety, dissociation, parasuicidal behavior, and substance abuse. Trafficking-related trauma and trauma-coerced attachment can even lead to a complete loss of identity and significant memory loss. Our survivor-clients require a tremendous amount of psychological, medical, and occupational support once outside of the commercial sex industry, as they painstakingly progress toward recovery.

<u>Countless human trafficking survivors are migrants.</u> Our state's migrant survivor population is difficult to estimate, but exceeds 500-1,000 people annually. These individuals are exploited in

local storefront brothels (such as fake massage parlors and relaxation therapy establishments), on local farms, and in our fishing industry, where they are forced to endure inhumane conditions and are stripped of any documentation and identification materials they may have.

We should provide assistance and a path to citizenship for immigrants, not punishment and fear. According to a report published by the American Immigration Council in 2020, Hawai'i is home to over 266,000 immigrants, including 45,000 thousand undocumented immigrants. As a society, we treasure our immigrant heritage, from which we have developed a legacy of multicultural cooperation and an abiding respect for the limitless value of diversity.

President Donald Trump has signaled his intent to implement a draconian, arbitrary, and cruel system of enforcement when it comes to immigration. Already, immigration raids have been initiated throughout the country, including in our island home. On January 27<sup>th</sup>, Hawai'i News Now reported that the local office of Homeland Security Investigations posted photos on social media of officers from U.S. Immigration and Customs Enforcement and Drug Enforcement Administration arresting immigrants on our shores. Trump officials have also begun issuing quotas to ICE officers to ramp up arrests, according to the Washington Post.

Advocates and, of course, immigrants themselves-both documented and undocumented-are justifiably concerned about these mass deportation actions. As the American Immigration Council stated in its "After Day One" factsheet: "The initial wave of executive actions scales up a "mass deportation" operation that everyone without legal status in the United States will be highly vulnerable to on the first day these practices go into effect. Indeed, by invoking the registration provision, the Trump administration is threatening to turn all immigrants into criminals by setting them up for the 'crime' of failing to register," which they have no way to do.

From a historical perspective, we are all immigrants. We urge your committee to act with haste to defend the many immigrants who make our communities proud and call the Aloha State home.

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 438, relating to due process protections, which establishes the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court.

Hawai'i understands the value of immigration and cultural diversity. Our island home-like the United States-is defined by immigration and a legacy of migrant labor that has bestowed upon us a rich social tapestry, multifaceted economy, and an everlasting respect for the principles of democracy and pluralism. As Barack Obama once said, "What makes someone American isn't just blood or birth, but allegiance to our founding principles and faith in the idea that anyone-from anywhere-can write the next chapter of our story."

Today, however, we are witnessing a cruel campaign of mass deportation being implemented throughout the country–including in our state–which is undermining the roots of communities in which migrants are celebrated members. Recently, the Trump administration has removed restrictions that prevented Immigration and Customs Enforcement from conducting raids at so-called sensitive locations, including schools (as well as houses of worship and hospitals).

We cannot sit idly by while Donald Trump enacts a campaign of fear against our immigrant neighbors. These actions will not prop up the American economy. On the contrary, immigrant labor is essential to the preservation of our society's financial well-being. Immigrants boost overall economic growth by expanding the labor force and increasing consumer spending. The foreign born also start new businesses at higher rates than U.S.-born individuals. Immigrants were involved in the development of 30 percent of patents in strategic industries in recent years and more than 40 percent of Fortune 500 companies were founded by immigrants.

Higher-than-expected immigration is driving job growth and productivity and *was* projected to continue doing so in the coming years: The Congressional Budget Office (CBO) estimates that a greater level of immigration expected between 2024 and 2034 *could have* boosted gross domestic product (GDP) by \$8.9 trillion. Yet, these gains will be jeopardized by the Trump Administration's inhumane mass deportation actions, which harken back to the race-based policies of the 19<sup>th</sup> and early 20<sup>th</sup> Centuries and draw frightening parallels to the policies put in place by violent authoritarian governments throughout history, including the Nazi regime.

Immigrants exist in our neighborhoods, our schools, our workplaces, and all other spaces in our state. They empower our society to thrive, despite the social and political violence with which they are forced to endure. As a state, we have a responsibility to protect their well-being. If we fail, history will remember our complicity in the annihilation of human rights and civil liberties, and our unwillingness to do what is right to preserve the most fundamental tenets of our democracy.

Dear Chair Ilagan, Vice Chair Hussey, and Committee Members: The ACLU of Hawai'i strongly supports H.B. 438 that establishes a program to provide access to legal representation for persons facing immigration court.

Due process of law and fair access to justice are essential to a healthy and functioning justice system, and to fostering public trust in legal outcomes. Given the importance of due process in our legal system, people who are facing the possibility of forced separation from their family, community, and homes should have basic resources to navigate the legal system and to ensure that their case is properly heard.

The ripple effects of deportation are often just as consequential for an individual's life as a criminal proceeding, if not more. Even though such safeguards exist for criminal cases, there is currently no guaranteed right to legal counsel in immigration hearings. The passage of H.B. 438 would remedy this and demonstrate Hawai'i's commitment to upholding justice and due process for all residents, especially our most vulnerable and threatened neighbors.

Providing counsel is also important to ensure that people are not wrongfully deported when they have a valid reason to be in the United States. A national study on immigration counsel found that immigrants who had legal representation were four times more likely to be released from detention when they had a custody hearing and were eleven times more likely to apply for relief from deportation (like asylum). Those that did seek immigration relief were also twice as likely to obtain it if they had legal representation.<sup>1</sup>

Without the provision of counsel, immigration hearings will become unjustly skewed against low-income people who may qualify for asylum but might have difficulty arguing this before a judge. Immigration law and individual cases are incredibly daunting to face alone, and an individual's success in the courts should not come down to whether or not they can afford a lawyer.
