**Re: H.B. 480 HD1 RELATING TO WORKERS' COMPENSATION**

**I. OVERVIEW OF PROPOSED LEGISLATION**

The **DLIR supports** this measure that adds a new section to Chapter 386, Hawaii Revised Statutes (HRS) that authorizes an attending physician to request or refer an employee to a functional capacity exam (FCE) when an injured employee has reached medical stabilization and is permanently unable to return to their usual and customary work without prior authorization. This measure also proposes to amend §386-27(a), HRS by allowing licensed occupational and physical therapists to be deemed qualified to perform functional capacity exams.

**II. CURRENT LAW**

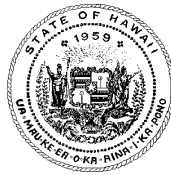
§386-21 (a), HRS, states that immediately after a work injury is sustained by an employee and for so long as reasonable needed, the employer shall furnish to the employee all medical care, services, and supplies as the nature of the injury requires.

**III. COMMENTS ON THE HOUSE BILL**

The DLIR supports this measure which encourages timely and accurate assessments of an injured worker's physical abilities. FCEs utilize a series of tests to assess an individual's level of ability to perform work-related tasks. The results can determine an employee's ability to return to work with or without accommodations and may also provide the employer with guidance on job duties to avoid while the employee recovers to full duty. These guidelines may prevent re-injury and ultimately accelerate the injured worker's return to full-duty work.

The bill proposes to:

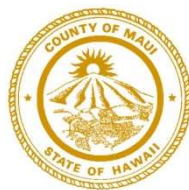
1. Authorize an attending physician to request a functional capacity exam and refer an injured employee for the exam without first obtaining permission from the employee's employer.
2. Allow licensed occupational and physical therapists to be deemed qualified to perform functional capacity exams.

Under Hawai'i Revised Statutes (HRS) §26-5, HRD administers the State's self-insured and centralized workers' compensation program and return to work program. The utilization of functional capacity exams is necessary in assessing an injured worker's ability to return to work, as they provide valuable medical information to objectively determine an employee's physical abilities. The proposed bill ensures exams will be conducted in a timely manner and at the appropriate stage in the workers' compensation process.

**RE HB 480 HD 1 RELATING TO WORKERS' COMPENSATION-** Workers' Compensation;  
Functional Capacity Exam; Occupational Therapy; Physical Therapy

### **Position: Support**

This measure would authorize an attending physician to request a functional capacity exam (FCE) and refer an injured employee for the exam without first obtaining permission from the employee's employer and allow licensed occupational and physical therapists to be deemed qualified to perform functional capacity exams.

The FCE is a set of tests that are used to identify the patient's physical skills, functional capabilities, activity endurance, and work tolerances, typically administered by a trained and licensed provider such as an occupational therapist or physical therapist. Employers understand well the importance of prompt evaluation as the FCE informs the clinical care team of possible diagnoses/ treatments and recovery. Additionally, the FCE will provide an objective assessment that assists with future job modifications and the safe gradual transition back to work, decreasing risks for reinjury or long-term disability.

Elimination of employer permission for FCE when requested by a physician is a reasonable step in decreasing unnecessary and harmful delays for patients and the future planning of their safe return to work. HMA supports this measure that will allow prompt and safe FCE evaluation of Hawaii patients by a trained and licensed provider with work related illness or injury.

Dear Chair San Buenaventura , Vice Chair Aquino and members of the committee

**I support SB 480.** The 340B Drug Discount Program was established in 1992 to help safety-net providers such as critical access hospitals and federally qualified health centers stretch their scarce resources to serve the most vulnerable populations. The savings realized by these covered entities through the 340B program are required, by statute, to be reinvested back into the communities they serve by expanding patient access to services that would normally be unfunded. These services include such things as adult dental care, enabling services, clinical pharmacy programs, and affordable medication programs. Contract pharmacies serve as extensions of the covered entities, increasing patient access by reducing geographic and financial access barriers. Four out of ten health centers rely solely on contract pharmacies and nine out of ten health centers use contract pharmacies to meet their community's medication access needs. Since 2020, drug manufacturers have begun restricting access to 340B priced medications at contract pharmacies such that 39 manufacturers now restrict shipments of their medications with limitations varying by covered entity type. This has resulted in dramatic decreases in the financial resources needed to support these otherwise unfunded patient access programs. Patient access to care and clinical outcomes suffer as a result.

As the medical director of Hawaii Health and Harm Reduction Center, we require 340B funds to help patients for example pay for/ obtain necessary labs and other necessary tests or medications that are crucial for patient care.
