RELATING TO RED HILL

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 505 adds a new chapter that: 1) establishes the Red Hill Water Alliance Initiative (WAI) Policy Coordinator within the Department of Land and Natural Resources to coordinate WAI initiatives; 2) creates the Red Hill Remediation Special Fund (RHRSF) that would generate revenues through legislative appropriations, gifts, donations, grants, and interest to address contamination resulting from the Red Hill Bulk Fuel Storage Facility; 3) requires State and county agencies to provide all information and data requested by the WAI Policy Coordinator within 30 calendar days; and 4) specifies annual reporting requirements.

As a matter of general policy, the department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges

made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 505, it is difficult to determine whether the proposed RHRSF would be self-sustaining as there does not appear to be any significant, recurring source of revenues to support the fund.

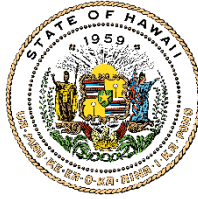

House Bill 505 proposes to establish a Water Alliance Initiative (WAI) policy coordinator and other positions within the Department of Land and Natural Resources (Department) to support the Red Hill WAI, and creates the Red Hill Remediation Special Fund. **The Department of Land and Natural Resources (Department) strongly supports this measure and provides comments.**

As stewards of Honolulu's sole source groundwater aquifer and Hawai'i's ecosystems, the Department recognizes the WAI's important role in ensuring that post-defueling remediation efforts restore the mauka to makai health of the aquifer. Our precious aquifer not only provides drinking water to hundreds of thousands of Honolulu residents but is also critical for the environment under the stewardship of the Department.

The Department supports the establishment and use of the Red Hill Special Remediation Fund for monitoring, applied research, public outreach and education, and evaluation.

The Department notes that following the 2024 Session, three full-time positions to support the WAI were funded within the Department's Office of the Chairperson:

- Policy Coordinator
- Outreach Coordinator
- Administrative Support Specialist

The Department completed its reorganization within the Office of the Chairperson and established the positions in late 2024. Currently, the Department is interviewing applicants for all three positions.

SUBJECT: House Bill 505: Relating to Red Hill

The Honolulu Board of Water Supply (BWS) is in strong support of House Bill (HB) 505. The purpose of the bill is to create a new chapter in Hawaii Revised Statutes (HRS) to establish within the Department of Land and Natural Resources (DLNR) to serve as the State's policy lead through the position of the Red Hill Water Alliance Initiative (WAI) policy coordinator and to place the coordinator in the office of the DLNR chairperson. The WAI coordinator shall facilitate implementation, monitoring and interface with federal entities on WAI initiatives outlined in the WAI's November 2023 report among other responsibilities.

It is important that we look at establishing government structures that can help to oversee remediation in the long term as this effort can extend well into the future. This bill also establishes a special fund to be administered by the WAI coordinator and be able to receive federal funds, appropriations by the Legislature, or gifts, donations, grants from public agencies, and private persons.

The WAI policy coordinator proposed in HB 505 is required to facilitate implementation and monitoring and interface with federal entities on WAI initiatives outlined in the WAI's November 2023 report, which includes remediation of the contamination resulting from the Red Hill Fuel Facility. Here the duties of the coordinator will serve to provide a framework that gives the officials from the State

and City and County of Honolulu a clear understanding of the WAI Initiatives, its mission, expectations, objectives, and reporting requirements.

Coalition Earth **supports** HB 505, which establishes a WAI Policy Coordinator for coordination of Red Hill WAI initiatives and creates the Red Hill Remediation Special Fund.

Ola i ka wai. Water is life.

The United States Navy's Red Hill Bulk Fuel Storage Facility consists of 20 steel-lined underground storage tanks that were built from 1940 to 1943, each of which can store 12.5 million gallons of fuel. In total, the Red Hill Bulk Fuel Storage Facility can store up to 250 million gallons of fuel. The tanks are located only about 100 feet above the United States Environmental Protection Agency's designated sole-source groundwater aquifer that provides drinking water to approximately 4,000 residents of the island of O'ahu.

Over the past eighty years, numerous spills have occurred at Red Hill. Most dramatically, on November 20, 2021, about 93,000 individuals served by the Navy's potable water system for Joint Base Pearl Harbor-Hickam were directly affected when the Navy's Red Hill shaft was contaminated by the release of up to 19,000 gallons of fuel, including JP-5 jet fuel, older fuels stored at the Red Hill Bulk Fuel Storage Facility, and any additives used. Over 6,000 individuals sought medical attention, and 1,000 were forced to leave their homes due to the contamination. Much of the fuel released from the Red Hill Bulk Fuel Storage Facility remains in the environment, trapped within the complex geological formations that surround the tanks. Notably, this leak also caused the restriction and diversion of Honolulu's water sources to cover losses from contaminated fuel, temporarily endangering the ability of the state and the county to perform vital public services, such as increasing the supply of affordable housing.

Subsequently, On May 9, 2023, officials from the state and City and County of Honolulu signed a unified statement on Red Hill, recognizing the stewardship responsibility to ensure that there is clean water on Oahu for future generations. The Red Hill Water Alliance Initiative (WAI), a working group, met regularly in 2023 after the signing of the unified statement, posing questions, conducting research, listening to subject-matter experts, and formulating policy recommendations to address the Red Hill contamination and prevent future leaks. The working group strived to preserve and protect public trust resources, including water resources that are essential for life to flourish in our island home.

Members of the Red Hill WAI working group focused on the remediation needs after the defueling of the tanks and removal of residual fuel and contaminants from the Red Hill Bulk Fuel Storage Facility. The working group expressed ongoing concerns about fuel contaminants already in the ground, as well as the residual supply of fuel plume in local aquifers because of the spill that occurred on November 20, 2021. The group found that there may be as many as 1,940,000 gallons of fuel constituents in the ground that have leaked over eight decades.

Accordingly, the group believes that remediation is necessary for the future well-being of the aquifer to contain the risk to current and future water sources, including the Halawa Shaft, Halawa wells, and Aiea wells; the water distribution system; and local ecosystems. For the sake of the public trust and future generations of Hawai'i's people, we must adopt the recommendations of the Red Hill WAI working group, coordinate an ongoing multiagency response to the crisis, and empower remediation efforts to proceed with haste.

In **SUPPORT WITH AMENDMENTS** of: **HB505: RELATING TO RED HILL**

Aloha Chair Hashem, Vice Chair Lamosao, and Members of the Water & Land Committee,

On behalf of our 20,000 members and supporters, the Sierra Club of Hawai'i **SUPPORTS WITH AMENDMENTS** HB505. The Sierra Club appreciates and supports the intent to institutionalize the Red Hill Water Alliance Initiative's (WAI's) commitment to fully remediate our 'āina and wai; however, **the lessons of the last decade demand much greater safeguards against political interference by the U.S. military and its benefactors that will otherwise frustrate this measure's goals.**

The Sierra Club commends the Red Hill WAI for its members' explicit commitment to ensuring the full remediation of our 'āina and wai from the release of up to 2 million gallons of fuel and other toxic substances from the Navy's Red Hill Bulk Fuel Underground Storage Facility. The Sierra Club also appreciates that the establishment of a governmental entity, as proposed by this measure, may be necessary to track and hold the Navy accountable for cleaning up its contamination of our island, particularly in light of the reality that it will take decades for full remediation to be achieved.

However, because of this lengthy remediation timeline – which will extend well beyond the tenure and even potential lifetimes of the Red Hill WAI's members – substantial amendments to this measure will be necessary to avoid the same political pitfalls that have led to the contamination of our aquifer and the poisoning of thousands of O'ahu residents. **The Sierra Club urges the members of the Committee to reflect upon the multiple missed opportunities that arose over the last ten years, that could have prevented our current water crisis – and to recognize that the U.S. military's political influence and willingness to deceive local and national elected officials as well as the general public contributed to our government's failure to protect our island and our people, until this crisis began.**¹ Unless precautions are taken to ensure

¹ For example, the responses of multiple administrations illustrate the unwillingness or inability of local political leaders to hold the Navy accountable, almost certainly due to the military's influence. After the reported release of 27,000 gallons of fuel from the Red Hill facility in 2014, Governor Abercrombie's administration negotiated a largely toothless "Administrative Order on Consent" (AOC) that surrendered ultimate decisionmaking authority over the Navy's response to the federal government in Washington D.C. Over the next six years, Governor Ige's administration did little to hold the Navy accountable to the AOC, which still remains largely

the political insulation of any government entity tasked with implementing the Red Hill WAI's goals over the ensuing decades, such an entity will be unable to achieve these objectives, and will fail to hold the U.S. Navy accountable to its responsibility to fully clean up its mess.

Accordingly, the Sierra Club of Hawai'i strongly urges the Committees to include the following amendments to this measure:

First, the WAI Policy Coordinator should be placed under a multi-member body, such as the Remediation Authority described in HB2691 from last session. Placing the WAI Policy Coordinator under the Chair of the Department of Land and Natural Resources, as proposed under this measure, will only subject them to the influence of the Office of the Governor, which the last decade has demonstrated is highly vulnerable to the U.S. military's political influence. **It is absolutely critical to have the WAI Policy Coordinator answer to a multi-member board, rather than a single political appointee of the Governor.**

Second, and for similar reasons, any such body overseeing the WAI Policy Coordinator should not be dominated by appointees of the Governor. **A majority of voting members overseeing the WAI Policy Coordinator should be selected by independent organizations that represent the Hawai'i community, which was and will continue to be a driving force for true accountability for our island, our people, and our future.** Such organizations could include: the Honolulu Board of Water Supply, the Office of Hawaiian Affairs, the Association of Hawaiian Civic Clubs, the University of Hawai'i Water Resources Research Center, and the Sierra Club of Hawai'i.

Third, the WAI Policy Coordinator should be supported by staff with skills and expertise relevant to achieving the Red Hill WAI's goals, to enable it to objectively analyze and respond to politically-driven and potentially biased actions and responses by the U.S. Navy. This could include experts in environmental remediation, public relations, federal funding pathways, and community organizing.

Finally, the Remediation Authority special fund should include provisions to support non-governmental education and organizing efforts as an essential ingredient in achieving true accountability.

unfulfilled – frustrating our current efforts to track and contain the contamination plume in our aquifer. Governor Ige's administration further failed to uphold state law and require the U.S. Navy to apply for an underground storage tank permit, until the Sierra Club of Hawai'i sued the Department of Health twice, in 2017 and 2019. Governor Ige also failed to call for the shutdown of the Red Hill Facility even after the catastrophic 2021 release, citing his belief that the military "is a vibrant part in our economy." Current Governor Green has also repeatedly made false claims regarding the status of the Facility's defueling, praising the efforts of the U.S. Navy even as O'ahu continues to struggle with the loss of our major drinking water shaft and while hundreds of individuals, including children, continue to report ongoing medical issues and financial instability.

Accordingly, the Sierra Club of Hawai'i respectfully but strongly urges the Committee to **PASS WITH AMENDMENTS** HB505. Mahalo nui for the opportunity to testify.

A BILL FOR AN ACT

RELATING TO RED HILL

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. The legislature finds that the United States Navy's Red Hill Bulk Fuel Storage Facility consists of twenty steel-lined underground storage tanks that were built from 1940 to 1943. Each tank can store 12.5 million gallons of fuel; in total, the Red Hill Bulk Fuel Storage Facility can store up to two hundred fifty million gallons. The tanks are located only about one hundred feet above the United States Environmental Protection Agency's designated sole-source groundwater aquifer that provides drinking water to approximately four hundred thousand residents of the island of Oahu. Over the past eighty years, numerous spills have occurred at Red Hill. Specifically, on November 20, 2021, about ninety-three thousand individuals served by the Navy's potable water system for Joint Base Pearl Harbor-Hickam were directly affected when the Navy's Red Hill shaft was contaminated by the release of up to nineteen thousand

1 gallons of fuel, including JP-5 jet fuel, older fuels stored at
2 the Red Hill Bulk Fuel Storage Facility, and any additives
3 used. Over six thousand individuals sought medical attention,
4 and one thousand were forced to leave their homes due to the
5 contamination. One year later, on November 29, 2022,
6 approximately 1,300 gallons of aqueous fire-fighting foam
7 concentrate containing per- and poly-fluoroalkyl substances, or
8 "forever chemicals," was unintentionally released from the
9 facility; little is known regarding the success of the Navy's
10 ad-hoc clean up efforts, although storm conditions suggest that
11 these "forever chemicals" may have spread across the landscape
12 and into the ground. Much of the fuel and other toxic chemicals
13 released from the Red Hill Bulk Fuel Storage Facility remains in
14 the environment, trapped within the complex geological
15 formations beneath and near the tanks.

16 The legislature further finds that on May 9, 2023, officials
17 from the State and city and county of Honolulu signed a unified
18 statement on Red Hill, recognizing the stewardship
19 responsibility to ensure that there is clean water on Oahu for
20 future generations. The Red Hill Water Alliance Initiative
21 (WAI), a working group, met regularly in 2023 since the signing
22 of the unified statement. The Red Hill WAI posed questions,
23 conducted research, listened to subject-matter experts, and
24 formulated recommended policies.

1 The legislature also finds that the Red Hill WAI's approach
2 of total stewardship responsibility required a stance of
3 extending beyond statutory roles, specific responsibilities,
4 tenure in those roles, and even personal lifetimes. Its inquiry
5 included the pursuit of critical questions for which there may
6 currently be no answers. Thus, the pursuit of those answers is
7 part of the ongoing work.

8 The legislature notes that besides its regulatory functions
9 under federal and state environmental laws, the State also has
10 unique public trust responsibilities set forth in the Hawaii
11 State Constitution, which establishes an affirmative duty of the
12 State to preserve and protect public trust resources, including
13 water resources.

14 The legislature additionally finds that the focus of the Red
15 Hill WAI's inquiry is the remediation needs after the defueling
16 of the tanks and removal of residual fuel and contaminants from
17 the Red Hill Bulk Fuel Storage Facility. In particular, the Red
18 Hill WAI is concerned with the unknowns posed by fuel and other
19 contaminants, including per- and poly-fluoroalkyl substances
20 already in the ground, as well as the residuals of the fuel
21 plume in the aquifer as a result of the spill that occurred on
22 November 20, 2021. In fact, there may be as many as 1,940,000
23 gallons of fuel constituents in the ground that have leaked or
24 spilled over eight decades. Pursuant to a proactive approach,

1 the Red Hill WAI seeks to describe the remediation it believes
2 necessary for the future well-being of the aquifer in which
3 there is a negligible risk to current and future water sources,
4 including the Halawa Shaft, Halawa wells, and Aiea wells; the
5 water distribution system; and the ecosystem, including springs,
6 streams, and nearshore waters.

7 After much diligent work, the Red Hill WAI issued a public
8 report in November 2023 that set forth its findings and
9 recommendations. Some of the recommendations can only be
10 addressed by the federal government, while other recommendations
11 can be undertaken by the State and city and county of
12 Honolulu. Moreover, the legislature finds that there must be no
13 delay in adopting the recommendations of the Red Hill WAI,
14 especially those that can be implemented at the state and county
15 levels.

16 The legislature recognizes that the latest 2021 release,
17 which has plunged O'ahu into a crisis that may take years to
18 recover from, is in many ways the result of the political
19 influence and active deception by the U.S. Navy and its
20 representatives over the past ten years, since the accidental
21 release of 27,000 gallons of fuel was reported in January 2014.
22 Despite the clear warning of this prior release, multiple
23 administrations, persuaded by the Navy's false assurances,
24 failed to take actions that may have avoided our current water

1 crisis. Remarkably, the Navy asserted on February 8, 2021 that
2 "the Red Hill Bulk Fuel Facility is not only well maintained and
3 carefully operated, but also uses the best available technology
4 to inspect and maintain the fuel tanks. These safety factors
5 meet and exceed industry and regulatory standards." As evidenced
6 by whistleblower accounts and a later engineering assessment,
7 this statement was patently false, as over 200 repairs were
8 revealed to be needed simply to safely defuel the Red Hill
9 facility. The legislature therefore acknowledges that strong
10 protective mechanisms are necessary to minimize the potential
11 for political influence and deception that could frustrate
12 efforts to hold the Navy and federal government accountable for
13 the full remediation of our aquifer and environment over the
14 ensuing decades.

15 Therefore, the purpose of this Act is to:

- 16 (1) Establish the Red Hill remediation authority, to
17 include representatives selected by independent
18 governmental and non-governmental entities;
19 (2) Provide the authority with staff with relevant skills
20 and expertise to pursue the full remediation of our
21 environment; and
22 (3) Create the Red Hill remediation special fund.

1 SECTION 2. The Hawaii Revised Statutes is amended by adding
2 a new chapter to be appropriately designated and to read as
3 follows:

4 **"CHAPTER**

5 **RED HILL WATER ALLIANCE INITIATIVE; REMEDIATION AUTHORITY**

6 **§ -1 Definitions.** As used in this chapter, unless a
7 different meaning is plainly required by the context:

8 "Authority" means the Red Hill remediation authority.

9 "Board of directors" means the board of directors of the Red
10 Hill remediation authority.

11 "Red Hill Water Alliance Initiative" means the group of
12 individuals composed of the governor, speaker of the house of
13 representatives, president of the senate, chairperson of the
14 board of land and natural resources and commission on water
15 resource management, president of the University of Hawaii,
16 mayor of the city and county of Honolulu, chairperson of the
17 Honolulu city council, and manager and chief engineer of the
18 Honolulu board of water supply that issued a public report in
19 November 2023 concerning the remediation of Red Hill following
20 the defueling of the Red Hill Bulk Fuel Storage Facility.

21 "Special fund" means the Red Hill remediation special fund.

22 **§ -2 Red Hill remediation authority.** (a) There is
23 established the Red Hill remediation authority, which shall be a
24 body corporate and public instrumentality of the State for the

1 purpose of implementing this chapter; provided that section 26-
2 35 shall not apply to the authority. The authority shall:

- 3 (1) Facilitate and oversee the remediation of
4 contamination resulting from the Red Hill Bulk Fuel
5 Storage Facility and on other WAI initiatives outlined
6 in the WAI's November 2023 report;
- 7 (2) Interface with federal entities;
- 8 (3) Periodically and regularly review:
 - 9 (A) The health status of the ecosystem; and
 - 10 (B) The state of science and opportunities for
11 remediation and rehabilitation;
- 12 (4) Develop and maintain a public-facing test results
13 dashboard describing the significance of results from
14 the State and city and county of Honolulu, as part of
15 a broader public education program; and
- 16 (5) Coordinate the implementation of a public information,
17 education, and engagement program to describe, inform,
18 and educate the general public and institutions on the
19 post-defueling remediation phases for Red Hill to
20 restore public trust, secure public support, foster
21 community-based advocacy around remediation efforts,
22 and address health and environmental concerns; and
- 23 (6) Engage in direct implementation, as appropriate.

1 (b) The authority shall be administratively attached to the
2 department of land and natural resources and governed by a board
3 of directors. All initial members of the authority who are to
4 be appointed shall be appointed no later than January 1, 2025.

5 (c) The board of directors shall consist of nine voting
6 members, who shall serve staggered four-year terms. The board of
7 directors shall select among its members a chairperson of the
8 board, to facilitate the convening of meetings and the
9 implementation of the board of director's responsibilities and
10 powers.

11 (d) Five voting members of the board of directors shall be
12 appointed by the following organizations:

- 13 (1) The Honolulu board of water supply;
- 14 (2) The Office of Hawaiian Affairs;
- 15 (3) The Association of Hawaiian Civic Clubs;
- 16 (4) The director of the Water Resources Research Center at
17 the University of Hawai'i; and
- 18 (5) The Sierra Club of Hawai'i.

19 (e) Four voting members of the board of directors shall
20 represent the following government entities:

- 21 (1) The chairperson of the board of land and natural
22 resources, or the chairperson's designee;
- 23 (2) The chairperson of the Honolulu city council, or the
24 chairperson's designee;

1 (3) The mayor of the city and county of Honolulu, or the
2 mayor's designee; and

3 (4) The manager and chief engineer of the Honolulu board
4 of water supply, or the manager and chief engineer's
5 designee.

6 (f) The members of the board of directors shall serve
7 without compensation but shall be reimbursed for expenses,
8 including travel expenses:

9 (1) For authority-related business, as approved by the
10 authority; and

11 (2) Necessary for the performance of their duties.

12 (g) The five community members identified in subsection (d)
13 and the four ex officio members identified in subsection (e)
14 shall appoint an executive director, who shall serve at the
15 pleasure of the board of directors.

16 The executive director shall:

17 (1) Administer and implement, under the direction of the
18 board of directors, all rules and directives adopted
19 by the authority;

20 (2) Hire staff or contract with professional service
21 providers with relevant skills and expertise; and

22 (3) Be exempt from chapter 76.

23 The salary of the executive director shall be subject to
24 section 26-53.

1 (h) The board of directors shall invite the following to
2 serve as ex officio, nonvoting members of the board of
3 directors:

4 (1) A representative of the United States Department of
5 Defense designated by the Department of Defense; and

6 (2) A representative of military families.

7 (i) In addition to the members listed in subsections (d),
8 (e), and (h), the board of directors may request the nonvoting
9 participation or input of members of the public; subject-matter
10 experts; county, state, or federal officials; and other
11 individuals, as necessary.

12 § -3 **Powers and duties.** Except as otherwise limited by
13 this chapter, the authority may:

14 (1) Make and execute contracts, leases, and all other
15 instruments necessary or convenient for the exercise
16 of its powers and functions under this chapter;

17 (2) Make and alter bylaws for its organization and internal
18 management;

19 (3) Adopt rules pursuant to chapter 91 for the purposes of
20 this chapter;

21 (4) Conduct meetings in accordance with chapter 92 for the
22 purposes of this chapter;

- 1 (5) Appoint officers, agents, and employees who may be
2 exempt from chapter 76, prescribe their duties and
3 qualifications, and fix their salaries;
- 4 (6) Engage the services of consultants on a contractual
5 basis for rendering professional and technical
6 assistance and advice;
- 7 (7) Procure insurance against any loss in connection with
8 its property and other assets and operations in
9 amounts and from insurers as it deems desirable;
- 10 (8) Contract for, accept, hold, or expend gifts or grants
11 in any form from any public agency or from any other
12 source;
- 13 (9) Adopt rules governing the procurement and purchase of
14 goods, services, and construction, not subject to the
15 requirements of chapter 103D;
- 16 (10) Enter into cooperative agreements, easements,
17 subleases, or other contracts, as necessary, with any
18 state agency, county agency, or private landowner;
- 19 (11) Contract for executive and administrative employee
20 services;
- 21 (12) Call upon the attorney general for legal services or
22 employ its own counsel in conformity with section 28-
23 8.3;

1 (13) Accept donations, grants, bequests, and devises of
2 money, property, services, or other things of value
3 that may be received from the United States or any
4 agency thereof, any governmental agency, or any public
5 or private institution, person, firm, or corporation,
6 to be held, used, or applied for any or all of the
7 purposes specified in this chapter;

8 (14) Establish and maintain a website that includes a
9 mission statement and access to related actions,
10 plans, reports, studies, policies, and results; and

11 (15) Do any and all things necessary to carry out its
12 purposes and exercise the powers granted in this
13 chapter.

14 **§ -4 Red Hill remediation special fund.** (a) There is
15 established in the state treasury the Red Hill remediation
16 special fund into which shall be deposited the following moneys:

17 (1) Appropriations by the legislature to the special fund;

18 (2) Gifts, donations, and grants from public agencies,
19 including the United States government, and private
20 persons; and

21 (3) All interest earned on or accrued to moneys deposited
22 in the special fund.

23 (b) The special fund shall be administered by the
24 authority.

1 (c) The moneys in the special fund shall be used solely for
2 the remediation of contamination resulting from the Red Hill
3 Bulk Fuel Storage Facility, including monitoring, applied
4 research, remediation, public outreach and education and
5 engagement, and evaluation.

6 § -5 **Cooperation by state and county agencies.** All state
7 and county agencies shall provide all information and data
8 requested by the authority within thirty calendar days; provided
9 that the authority may, in its discretion, set a longer
10 deadline.

11 § -6 **Report.** The authority shall submit a report of its
12 activities and expenditures to the legislature, governor, and
13 mayor and city council of the city and county of Honolulu no
14 later than December 1 of each year, beginning in 2026."

15 PART III

16 SECTION 3. The following positions, which shall be exempt
17 from chapter 76, Hawaii Revised Statutes, are established under
18 the authority for the purposes of Red Hill WAI policy
19 coordination and implementation:

20 (1) One full-time equivalent (1.0 FTE) executive director;

21 (2) One full-time equivalent (1.0 FTE) community and
22 government outreach coordinator;

23 (3) One full-time equivalent (1.0 FTE) administrative
24 assistant;

1 (4) One full-time equivalent (1.0 FTE) environmental
2 remediation specialist;

3 (5) One full-time equivalent (1.0 FTE) community
4 organizer; and

5 (6) One half-time equivalent (0.5 FTE) grantwriter.

6 SECTION 4. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$ or so
8 much thereof as may be necessary for fiscal year 2025-2026 and
9 the same sum or so much thereof as may be necessary for fiscal
10 year 2026-2027 for the positions identified in section 3 of this
11 Act.

12 The sum appropriated shall be expended by the authority for
13 the purposes of this Act.

14 SECTION 5. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$ or so
16 much thereof as may be necessary for fiscal year 2025-2026 and
17 the same sum or so much thereof as may be necessary for fiscal
18 year 2026-2027for ecosystem monitoring of the area surrounding
19 the Red Hill Bulk Fuel Storage Facility by the authority.

20 The sum appropriated shall be expended by the authority for
21 the purposes of this Act.

22 SECTION 7. This Act shall take effect upon its approval.

My name is Lily Okimura, resident of Honolulu, HI. I am writing in strong support of HB 505, which establishes a WAI Policy Coordinator for the coordination of Red Hill Water Alliance Initiative (WAI) activities and creates the Red Hill Remediation Special Fund.

The contamination of Oʻahu’s sole-source aquifer by the Red Hill Bulk Fuel Storage Facility has had catastrophic impacts on the health, safety, and well-being of our community. Specifically, I support the following aspects of the bill:

1. WAI Policy Coordinator Role:

- Coordinating efforts between state, county, and federal agencies is essential to the successful implementation of the recommendations made in the Red Hill WAI’s November 2023 report.
- Developing public-facing dashboards and educational initiatives will help rebuild public trust and ensure transparency.

2. Red Hill Remediation Special Fund:

3. Commitment to Future Generations:

- HB 505 aligns with the principles of mālama ‘āina (care for the land) and recognizes the long-term stewardship needed to restore and protect Oahu’s aquifer for future generations.

There is no room for delay in addressing the ongoing threats posed by the contamination at Red Hill. I am currently a senior from Hālau Kū Māna Public Charter School and I have written this testimony in full support of House Bill 505 in referral to the Red Hill fuel tanks. As a Native Hawaiian, myself and my 'ohana have been greatly affected by the leaking of the Red Hill fuel tanks into our aquifer. Because of this incident, we had to resort to filtering our water and storing bottled waters in fear of our tap water being contaminated by jet fuel. This same water, which we use to water our plants to feed our family, used in cooking, and given to pets and our younger siblings and nieces, has been ultimately contaminated. The leaking of the Red Hill fuel tanks is something that should have never happened at all, especially considering the impact it had on the community as a whole, regardless if you are Native Hawaiian, Caucasian, Filipino, or any other ethnicity that lives in Hawai'i. Due to the leaking, I believe that our faith and trust in the government and U.S. military has greatly faltered and lost after this incident. It is thought that the government and U.S.

military are designed and made to protect and defend its residents and territories from enemy advances, and to not have any failures that could potentially harm us. However, this has happened time and time again, now including Red Hill. As it was unfortunate that such tanks had to be designed above one of the many island aquifers due to World War II and the Attack of Pearl Harbor, the thought of possibly draining and maintaining the tanks up to code should have already been considered and done in the time of 84 years. It is obvious that the U.S. military is at fault for the leaking of the Red Hill fuel tanks, and it is best that a Wai Policy Coordinator be put into play for the betterment of the community of Hawai'i, especially for us Native Hawaiians. It is disgraceful for our lands to continuously be ruined by the U.S. military time and time again, and it is time for change and the turning of the system that is long overdue.

My kuleana is also to my ‘ohana to support and defend my husband in his pursuit of his love and service for his country. That is why this pain cuts so deep into my soul. When my husband took an oath to serve his country, what he also did was place us, his ‘ohana in the care and safety of the U.S. Military Armed Services. As a Hawaiian, I understood this reciprocity of kuleana. Now, this Hawaiian, military family is faced with betrayal at the hands of those who pledged to protect us from harm. On Sunday November 28, 2021, our family fell ill to fuel contaminated water by living on Navy run military housing. The lack of transparency, communication, and help for us and many other military families fell short and on deaf ears to those in military leadership. This, however, was not a new threat.

I am asking as a military spouse, as a Native Hawaiian whose very life essence is sourced through this land, and as a person who depends on fresh, clean water that the military comply with the orders set forth by the Governor of Hawaii. I am asking that the wrongs be made right, for what is pono and just. I echo Ernie Lau, chief engineer of the Board of Water Supply who stated the words printed on every Board of Water Supply truck: There is no substitute for pure water. We need to act now before it is too late and more families and communities are hurt. E ola i ka wai. Water is Life. E Ola!

Dear Chairperson, Vice Chairperson, and Members of the Committee,

Thank you for the opportunity to provide testimony on H.B. No. 505, which seeks to address the critical environmental and public health challenges posed by the contamination of the Red Hill Bulk Fuel Storage Facility. I/We strongly **support** the intent of this legislation to protect Oahu’s vital water resources and ensure the long-term health and safety of Hawaii’s residents.

While I/we firmly support H.B. No. 505, I/we respectfully offer the following **comments and recommendations** to strengthen the bill and ensure its success in achieving its objectives:

****1. Federal Accountability and Funding****

H.B. No. 505 rightly emphasizes the need for the federal government to bear the costs of aquifer remediation. However, I/we recommend including specific mechanisms in the bill to ensure federal accountability and timely funding. Without legally binding agreements or clear timelines for federal contributions, the State of Hawaii risks bearing undue financial burdens or experiencing delays in remediation efforts.

****2. Long-Term Monitoring and Funding****

The contamination of Oahu's groundwater and surrounding ecosystems is a long-term challenge that will require decades of monitoring and management. While the establishment of the Red Hill Remediation Special Fund is an important step, the bill does not sufficiently address how long-term efforts will be sustainably financed. I/we recommend including provisions to ensure that the fund has robust and secure funding mechanisms beyond the initial phases of remediation.

Additionally, the bill should outline how long-term monitoring of water quality and ecosystem health will be conducted and financed to ensure the continued safety of the aquifer and surrounding environments.

****3. Public Engagement and Transparency****

The inclusion of a public-facing dashboard and a 36-month public information and education program is commendable and necessary for rebuilding public trust. However, I/we recommend extending the duration of the public education program beyond 36 months, given the complexity and potential duration of remediation efforts.

Furthermore, the bill should include provisions to ensure that technical reports and test results are communicated to the public in a clear and accessible manner, with simplified summaries to ensure broad understanding.

****4. Clarity of Goals and Definitions****

H.B. No. 505 contains terms such as "negligible risk" to current and future water sources, which are not clearly defined. I/we recommend providing specific definitions and measurable targets for terms like "negligible risk" to ensure transparency and alignment of expectations among stakeholders.

Additionally, the bill should clarify whether the ultimate goal of remediation is to fully restore the aquifer to pre-contamination conditions or to achieve a lesser standard of safety.

****5. Interagency Coordination and Oversight****

The bill mandates cooperation from state and county agencies but does not specify enforcement mechanisms or consequences if agencies fail to meet the 30-day deadline for providing information. I/we recommend adding provisions to address potential delays or noncompliance to ensure efficient implementation.

Additionally, while the WAI Policy Coordinator is tasked with significant responsibilities, the bill does not include provisions for independent oversight. Establishing an independent oversight body or periodic external evaluations could enhance accountability and transparency in the implementation of WAI recommendations.

****6. Ecosystem-Wide Considerations****

While the focus of the bill is on the aquifer and wells, contamination from the Red Hill facility also poses risks to interconnected ecosystems, such as streams, nearshore waters, and marine environments. I/we recommend broadening the scope of the bill to include measures for monitoring and protecting these ecosystems, which are critical to Hawaii's environmental and economic health.

****7. Timeline for Implementation****

The effective date of July 1, 2025, may delay immediate action on critical remediation efforts. Given the urgency of the Red Hill contamination crisis, I/we urge the Legislature to consider accelerating the timeline for implementation to address these pressing issues without delay.

****Conclusion****

H.B. No. 505 is a critical step forward in addressing the environmental and public health challenges caused by the contamination at the Red Hill Bulk Fuel Storage Facility. I/we commend the Legislature for its commitment to protecting Oahu's water resources and ensuring a safe and sustainable future for Hawaii's residents.

By addressing the concerns and recommendations outlined above, the bill can be further strengthened to ensure its success in achieving its goals. Thank you for the opportunity to provide testimony on this important legislation, and I/we urge the Committee to pass H.B. No. 505 with the suggested amendments.
