Chair Tarnas, Vice Chair Poepoe, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports House Bill 508. Act 67, Session Laws of Hawai'i, 2023, established the Illegal Fireworks Task Force to plan, coordinate, and engage in law enforcement operations to interdict illegal fireworks; develop a comprehensive strategic plan to stop the importation of illegal fireworks and explosives into Hawaii; promote compliance with the state fireworks control laws; and ensure the safety and security of the airports, harbors, and other facilities and institutions in the State against the discharge of illegal fireworks and explosives.

Since its establishment, the Illegal Fireworks Task Force has demonstrated significant success in its operations. Through coordinated efforts with partner agencies, the Task Force has successfully removed over 200,000 pounds of illegal fireworks from Hawaii's streets, with operations and investigations continuing to yield positive results. The extension of the sunset date from June 30, 2025, to June 30, 2030, is crucial for maintaining this momentum and ensuring long-term effectiveness in combating illegal fireworks.

The appropriation of funds for fiscal years 2025-2026 and 2026-2027 is essential for the Task Force to continue its successful operations. These funds are necessary for maintaining administrative support staff, sustaining Task Force operations, and providing reimbursements to law enforcement agencies for Task Force-related activities, including personnel costs, overtime and other salary-related payments, fuel charges, equipment, and expenses related to the storage and disposal of confiscated fireworks.

On behalf of the Hawaiian Humane Society, thank you for considering our support for House Bill 508, which amends Act 67, SLH 2023, to appropriate funds for the illegal fireworks task force for FY 2025-2026 and FY 2026-2027 and to extend the sunset date of the Act from 6/30/2025 to 6/30/2030.

This measure supports the incredible work of the Illegal Fireworks Task Force, which has seized 187,000 pounds - or more than 93 tons - of illegal fireworks found in shipping containers since it was established. Add that to the ample evidence that tons of illegal fireworks are still making it onto the local black market and the magnitude of this insidious problem is staggering.

Hawaiian Humane supports any attempt to restrict fireworks from residential neighborhoods. After the tragic deaths and injuries on O'ahu this year, it should be clear to our community that lighting off explosives in our neighborhoods poses an unacceptable risk. Hawaiian Humane has long educated our community about keeping pets safe from the terror of fireworks around New Years and July 4, but these bombs increasingly go off for months at a time without warning. That makes it impossible for pet owners to prepare and creates sustained stress on people and animals, which can do lasting damage to their emotional, mental and physical health.

I STRONGLY SUPPORT HB508 that Amends Act 67, SLH 2023, to appropriate funds for the illegal fireworks task force for FY 2025-2026 and FY 2026-2027 and to extend the sunset date of the Act from 6/30/2025 to 6/30/2030.

Act 67 established the Illegal Fireworks Task Force (IFTF) under the Department of Law Enforcement (DLE) on June 7, 2023. The IFTF has made the most progress thus far, to interrupt the supply chain and distribution that led to some areas on Oahu noting a slight reduction of illegal fireworks in 2023. This effort has accomplished more than any other initiative to reduce illegal fireworks use, and has resulted in ongoing criminal investigations, two felony indictments, and covert operations that resulted in twenty criminal citations. There is a need to continue this effort to reduce illegal fireworks at the ports so it will make it much easier for police to enforce end-users.

In the year 2024 illegal fireworks made a comeback. This is due to the IFTF members being able to commit only part-time due to other primary duties. Much of the IFTF's daily work is done by state narcotics investigators because the technique to interdict illegal fireworks are the same used to interdict illegal drugs. To continue the excellent work that has been done so far, Jordan Lowe's 2025 Report to the Legislature on the IFTF recommended the "creation of a full-time fireworks control unit comprised of criminal investigators".

The Aliamanu tragedy was sad, and it is hopeful that the lives lost and those suffering from lifechanging critical injuries were not in vain but will provide the wake-up call to take the use of illegal fireworks seriously. This all starts with legislators creating laws to invoke stiffer penalties and higher fines, and allows enforcement to the fullest extent of the law to instill a fear of getting caught and induce deterrence. This may require more appropriations committed this year to be effective, but how do you put a price on lives lost, life-changing deformities, and psychological issues that may require medical attention for the rest of one's life? Yes, enough is enough.

Honorable Chair, Vice Chair, and Members of the Committee,

I write in strong OPPOSITION to this bill, which seeks to extend and fund government enforcement measures against fireworks use in Hawai'i. While public safety concerns are valid, this bill represents government overreach, inefficient use of taxpayer dollars, and unnecessary interference with cultural traditions.

Fireworks are a longstanding cultural tradition in Hawai'i. Penalizing individuals for using fireworks responsibly infringes on personal freedoms without effectively addressing safety concerns. Instead of blanket bans, we should consider controlled solutions, such as designated community fireworks zones, that allow safe use while preserving traditions.

At a time when Hawai'i faces critical challenges—housing, rising costs, and infrastructure spending on fireworks enforcement is wasteful. Studies show that increased enforcement has little impact on reducing illegal fireworks use or injuries. Resources should be focused on more pressing public safety issues.

Extending this law risks increasing selective enforcement and unnecessary confrontations between law enforcement and citizens. Hawai'i already has strict fireworks laws, and further crackdowns are unlikely to eliminate the underground market for fireworks.

Instead of expanding enforcement, I recommend:

- Designated Fireworks Zones for safe, controlled celebrations.
- Public Education on fire safety and responsible use.
- **Decriminalization** of consumer fireworks with safety regulations to ensure safe access.

These solutions would balance safety with individual freedoms, reduce harm, and avoid further government overreach.

This bill is an unnecessary expansion of state power that wastes taxpayer dollars and infringes on personal freedoms. I urge the committee to reject it and explore community-based alternatives that prioritize public safety and respect cultural traditions.
