In consideration of HOUSE BILL 534, HOUSE DRAFT 2 RELATING TO LABELING REQUIREMENTS

House Bill 534, House Draft 2, proposes to prohibit the sale of any processed food item with raw ahi product as an ingredient in retail establishments without a label that states the country where the ahi was landed. **The Department of Land and Natural Resources (Department) supports this bill.**

Today's consumers are increasingly aware of the sourcing of their seafood, with many looking for insight into the quality, safety, and sustainability of products they purchase and consume. The United States Department of Agriculture (USDA) Country of Origin Labeling (COOL) law (7 CFR Part 60) requires that seafood products be labeled with the country of origin. The COOL requirement does not apply to prepared foods offered for retail sale at food service establishments. This means that prepared products such as poke currently have no labeling requirement. This bill would extend country of origin labeling requirements for certain ahi tuna products at Hawai'i retail establishments, enabling consumers to make informed choices when purchasing seafood.

Yellowfin and bigeye tuna are highly migratory species that are managed at the international, national, and state levels. Internationally, fisheries targeting these species are managed by regional fishery management organizations (RFMOs), which set annual catch quotas for participating countries. Domestically, commercial landings of these species are closely monitored to ensure compliance with quotas established by RFMOs. The largest domestic fishery for ahi in the State, the Hawai'i longline fishery, is closely managed by the National Marine Fisheries Service (NMFS) through a limited entry permit system and strict regulations

which include mandatory reporting, observer coverage, crew training, gear identification requirements, special area closures, and other measures to minimize impacts on bycatch and protected species. Fisheries that land tuna in other countries often lack this high level of management oversight.

Aloha Chair DeCoite, Vice-Chair Wakai, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai i Farm Bureau supports HB 534, HD2, which prohibits the sale of processed food item with raw ahi in retail establishments without a label that states the country where the ahi was landed.

Hawai'i is known for its high-quality ahi, which are caught under strict fishery management standards. Imported ahi, often caught under less stringent regulations, is sometimes misleadingly marketed as "Hawaiian" or "local." This measure ensures that consumers can distinguish between authentic Hawai'i-landed ahi and imported products

Many consumers prefer to buy locally sourced food to support the local economy. Labeling processed ahi by country of origin gives them the necessary information to make informed choices.

We should protect Hawai'i's fishing industry, support local fishermen, and ensure consumer transparency by requiring country-of-origin labeling for processed ahi products.

Aloha Chair Decoite, Vice Chair Wakai, and Members of the Senate Economic Development and Tourism Committee,

The Hawai'i Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFU supports HB534.**

HB534 HD2 aims to enhance consumer transparency by requiring country-of-landing labeling for raw ahi products sold in retail establishments. This bill aligns with consumer right-to-know principles by ensuring buyers can easily distinguish between locally caught and imported ahi, addressing misleading marketing terms such as "fresh" or "locally made" when the product is actually previously frozen and imported. By mandating clear labeling, HB534 HD2 supports Hawaii's fishing industry by giving local fishers a competitive edge, increasing demand for sustainably caught ahi, and strengthening the state's seafood economy.

The National Farmers Union has been a leading advocate for mandatory country-of-origin labeling for decades, championing transparency for consumers and fairness for American farmers and ranchers. HB534 HD2 aligns with HFUU's commitment to strengthening local food economies and ensuring clear, accurate labeling for food products. By promoting fair market representation and consumer awareness, the bill benefits Hawaii's farmers, fishers, and businesses.

To enhance its effectiveness, HB534 HD2 should **clarify labeling requirements** by ensuring labels are conspicuous, standardized, and easy to read. A **phased implementation timeline** with Department of Agriculture guidelines and support for retail establishments will facilitate compliance, while a **consumer awareness campaign** should be included to educate the public on country-of-origin labeling and the benefits of purchasing local seafood.

Specific language is provided on the following page.

HB534 HD2 is a strong step toward improving consumer transparency and supporting Hawaii's local fishing industry. However, clarifications on labeling requirements, implementation guidelines, and consumer education will enhance its effectiveness. These amendments will ensure that the bill achieves its intended goals while providing practical pathways for compliance.

Recommendations and Proposed Amendments

Clarity on Labeling Requirements

The current bill states that ahi products in processed food items must include the country of landing, but it should also specify how the label should appear to ensure consistency and visibility.

Section 2 - Amended Subsection HRS §481B- (a):

(a) No retail establishment shall keep, offer, display, expose for sale, or solicit for sale any raw ahi product that is an ingredient in a processed food item without a label placed in a conspicuous location that clearly states "Country of Landing: [Country]" in a font size no smaller than 12-point type, positioned near the price display or on the product packaging.

Implementation Guidelines

The bill currently does not specify a timeline for implementation or offer guidance for businesses to comply. A phased approach could help ensure a smooth transition for retailers.

Section 2- New subsection HRS §481B- (c):

(c) The Department of Agriculture shall establish compliance guidelines, including a phased implementation period of up to twelve (12) months, and shall provide outreach and support to retail establishments to ensure effective and timely adherence to this section.

Consumer Awareness Campaign

Education efforts should be included to ensure consumers understand the importance of country-of-landing labeling.

Section 2- New subsection HRS §481B- (d):

(d) The Department of Agriculture shall develop a consumer awareness campaign to educate the public on country-of-origin labeling, the benefits of purchasing locally sourced seafood, and the distinctions between fresh and previously frozen imported ahi.

My name is Andrew Evans, I'm born and raised on the Windward side of Oahu, and as a environmental conservation worker, I am particularly interested in the sustainability of our natural recourse and its ability to support our local economy. I am writing to encourage your committee to pass's HB534 and continue to support those measures that further refine the promotion of our local businesses and fishermen.

While there is great value in the established practices of labeling whole or raw seafood at grocery outlets, the benefit of labeling has been absolved when it comes to a great majority of our fish consumption—poke. This bill will play a pivotal role in promoting local fishing by requiring sufficient and transparent labeling in local prepared seafoods on our islands.

Although we will need further work and further regulation to better refine which fish we promote as "local" (i.e. fish that is actually caught in Hawaiian waters rather than just fish that is landed in Hawaii), and expand what businesses this labeling legislation applies to (expand to poke restaurants that purchase less fish than the \$230,000 minimum) and to apply to restaurants and preparations beyond poke, HB534 is an important step better direct our economy toward our local products.

Please continue to support our local businesses and our local island-caught fishermen.
