HB 548 – RELATING TO THE ACQUISITION OF THE SAINT FRANCIS SCHOOL CAMPUS FOR THE UNIVERSITY OF HAWAII AT MANOA

Chair Garrett, Vice Chair Amato, and Members of the Committee:

Thank you for the opportunity to present testimony today. The University of Hawai'i (UH) supports House Bill (HB) No. 548, Relating to the Acquisition of the St. Francis School Campus for the UH Mānoa. The St. Francis School campus is located at 2707 Pamoa Road and identified as Tax Map Key No.: (1) 2-9-004: 001 ("Property"). The Property is approximately 11.120 acres in size and is owned by the Avalon Group, a local real estate development company. The Property is adjacent to the UH Mānoa campus, and the St. Francis School used the Property until it ceased school operations in May 2019.

The Property was sold to the Avalon Group in 2024. In 2020, UH submitted an offer to acquire the Property – and, was even provided with a Legislative authorization/ appropriation in the FY2020 and FY2021 biennium budget to acquire the property. This bill does not grant any special powers or authorities to the UH to acquire the property, other than to provide an appropriation to which the UH could pursue negotiations with the landowner.

The UH is interested in this Property because of its close proximity to the UH Mānoa campus and the potential integration into its long-range development plan.

Aloha Chair Garrett, Vice Chair Amato, and members of the committee,

Mahalo for the opportunity to submit testimony on behalf of Avalon Group in OPPOSITION to **HB 548 – Relating to the Acquisition of the Saint Francis School Campus for the University of Hawaii at Manoa**. Avalon plans to create housing options for local residents at the Aria Lane project at the former Saint Francis School Campus in Mānoa.

This project is consistent with the objectives of the O'ahu General Plan, in that it creates housing in the Primary Urban Center in harmony with the surrounding neighborhood, convenient to shopping centers, schools and bus lines. We have worked with archeological and cultural consultants to identify historically important features on the property. Avalon has retained architectural consultant Mason Architects Inc, archaeological consultants, Hōnua Consulting and Cultural Surveys Hawai'i, and Native Hawaiian cultural consultants for guidance throughout this project.

The property sale to Avalon included a 2020 archaeological literature review and field inspection (LRFI), prepared by Honua Consulting at the request of the Sisters of St. Francis (Thurman et al. 2020). The LRFI found no evidence of heiau or burials and reported that development and grading activities within the main grounds of the school likely destroyed or displaced any potential pre-contact and/or early-historic deposits that may have been present. The LRFI identified significant surface architecture still present on the perimeters of the property (historic boundary walls and features along the slope to the stream), and Avalon has taken steps to protect the existing boundary walls and preserve the property bordering Mānoa Stream.

The 1910 Army map that includes labels for "heiau" and "temple" was previously unknown to the project (not included in the 2020 LRFI) and found during CSH's background research for the Aria Lane Archaeological Inventory Survey (AIS). Although a 1910 map of Mānoa includes a label reading 'Heiau' 'Temple', no other historic maps, either prior to or after the 1910 map, depict a heiau or remnants of heiau in the project area. However, based on community concerns and out of an abundance of caution, we are planning to conduct a full AIS to conduct surface and subsurface testing for remnants of heiau or other land use activities.

We will be submitting an AIS Plan showing all the proposed locations of subsurface testing to SHPD for approval. Test excavations will be placed to target the area labeled "heiau"" temple" on the 1910 Army. We will await SHPD's review and approval of the coming AIS to bring clarity as to what may or may not exist on the property and will be very transparent with the cultural descendants, stakeholders, and potential buyers about our findings.

We have also commissioned a Reconnaissance Level Survey (RLS) report from Mason Architects Inc, who is well-known for their fine work on many historic sites in Hawai'i. Mason's RLS states that none of the original 1930s structures built by the Sisters of Saint Francis remain on the property. Of the 18 buildings currently on site, 11 are more than 50 years old. Mason has found that one of those buildings meets Hawai'i Administrative Rules Criterion "c" "as a representative example of a postwar institutional building with Streamline Moderne Style with regional Hawaiian elements designed by prominent Hawai'i architect Guy Rothwell." Mason has proposed mitigation commitments to include an outward-facing Wall of History that honors Rothwell's work and commemorates the history of the site and of Mānoa Valley. Mason requested concurrence from SHPD for this plan in a letter submitted on July 18, 2024.

Avalon is committed to creating homes for Hawai'i's families that reflect the character and charm of the Mānoa Community and honors the history of the site. There is a shortage of housing in Hawai'i. To fill the gap, it is imperative to provide housing in established neighborhoods like Mānoa. Aria Lane allows families to take care of their elderly right in their homes, allowing aging parents to have a semblance of independence such as the ability to legally cook in their own studio. Each single-family home will have the option to convert an existing ground floor bedroom and bathroom into a studio suite with a legal kitchen, roll-in shower with grab bars, and a separate entrance. These homes are ideal for families gathering joint resources to buy their homes together with two or more generations under one roof.

Avalon will continue to work closely with the State Historic Preservation Division to follow any recommendations from SHPD and will comply with all laws and regulations if iwi kupuna or any heiau are discovered.

I support this bill for the following reasons:

The location is ideal for UH.. This ultimately benefits students and faculty. UH acquisition of the property would facilitate direct access from Maile Way, reducing traffic and safety risks associated with Pamoa Road: this is a much more viable use of the property than the proposed Avalon development of Aria Lane.

The current St. Francis campus contains archeological sites that should be preserved, not taken away or plowed over by a housing development. I believe Dr. Ellen Sofio has presented crucial data/evidence of the Heiau on this.

If not acquired, the developer's request for emergency access through the UH campus poses significant safety and liability risks for students. Emergency access through UH has the potential for injuries and impacts on the university community.

Hawaii is unlikely to ever have another opportunity to expand its flagship ' university campus onto contiguous property.

Finally, I really don't believe the Avalon's proposed development of the St. Francis property into private homes will have little or no impact on traffic on Pamoa Road. There's already too much traffic on Ala Ula as well as Pamoa Road. Adding more homes on the current St. Francis campus (with only one way in and out) jeopardizes emergency access to the inhabitants along Pamoa Road. Recall the issues with the recent fireworks catastrophe in Aliamanu area where several people died. That road was also very narrow, limiting the emergency vehicles response and access time.

I strongly oppose the proposed demolition of Kauala'a Heiau. This site is an irreplaceable part of our history, culture, and identity, and its loss would be devastating to both our lāhui and our future nā keiki o ka 'āina.

Testimony in conditional support of HB548 suggesting amendments to acknowledge that the property is a historic heiau with multiple historic buildings on site

Dear Representative Garrett and members of the House Higher Education Committee,

I have spent considerable time over the past 9 months researching the cultural history of the Saint Francis Mānoa Property, I strongly support HB 548 to appropriate funds to transfer the property to the University of Hawai'i but with conditions.

Old maps, historic literature and legends, previous archeological surveys and other documents which have surfaced from my own research as well as the extensive photographs I took early last year and incorporated into a power point presented to the city's O'ahu Historic Preservation Commission in September, 2024, as well as research done by Avalon's contract archeologist, suggest strongly the entire 11.2 acre Saint Francis Mānoa property is a heiau in its entirety.

The heiau was originally recorded by SHPD archeologist Carol Kawachi in her 1988 field study as an agricultural heiau (The Kūkao'o Heiau chapter 8, Archeology of Mānoa Valley).

A 1910 Army Map which surfaced early in Avalon's archeological inventory study labels the entire property as a heiau. An1847 Metcalf map has the name of high chief Abner Paki. He was the father of Bernice Pauahi Bishop, who's legacy founded Kamehameha Schools Bishop Estate, and was the grandson of the 18th century King of Maui. In 1847 King Kamehameha III, Kauikeaouli, had initiated the Mahele in hopes of keeping Hawaiian lands in Hawaiian hands. He was a close friend of Abner Paki. Emma Ka'ilikapuolono Metcalf Beckley Nakuina, daughter of high chiefess Ka'likapuolono and Massachusetts surveyor Theophilus Metcalf, was born in 1846 on land adjacent to the heiau and raised there. She later was appointed to become the first Hawaiian woman judge and water commissioner and was also made curator of the National Museum of the Hawaiian Kingdom by King Kamehameha IV. Emma was considered an authority on Hawaiian language and legends. In her book of legends published in 1904, "Hawai'i its People their Legends", Emma referred to the high priest of the heiau at what is now Saint Francis Mānoa in the Legend of Kahalaopuna, as the Kauala'a Heiau. Kauala'a can be translated to mean "the sacred rain" Lono is the Hawaiian god of rain, agriculture, fertility, music and peace.

I am happy to share my power point and these documents and others with any interested legislators.

The University of Hawai'i has a declared mission to be a place of Native Hawaiian Learning. This iconic, beautiful and sacred property which is literally right at the back door of the University contiguous with its mauka boundary, has the potential to add immensely to fulfilling that mission. The historic convent could be repurposed to provide housing for Lahaina fire survivors and other Hawaiians who desperately need shelter, giving them the opportunity to seek a higher education here instead of becoming homeless or having to leave for the mainland and empowering them to use their education as a means of helping rebuild their community on Maui. The original historic school building could be restored to be used as a school again, to teach Hawaiian language, history and culture to the children of local residents and community including University of Hawaii faculty. It could also act to supplement the education of public school children at Noelani and Mānoa Elementary and other schools who could be bussed in for classes and events. Office space, conference space.... I'm sure faculty and administration at UH could add to this list of possibilities.

The goals of protecting both the neighborhood and the Mānoa community from the dangers inherent in inappropriately sited high density development and the goal of historic preservation are compatible.

The price of the property for acquisition by the University will be more reasonable if the critical need for historic and cultural preservation and the goal of making Saint Francis Mānoa and the Kauala'a Heiau a Hawaiian cultural and educational sanctuary in perpetuity is taken into consideration in the appraisal. Mahalo nui for your kind consideration and your efforts to preserve and protect this irreplaceable and priceless cultural historic property in perpetuity for Hawaiians, for the University and for the immense benefit of the community at large.
