The Executive Office on Early Learning (EOEL) offers the following comments in support of H.B. No. 549, S.D. 1, and defers to the University of Hawai'i regarding implementation and funding.

Early Learning Registered Apprenticeship Programs (ELRAPs) create structured pathways for aspiring early childhood professionals to gain hands-on experience, earn credentials, and achieve career advancement through apprenticeships that integrate employer-paid classroom learning with on-the-job training and comprehensive wraparound support.

This bill creates a grant program to mitigate financial barriers to participation in state-approved or federally approved ELRAPs for licensed or registered early learning program service providers, with priority given to infant and toddler programs.

EOEL is committed to improving the recruitment, retention, and career pathways for our early learning workforce, and recognizes that our capacity to expand access to early learning opportunities for Hawai'i's keiki is dependent on our ability to grow and support our workforce. ELRAPs can enhance the sustainability and capacity of the workforce by:

- Addressing workforce shortages in the early childhood field by supporting recruitment and retention;
- Providing competitive compensation and benefits to ensure employees are valued; and

• Improving opportunities for professional advancement.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports this measure and defers to the University of Hawaii. DHS supports the apprenticeship program, which aims to increase the number of qualified early learning professionals and add to the existing child care capacity. An apprenticeship program provides opportunities to support the recruitment, retention, and professional development of early learning professionals in a career field that has been experiencing a continuous shortage of qualified caregivers and staff for early learning programs.

The Office of Hawaiian Affairs (OHA) submits this testimony in **SUPPORT of HB 549 HD3 SD1**, which proposes establishing an early learning apprenticeship grant program. This bill is a critical and timely initiative that addresses the shortage of qualified early learning professionals in Hawai'i, and its benefits will be especially impactful for Native Hawaiian children and families.

We acknowledge the recent amendments made in HB 549 HD3 SD1, particularly the declaration of the program as a matter of statewide concern. The proposed apprenticeship model is a proven pathway to equip educators with both practical experience and academic knowledge, ensuring they are well-prepared to meet the diverse needs of our keiki. **Furthermore, HB 549 HD3 SD1 recognizes the importance of providing fair and competitive wages for early learning professionals.** In Native Hawaiian communities, where economic disparities have historically created barriers to success, offering fair compensation is essential to attracting and retaining high-quality educators. By aligning salaries with industry standards, this bill ensures that early learning professionals are not only well-prepared but also fairly compensated for their important work.

This bill directly aligns with OHA's Mana i Mauli Ola Strategic Educational Pathways, which focuses on culturally grounded and equitable learning opportunities for Native Hawaiian children. By supporting the training, recruitment, and retention of skilled early learning professionals, we contribute to the success of Native Hawaiian students and ensure that they receive a culturally relevant education that will empower them to thrive academically, socially, and culturally.

We strongly urge the Committee to **pass HB 549 HD3 SD1**, this important bill, and look forward to its positive impact on our keiki and communities. Mahalo nui loa for your time and consideration.

Mahalo for the opportunity to testify in strong support of H.B. No. 549 H.D. 3 S.D. 1.

Our State faces a critical shortage of affordable, high-quality child care options. Families are struggling to secure the care they need to support their children's development while maintaining economic stability. This bill offers a tangible solution to this urgent issue by:

- 1. **Supporting the Early Learning Workforce:** The grant program will fund training and professional development opportunities for over 500 existing early learning professionals. This investment will enhance the quality of care, improve retention in a historically low-paying field, and address turnover rates by offering pathways for career advancement.
- 2. **Increasing the Supply of Child Care Slots:** By incentivizing individuals to enter and advance in the field, this program has the potential to create 100- 150 additional slots for infants and toddlers under the age of three, or up to 200 slots for three- and four-year-olds. These added slots will help families currently on waiting lists and those forced to make difficult compromises between work and caregiving.

- 3. **Creating Sustainable Career Pathways:** Funding apprenticeship programs will recruit new talent into the early learning profession, while offering structured pathways for career growth. This approach builds a sustainable pipeline of high-quality child care professionals, many of whom reflect the diverse communities they serve.
- 4. **Strengthening Economic Stability:** The child care industry generates over \$300 million in revenue for the State. In addition, access to reliable child care is critical for families in Hawai'i where the high cost of living makes workforce participation a necessity. This program helps to strengthen Hawai'i's economy by generating revenue and creating new jobs, while also supporting families in securing employment opportunities.

This legislation aligns with our shared vision of prioritizing early learning as a cornerstone of Hawai'i's future. By investing in this apprenticeship grant program, we address immediate workforce while laying the foundation for long-term, systemic improvement in field. Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

**ECAS strongly supports passage of HB549 HD3 SD1**, which would provide financial support for early learning employers to participate in Early Learning Registered Apprenticeship Programs (ELRAPs).

High-quality early learning programs are fundamental to thriving children, flourishing families, and a robust economy. An effective, well-trained, early learning workforce is the backbone of these programs. Chronic issues related to poor compensation and limited professional advancement opportunities, however, pose huge barriers to workforce recruitment and retention.

Early Learning Registered Apprenticeship Programs offer new early learning professionals appropriately-scaled, higher compensation, and valuable on-the-job learning experiences as they work towards earning college degrees. ELRAPs have proven to be an effective recruitment and retention strategy, faciltating a pipeline of new employees into early learning programs and providing the compensation and career pathways instrumental to retaining professionals in the field.

However, many early learning providers are unable to participate in ELRAPs because they cannot afford to pay the higher wages of apprentices and ensure wage parity for existing staff, as well as support the training and mentoring activities associated with apprenticeship. By providing key grant funding, this measure would help close budget shortfalls and remove the financial barriers impeding the participation of eligible early learning providers in state- or federally-approved ELRAPs.

By building the supply of highly-skilled and well-compensated early learning professionals, expansion of ELRAP participation, via the support of grants, would ultimately increase the number and seat capacity of early learning programs, as well as enhance the quality of care provided by programs.

In order for Hawai'i to meet the education, employment, and economic needs of the state, the state must support and sustain the child care sector and improve families' access to child care and early learning programs by prioritizing strategies to stabilize and expand the early childhood workforce. Towards this end, we strongly urge you to support HB549 HD3 SD1.

Members of AAUW of Hawaii thank you for this opportunity to testify in **strong support of HB 549**, **HD 3**, **SD1** which establishes an Early Learning Apprenticeship Grant Program to be administered by the University of Hawaii to provide financial support for early learning program service providers in the State to participate in state or federally approved early learning apprenticeship programs.

Hawaii has a shortage of qualified child care employees to fill these many vacant, but critical positions. Early childhood care and educational professionals are undervalued in Hawaii, averaging just \$13 to \$17 per hour wage. It is no surprise that the number of professionals in this sector has been decreasing, although they are in high demand.

Early Learning Registered Apprenticeship Programs (ELRAP) are a proven recruitment and retention strategy, offering apprentices higher compensation and valuable on-the-job learning experiences as they work towards earning a higher education degree. AAUW of Hawaii supports this measure that will aid Hawaii in retaining and recruiting qualified child care workers, including women who want to work in the field, but cannot, or will not, due to the current low wage. An important feature in this bill will provide funding to eligible providers participate in state- or federally-approved ELRAPs to adequately compensate these workers in training as well as allow providers to pay their existing staff higher wages, ensuring that wages are comparable to federal wage requirements or prevailing industry standards.

Please pass this important measure which will support working families and child care workers by helping them stay in the work force and be productive, tax-paying members of society. Mahalo for your consideration.

Aloha Chair Dela Cruz, Chair Moriwaki, and Committee Members:

We write in support of HB 549 SD1, Relating to An Early Learning Apprenticeship Grant Program. The purpose of HB 549 SD1 is to establish an Early Learning Apprenticeship Grant Program to provide financial support for early learning program service providers in the State to participate in state- or federally-approved early learning apprenticeship programs. This Program will help with the recruitment, retention, and upskilling of our early learning workforce so parents can fully participate in the workforce.

Multiple studies have shown that a person's most dramatic brain development occurs in the first three years of their life. Making sure that frontline early learning workers-who are in charge of molding the minds of young children during these critical years-are paid well enough to stay in the profession benefits: (1) the workers who can now stay in the profession; (2) the children who will receive professional care during critical years; (3) businesses whose employees depend on child care; (4) parents who can stay at their jobs because of greater access to child care; and (5) society as a whole, because a new generation of children will be better prepared to learn, grow, and thrive.

Hawai'i is having an increasingly difficult time retaining and recruiting infant and toddler child care and early learning workers. The RAND Corporation<sup>1</sup> has noted that as of May 2021, the typical child care worker in Hawai'i earned just under \$13.79 on an hourly basis. When adjusting for cost of living, this is lower than the national median hourly wage for child care workers. This is unsustainable.

Indeed, between 2018 and 2020 Hawai'i lost 20% of its child care workforce. When child care workers leave the profession, it becomes harder for child care providers to stay open. This ultimately makes it harder for families to get access to child care as demand increases while supply shrinks. And this disparity between supply and demand for child care is why families struggle to pay for facilities that charge \$20,000 per year per child, because that is what they must do to stay afloat.

We know that early learning and child care program service providers operate on miniscule financial margins with fixed costs that can't be negotiated or reduced, like rent or electricity. This means that when they need to lower expenses they must turn to wages. And in turn, early learning professionals leave the state.

The Grant Program established by HB 549 SD1 will allow early learning program service providers to cover costs associated with participation in state- or federally-approved early learning programs, including personnel expenses and wages, training expenses, mentorship stipends, administrative costs, wage supplements, wage or salary increases, and other compensation enhancements to attract and retain qualified employees.

The establishment of the Early Learning Apprenticeship Grant Program will help break this cycle of poor retention and recruitment, and put us on a path to greater affordability both for early learning workers and for those who need access to early learning.

We are proud to support HB 549 SD1 and urge you to pass it.

Child care workers face disproportionately low wages, which contributes to high turnover rates and loss of workforce. Lack of affordable and available child care has far reaching consequences, from the individual development of children to family economic stability, to employer operations. When child care is not available, parents cannot work, triggering a cascade of problems for the family and for employers.

Early learning registered apprenticeship programs (ELRAPs) are a proven recruitment and retention strategy, offering apprentices higher compensation and valuable on-the-job learning experiences as they work towards earning a higher education degree. ELRAPs have also been successful at increasing the quality of early learning programs as they develop a well-prepared, well-supported, and well-compensated ECE workforce.

Many early learning providers are unable to participate in ELRAPs because they cannot afford to pay the higher wages of apprentices and ensure wage parity for existing staff. The ELRAP grant would remove this financial barrier and allow providers to pay their existing staff higher wages, ensuring that wages are comparable to federal wage requirements or prevailing industry standards.

Founded in 1968, PACT is a statewide community-based organization providing a wide array of innovative and educational social services to families in need. Assisting more than 15,000 people across the state annually, we help identify, address, and successfully resolve challenges through our 20 programs. Among our services are early education programs, domestic violence prevention and intervention programs, child abuse prevention and intervention programs, childhood sexual abuse supportive group services, child and adolescent behavioral health programs, sex trafficking intervention, poverty prevention and community building programs.

Our state's families are struggling to find affordable and high quality child care to support their young children's development across all islands. HB549 addresses one of the most pressing challenges faced by Hawai'i's early childhood care and education sector: the recruitment and retention of a well-trained workforce. This bill incentivizes providers to join apprenticeship models, invest in their staff and communities, and retain qualified and committed staff within their programs– all of which directly contribute to the stabilization and affordability of Hawai'i's ECCE sector, and benefit:

*Early Learning Providers:* By providing financial support to providers who otherwise would not be able to participate, this program offsets operational costs and allows providers to increase staff wages and retention, allowing for more funds to be invested in program quality and preventing program closures in our already-limited market. Currently, there is only 1 licensed ECCE seat available for every four young children in Hawai'i, with demand only growing.

*ECE Workers:* This program provides an "earn while you learn" workforce pathway that allows apprentices to retain full-time employment. This increases accessibility of ECCE credentials and workforce entry, as well as provides wage parity for existing staff, in turn reducing inequities and chronic turnover in the field and negatively impacting the number of child care slots available.

*Children and Families:* By investing on well-trained and well-compensated staff, this program allows for providers to develop high-quality programming and keeps more programs open with lower tuition, allowing for families to access the high-quality care their children deserve. This bill prioritizes the infant and toddler care market, which suffers the smallest capacity–11%– of licensed child care slots per child across the islands. As of 2022, only 12% of Hawai'i's 1- to 2-year olds are served and 3% of infants.

*Employers:* Child care shortages directly and negatively impact workforce participation. This program supports parents in staying in or returning to the workforce by increasing options for accessible child care. This bill provides a vital step towards strengthening Hawai'i's ECCE landscape and the overall wellbeing of our families. Through this legislation, we provide support

to directly impact our early learning providers, invest in our vital ECCE workforce, and lay the foundation for a greater system of sustainable care for our families and children.

My name is Dr. Terry Lock and I am the Director of the Hawai'i Early Childhood Educator Excellence and Equity (ECE<sup>3</sup>) Project at the University of Hawai'i Mānoa College of Education.

In Hawai'i, many parents with young children continue to struggle to find high-quality reliable early learning programs that support their young children's development and simultaneously help them to work and achieve economic security. Unfortunately, many early learning programs are having difficulty recruiting and retaining quality early learning professionals.

This proposed Early Learning Apprenticeship Grant Program administered by the University of Hawai'i offers a tangible solution to these pressing issues by:

- Supporting the Early Learning Professionals: The grant program will provide funding to support existing early learning professionals, helping them access critical training and professional development opportunities. This investment will not only enhance the quality of care but also improve recruitment and retention in the early care and education field that has historically faced high turnover due to low wages and limited growth opportunities.
- 2. Increasing the Supply of Early Learning Slots: By incentivizing individuals to enter and advance in the field, this program has the potential to adding more child care slots for young children. These additional slots will directly benefit families who are on waiting lists or forced to make difficult compromises in their work and other responsibilities.
- 3. **Creating Career Pathways:** By funding apprenticeships, the program will offer a structured pathway for career entry and advancement, that will enhance the recruitment new individuals into the early learning profession. This is especially important in creating good jobs for individuals who reflect the diverse communities they will serve.
- 4. **Strengthening Economic Stability:** For families in Hawai'i who struggle with the high cost of living, access to reliable child care is often the key to maintaining stable employment and achieving economic security. The proposed program will play a critical role in ensuring parents can

participate fully in their jobs and careers, knowing their children are in safe, nurturing, and developmentally appropriate settings.

As the Director of the ECE<sup>3</sup> Project at the UHM College of Education, I supported Honolulu Community College (HonCC) and Keiki O Ka 'Āina Family Learning Centers' (KOKA) in launching our state's first early childhood education (ECE) registered apprenticeship program through KOKA in the summer of 2023. Recently, I spoke to one of KOKA's apprentices. She is employed as an aide at KOKA's Ka Pua Preschool, located in Mā'ili, 'Oahu. With strong support from her husband and their four boys, ages 14, 11, 10, and 5, she enrolled in her first ECE course at HonCC in the 2023-2024 academic year. She shared, "To be in a job, while going to school, has made a huge difference. This [apprenticeship program] fits the type of learner that I am. I love that I get to apply what I learn from my mentor and my college instructors, while interacting with preschool children." She also credits her "very encouraging" instructors at HonCC. She is on target to complete her first of three milestones, a Child Development Associate (CDA), a nationally recognized credential in May 2025. Her goal is to be a preschool lead teacher or open her own day care program.

HB 549 HD2 SD 1 will help to grow our early learning workforce and aligns with the shared vision of prioritizing early learning as a cornerstone of our state's future. By investing in the apprenticeship grant program, we are not only addressing immediate needs but also laying the groundwork for long-term systemic improvements in early learning for our young children's success in school and in life.

We are public preschool teachers and graduate students studying Early Childhood Education.

We strongly urge you to pass HB549, Relating to Early Learning Apprenticeship Grant Program.

We have collectively been working as teachers in the State of Hawaii between 3-13 years. We, like many others, began to notice symptoms of teacher burnout at varying times in our careers. Recently, we have begun to rediscover the joy in our careers of being as early childhood educators thanks to collaborating with other early childhood educators in the field. These are the reasons that we believe have contributed to this positive change for our experience, which this bill might also bring forth for other educators like us in the field:

• Opportunity to attend professional learning communities (PLCs) with our district or statewide teachers on a regular basis

Periodic time spent away from teaching in the classroom allows teachers to gain new teaching strategies, learn about child development and have intellectual discussions with our colleagues. This contributes to the betterment of teaching practice by making us feel more equipped as teachers and refreshed going back into our classrooms to apply what we learned the next day.

• The quality of professional development matters

Meetings that are PowerPoint lectures as professional development do not address or feel supportive of our needs as educators and contribute to the early burnout we once felt. Much like teaching our youth, when professional development for educators is relevant, held in comfortable settings, involves engaging activities, hands-on materials, and interactive experiences, the training sessions or workshops become not only useful, but also enjoyable. This adds to our motivation to learn as educators, which in turn directly positively impacts our students. Impactful professional development requires appropriate funding, thus apprenticeship is an ideal model for training.

• Mentors/mentorship, collaboration, and networking opportunities

Something that has kept us afloat in our careers has been the personal relationships that we have developed with mentors. As educators, we are expected to be responsive to the mental and

emotional well-being of our students and develop positive connections with them to increase their motivation to be in school. Our mentors model this for us as educators. They alleviate the strain of teaching that we sometimes feel, which, when neglected, results in burnout and leaving teaching. Investing in professional interactions with experienced mentors improves instructional quality. This, in turn, benefits both teachers and students. Mentors also are encouraged to take on the added responsibility of supporting others in the workforce if they are able to receive stipends for their efforts.

As we have slowly come to rediscover the joy in our careers due to the above-mentioned reasons, others in similar positions and backgrounds to us may also benefit if this bill were to pass. High-quality, hands-on training from the early state of our career must prevent burn out from happening. That is why high-quality, hands-on training from the early stage of teachers' careers must be provided in order to prevent burn-out from happening.

We also believe that improving the compensation for wages or salaries of all early childhood educators in the State of Hawai'i, regardless of the sector they are working in, will greatly improve the retention rate that we have been struggling with as a field of practice. We all know colleagues who have after-school night jobs to stay financially afloat, which also leads to days of exhaustion trying to teach in the classroom. Mentors' stipends and compensation rates not only would increase job satisfaction, but it would also help alleviate the financial burdens many experienced educators face in this economy as well as acknowledge their contributions to their mentees and the broader workforce. We believe that financial support for early learning program service providers would offer a glimmer of hope to our fellow educators and will encourage more teachers to rise as leaders in the field of early childhood education and train up the next generation of educators.

For these reasons, we sincerely urge the committee to pass HB549.
