
The Department of Hawaiian Home Lands (DHHL) <u>strongly supports</u> this bill which extends the Act 279 Special Fund to 6/30/2028, 2) deposits funds into and appropriates funds out of the Act 279 Special Fund to eliminate its waitlist, 3) requires DHHL to submit a strategic plan detailing the anticipated uses of the funds appropriated, 4) requires an annual report, and 5) sunsets 6/30/2028.

DHHL continues to make progress regarding the encumbrance of funds, the expenditure of funds, and the delivery of lots pursuant to Act 279, SLH 2022. Attached is the Annual Activity Report as required under Act 125/24 (Act 279, Session Laws of Hawai'i 2022). HB606, HD1, provides sustained legislative action to fulfill the State's trust obligations under the Hawaiian Homes Commission Act, 1920, as amended, and the Hawaii State Constitution. This bill will ensure that DHHL has adequate time to encumber and expend the necessary funds and will secure additional funds that will allow DHHL to continue to address the DHHL applicant waiting list.

In 2022, the Hawai'i State Legislature appropriated \$600 million through Act 279 to the Department of Hawaiian Home Lands. The purpose of this funding is to reduce the Hawaiian Homes waitlist. To this end, the Department has been actively pursuing new lot development projects as well as awarding all available lots to beneficiaries on the waitlist.

- 2. The number of applicants on the waiting list assisted.

Aloha e Chairs Chang and Richards, Vice Chairs Hashimoto and San Buenaventura, and the Senate Committees on Housing and Hawaiian Affairs:

The Office of Hawaiian Affairs (OHA) **SUPPORTS HB606_HD1**, which would provide critical support to the Department of Hawaiian Home Lands (DHHL) by: (1) extending the Act 279 Special Fund to June 30, 2028, (2) depositing funds into and appropriating funds out of the Act 279 Special Fund to increase DHHL lease awards to waitlisted beneficiaries, and (3) requiring DHHL to submit a plan and report on its use of Act 279 funds.

As detailed in a recent study published by the Economic Research Organization at the University of Hawai'i (UHERO), as of 2023, the consequences of unaffordable housing continue to show up in out-migration, homelessness, and more families being priced out of the local market." For example, in 2022, more than 67,000 former Hawai'i residents moved to other states, with the high-cost of housing identified in surveys as a leading cause of out-migration. As a result of the cost driven out-migration, more Native Hawaiians now live outside of Hawai'i than in Hawai'i.

DHHL plays a vital role in addressing the housing needs of Native Hawaiians and reversing this disturbing trend of Native Hawaiians being priced out of their ancestral homelands. Historic underfunding and marginalization of DHHL has led to today's contemporary crisis where the number of qualified beneficiaries vastly outnumbers the agency's ability to provide habitable land and housing. However, Act 279 is an important step towards meeting the

My name is Shane Pale, and I submit testimony on behalf of Kūpa'a Lāhui Alliance in strong support of HB606. This bill is not just about housing—it's about securing the future of Native Hawaiians and ensuring that Hawai'i remains a home for its people, not just for tourists and outside investors.

1. HB606 Addresses the Native Hawaiian Diaspora

Hawaiians are being displaced at alarming rates. More Native Hawaiians now live outside of Hawai'i than in their homeland—a direct result of skyrocketing housing costs and the lack of affordable options. The State of Hawai'i has an obligation to ensure that Native Hawaiians can live in the land of their ancestors. HB606 is a necessary step in stopping the forced outmigration of our people.

2. Addressing the 29,000+ on the Waitlist Helps Solve Hawai'i's Housing Crisis

Hawaii is facing an extreme housing crisis, with the median home price now at \$1.1 million. For the 29,000+ Native Hawaiians still waiting for DHHL homesteads, this cost makes homeownership nearly impossible. Funding DHHL and providing housing for these families will reduce pressure on Hawaii's overall housing market, offering relief to all local residents.

3. Hawaiian Lands & Hawaiian Identity Drive Hawai'i's Economy

Hawai'i's two largest industries—tourism and the military—operate on stolen Kanaka Maoli lands.

- The military controls thousands of acres of Hawaiian land, often leased for as little as \$1 per year.
- The tourism industry generates billions annually by commodifying Hawaiian identity—using our culture, language, hula, and 'aina as marketing tools, while many Native Hawaiians struggle to afford housing.

Hawaiians have given more to this state than any other group, yet we are being systematically displaced from our homeland. It is time for the state to fulfill its commitments under the Hawaiian Homes Commission Act and reinvest in the people whose identity sustains Hawai'i's economy.

4. The \$600M is an Investment in Hawai'i's Future HB606 is not just a housing bill—it's an economic investment.

- Job creation Home construction supports contractors, local laborers, and small businesses.
- Stronger communities Stable housing leads to better educational outcomes, economic mobility, and reduced homelessness.
- Economic return Every dollar invested in housing leads to increased consumer spending, local business growth, and lower state costs for social services.

This is not about giving Native Hawaiians a handout—it's about ensuring that the people who built this place, who continue to give to this place, have the ability to stay. I strongly urge the committee to pass HB606 and take a stand for housing justice, economic stability, and the future of Hawai'i.

I'm in <u>STRONG OPPOSITION</u> of HB606 HD1, in consideration of the actions by the current DHHL Chairman leading Administration and the HHC

The **ORIGINAL** Strategic Plan (SP) and Budget to Implement Act 279 was submitted to the legislature on December 6, 2022. It was approved by the Hawaiian Homes Commissioners of 2022, as led by DHHL Chairman William Aila, Jr.

Stewart Matsunaga was the Land Development Division (LDD) Administrator that completed the SP and Budget with Chair Aila and the Commissioners. He worked for DHHL for over 40 years from 1981 through January 2024. He worked most of the years for LDD as the Administrator. His resume is attached.

Below is a budget summary and the total lots planned to be developed by County. Each lot would assist one applicant on the waitlist. Also below are the anticipated rental units to be developed on Oahu only, which does NOT remove an applicant from the waitlist. Lastly, below includes the planned Statewide land/project acquisitions which estimates the development of 300 additional lots.

Stewart Matsunaga, LDD Administrator, consistently provided Act 279 progress status reports to the HHC at every monthly meeting throughout the year 2023. It included a spreadsheet of the strategic plan projects and budget, encumbered funds, projected encumbered funds, and projected lots.

The last report from Matsunaga was provided to the HHC on December 18, 2023. Matsunaga was out for medical leave during the HHC meetings in January and February 2024, which ended in his retirement (date unknown). During Matsunaga's absence, Administration did NOT provide the monthly Act 279 progress status report of the strategic plan and budget.

At the March 18, 2024 HHC meeting, **Kalani Fronda** presented various LDD reports under the office of the chairman, but no report for Act 279. **At the April 22, 2024 HHC meeting, Fronda was introduced as the new Acting LDD Administrator**. Again, no Act 279 progress status report. From March 2024 to present date, Fronda NEVER provided the HHC an Act 279 monthly progress status report of the strategic plan projects and budget approved by the HHC.

<u>For FY2023</u> (ending 6/30/2023), DHHL submitted its <u>Act 279 Annual Report to the legislature</u>. The report was dated January 17, 2024 and it <u>aligns with Matsunaga's last report to the HHC on December 18, 2023, as follows:</u>

Based on Matsunaga's last report to HHC on December 18, 2023, the **ORIGINAL Act 279 Strategic Plan** and **Budget (2022)** were on-course to be accomplished, to encumber \$600,000,000 by the deadline and assist the projected number of applicants on the waitlist with a lot and 99-year lease.

Shockingly, Fronda's Act 279 Annual Report to the legislature dated January 15, 2025, to report FY2024 encumbrances and expenditures of \$363,461,222.45, will only assist 185 applicants on the waitlist.

The FY 2024 Annual Report under Fronda's LDD administration fails to provide clarity if it includes the budgeted \$60,000,000 to address barriers to home ownership.

Almost all of Act 279 appropriations of \$600M have been encumbered yet DHHL will assist significantly less applicants on the waitlist than the ORIGINAL Act 279 Strategic Plan and Budget (2022) by 1,353 less applicants.

Act 279 changes (deviations) to the strategic plan and budget initiated by both PIGs, the report is confusing. Also changes made during the meetings are difficult to follow since some Commissioners don't speak into the microphone.

Fronda never provides monthly Act 279 Strategic Plan and Budget progress status reports, before or after the two (2) PIGs.

Projects on Oahu on the ORIGINAL Act 279 SP and Budget were removed and total applicants on Oahu assisted were significantly decreased, yet Oahu have the highest number of applicants on the waitlist.

The ORIGINAL Act 279 SP and Budget should never have been changed. Matsunaga had 40 years+ of experience managing DHHL projects and budgets. He was familiar with our DHHL lands and the opportunities for development were only limited due to lack of funding. Matsunaga was part of the Master planning statewide, all regional and all island plans. He honored the beneficiary survey results of 2020 and the Commissioners of 2022.

For these reasons, I STRONGLY OPPOSE HB606 HD1.



Ka Lāhui Hawai'i strongly supports HB 606 HD1, which extends the Act 279 Special Fund and ensures continued funding for the Department of Hawaiian Home Lands (DHHL) to fulfill its obligation to the indigenous peoples of Hawai'i. This bill is a critical step toward addressing Hawai'i's housing crisis and fulfilling the promises of the Hawaiian Homes Commission Act (HHCA) and the Hawaii'i State Constitution.

The ongoing housing crisis has forced thousands of Kanaka Maoli to leave their homeland due to the high cost of living and lack of affordable housing. The DHHL has been underfunded for decades and meanwhile the Hawaiian diaspora continues to grow - cutting cultural and familial ties to 'āina for generations.

There are currently 29,000 Native Hawaiians on the DHHL waitlist. The estimated cost to eliminate the waitlist is over \$6 billion, requiring sustained legislative action. The average Native Hawaiian household has 4.1 individuals, meaning that funding housing for these 29,000 applicants would directly house over 118,900 people. Fully funding DHHL will not only provide housing but will also stimulate the economy, create jobs, and reduce dependence on public assistance.

The passage of HB 606 HD1 is essential to fulfilling the State's trust obligation and ensuring that Native Hawaiians can remain in their homeland. Ka Lāhui Hawai'i urges the legislature to support this bill and take action to address the long-standing housing crisis affecting our people and to fulfill the promise.

Dear Honorable & Honest Members of The Hawaii State Legislature,

I write to fiercely oppose House Bill No. 606 (H.B. 606), "Relating to the Department of Hawaiian Home Lands," a bill that's less about housing native Hawaiians and more about letting white-collar criminals at DHHL fleece the trust while treating beneficiaries like they're too stupid to see the scam. Under Kali Watson, millions roll in, the waitlist festers, and the dead pile up—yet H.B. 606 hands these crooks more rope. Here's why you should torch it or summon real accountability:

- Waitlist Limbo, Death's Dividend: DHHL's 29,000 waitlisters—11,441 on O'ahu (HPR, 2024)—rot while Act 279's \$600 million served just 6,075 (21%). Over 2,000 died since 2022 (KHON2, 2025), and Watson shrugs, "A ton of people are dying every day" (Civil Beat, 2024). H.B. 606 stretches the fund to 2028 (Section 2) with no \$6 billion guarantee (Section 1). Are they banking on kūpuna dying to dodge the problem?
- Kali Watson, Master of Misdirection: Watson crows about 3,100 lots from 1995–1998 (Lambda Alpha, 2023), but his \$600 million settlement then synced with trust failures—\$1.2 million misspent by OHA (2019 audit). Now, Act 279's \$600 million feeds private developer schemes—\$561 million more, he begs (HPR, 2023). Who's cashing out—beneficiaries or his Hawaiian Community Development Board pals?
- Act 279's Black Hole: Of Act 279's \$600 million, \$193 million is "spoken for"—\$160 million to private cronies, \$94 million for land like Wai'ehu (HPR, 2023). Only 7,800 lots planned, not 29,000. H.B. 606's vague appropriations (Sections 5 and 6) and toothless reports (Sections 3 and 4) scream cover-up. Honolulu rail's \$330 million insider overages say it all—money vanishes when oversight's a joke.
- Commercial Cash, Beneficiary Crumbs: Nānākuli Village Center and Ka Makana Ali'i pump millions into DHHL via triple net leases—tenants like Longs Drugs and Macy's pay rent, taxes, and upkeep for pure profit. Ka Makana Ali'i's 65-year lease nets \$200 million (DHHL, 2014); 2022 lease revenue hit \$13.5 million (DHHL Audit, 2022). Where's it go? Not to beneficiaries—no homes, no checks—just Watson's murky "operations." White-collar theft, plain as day.
- Trust Trashed, Corruption Reigns: Only 14% of DHHL leases go to native Hawaiians (Star-Advertiser, 2019), despite federal rules. The 2019 Kalaeloa solar deal to a Canadian firm over local Edward Maria oozed favoritism. H.B. 606's no-bid free-for-all (Section 1) and UHERO's 20–30% inflated construction costs (2021) guarantee profiteering. They think Hawaiians won't notice the grift?
- **Legislative Charade**: An effective date of July 1, 3000 (Section 8)? A typo or a spit in the face. Even fixed, dragging this to 2028 with no \$6 billion lock-in is a dodge.

- DHHL's \$328 million Kalima settlement (2020) proves they've screwed beneficiaries for decades—why trust these suits now?
- **Economic Smoke Screen**: H.B. 606 promises jobs (Section 1), but 65,000 of 200,000 DHHL acres lack pipes or power (Ka Wai Ola, 2023). Haseko's 211 acres (Civil Beat, 2024) need \$561 million more—taxpayers pay, developers pocket, beneficiaries get squat. Same old scam.

Legislators, this is a slap to native Hawaiians—DHHL's white-collar crooks rake in Nānākuli and Ka Makana Ali'i cash while treating beneficiaries like dumb marks. H.B. 606 greenlights the heist. Summon the doge—unleash a relentless probe into Watson's books, Act 279's ghost funds, and every commercial dollar. Lock in \$6 billion, enforce ironclad oversight, and jail these frauds if they're guilty. Anything less, and you're letting them laugh all the way to the bank on Hawaiian backs.

My name is Luanna Peterson and I strongly support HB606. This bill is not just about housing—it is about justice, dignity, and the survival of the Native Hawaiian people.

The cost of living in Hawai'i is prohibitive for the majority of its people and feels like a violation of basic human rights. I am struggling to surivive, and provide for my family despite my education, and full time employment. I am a local girl and know Hawai'i as my only home. As an ally, and non-indigenous guest here, I feel that Native Hawaiians, especially, should not have to struggle to exist in their own homeland. Yet, rising costs—driven by unchecked foreign investment, short-term rentals, and the overwhelming military presence—have made it nearly impossible for many in our lāhui to afford a stable home.

The Hawaiian Homes Commission Act was meant to ensure that Native Hawaiians have access to safe, affordable housing, yet the continued failure to fund the Department of Hawaiian Home Lands undermines this promise. Over 29,000 Native Hawaiians remain on a waitlist for homesteads while luxury developments and outside interests continue to profit from stolen land. This is not just an economic issue; it is a deep injustice that must be corrected.

A thriving Kanaka Maoli population strengthens all of Hawai'i. When Native Hawaiians have access to stable housing, we are able to perpetuate our culture, traditions, and values—benefiting not just our own families but the entire lāhui. HB606 honors the vision of Prince Kūhiō by ensuring that Native Hawaiian families can live with dignity in their own homeland.
