HB 606, RELATING TO THE DEPARTMENT OF HAWAIIAN HOMELANDS

January 28, 2025

Aloha Chair Evslin, Vice Chair Miyake, and Members of the Committee:

The Department of Hawaiian Home Lands (DHHL) <u>strongly supports</u> this bill which extends the Act 279 Special Fund to 6/30/2028, 2) deposits funds into the Act 279 Special Fund and appropriates funds out of the Special Fund for DHHL to eliminate its waitlist, 3) requires DHHL to submit a strategic plan detailing the anticipated uses of the funds appropriated, and 4) requires an annual report.

DHHL continues to make progress regarding the encumbrance of funds, the expenditure of funds, and the delivery of lots pursuant to Act 279, SLH 2022. Attached is the Annual Activity Report as required under Act 125/24 (Act 279, Session Laws of Hawai'i 2022). HB606 provides sustained legislative action to fulfill the State's trust obligations under the Hawaiian Homes Commission Act, 1920, as amended, and the Hawaii State Constitution. This bill will ensure that DHHL has adequate time to encumber and expend the necessary funds and will secure additional funds that will allow DHHL to continue to address the DHHL applicant waiting list.

Department of Hawaiian Home Lands Annual Activity Report

As required by: Act 125/24 (Act 279, Session Laws of Hawai'i 2022)



HAWAIIAN HOME LANDS TRUST Department of Hawaiian Home Lands

In 2022, the Hawai'i State Legislature appropriated \$600 million through Act 279 to the Department of Hawaiian Home Lands. The purpose of this funding is to reduce the Hawaiian Homes waitlist. To this end, the Department has been actively pursuing new lot development projects as well as awarding all available lots to beneficiaries on the waitlist.

Section 5 of the Act requires the Department to submit an annual report to the legislature on the first day of each regular session that includes:

- 1. An accounting of the expenditures for the purposes of this Act in the previous fiscal year; and
- 2. The number of applicants on the waiting list assisted.

Below please find a report of expenditures and encumbrances for fiscal year 2024 (ending June 30, 2024) as well as the projected number of applicants who will benefit from these development projects.

Aloha Chair Evslin, Vice Chair Miyake, and Members of the Committee,

We are equally concerned that the apparent answer to this, YIMBYism, insists that anything resembling true affordability is impossible so instead they promote building housing that gets bought by overseas investors. *We know we won't solve our housing woes without building more, but we won't solve them by simply building more.*

Reevaluation of House Bill No. 606 (HB606) Considering Allegations of Misappropriation and Corruption:

Support or Oppose?

Given the new context with allegations against Director Kali Watson and concerns about the integrity of the Department of Hawaiian Home Lands (DHHL), the decision to support or oppose HB606 becomes more complex:

Support:

- 1. Critical Need for Housing: Despite the allegations, the underlying need for housing among Native Hawaiians remains urgent. If managed correctly, the funds could still serve their intended purpose.
- 2. Community Advocacy: The bill reflects community demands for action on housing, and many might see it as necessary despite distrust in leadership.
- 3. Economic and Cultural Benefits: The potential for economic stimulation and cultural preservation might still outweigh concerns, provided there are stringent oversight mechanisms.

Oppose:

- 1. Misappropriation Concerns: Allegations of misappropriation by Director Kali Watson, especially if linked to laundering funds through nonprofit connections, severely undermines trust in how these funds will be used.
 - Corruption Allegations: The involvement of Watson with over 20 nonprofit groups, potentially used for personal or familial gain, would raise significant red flags about the integrity of the fund management.
- 2. Lack of Trust in DHHL: If the public perceives DHHL as corrupt or mismanaged, there would be little confidence that these funds would reach their intended beneficiaries or be used appropriately.
- 3. Risk of Fund Diversion: With such connections to nonprofits, there's a perceived risk that funds could be siphoned off, not benefiting those on the waitlist but rather enriching individuals or groups connected to Watson.
- 4. Need for Reform Before Funding: Critics might argue that before any additional funds are appropriated, there should be a thorough investigation, reform, and possibly new leadership to ensure accountability.

Potential Recommendations if Opposing:

- Investigation: Call for an immediate, transparent investigation into the allegations of corruption and misappropriation.
- Pause on Funding: Advocate for a pause or conditional release of funds based on the outcome of an investigation and the implementation of reforms to ensure oversight.
- Independent Oversight: Suggest the establishment of an independent body or commission to oversee the use of these funds, ensuring they are used for housing and not diverted.
- Reform of DHHL: Push for structural and leadership changes at DHHL to rebuild trust, including stricter regulations on conflicts of interest and financial dealings with nonprofits.
- Public Accountability: Demand more transparent reporting mechanisms, perhaps involving community representatives in oversight roles to monitor fund use.

Conclusion:

Worth Opposing: Given the serious allegations, it might be prudent to oppose this bill in its current form until:

- The allegations against Director Watson and the integrity of DHHL's operations are thoroughly investigated.
- Reforms are introduced to prevent potential misappropriation and ensure that the funds benefit Native Hawaiian beneficiaries directly.

However, if the bill were to include provisions for:

- Independent oversight,
- Enhanced transparency,
- A clear mechanism to prevent corruption,

then there might be a case for conditional support. The focus should be on ensuring that the noble aims of providing housing are not undermined by corruption or mismanagement.

Aloha,

I am in strong support of HB 606 especially since it prioritizes housing to get Native Hawaiians off the waitlist of Hawaiian Homes and onto the land. My grandpa died on the list of Hawaiian homes, my mom has been on the list since the 1980's, my siblings and I have been on the list since the early 2000's. We are three generations on the list and dying on the list. None of us have been awarded a lot!?! Now half the list are seniors at 29,000 currently waitlister. Thousands have died and about 15,000 will die on the list in the next 10-15 years. This is "Justice delayed is Justice denied!" But in this case, this is:

Justice.

FOREVER.

Denied.

To lose a chance of building generational wealth because of dying on the list is a grave injustice on top of injustice on top of injustice done to the Native Hawaiian people. It's no wonder Native Hawaiians are over represented in poverty, incarceration, and homelessness, while under represented in home ownership! It's no wonder more Hawaiians live outside the state of Hawaii, than in the state of Hawaii!

The market for housing here is very high for the workforce and not working for Native Hawaiians. We can't afford to buy a market rate houses because we are discriminated in the workplace from making a liveable wage. There are hardly any Native Hawaiian white collared workers. They are mainly blue collared workers. Also, many Native Hawaiians face glass ceilings of discrimination in workplaces from rising to better paid jobs, despite being highly qualified for positions. No one knows this better than me!!! We need Hawaiian homes built because it ours only chance at affording to build generational wealth for our moopuna to have a fighting chance at living in Hawaii nei, where their koko is tied to. Our identity doesn't allow us to exist outside Hawaii because we are so closely tied to the lands, waters. Our Gods are literally the plants and wildlife that exist in Hawaii and only Hawaii!!! Our mo'olelo are unique to the places of Hawai'i. We must be living here in Hawaii for our identity to exist. At least Hawaiian homes is one way to make housing affordable for us because we don't need to pay for the land

which is highway robbery. We only pay for the house. It would be wise if we can just put our tiny homes on the land to cut costs. It would be wise if shipping was not charging so much for building supplies to be transported into Hawaii to since that makes it so much more expensive.

I am in support of prioritizing the \$600 million for Hawaiian homeland housing because it's very costly at \$375k per house to pay for the infrastructure needed for a house to be built. \$375k per house for the sewer, water, utilities, roads infrastructure. That's not including to build a house. That's because when Hawaiian Home Commission Act (HHCA) was passed in 1920, the only lands not privately owned were far from water, in arid lands. So since it's far from water and therefore infrastructure, it costs a lot to have to build access. It can't be fast tracked as easily since it's not close to existing infrastructure. Unless they were to make a deal and buy land or switch land like the private land that is closer to infrastructure in order to fast track it. At least with the Lahaina wildfire, Hawaiian Homes is able to piggyback off the infrastructure FEMA has built in order to use for Hawaiian homes after 5 years of housing fire survivors. This is smart thinking and hopefully they can build on this too. The unfortunate thing is that even though I have already waited 20 years on the list, I still need to wait another 20 years before getting an award because that's how little monies are appropriated to Hawaiian Homes.

I ask that instead of \$600 million be appropriated for housing to reduce the Hawaiian homeland list, I ask for \$1,800,000 instead. That way I can get an award for housing in the next 5 years so I can plop my tiny home on the land, instead of waiting 20 years. Why wait? There is no need for more waiting. We have waited enough. We need housing now. We need housing 50 years ago when Mayor Cravalho was exploiting our Hawaiian homeland for his own personal plantation! He doesn't even have a drop of Hawaiian blood. But he sure too our generational wealth that we feel to this day. As we pay high rents all our adult lives for generations with no hope for our hard earned money to go towards equity. Just paying rent to pay other people's mortgages on their 2nd,3rd, 4th homes because it is so much more important for a non Hawaiian from a foreign country to own a vacation home on Maui and not a kanaka maoli. Wow. Who does this system really serve? Follow the money is what.
