Chair Elefante and Members of the Committee:

The Department of the Attorney General offers the following comments.

This bill establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement to conduct community outreach on gun violence, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank. The bill also makes an appropriation to establish the new office.

There appear to be overlapping responsibilities with the proposed OGVP and the existing Gun Violence and Violent Crimes Commission (GVVCC), codified under chapter 134C, HRS.

GVVCC is tasked with identifying criminal data that could be used to reduce gun violence and violent crimes and to maximize the sharing of that data between criminal justice agencies. GVVCC's membership includes individuals with expertise in research from different public sectors including the Judiciary. Examples of overlapping responsibilities are:

**(1) Data Identification and Collection:**

**GVVCC:** Identify relevant data that may be used to reduce gun violence and violent crimes.

**OGVP:** Collect relevant data to support efforts in reducing gun violence.

**(2) Identification of Data Gaps:**

**GVVCC:** Identify areas where relevant data is unavailable.

**OGVP:** Identify gaps in available data.

**(3) Data Sharing:**

**GVVCC:** Maximize data sharing among represented agencies and stakeholders.

**OGVP:** Facilitate data sharing among law enforcement, researchers, and the public.

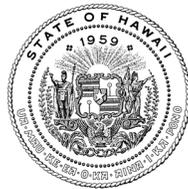
**(4) Research:**

**GVVCC:** Conduct research on gun violence and violent crimes.

**OGVP:** Support researchers in analyzing data and improving data collection methods.

To avoid overlapping responsibilities that may cause confusion and duplication of efforts, we recommend the Committee consider amending this bill to first consolidate GVVCC's responsibilities into the new office, and then repeal chapter 134C, HRS. Consolidating GVVCC's responsibilities into the new office will better accomplish the objectives of this bill by: (1) centralizing data collection to support efforts in reducing gun violence; (2) improving collection and facilitating data sharing among law enforcement, researchers, and the public; and (3) making government more efficient by reducing duplicative meetings that public servants attend.

We are available to work with the Committee on any potential amendments to the bill. Thank you for the opportunity to testify on this bill.

RELATING TO GUN VIOLENCE PREVENTION

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 664, H.D. 1:

- Establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement, for administrative purposes only.
- Requires the OGVP to: 1) conduct public awareness campaigns in a culturally appropriate manner to educate Hawai'i residents about State and federal laws and existing resources relating to gun violence prevention (GVP); and 2) develop a plan to address gun violence in Hawai'i and coordinate, improve, and expand upon existing plans for GVP.
- Establishes a GVP grant program to be developed and administered by the OGVP to conduct community-based gun violence intervention initiatives.
- Establishes a GVP Special Fund (GVPSF) to be administered by the OGVP which will be funded by grants, donations, and appropriations made by the Legislature.

- Requires the OGVP to create and maintain a resource bank of regularly updated and accurate materials and resources as a repository for data, research, and statistical information regarding gun violence in the State.
- Requires the OGVP to submit a report to the Legislature containing a summary of its activities during the preceding year.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 to be deposited into the GVPSF.
- Appropriates an unspecified amount of special funds in FY 26 and FY 27 from the GVPSF for grants to organizations to conduct community-based gun violence initiatives.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 for the establishment of a gun violence resource bank, including the hiring of personnel.

As a matter of general policy, B&F does not support the creation of any special fund, which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work, and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 664, H.D. 1, it is difficult to determine if the GVPSF would be self-sustaining.

Chair Elefante, Vice Chair Wakai, and members of the Committee:

The Department of Law Enforcement (DLE) supports House Bill 664, House Draft 1. This bill establishes the Office of Gun Violence Prevention within the Department of Law Enforcement to conduct community outreach on gun violence prevention, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank.

The DLE believes this Office would be a valuable asset in our mission to protect public safety in Hawaii. By creating a dedicated entity focused on research, community engagement, and evidence-based prevention strategies, we can address gun violence through a comprehensive public health approach that complements existing law enforcement efforts. DLE prefers that the Office of Gun Violence Prevention be established within the Department of Law Enforcement rather than being administratively attached.

The establishment of a Gun Violence Prevention Special Fund would provide sustainable resources to support community-based initiatives, research, and intervention programs that have proven effective in other jurisdictions. The grant program would enable the DLE to collaborate with and support community organizations already doing important work in this field.

The resource bank would provide valuable data and research to inform policy decisions and prevention strategies, ensuring that Hawaii's approach to gun violence prevention is guided by the most current research and best practices.

We believe this Office would strengthen Hawaii's existing gun violence prevention framework and enhance coordination across government agencies, community organizations, and other stakeholders committed to reducing gun violence in our state.

BILL NUMBER: HB 664 HD 1

INTRODUCED BY: House Committee on Finance

EXECUTIVE SUMMARY: Establishes the Office of Gun Violence Prevention to conduct community outreach on gun violence prevention, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank. Establishes the Gun Violence Prevention Special Fund and appropriates funds into and out of the special fund.

SYNOPSIS: Adds a new chapter to the HRS entitled Office of Gun Violence Prevention, (“Office”). The Office would conduct appropriate public awareness campaigns, administer a grant program, and develop a plan to address gun violence and expand upon existing plans for gun violence intervention..

The new chapter establishes a gun violence prevention Grant program to award grants to organizations to conduct community-based gun violence intervention initiatives.

The measure establishes a Gun violence prevention special fund (“Fund”) to be used to award grants to organizations to conduct community-based gun violence intervention initiatives. The Fund would receive moneys from grants, donations, and legislative appropriations.

EFFECTIVE DATE: July 1, 3000.

STAFF COMMENTS: This bill creates a new special fund, administered by the newly established Office of Gun Violence Prevention, to award grants to organizations to conduct community-based gun violence intervention initiatives.

Special funds are pots of money that exist for a specific purpose and largely bypass the legislative appropriation process. The existence of hundreds of these special funds has often confounded those who seek answers to simple questions like “How much money does the State have?”

Our Legislature is supposed to be the steward of all state moneys, but special funds make it very easy to lose track of where the money is and how it is being spent. Departments are supposed to tell the Legislature if they have special funds and how much is in them, but let’s just say they don’t always. Recently, in Report No. 20-01, the State Auditor took DBEDT to task for failing to report \$6.5 million in non-general fund moneys. DBEDT’s response? Just that they’ll “take corrective action.” Not even a “Whoops! We screwed up and promise to do better next time!” This followed closely on the heels of Report No. 19-16, where the Auditor found that \$1.04 million in non-general fund moneys administered by the Attorney General wasn’t reported. That department responded that they “shall establish procedures to assure required

reports are issued.” Is it any wonder that it’s getting harder and harder to follow the money and rein in government spending?

Perhaps as the result of the foregoing concerns, the Legislature has itself established criteria for when a special fund may be maintained (HRS section 37-52.3). Those criteria are that the special fund:

(1) Serves a need, as demonstrated by:

(A) The purpose of the program to be supported by the fund;

(B) The scope of the program, including financial information on fees to be charged, sources of projected revenue, and costs; and

(C) An explanation of why the program cannot be implemented successfully under the general fund appropriation process;

(2) Reflects a clear nexus between the benefits sought and charges made upon the program users or beneficiaries or a clear link between the program and the sources of revenue, as opposed to serving primarily as a means to provide the program or users with an automatic means of support that is removed from the normal budget and appropriation process;

(3) Provides an appropriate means of financing for the program or activity that is used only when essential to the successful operation of the program or activity; and

(4) Demonstrates the capacity to be financially self-sustaining.

Of these, at least two of the criteria are violated. There is no indication that the proposed fund can be financially self-sustaining, and there is no indication why the general fund appropriation process is incompatible with the program. Establishing this special fund is inappropriate.

Dear Chair Elefante, Vice-Chair Wakai and Distinguished Members of the Senate Committee on Public Safety and Military Affairs,

Founded in 1974, Brady works across Congress, courts, and communities, uniting gun owners and non-gun owners alike, to take action, not sides, and end America's gun violence epidemic. Brady today carries the name of Jim Brady, who was shot and severely injured in the assassination attempt on President Ronald Reagan. Jim and his wife, Sarah led the fight to pass federal legislation requiring background checks for gun sales. Brady continues to uphold Jim and Sarah's legacy by uniting Americans from coast to coast, red and blue, young and old, liberal and conservative, to combat the epidemic of gun violence. **In furtherance of our goal to reduce firearm violence across Hawai'i, the Brady Campaign to Prevent Gun Violence is proud to support the passage of SB HB 664.**

Hawai'i leaders have persisted in prioritizing the safety and well-being of the people of Hawai'i by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. However, the latest data from the Centers for Disease Control and Prevention shows that 56 people in Hawai'i are killed by gun violence each year, over 50% of whom die by firearm suicide.<sup>1</sup> This number does not include those who are shot and survive with life-altering physical and mental injuries, nor does it account for survivors and families left with grief, expensive lifelong care, trauma, or many other consequences of gun violence.

One firearm death is too many, and these numbers demonstrate that there remains more work to be done to ensure the safety of Hawai'ian residents and visitors.

It is imperative that we start treating gun violence as a public health epidemic, because it is. By prioritizing research and programs that are tailored towards addressing the root causes of gun violence, this legislature has the chance to disrupt cycles of violence and create safer, healthier communities for all citizens of Hawai'i.

**In furtherance of Brady's goal to reduce firearm violence across Hawaii, the Hawaii Chapter of the Brady Campaign to Prevent Gun Violence is proud to offer its strong endorsement of HB 664, HD 1.**

For decades, Hawaii leaders have prioritized the safety and well-being of the people of Hawaii by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. However, the data from the Centers for Disease Control and Prevention as of 2024 is disturbing:

- Every year, 34 people in Hawaii die by firearm suicide.
- Every year, 15 people in Hawaii are victims of firearm homicide.
- On average, 55 people in Hawaii are killed by gun violence each year and an average of 30 of those deaths occur in Honolulu County.
- Every 7 days, someone in Hawaii is shot and killed.

Since the US Supreme Court has eased the way for more firearms to be carried in our public places, there has been an increase of gun-related violence in Hawaii. **HB 664** is an important step in the right direction. The proposed Office of Gun Violence Prevention would serve as a vital first step towards expanding access to funding for the state to address various forms of gun violence, including suicides, mass shootings, and surges in other forms of gun violence. The Office's focus on data collection will

empower future State Legislatures to continue to lead in this space, by introducing and implementing violence reduction policies that are backed by data. HB 664, HD1 would enable the Office of Gun Violence Prevention to conduct public awareness campaigns on important subjects including, but not limited to, safe and responsible ownership, lost and stolen reporting requirements, and the safe storage of firearms. Chris Marvin, US Army combat veteran, testifying for the Vet Voice Foundation.

We support HB664 and believe that the creation of an Office of Gun Violence Prevention in Hawai'i will help to address the rise in gun violence we've seen in the wake of the the Bruen decision.

In the two years since that deicsion, gun permit applications in the state have increased 280%. And these applications are being approved. Gun purchasers no longer have to demonstrate a specific need to purchase a firearm. That means there are many, many more guns out there.

And we've seen the requisite uptick in gun violence. In the same period, we've seen a 70% increase in gun deaths. And just in the last two weeks we've seen a shooting at Ala Moana Beach Park, a drive by shooting in Kapolei, and not one, but two, manhunts in East Hawai'i Island after violent use of firearms -- both of which resulted in the deaths of armed suspects and one of which resulted in a police officer being shot.

The guns are out there. We can't put this toothpast back in the tube. We now live in a more violent state, and gun violence will continue to increase. This bill will -- at the least -- support and assist the governor, legislators, and law enforcement as we all figure out what to do about it.



As a gun violence survivor, business owner, mother of two children in our public schools, and adjunct faculty member at the University of Hawai'i. I also serve as volunteer state co-lead of the Hawai'i chapter of Moms Demand Action. On behalf of our three local groups on Hawai'i Island, Kaua'i and O'ahu, and our 2,000+ supporters across the islands, **I'm writing today in strong support of House Bill 664.**

These bills would create a state Office of Gun Violence Prevention, bringing Hawai'i in line with our peer gun safety states that already have such offices, including California, Washington, Massachusetts, New York and Illinois.

With the increase in gun violence we have witnessed in our state over the last decade, including a mass shooting in Wai'anae last year and a shootout just a few days ago in Waikīkī, we need to ensure that we're approaching this crisis from every possible angle.

A statewide office will be able to direct, coordinate and support the state's gun violence prevention efforts at multiple stages – from collecting and tracking data to inform policy, to increasing public awareness of secure storage and extreme risk protective orders (ERPOs), to administering funding to lifesaving community violence intervention programs that prevent shootings.

I'm here to voice support for HB 664, the creation of the Office of Gun Violence Prevention. I'm a writer. My days revolve around harnessing the power of story and communication. I'm also mother to two daughters. In the years I've served as a nonprofit professional, I've had the opportunity to study systems thinking and community. And unfortunately, I've seen first hand the impact gun violence has had on people I care about. The intersection of all these things is what brings me here today.

A few years ago, a long-time friend of our family, shot and killed his wife and then himself. His name was Dave, and he'd struggled with mental health issues for decades. He kept a large store of weapons in his home. He was physically and emotionally abusive to his wife and sons. Like so many other families, we're left asking if this tragedy could have been avoided. Too often, we throw up our hands and the conversation ends with the words, "We'll never know." But Dave's story doesn't have to end at the cemetery or in a newspaper headline. Understanding patterns in behavior, triggers and actions can help save lives. Having an office dedicated to communicating, sharing and studying gun violence protects our community.

Issues around gun control are often lightning rods for division. But preventing gun violence, whether from mass shootings, suicide, domestic abuse or other crimes, seems like an issue we could all get behind. No one wants to see families and communities ripped apart. Understanding what works with responsible gun ownership, strengthening coordination between legislators, law enforcement and the judiciary, studying how mental health issues play a part in gun violence and then sharing this data and information with the public are some of the ways this office could function. I urgently implore you to vote NO on H.B. No. 664, which establishes an Office of Gun Violence Prevention within the Department of Law Enforcement. Though framed as a tool to curb gun violence, this bill is a costly, redundant, and perilous overreach that strains Hawaii's taxpayers, threatens constitutional rights, and defies the Trump administration's clear agenda—risking severe consequences for our state. As a concerned citizen rooted in limited government and practical solutions—values that cross party lines—I offer the following objections to prove this bill's folly.

## **1. Squandering Taxpayer Money on Bureaucratic Waste**

H.B. 664 demands unspecified funds from Hawaii's general revenues for a new office, staff, and special fund, all while our state struggles with housing and healthcare crises. ## **2. Duplicating Existing Efforts and Eroding Efficiency**

The bill replicates duties already managed by the Department of Law Enforcement, Department of Health, and local police—public outreach, mental health support, and crime prevention. [Illinois' Office of Firearm Violence Prevention](#), started in 2021, floundered due to redundancy. A [2023 audit](#) found it muddled existing efforts, wasting time and money. Hawaii risks the same chaos—let's reject this bureaucratic burden.

## **3. Jeopardizing Second Amendment Freedoms**

H.B. 664's broad mandate to "advise on legislation" and push "prevention" policies could pave the way for restrictive gun laws, burdening law-abiding citizens—hunters, sport shooters, and those defending themselves. Democrats who value pragmatism should weigh this: defying Bondi and Vance could cost us dearly.

[Washington State’s Office of Firearm Safety and Violence Prevention](#), funded in 2020, lost [DOJ grants](#) in 2021 under Trump’s first term for its perceived anti-gun stance. With Bondi at DOJ and Vance in the White House, Hawaii could face worse—why invite that punishment?

## **5. Unproven Grants Threaten Community Stability**

The bill’s grant program for “community-based initiatives” lacks solid evidence of efficacy and risks misfiring, wasting funds or stirring unrest. Democrats who demand accountability should demand proof—where’s the data showing this succeeds?

[Philadelphia’s grant program](#), begun in 2021, faltered. A [2023 analysis](#) revealed funds squandered on overhead while gun violence rose in some areas due to sloppy execution. Hawaii deserves tested solutions, not gambles that could backfire.

Members of the Committee, H.B. 664 offers a façade of safety but delivers waste, redundancy, and risk—flaws Democrats and Republicans must reject. My name is Olesya Noerper, and I am a freshman at Punahou Academy who strongly supports HB664.

Before I transferred to the Academy, the middle school that I attended was shaken by a gun scare that left a lasting mark on all of us. It started as a whisper in the morning that I arrived—a rumor that a student had brought a gun to campus. At first, I brushed it off. Gossip spreads easily in school, with a majority of it contributing little. Soon, however, reality set in. I watched as students checked their phones, faces growing pale and fingers rushing to call buttons. Some bolted from campus before the first bell even rang. Others, like me, called their parents and left, unwilling to take the risk. By the end of the first period, nearly a third of the school had disappeared. Those who stayed sat in uneasy silence, their teachers struggling to maintain a sense of normalcy while fear pulsed beneath the surface.

In the end, there was no gun. But there was a threat. The student at the center of it all had posted online, stating his intent to bring a gun to school, even taking a photo of the weapon. The fear that gripped us that morning was not imagined—it was justified. And though the threat never materialized, the damage was already done. The school faced an avalanche of backlash, but no amount of explanations or apologies could erase the terror we had felt. I remember how my hands shook as I texted my parents, my friends and classmates mirroring my rushed and panicked movements. I remember the way my chest tightened every time I thought about what could have happened, about how close we might have been to tragedy. That day, I learned how fragile the illusion of safety is. For many students across the country, that fear turns into something much worse—something irreversible.

This is why having HB664 is critical. Establishing an Office of Gun Violence Prevention in Hawaii would allow the state to gather essential data on gun-related incidents, ensuring that lawmakers and community leaders have the necessary information to make informed decisions. Without reliable, Hawaii-specific data, we are left in the dark about the patterns and causes of gun violence in our own communities. This office would also support Community Violence Intervention programs that aim to address conflict before it escalates, providing resources and outreach to those most at risk. By taking a proactive approach, we can prevent tragedies and build safer communities.

When the Bill of Rights was written in 1791, the firearms in existence were muskets—single-shot, muzzle-loaded weapons that required time and effort to fire. The concept of semi-automatic rifles or modern firearms was not even conceivable. To suggest that the Second Amendment protects the ownership of weapons that did not exist at the time of its creation ignores both historical context and common sense.

We must acknowledge that times have changed. The framers of the Constitution could not have foreseen a world where the threat of gun violence was constantly looming over their shoulder. The laws that govern us must evolve with society to keep us safe. HB664 is a necessary step in ensuring that we have the data and resources to understand and prevent gun violence. No student should have to experience the fear that my classmates and I felt that day. No community should have to grieve because of preventable violence. This bill is not just about policy—it is about protecting lives.

While I agree with the intent of the bill to help reduce gun violence in the state, I have grave concerns that given the State’s anti-gun bias that this office will be weaponized with the goal to tweak information to support anti-gun laws, as has been seen in similar offices throughout the nation.

Recently there have been cases where anti-gun groups have submitted manipulated data to similar offices with the goal of promoting further infringements on the Second Amendment. One includes the often repeated, and disproven statement that guns are now the leading cause of death for children. Among other offenses, the data was manipulated to include people up to the age of 25 as ‘children’, included instances of gang on gang violence where the only victims were rival gang members, and included instances of justified police shootings. The mentioned study has been fact checked by several sources and found to be false despite it being touted by the former Presidential Administration. **Simply altering the study to only include persons under the age of 18 debunked the claim that firearms are the leading cause of death in children.**

Another instance resulted in the ending of a popular and successful program that was having positive effects on reducing gun violence. **Giffords Law Center**, who has the stated goal of wanting to reduce gun violence, did a study on a program known as ‘**Oakland Ceasefire**’. **In their findings it was discovered that the program reduced gun violence in Oakland by 50%**, and in 9 other cities that had similar programs reduced crime from 30% to 60%. The Oakland Ceasefire program relied upon Community Outreach and Mentorship programs for at-risk youth, as well as enforcement and prosecution of current laws.

Giffords is being accused of trying to hide the study from the public, and of using their influence to end the highly successful program because it undermined the message that the only way to reduce gun violence is to get rid of guns. **Even if these accusations are false, the reality is inconsistent with their stated goal as there is little to no fanfare regarding such a successful program.**
