Chairs Dela Cruz and Rhoads and Members of the Committees:

The Department of the Attorney General offers the following comments.

This bill establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement to conduct community outreach on gun violence prevention, develop and administer a grant program for gun violence prevention, and develop and administer a gun violence resource bank. The bill amends sections 134C-1 and 134C-2, Hawaii Revised Statutes (HRS), to move the Gun Violence and Violent Crimes Commission (GVVCC) from the Department of the Attorney General to the Department of Law Enforcement.

We note that the amendments to section 134C-2, HRS, effectively remove the Attorney General from the GVVCC. To keep the Attorney General or the Attorney General's designee as a member of the GVVCC and clarify that the Director of Law Enforcement or the Director's designee serves as the GVVCC chair, we ask the Committees to amend section 3 of the bill on page 8, line 17, to page 9, line 2, to read as follows:

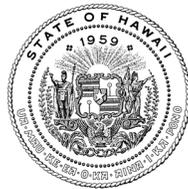
Section 3. Section 134C-2, Hawaii Revised Statutes, is amended by amending subsections (a) and (b) to read as follows:

"(a) The [~~attorney general~~] director of law enforcement or the [~~attorney general's~~] director's designee shall coordinate and serve as the chair of the gun violence and violent crimes commission.

(b) The following individuals, or their designees, shall serve as members of the gun violence and violent crimes commission:

- (1) The chief justice of the supreme court of Hawaii;
- (2) The director of health;
- (3) The [~~director of law enforcement;~~] attorney general;
- (4) A county prosecuting attorney to be selected by the chair of the commission;
- (5) The public defender;
- (6) The chief of police of each county;
- (7) The administrator of the Hawaii state hospital;
- (8) The dean of the college of social sciences at the University of Hawaii at Manoa;
- (9) The dean of the John A. Burns school of medicine;
- (10) One representative from a group that advocates for stricter gun safety laws; and
- (11) One representative from a firearm advocacy group."

RELATING TO GUN VIOLENCE PREVENTION

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 664, H.D. 1, S.D. 1:

- Establishes the Office of Gun Violence Prevention (OGVP) within the Department of Law Enforcement (DLE) for administrative purposes only.
- Requires the OGVP to: 1) conduct public awareness campaigns in a culturally appropriate manner to educate Hawai'i residents about State and federal laws and existing resources relating to gun violence prevention (GVP); and 2) develop a plan to address gun violence in Hawai'i and coordinate, improve, and expand upon existing plans for GVP.
- Establishes a GVP grant program to be developed and administered by the OGVP to conduct community-based gun violence intervention initiatives.
- Establishes a GVP Special Fund (GVPSF) to be administered by the OGVP which will be funded by grants, donations, and appropriations made by the Legislature.

- Requires the OGVP to create and maintain a resource bank of regularly updated and accurate materials and resources as a repository for data, research, and statistical information regarding gun violence in the State.
- Requires the OGVP to submit a report to the Legislature containing a summary of its activities during the preceding year.
- Moves the Gun Violence and Violent Crimes Commission from administratively under the Department of the Attorney General to administratively under DLE.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 to be deposited into the GVPSF.
- Appropriates an unspecified amount of special funds in FY 26 and FY 27 from the GVPSF for grants to organizations to conduct community-based gun violence initiatives.
- Appropriates an unspecified amount of general funds in FY 26 and FY 27 for the establishment of a gun violence resource bank, including the hiring of personnel.

As a matter of general policy, B&F does not support the creation of any special fund, which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work, and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 664, H.D. 1, S.D. 1, it is difficult to determine if the GVPSF would be self-sustaining.

organization representing nurses across Hawai`i, Hawai`i-ANA firmly believes that gun violence is not only a public safety issue but also a pressing public health concern that demands the immediate and comprehensive action proposed in this bill.

This measure aligns with the national priorities of the American Nurses Association (ANA) which our local chapter fully supports as a critical measure for the health of our community. ANA has consistently called for meaningful legislation to promote firearm safety, reduce gun violence, and address the public health crisis that firearms pose in the United States. Dear Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Senate Committee on Ways and Means, and Chair Rhoads, Vice Chair Gabbard, and Members of the Senate Committee on Judiciary:

The Hawai'i State Coalition Against Domestic Violence (HSCADV) addresses the social, political, and economic impacts of domestic violence on individuals, families, and communities. We are a statewide partnership of domestic violence programs and shelters.

On behalf of HSCADV and our 25 member programs statewide, I respectfully submit testimony in support of HB664 HD1 SD1, which seeks to establish the Office of Gun Violence Prevention within the Department of Law Enforcement. This bill is a critical step toward enhancing public safety, reducing gun-related violence, and providing resources for intervention and prevention efforts in our communities. It is particularly crucial for addressing domestic violence.

Research has consistently shown that the presence of a firearm in a domestic violence situation significantly increases the risk of homicide. According to studies published by the American Journal of Public Health, domestic violence victims are five times more likely to be

killed when their abuser has access to a firearm.¹ The National Coalition Against Domestic Violence also reports that in the United States, over half of all female homicide victims are killed by a current or former intimate partner, with firearms being the most common weapon used.²

By incorporating gun violence prevention into domestic violence response strategies, HB664 HD1 SD1 can help save lives by promoting education on firearm-related risks in abusive households, facilitating legal protections such as firearm relinquishment for individuals with domestic violence restraining orders, and providing resources for victims seeking safety.

These provisions will enhance public safety and provide communities with the tools and resources needed to address gun violence proactively. Prevention-based approaches, such as those outlined in HB664 HD1 SD1, have been proven to reduce violence in other jurisdictions, and Hawai'i can benefit significantly from similar strategies.

I respectfully urge this committee to pass HB664 SD1 and take this important step toward reducing gun violence and protecting domestic violence survivors in our state.

I serve as the President of the State of Hawaii Organization of Police Officers ("SHOPO") and write to you on behalf of our Union in support of HB 664 SD1, which seeks to establish the Office of Gun Violence Prevention within the Department of Law Enforcement. This bill represents a significant step forward in our collective efforts to address and mitigate gun violence in our communities. The key provisions of this bill:

- creates an Office of Gun Violence Prevention, which will serve as the principal entity responsible for the development, performance, and control of programs and policies aimed at reducing gun violence in Hawaii;
- mandates the office to conduct culturally appropriate public awareness campaigns. These campaigns will educate residents about safe gun ownership, reporting lost or stolen firearms, and accessing mental health resources, among other critical topics.
- establishes a grant program to support community-based gun violence intervention initiatives. These initiatives are designed to interrupt cycles of gun violence and trauma without contributing to mass incarceration.
- calls for the creation of a resource bank to serve as a repository for data and research on gun violence. This will facilitate collaboration with researchers to identify data gaps and improve evidence-based prevention tools.
- establishes a Gun Violence Prevention Special Fund to finance these initiatives, ensuring that the office has the necessary resources to fulfill its mandate.

The establishment of the Office of Gun Violence Prevention is a proactive measure that will enhance the safety and well-being of Hawaii's residents. By centralizing efforts and resources, the office will be better equipped to coordinate statewide initiatives, foster community partnerships, and implement effective strategies to reduce gun violence.


We don't need another layer of tax funded programs. We have existing laws to handle any issues we have now.

My name is Erica Yamauchi, and I live in the Kaimukī area. As a gun violence survivor, business owner, mother of two children in our public schools, and adjunct faculty member at the University of Hawai'i. I also serve as volunteer state co-lead of the Hawai'i chapter of Moms Demand Action. On behalf of our three local groups on Hawai'i Island, Kaua'i and O'ahu, and our 2,000+ supporters across the islands, **I'm writing today in strong support of House Bill 664.**

These bills would create a state Office of Gun Violence Prevention, bringing Hawai'i in line with our peer gun safety states that already have such offices, including California, Washington, Massachusetts, New York and Illinois.

With the increase in gun violence we have witnessed in our state over the last decade, including a mass shooting in Wai'anae last year and a shootout just a few days ago in Waikīkī, we need to ensure that we're approaching this crisis from every possible angle.

A statewide office will be able to direct, coordinate and support the state's gun violence prevention efforts at multiple stages – from collecting and tracking data to inform policy, to increasing public awareness of secure storage and extreme risk protective orders (ERPOs), to administering funding to lifesaving community violence intervention programs that prevent shootings.

Our lower incidence of gun violence historically here in the islands hasn't been by accident, but due to sound public policy and commonsense gun safety laws. We urge you to pass this bill.

Comments:

Aloha,

I write to you today as the President of the Hawaii Rifle Association to express our strong opposition to House Bill 664, which seeks to establish the Office of Gun Violence Prevention within the Department of Law Enforcement.

While the Hawaii Rifle Association supports genuine efforts to enhance public safety, we have serious concerns that HB 664 is a political gesture rather than a practical solution to reduce violent crime. The proposed Office of Gun Violence Prevention is not only unnecessary but would also serve as a bureaucratic tool to further infringe on the rights of law-abiding citizens.

Primary Concerns:

1. Duplicative and Unnecessary Bureaucracy:
 - o The State of Hawaii already possesses extensive mechanisms for addressing crime and violence through the Department of Law Enforcement and existing law enforcement agencies.
 - o Creating a new, politically-driven office would only divert valuable resources away from effective crime prevention and place them in a redundant entity with no real authority to combat violent crime.
2. Misplaced Focus on Legal Gun Owners:
 - o Despite the bill’s language about community-based interventions, the reality is that most of the attention will be directed toward regulating lawful firearm ownership rather than addressing actual criminal behavior.
 - o The focus on gun violence prevention should be on targeting illegal firearms and criminal misuse, not imposing additional layers of regulation and restrictions on responsible gun owners who already comply with some of the strictest regulations in the nation.
3. Funding Misappropriation:
 - o HB 664 allocates funds to organizations with agendas that may not reflect the needs or values of Hawaii’s lawful firearms community.
 - o Without clear oversight or accountability measures, the proposed grant program could easily become a slush fund for politically-motivated organizations that promote restrictive and punitive policies against law-abiding citizens.
4. Data Manipulation Concerns:

- The creation of a resource bank of data and research is framed as a neutral initiative. However, experience has shown that selective data collection and biased research can be used to justify unconstitutional restrictions on firearm ownership.
 - There are already extensive studies and data available from reputable institutions, including the FBI and CDC. Establishing a state-run database that selectively focuses on gun-related incidents, without considering broader criminal factors, undermines objective analysis.
5. Lack of Meaningful Crime Prevention Measures:
- If the intent of this legislation is truly to reduce gun violence, then the focus should be on enforcing existing laws, increasing penalties for criminal use of firearms, and enhancing mental health resources.
 - Instead, this bill proposes to funnel money into community-based initiatives with vague goals and questionable effectiveness, while ignoring proven strategies that target criminal activity directly.

Conclusion:

HB 664 is a misguided effort that ignores the root causes of violent crime and instead focuses on creating an unnecessary government office that will waste taxpayer dollars and target law-abiding citizens rather than actual criminals.

The Hawaii Rifle Association urges you to reject HB 664 and instead pursue policies that focus on prosecuting violent offenders, improving mental health services, and enhancing law enforcement resources to combat crime effectively.

While I agree with the intent of the bill to help reduce gun violence in the state, I have grave concerns that given the State's anti-gun bias that this office will be weaponized with the goal to tweak information to support anti-gun laws, as has been seen in similar offices throughout the nation.

I've recently been informed that we actually already HAVE an Office of Gun Violence Prevention, which shows how effective such offices can be since apparently not only myself, but even the legislature didn't know about it until someone in the Prosecutor's office mentioned it. Since it seems people are hellbent on pushing this through, I hope I am genuinely wrong and that this office will actually make some meaningful progress towards reducing gun violence here in Hawaii that doesn't involve drafting legislation that will infringe on citizens' gun rights.

Recently there have been cases where anti-gun groups have submitted manipulated data to similar offices with the goal of promoting further infringements on the Second Amendment. One includes the often repeated, and disproven statement that guns are now the leading cause of death for children. Among other offenses, the data was manipulated to include people up to the age of 25 as 'children', included instances of gang on gang violence where the only victims were rival gang members, and included instances of justified police shootings. The mentioned study has been fact checked by several sources and found to be false despite it being touted by the former Presidential Administration. **Simply altering the study to only include persons under the age of 18 debunked the claim that firearms are the leading cause of death in children.**

Another instance resulted in the ending of a popular and successful program that was having positive effects on reducing gun violence. **Giffords Law Center**, who has the stated goal of wanting to reduce gun violence, did a study on a program known as '**Oakland Ceasefire**'. **In their findings it was discovered that the program reduced gun violence in Oakland by 50%**, and in 9 other cities that had similar programs reduced crime from 30% to 60%. The Oakland Ceasefire program relied upon Community Outreach and Mentorship programs for at-risk youth, as well as enforcement and prosecution of current laws.

Giffords is being accused of trying to hide the study from the public, and of using their influence to end the highly successful program because it undermined the message that the only way to reduce gun violence is to get rid of guns. **Even if these accusations are false, the reality is inconsistent with their stated goal as there is little to no fanfare regarding such a successful program.**

The office is tasked with conducting public awareness campaigns and community education initiatives. Without clear guidelines, this risks turning into one-sided messaging that does not respect Hawaii’s cultural diversity or the rights of lawful gun owners. Public education must be objective, not advocacy-driven.

5. Questionable Impact on Public Safety

Evidence from other states suggests that creating more administrative offices does not

necessarily translate to reduced gun violence. Effective interventions require a holistic approach involving community engagement, law enforcement, mental health services, and education—not simply the formation of another agency.

For these reasons, I respectfully urge you to reconsider and vote **NO** on HB664 SD1. Let us focus on reinforcing existing efforts, supporting community-based solutions, and respecting both public safety and constitutional rights.

I am writing to strongly oppose this proposed measure. I will point out a few of the several reasons to oppose it below.

First and foremost is redundance. It may come as a surprise that Hawaii already has the Gun Violence and Violent Crimes Commission (GVCC), enacted by Act 74 during the 2020 regular session and codified in Hawaii Revised Statutes § 134C et seq., the GVVCC's purpose is to provide coordination, facilitation, and planning among state and county agencies, federal agencies, and other appropriate partners to reduce gun violence and violent crimes. The commission's objectives include identifying relevant data, maximizing data sharing among agencies, and coordinating research on gun violence and violent crimes. This proposed measure indicates that the GVCC is so ineffective that we need yet another commission, or the current legislature is unfamiliar with the current HRS and their oversight responsibilities. Neither of these provide any support to moving this measure forward, unless the legislature is intentionally deciding to establish a duplicative commission which is obviously a waste of State resources and the tax dollars the citizens of Hawaii pay. In case you are unaware of current events, most US citizens are tired of government waste and this measure is exactly that.

Second, the promotion of special interest agendas by the State. These commissions are rarely comprised of balanced membership. I think we can all agree the "experts" who will chair and staff this commission will have strong ties to anti-gun special interest groups. This is an example of the State choosing "winners & losers" to promote an agenda. Those who oppose this agenda will see their tax dollars utilized to degrade our Constitutional right to keep and bear arms. As you are all well aware, criminals do not follow the law so passage of yet another law that restricts law abiding citizens does absolutely nothing to make us safer.

Third, is cost and effects on our already high cost of living. The proposed measure indicates there are many grants this commission with oversee.
