HB 72 - RELATING TO PHARMACY

Chair Takayama, Vice Chair Keohokapu-Lee Loy and Members of the Committee:

Thank you for the opportunity to submit testimony on HB 72. The University of Hawai'i at Hilo (UH Hilo) supports HB 72, which will require the registration of pharmacy technicians through the Department of Commerce and Consumer Affairs. Pharmacy technicians are career professionals working under the supervision of a pharmacist, and have an essential role in the daily operation of pharmacies.

Hawai'i is the only state that does not maintain a list of practicing pharmacy technicians. Legislation to address this oversight is important for supporting public health and safety by ensuring that these essential health care workers have the appropriate background and supervision, can receive timely communications and updates regarding relevant practice and regulation changes that impact their work, and facilitate access to training opportunities as the scope of practice of pharmacy technicians expands nationwide.

We would like to clarify that pharmacy technicians are professionals and represent a distinct category from pharmacy interns who are students in training to become future pharmacists. As career professionals in the health care workforce, pharmacy technicians perform functions under the supervision of pharmacists and may include roles such as dispensing medications, processing insurance claims, and with additional certifications, administering vaccines to patients. As career professionals in the health care workforce, the registration of pharmacy technicians is warranted and appropriate for the level of responsibility and trust afforded by the public.

Honorable Chair Takayama, Vice Chair Keohokapu-Lee Loy, and Members of the Committee,

The Hawai'i Pharmacists Association (HPhA) strongly supports HB72, which will require the registration of pharmacy technicians through the Department of Commerce and Consumer Affairs. Currently, Hawai'i is the only state in the nation without an active and managed registry of practicing pharmacy technicians. This lack of oversight presents challenges in ensuring consistent training, competency, and accountability within the pharmacy technician workforce. By mandating a registration process, HB72 enhances patient safety, improves workforce standards, and aligns Hawai'i with national best practices.

Pharmacy technicians play an essential role in supporting pharmacists and ensuring the safe and efficient delivery of medications. Under the supervision of a pharmacist in the community setting, pharmacy technicians can fill and dispense medications, process insurance claims, and with additional training, administer vaccinations. In the hospital setting, we rely on pharmacy technicians to support the compounding of intravenous medications and to stock medication cabinets and other medication delivery systems.

As the roles of pharmacy technicians expand across the country, including here in Hawai'i, it's vital to ensure these essential workers meet a baseline level of competency to ensure patient safety and enhance patient care. Additionally, establishing a technician registry will create a vital data repository that enables clear communication of regulatory and practice updates, ensuring the workforce remains aligned with evolving state and federal requirements.

HPhA believes that HB72 is a crucial step toward strengthening Hawai'i's pharmacy infrastructure and ensuring that pharmacy technicians can continue to serve patients with the highest level of professionalism and safety. We suggest the following minor amendments:

- Deletion of the duplicative "registered pharmacy technician" in Section 2
- Creation of three new definitions to designate between registered pharmacy technicians, pharmacy interns, and auxiliary personnel in Section 2
- Removal of 'continuing education requirements' in Section 5 as requirements are not specified elsewhere within the bill

Dear Chair Takayama, Vice Chair Keohokapu-Lee Loy, and Members of the Committee on Health:

Walgreens submits these **comments** in support of H.B. 72 and offers suggested amendments.

Walgreen Co. ("Walgreens") operates stores at more than 9,000 locations in all 50 states, the District of Columbia, and Puerto Rico. In Hawaii, Walgreens has 13 stores on the islands of Oahu and Maui.

Pharmacy technicians play an important role in the pharmacy setting by handling a range of tasks that allow pharmacists to focus on more complex responsibilities like patient consultations and clinical services. For example, pharmacy technicians can assist pharmacists with the preparation, dispensing, and managing of patient medications. Typically, pharmacy technician tasks include filling prescriptions, labeling and packaging medications, managing medication inventory, and performing administrative duties such as record-keeping and insurance processing.

The 2024 Legislature passed Act 104 that allows, in part, pharmacists, pharmacy technicians and pharmacy interns the ability to administer immunizations and vaccinations to persons three years and older under the direct supervision of a pharmacist. This measure builds upon Act 104 to require that pharmacy technicians are registered by the state.

In Hawaii, pharmacy technicians are not currently regulated. This important measure will bring a regulatory framework to the critical role that pharmacy technicians fill, which Walgreens supports. We suggest several amendments to clarify the different roles of pharmacy personnel, including roles that don't perform the duties of a pharmacy technician.

First, Walgreens is concerned that this bill as introduced is overly broad in its definition of "registered pharmacy technician." As drafted, this definition would capture all pharmacy personnel behind the pharmacy counter, including those personnel such as cashiers whose responsibilities are purely clerical in nature. To address this concern, Walgreens suggests adding on page 3, section 2 of the bill a new definition for "Auxiliary Pharmacy Personnel" as follows:

"Auxiliary pharmacy personnel" means a person who works in a pharmacy assisting a registered pharmacist and registered pharmacy technicians, who may perform the following tasks: (1) retrieval tasks such as retrieving prescriptions or files, (2) clerical tasks such as data entry, typing labels, and maintaining patient profiles, (3) tasks including selling prescriptions, telephoning, filing, and typing, (4) accounting tasks such as record keeping, maintaining accounts receivables, third party billing and posting, (5) inventory control tasks including monitoring, pricing, dating, invoicing, stocking pharmacy, and preparation of purchase orders, and (6) help maintain a clean and orderly pharmacy.

Second, to clarify the specific duties of a pharmacy technician, Walgreens also suggests the following amendments to the definition of "Registered pharmacy technician," which is language used in other states that regulate pharmacy technicians and better clarifies their duties, at page 3, section 2, lines 4-10 as follows:

"Registered pharmacy technician" means a person, exclusive of pharmacy interns and auxiliary pharmacy personnel, registered with the board who may in addition to the tasks of an auxiliary pharmacy personnel, perform filling, packaging, manipulative, repetitive, or other nondiscretionary tasks, and tasks specified in Section 461-11.4, only while assisting and while under the direct supervision and control of a pharmacist [is utilized in pharmacies and whose responsibilities are to provide nonjudgmental technical services concerned with the preparation for dispensing of drugs under the direct supervision and responsibility of a registered pharmacist].

Third, Walgreens suggests the following amendment at 3, section 2, line 10 as follows:

"Supervision" means the [observation], direction, and oversight [overseeing] of a registered pharmacy technician or pharmacy intern by a physically present, responsible registered pharmacist at all times when either party performs acts specified in this chapter or rules adopted pursuant to this chapter."

In the pharmacy setting, the word "observation" implies a direct line of sight by the pharmacist over the pharmacy technician or pharmacy intern. In the case of vaccinations, a technician may be in the patient room administering a vaccination while the pharmacist is behind the counter. This is still considered "direct

supervision" in the pharmacy setting but does not require the technician to be in their line of sight.

Last, we would also suggest replacing the language on page 8, lines 3-8, at subsection (c) to establish the specific functions of a pharmacy technician by statute versus by administrative rule:

(c) A registered pharmacy technician may be employed to perform filling, packaging, manipulative, repetitive, or other nondiscretionary tasks, and the tasks specified in Section 461-11.4, only while assisting and while under the direct supervision and control of a pharmacist and under rules adopted by the board pursuant to chapter 91. [A registered pharmacy technician may be employed to assist the registered pharmacist under rules adopted by the board pursuant to chapter 91 that define the qualifications and functions of the registered pharmacy technician and provide the procedures for control and supervision by a registered pharmacist.]
