**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent of the measure, defers to the Department of Education, and provides comments. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget.

Bill Title: HB 0754 RELATING TO COMMUNITY SCHOOLS.

**Purpose of Bill:** Appropriates funds to the Department of Education for community schools and a program manager position.

#### **Department's Position:**

The Hawaii State Department of Education (Department) supporting the intent of HB 754, provided that it does not affect the priorities identified in the Board of Education approved budget.

The Department supports the implementation of community schools programs to provide high-quality educational opportunities by focusing on the whole child, their family, and their community when providing educational experiences for our students. To accomplish this, the community school model requires the support of school staff, teachers, families, and communities. Creating these partnerships and valuable relationships enrich students and their surrounding communities.

Currently, the Department requires that the schools designated under federal requirements as Comprehensive Support and Improvement with More Rigorous Interventions (CSI-MRI) move to a full-service community schools model. CSI-MRI schools have been identified as the lowest performing schools in need of support for their students. To bolster the support, one of the requirements of the CSI-MRI schools is to partner with community organizations to implement the community schools approach fully. The Department also has a Memorandum of Agreement in place with the Hawaii Afterschool Alliance, who provides support to our schools who are currently implementing a community schools model.

In this work, we have seen firsthand the impact of community schools. ### HOUSE BILL 754, RELATING TO COMMUNITY SCHOOLS

### FEBRUARY 6, 2025 · EDN HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 754, relating to community schools, which appropriates funds to the Department of Education for community schools and a program manager position.

Policymakers should promote education programs that deliver wraparound care for students and deal with educational "inputs" that impact student success, like poverty and access to healthcare. An example of such a program is the community schools model of education, which as noted in Hawai'i's Consolidated State Plan under the Every Student Succeeds Act, is a research-based strategy for school improvement that emphasizes high-quality teaching, culturally relevant curricula, wraparound student supports, positive disciplinary practices and restorative justice, parent and community engagement, and inclusive school leadership.

In prioritizing student wellness, community schools have been shown to increase learning growth and graduation rates, while decreasing behavioral referrals and chronic absenteeism. In New York City, for example, community schools that highlight mental health counseling and consistent family outreach have seen chronic absenteeism rates fall by 7.8 percent as of 2017, with graduation rates rising 4.8 percent. Engaged learners are more like to acquire the skills necessary to become active citizens and productive members of the workforce. Additionally, since even the

most affluent and well-adjusted children face challenges in their maturation processes, guaranteeing that schools have the resources to respond to childhood pressures and trauma with compassion and sensitivity may make the difference between sending a student to college or losing them to social threats, like substance abuse or our state's prolific sex trade.

As the National Education Association states, "Community Schools transform traditional public schools into neighborhood hubs that mobilize students, staff, families and community members to reimagine education and co-construct a shared vision for their school and community. Community Schools are developed with the understanding that every community is different." Community schools rely on integrated student supports, expanded and enriched learning opportunities, active family and community engagement, and collaborative leadership to strengthen educational outcomes. Currently, 25 community schools exist in our state.

Mahalo for the opportunity to provide comments on this topic. For nearly a decade, one of the Harold K.L. Castle Foundation's goals has been to help Hawaii's youth fulfill their most ambitious dreams, by placing public school students on a path to success with college credits and relevant career experiences. To help meet this goal, we've invested in student supports that complement existing school structures, such as expanded summer counseling and family engagement around college and careers pathways.

This mission became even more urgent in the wake of the pandemic, which wiped out more than two decades of progress in reading and math—disproportionately impacting students from low-income communities. Also exacerbated, were longstanding health and economic inequities in vulnerable neighborhoods.

Amid these challenges, federal funding created a once-in-a-generation opportunity to rethink how schools serve students and their communities. Public schools had the chance to transform into *community schools*, places that go beyond good teaching and learning to also support student's health and social needs, expand learning time to out-of-school time and the summer, and actively engage families and the community.

Here in Hawai'i, what began as three community schools in Kohala in 2019, has now rapidly grown to 26 schools, most of which are located in rural and remote regions of the state. These schools are supported by the Hawaii Afterschool Alliance (HAA) that convenes the Hawai'i State Coalition for Community Schools.

We provided a three-year grant to HAA (\$75,000) to help evaluate the impact of the community schools model in twelve public schools across Hawai'i, provide a roadmap for implementation, and share out learnings with the broader education community. Our hope is that this will provide evidence for sustained and consistent public funding for community schools.

At their core, the community schools model helps to remove barriers to learning by connecting students with essential resources—business partnerships, health and social services, parent organizations, and community volunteers—all within the school itself. By addressing a broad spectrum of student needs, particularly for those facing the greatest challenges, these schools create a learning environment where every student has the opportunity to thrive.

We applaud the committee for considering this bill in support of community schools. The Harold K.L. Castle Foundation remains committed to supporting Hawaii's students and schools.

In Hawai'i, full-service community schools are innovative, thriving hubs of learning in which partnerships and collaboration create a'o aku, a'o mai, reciprocal relationships between learners and place, content and context, and schools and communities.

Community schools is a proven, time-tested strategy that can bring forth short term results like improving family engagement and attendance and decreasing behavioral referrals. It is also proven to show long term results like closing the achievement gap, improving academic scores and graduation rates.<sup>1</sup>

There are currently 26 community schools in Hawai'i across four islands that are mobilizing their community partners, families, students, and school staff to ensure that all students thrive in their school community. Each school has a Community School Coordinator who facilitates the co-creation of innovative strategies and are building a system of support to address the barriers students and families face. These innovative strategies fall under the following key practices:

- Collaborative leadership, shared power, and voice;
- Expanded, enriched learning opportunities;
- Rigorous, community-connected classroom instruction;
- Culture of belonging, safety, and care;
- Powerful family and student engagement;
- Integrated systems of support; and
- Grounded in Hawai'i.<sup>2</sup>

As a community member invested in supporting my children's education from birth I have grown alongside my children through a Family and Early Childhood Education program called Na Pono No Na Ohana located at Blanche Pope Elementary in Waimānalo. Over time I have worn various hats in our community leading me to accomplishing my BSW and returning to the school where it all started and where my Ohana have been students for over four generations, as the Community School Coordinator at Blanche Pope Elementary ame Ke Kula Kaiapuni O Wainānalo. Through my lived experiences I have seen what works in and for our community. The Community School strategy and framework brings together stakeholders within the community and school in order address matters through collaborative leadership, shared power and voice, expanded and enriched learning opportunities, rigorous, community-connected classroom instruction, culture of belonging, safety, and care, integrated systems of support, powerful student and family engagement, and grounded in Hawai'i. Through the Community School strategy and framework there is significant opportunity in building strong, flourishing schools and communities through sustainable resources, shared governance, continuous improvement, data systems, professional learning opportunities, and strategic partnerships.

Over the past year and a half as the Community School Coordinator here at Blanche Pope Elementary ame Ke Kula Kaiapuni O Waimānalo I have learned that this strategy has a long way to go. Support for Community Schools embedded in the system of education can only benefit our schools and communities across the pae aina. Building a hub, support, and open space for school, families, and community to share and collaborate while focusing on a shared vision and towards a common goal.

Here are some things to know about Hawai'i Community Schools:

- In Hawai'i, community schools are innovative, thriving hubs of learning in which partnerships and collaboration create a'o mai, a'o aku, reciprocal relationships between learners and place, content and context, and schools and communities.
- Community schools intentionally connect schools, 'āina, indigenous and contemporary knowledge and ensure that learners belong to a thriving community.
- Systems of support form the foundation for community schools that are rooted in organizing resources towards the success of learners, families, and communities.
- Hawai'i-based community schools reflect who we are, how we live, and what we aspire to become.
- The intended outcomes of Community Schools in Hawai'i are:
  - Thriving learners, educators, families, 'āina, and communities are supported by nurturing networks that promote reciprocity.
  - Innovative, thriving hubs of learning that incubate and connect Indigenous wisdom and contemporary knowledge to create and meet local and global opportunities.

- A time-tested strategy for social and civic needs: Community Schools are a timetested strategy for connecting students to the supports they need to thrive. - A strategy that believes in people: In Community Schools, every family and community member is an asset. Each person's skills, talents, and generosity of time are utilized to build on students' strengths, engage them as learners, and enable them to reach their full potential.
- Community Schools are an investment in children, families, and our shared future. Quality Community Schools support higher student achievement and graduation rates and lead them to become contributing members of society by increasing opportunities for ALL students.
- CS is a strategy for transforming high-poverty, low-performing schools into thriving schools. With schools so often serving as centers of community life, transforming schools can lead to transformed communities.

- Community Schools are able to mobilize their community in times of uncertainty or hardship, through well-established partnerships built on trust. These partnerships can often ensure that basic needs, and other necessities are still available to those who need them.
- A CS strategy puts more power in the hands of parents and families.
- Kids and families do better when communities work together. More public funding can ensure that ALL students and families benefit from the holistic framework that Community Schools offer--including urban, suburban, and rural communities. It is also a great way to address the needs of parents and students who need specialized support--such as children with disabilities and English language learners.
