- 1 **Fiscal Implications:** The Department of Health (DOH) defers to the Department of Education
- 2 (DOE) for fiscal implications of implementation.
- 3 Department Position: The DOH offers comments on House Bill 757 (H.B. 757), which requires
- 4 and appropriates funds for the (DOE) to provide free breakfast and lunch to all students
- 5 enrolled in DOE schools regardless of a student's eligibility for participation in the national
- 6 school lunch program.
- 7 Department Testimony: Proper and adequate nutrition is essential for student focus,
- 8 classroom engagement, and academic success. Students who are food insecure and do not
- 9 have access to consistent, healthy meals are at increased risk for stress, anxiety and depression,
- and chronic diseases. Providing universal free school meals enhances the nutritional intake of
- 11 students and promotes equitable access to the opportunity to learn and engage in school.
- 12 The National School Breakfast and Lunch programs are vital, but currently fail to reach 13 every food insecure child in need in Hawaii. One in three families in Hawaii is food insecure, and 14 one in ten households reported going without food for a whole day for some or most months of 15 the year.¹ Hawaii's current eligibility threshold for participation in the free school breakfast and

lunch program (less than \$47,000 for a family of four) stands in stark contrast to the estimated
\$110,000 needed to cover the basic cost of living in Hawaii.² Many students, including those
from asset-limited, income-constrained, employed (ALICE) households, start their schooldays
hungry and nearly half (46%) of ALICE households struggle with consistent food access.³
Additionally, our students themselves report going hungry because there was not enough food
in their home.⁴

A new federal proposal of \$12 billion in cuts to school meals could drastically reduce the number of schools able to offer free meals through the Community Eligibility Provision (CEP), which includes an estimated 52 schools and 27,018 students in Hawaii.⁵ Providing universal free school meals ensures that Hawaii's keiki have equitable access to healthy, nutritious meals and drastically reduces the administrative burden on both families and the DOE caused by the current requirement to demonstrate income and need.

- If Hawaii adopts H.B. 757, we would be joining eight other states that are using the
 universal school free schools meals program to reduce hunger and ensure children have the
 support and access they need to healthy, nutritious meals to enhance their health, well-being,
 and academic success.

Bill Title: HB 0757 RELATING TO EDUCATION.

Purpose of Bill: Beginning with the 2025-2026 school year, requires the Department of Education to provide free breakfast and lunch to all students enrolled in department schools. Appropriates funds.

Department's Position:

The Hawaii State Department of Education (Department) supports the intent of HB 757.

The school meal program operates in each of the Department's non-charter schools and offers meals to its students in elementary through high school. The Department understands the importance of child nutrition and its role in improving overall student health and agrees that children should have adequate meals provided to them, including breakfast and lunch. It supports universal meals if the State can subsidize what is not received through Federal claim reimbursements.

Additionally, the Department supports maximizing opportunities for student access to school meals by examining appropriate meal service models, such as breakfast in the classroom or Grab and Go. Second-chance breakfast is presently implemented in the school meal program.

Currently, the Department is working to calculate what the potential cost might be of providing universal free school breakfast and lunch.

The Department appreciates this proposal and the inclusion of funding but asks that any additional funding does not affect the Governor's approved budget requests.

Aloha Chair Woodson, Vice Chair La Chica and Members of the Committee,

I am Benson Medina, Director of the Department of Research and Development, County of Hawai'i. One of the agricultural objectives of this department is to "support collaboration, innovation, resource development, and programmatic sustainability throughout the food system to reduce food waste, improve producer viability and resilience, develop workforce development pathways, or increase access to locally produced food among low-income residents."

The County of Hawai'i provides written testimony in **STRONG SUPPORT of HB757**, requiring the Department of Education to provide free breakfast and lunch to all students enrolled in department schools.

The Hawai'i County Council has demonstrated its commitment to free school meals by adopting Resolution 42-25, urging the Hawai'i State Legislature to establish a universal free school lunch program for public school students, prioritizing local sourcing and regional procurement. This resolution highlights the pressing need to ensure that all students have access to nutritious meals essential for academic success and personal well-being, regardless of socioeconomic status.

Hawai'i County faces the highest rates of food insecurity in the State, with an alarming 40% of households reporting food insecurity in a 2023 study commissioned by Hawai'i Foodbank. The cost of school meals poses a significant barrier to accessing balanced nutrition for many students; two out of three struggling families in Hawai'i are ineligible for free school meals due to strict eligibility thresholds (HIPHI, 2024). Implementing universal free school meals would ensure that all students receive the nourishment they need, regardless of household income, thereby combating hunger and its associated negative impacts on health, well-being and learning outcomes.

Additionally, implementing universal free school meals provides an opportunity to support local farmers through Farm-to-School initiatives. Increasing school meal participation enables the

February 10, 2025 Page 2 HDOE to incorporate fresh, locally grown produce into school meals. Thus, providing students with healthier, more sustainable food options while bolstering Hawai'i's agricultural economy.

HOUSE BILL 757, RELATING TO EDUCATION

FEBRUARY 11, 2025 · EDN HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 757, relating to education, which, beginning with the 2025-2026 school year, requires the Department of Education to provide free breakfast and lunch to all students enrolled in department schools.

Hungry children can't learn.

A recent study released by the National Bureau of Economic Research focused on the federal National School Lunch Program's Community Eligibility Provision, which allows schools where many students qualified for free or reduced-price meals to provide a free meal to all students. The study examined whether the provision of schoolwide free meals through the Community Eligibility Provision impacted school suspension rates and <u>estimated that the chances of being</u> <u>suspended multiple times fell in both elementary school and in middle school.</u>

Moreover, a 2021 study by the Brookings Institute found that schoolwide free meals improve math performance. This is further bolstered by research conducted by the Food Research and Action Center, which has noted that <u>students who participate in school breakfast programs have</u> <u>improved attendance, behavior, academic performance, and achievement.</u> Studies have clearly demonstrated the link between school meals and student success, which is especially

important as schools and educators continue to strategize how to combat the lingering loss of opportunity to learn caused by the COVID-19 pandemic.

Furthermore, improving access to school meals will boost overall health outcomes, both now and in the future. Thirty million students rely on schools to provide them with breakfast and lunch every day in the United States. Those who participate in the school meal program consume breakfasts and lunches of higher nutritional quality than nonparticipants and are more likely to eat fruits and vegetables. Participation in the school breakfast program is associated with lower body mass index (BMI), lower probability of being overweight, and a lower likelihood of obesity. More Americans are sick than they are healthy: half of adults have diabetes or prediabetes; more than half of adults have cardiovascular disease; and 3 in 4 adults are overweight or obese. Healthcare costs account for 29 percent of state budgets and 28 percent of the federal budget.

As the National Education Association has stated, through universal free school meals programs, "We can grow generations of healthy eaters and save our country billions." School meals cost less per student when more students participate in a free meal program. An article in *Nutrients* entitled "Universal Free Meals Associated with Lower Meal Costs While Maintaining Nutritional Quality" found that <u>schools that participated in a universal meal program spent 67 and 58</u> <u>cents less per lunch and breakfast</u>, respectively, while maintaining the same nutritional quality.

Nutrition is essential to academic success. This bill will help to ensure that Hawai'i's keiki are healthy and ready to reach their full potential.

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of HB 757**. This bill, beginning with the 2025-2026 school year, requires the Department of Education (DOE) to provide free breakfast and lunch to all students enrolled in department schools and appropriates funds.

Hawai'i public schools provide students with access to meals through the federal National School Lunch Program and School Breakfast Program. Currently, students qualify for free school meals if their families earn up to 130% of the federal poverty level (FPL) and for reduced-price lunch if their income is between 130% and 185% of the FPL.

Many families who have to pay the full price for school meals struggle to make ends meet. For example, a family of four that makes \$67,000 per year doesn't qualify for free or reduced-price lunch,¹ while the ALICE household survival budget to be able to afford the "bare-minimum costs of basic necessities" for that same family nearly \$108,000.² If that family has two students eating breakfast and lunch at school, they pay about \$1,300 per year for those meals.

The case for universal free school meals is strong.³ Schools benefit from reduced administrative burdens and costs because they no longer need to collect and track meal payments. Students see better academic performance and nutrition. Currently 94 DOE schools already provide universal free meals.⁴

If DOE were to provide **free breakfast and lunch to all students**, and there was no increase in meal participation, we estimate it would cost about **\$19.2 million per year**. We based our calculations on the free, reduced-price and paid student participation in school meals in Hawai'i during the 2018-19 school year⁵ (before the pandemic disrupted participation rates) and the current school meal prices.

From kindergarten to senior year, I attended public schools here on O'ahu. I remember carrying lunch money each day then eventually having a meal card that had to be filled with funds. I was very fortunate to be able to buy school meals whenever I wanted, but if I ever forgot my money or card or didn't realize my funds were insufficient, not being able to buy and eat lunch would be a major disruption to my day. For some kids, not being able to buy lunch is their reality more often than not. All kids should be able to eat while in school (where they are required to be) regardless of their family's ability to pay.

Universal free school meals can provide meals to students who may otherwise not eat at all. For just 1% of the DOE budget we can ensure every student gets the meals they need while in school. I would be happy for my tax dollars to fund this. Ensuring our keiki are fed today is an important investment for our future. It would also greatly help working class families.

Following the example of Christ who fed crowds not just with spiritual food but also with physical sustenance, we support free school meals! When bodies are nourished, brains can be nourished. We cannot expect to provide quality education if we are neglecting to nourish the full person.

Aloha,

We, PD 6 Castle High School MOW II students, strongly support providing free school lunch to every student, as outlined in the proposed bill. We believe this initiative is crucial for the wellbeing and academic success of all students in Hawai'i. Our previous testimony highlighted the financial struggles many families face, and this proposal offers a vital solution.

Key Points in Support of Free School Lunch:

- **Easing Financial Strain:** Previously proposed increases would impact the cumulative effect of rising costs in Hawai'i, especially the 80-90% increase in school lunch prices over five years, which would place immense pressure on household budgets. This increase, which saw high school lunch prices rise to \$5.00 and elementary/middle school prices to \$4.75, would force families to make difficult choices. Free school lunch eliminates this burden, freeing up family resources for other essential expenses like housing and transportation. For example, a family with one high school student and one elementary student could save approximately \$732 annually.
- **Supporting Low-Income Families:** Our earlier testimonies emphasized how lowincome families are disproportionately affected by rising costs. Free school lunch ensures that all students, regardless of their family's financial situation, have access to a nutritious meal. This is particularly important in Hawai'i, where many families are living paycheck to paycheck and struggling to make ends meet. As one student shared, making only \$300 a week with \$250 going to necessities makes it difficult to afford increased school meal costs. Free lunch would alleviate this stress.
- **Promoting Educational Equity:** Students who are hungry struggle to learn. Providing free school lunch removes a significant barrier to learning for students from low-income families, promoting greater educational equity. When students are well-fed, they can focus on their studies and achieve their full potential.

- **Improving Student Health:** Nutritious meals are essential for student health and development. By ensuring access to healthy meals that meet federal nutritional guidelines (7 CFR 210.10), free school lunch contributes to improved student health and well-being. Our previous testimonies mentioned concerns about the current quality and portion sizes of school meals; this initiative, coupled with the nutritional guidelines, will address these concerns.
- **Reducing Stigma:** Providing free meals to all students eliminates the stigma associated with receiving free or reduced-price lunch. This creates a more inclusive and supportive school environment for all students.

We believe that providing free school lunch to all students is a vital investment in the future of Hawai'i. It will improve student health, reduce financial strain on families, enhance academic performance, and create a more equitable learning environment. We urge the Board of Education to fully support this initiative.

Student Testimony Regarding Proposed FREE School Meals

Aloha,

We, DOE high school students in MOW II PD 1, strongly *support* the provision of free school meals. We believe that access to nutritious school meals is essential for all students, and providing these meals at no cost will eliminate the significant hardship that paying for meals creates for many families in Hawai'i.

Key Concerns:

- **Unreasonable Price Increases:** The previously proposed increases are excessive and will place an undue burden on families. Elementary/middle school lunch costs have already increased by 90%, and high school lunch costs by 82%. These increases are particularly concerning given the already high cost of living in Hawai'i.
- **Impact on Low-Income Families:** Many families in Hawai'i are struggling to make ends meet. As one student shared, "I know a lot of families that don't make enough money to even pay their bills on time and have money to feed their families." These price increases will force difficult choices, potentially leading to students skipping meals. Students have expressed concern that "kids in high schools have to skip lunch so their younger siblings can have money to eat and so their parents can pay their bills."
- Negative Impact on Student Health and Academic Performance: If students cannot afford school lunch, their health and academic performance will suffer. "If these prices increase it will most likely decrease the number of students who eat school lunch, which will negatively impact the students' health and academic performance." Hungry students cannot focus on learning.
- **Concerns about Food Quality and Quantity:** Students have also raised concerns about the quality and quantity of food served. One student noted, "A 90% and 82% increase is way too high because it would make the kids not want to get lunch because of how little bit of food they give us and how bad the food is." Another student described receiving a very small portion of rice and meat. Raising prices without improving the quality and quantity of food is unacceptable.
- **Exacerbating Existing Financial Struggles:** "Hawaii is already so expensive on its own they want to increase it by over 80% where people are struggling to pay the school meal price now. It just doesn't make any sense." The high cost of living in

Hawai'i makes these increases particularly damaging.

• **Personal Hardships:** Students shared personal experiences of financial strain. One student explained, "I also have a kid so I have to work harder to make enough money to buy all the things he and I need. It's ready, hard as it is but when the price is raised by 90% or even 82% it will make it 100 times harder to make enough money. I skip breakfast and lunch and mostly eat at my job so I can save money for my kid."

We urge the Board of Education to prioritize the implementation of free school meals and thereby prioritize the nutritional needs and academic success of all Hawai'i's students. We believe that access to nutritious school meals is a right, not a privilege, and that providing these meals free of charge is the best way to ensure this right for every student.

We, DOE high school students in MOW II PD 2, strongly support the proposed FREE school meals. We believe this initiative will alleviate significant financial hardship for families in Hawai'i and improve students' access to nutritious meals.

Key Concerns:

- **Excessive Financial Burden:** The previously proposed increases are substantial and will place a significant strain on family budgets. With elementary/middle school lunch prices rising by 90% and high school lunch prices by 82%, families will face a considerable increase in expenses.
- **Impact on Family Budgets:** As one student explained, "A parent with a child in elementary and high school would pay roughly an extra \$1,260" per year. A family with children in both elementary and high school would face a similar increase. This added cost can make a significant difference, especially for low-income families. "A \$500 weekly income for a low-income family (minus taxes) can barely cover the bills of weekly living expenses, let alone the new costs of school meals."

- **Potential for Severe Consequences:** The financial burden could have serious consequences for families. One student expressed concern that these increased costs could even lead to families losing custody of their children due to an inability to afford basic necessities. While this is an extreme scenario, it highlights the level of financial pressure many families are already under.
- **Disproportionate Impact on Low-Income Families:** Many families in Hawai'i already struggle financially. These price increases will disproportionately affect low-income families, making it even harder for them to provide for their children. "A couple reasons why it is bad is because many people can't afford to pay that much, especially a cost upwards of 1,000 dollars or more a year. A lot of people face financial problems and upping the price on these things puts them in a bad position."
- **Proposed Alternative:** Students suggest exploring alternative solutions, such as providing free meals to students who qualify based on specific needs. "Maybe they could make free meals for students who qualify for specific things that lead to them getting free meals. That would be the best outcome in my opinion."

We urge the Board of Education to reconsider this proposed price increase and prioritize the nutritional needs and academic success of all Hawai'i's students. We believe that affordable, nutritious school meals are essential for student well-being and academic achievement.

Aloha,

We strongly support the implementation of free school meals for all students in Hawai'i. Our previous concerns regarding proposed meal price increases highlighted the significant financial strain such increases would place on families, and we believe that free school lunch is the most effective solution to address this issue and ensure the well-being of all students.

Our Previous Concerns Regarding Price Increases:

We previously expressed serious concerns about the financial burden of the proposed 80-90% meal price hike. This increase would have raised school lunch costs to \$4.75 for elementary and middle school students and \$5.00 for high school students. For a household with two children, this would have resulted in an annual cost of approximately \$1,700, a significant jump from the current \$968. This substantial increase would have been particularly difficult for families already struggling with Hawai'i's high cost of living, including housing, transportation, and taxes. We emphasized how adding this expense would create additional financial strain, especially for those living paycheck to paycheck.

We also raised concerns about the negative impact on students' well-being. We feared that some students would be forced to skip meals, negatively affecting their health, focus, and academic performance. The increased price could have forced parents to make impossible choices between paying for food or other necessities like rent and utilities. We also pointed out that many students who do not qualify for free or reduced lunch would have struggled to afford daily meals at school.

Finally, we expressed concerns about the quality and quantity of school meals. We argued that despite the drastic price increase, school meal quality and portion sizes remained inadequate. Many students reported that the food was unappetizing, lacked nutritional value, and was often not filling. We stressed that if prices were going to rise, meal quality and portion sizes should improve significantly to justify the cost.

Why Free School Lunch is the Solution:

These previous concerns underscore the urgent need for a different approach. We believe free school meals for all students would be a better long-term investment in Hawai'i's youth. It would ensure that no student goes hungry while receiving an education, regardless of their family's financial situation. Free school lunch directly addresses the financial strain we previously highlighted, removes the stigma associated with reduced-price meals, and promotes better nutrition and academic performance for all students.

We urge the Board of Education to prioritize the implementation of free school meals and thereby prioritize the nutritional needs and academic success of all Hawai'i's students.

Hawai'i Public Health Institute (HIPHI)¹ **supports HB 757**, which beginning with the 2025-2026 school year, requires the Department of Education to provide free breakfast and lunch to students enrolled in department schools.

One in three families in Hawai'i face food insecurity, leaving many students to go hungry throughout the school day. One in ten keiki in Hawai'i skip meals due to food insecurity. Hawai'i can ensure all students are able to eat by providing free school meals for all students.

Half of Struggling Families are Currently Ineligible for Meal Subsidies The current federal free and reduced-price school meals programs fail to support all students in need. Eligibility is limited to families earning below 130% of the Federal Poverty Level (FPL) for free meals and below 185% for reduced-price meals, even though a family needs at least 300% of the FPL to meet basic living expenses. As a result, half of the families earning below this threshold receive no meal assistance at all.²

This large assistance gap leaves behind many ALICE families who are struggling to make ends meet. As a result, countless students go hungry throughout the school day, impacting their health, well-being, and ability to learn.

Health Risks

Students experiencing food insecurity face a higher risk of stress, depression, and chronic disease.³ By failing to ensure they have access to

meals during the school day, we are undermining their health, development, and future success.

Improved Academic Achievement

Hungry students can't learn. Providing healthy nutrition to our students will ensure they have the resources they need to thrive. Studies have shown that free school meal programs lead to improved student performance.⁴ This program is only estimated to cost around 1-2% of the Department of Education's total budget and provide a 15% increase in test scores, a 15:1 return on investment.⁵

Federal Funding Increases

Eight other states–California, Colorado, Maine, Massachusetts, Michigan, Minnesota, New Mexico and Vermont–have implemented free school meal programs, with data showing increases in their federal reimbursement funding. In California, free and reduced-price lunch enrollment rates have risen alongside the implementation of their program, further maximizing federal support for students.⁶ Hawai'i can follow the lead of these other states by implementing free school meals for all students while also increasing the federal funding we receive to support the program.

Thank you for considering increasing access to school meals for our keiki. Please support HB 757 to deliver free school meals for all students.

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

ECAS strongly supports passage of House Bill 757 which would require the State Department of Education to provide free breakfast and lunch to all students enrolled in department schools.

ECAS recognizes the economic situation that many families in our community face each day. It is expensive to live, work, and raised a family in this state, and this results in numerous families living at or below the federal poverty level. Furthermore, these economic factors often lead to food insecurity for countless local families and their children.

Currently, the income eligibility threshold to qualify for free school meals sits at \$47,000 for a family a four. At the same time, this same family would need to bring home more than \$100,000 each year in order to cover their basic needs like housing and food. The disparity between these two numbers is exactly why we must expand the meals offered to children in our schools.

ECAS would like to particularly emphasize that the cost of providing these meals is vastly outweighed by the impact it could have on keiki in our schools. As noted in the measure's preamble, research into school meal programs continues to show that access to free meals has a marked impact on student test scores.

If we are committed to providing our keiki with the best possible educational opportunities, supplementing their school day with free, nutritious meals is an absolute necessity.

On behalf of Hawai'i Foodbank, I express our support for HB 757 Relating to Education. This bill, beginning with the 2025-2026 school year, requires the Department of Education to provide free breakfast and lunch to all students enrolled in department schools and appropriates funds.

Food insecurity is a growing crisis in Hawai'i. The State of Food Insecurity in Hawai'i report, released by Hawai'i Foodbank in May 2024, found that in 2023, 29% of households with children had one or multiple children facing food insecurity. Among these households with children, 9% had children skipping meals because there was not enough food. At the most extreme, 6% of these households had a child or children go a whole day without food because of a lack of money. Further, in households with children, food insecurity among adults was especially high at 38%, and those with young children found themselves most susceptible — indicative that parents and caregivers will sacrifice their own food security before letting their children go without food.

As the state's largest hunger-relief organization, Hawai'i Foodbank has been committed to ensuring no one in Hawai'i goes hungry since 1983. Last year, we worked with over 225 agency partners on O'ahu and Kaua'i to provide food for 17.7 million meals and serve an average of more than 150,000 people each month. As part of that work, we provide food to school pantries in every school on Kaua'i and Ni'ihau, as well as 38 schools on O'ahu, giving us a firsthand view of the challenges many families are facing to feed their children.

There are well-documented links between food insecurity and poor child health and behavioral outcomes, including physical, developmental, and cognitive impairments. Providing school meals to children is an important step in our collective effort to address food insecurity and care for our most vulnerable keiki. We urge you to consider this important measure.

On behalf of the Maui Food Bank, I express our strong support for HB 757 Relating to Education which beginning with the 2025-2026 school year, requires the Department of Education to provide free breakfast and lunch to all students enrolled in department schools.

For 30 years, Maui Food Bank has provided daily and emergency assistance to those facing food insecurity in Maui County. Maui Food Bank distributes food to families and individuals on Maui, Molokai and Lanai through direct service programs and through our network of 170 agency partners. Last year, we served an average of 45,000 people each month, distributing a total of 8.7 million pounds of nutritious food, including 2.3 million pounds of fresh produce. Of those served, 40% are children and youth.

Many struggling families do not meet the strict income limits for free and reduced-price lunch, which are capped at 185% of the Federal Poverty Level—far below the 300% or more that is actually needed to cover basic living expenses. Students who experience hunger face greater risks of stress, depression, and long-term health issues. AlohaCare appreciates the opportunity to provide testimony in **support** of **HB757**. This measure requires the Department of Education to provide free breakfast and lunch to all students enrolled in department schools beginning with the 2025-2026 school year; appropriates funds.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

Proper nutrition is vital for keiki growth and development and may reduce the risk of health conditions like anemia, asthma, hyperactivity and anxiety.¹ According to the Hawai'i Foodbank, 1 in 4 keiki in Hawai'i may not know where they will get their next meal, and for more than 81,000 keiki, getting the energy they need to learn and grow can be a daily challenge.²

While assistance is available for students who qualify, many students may be denied meals due to inability to pay and their household's income being even slightly over the income requirements to participate in the free or reduced school meal program. This measure would remove the stigma for students accessing free or reduced meals and ensure every student has access to a consistent source of nutritious food.

By ensuring all students have access to free school meals, we are addressing immediate and basic nutritional needs, combating the numerous health risks that are associated with hunger, and giving kids the energy they need to learn and grow.

Dear Chair Woodson, Vice Chair La Chica, and members of the Committee:

Thank you for the opportunity to submit testimony in support of HB 757, which would appropriate funds to the Department of Education (HIDOE) to provide up to two free, nutritious meals to all students, regardless of their financial situation.

School meals are one of the government's most powerful tools for delivering good nutrition to students. In Hawai'i, there are still three in 10 households with children facing food insecurity.¹ This means that for many children in Hawai'i, school breakfast and lunch are the most nutritious meals they eat in a day.

Despite this, many students in Hawai'i are not getting the nutrition they need. In some cases, their families don't meet the strict eligibility thresholds for free or reduced-price meals, yet still struggle to stretch their budgets. For example, a family of four that makes \$47,000 per year doesn't qualify for free lunch,² while Hawai'i's costs of living require that same family to make over \$107,000 to simply survive.³ In other cases, even students who do meet the eligibility requirements can slip through the cracks. In fact, one study found that 34 percent of students not receiving school meals were actually eligible to receive them.⁴

Hawai'i still allows schools to deny meals to students who have a negative meal balance, leaving students not only hungry but also ashamed. One student testifying asking the legislature to pass this bill last year stated, *"Earlier this year I ran out of money on my lunch account and the lady sent me to put my food back because I didn't have enough...I wouldn't want another student to feel that type of embarrassment."* Implementing UFSM would serve as a vital safety net, ensuring no child goes hungry during school hours and fostering a more equitable educational environment.

Research consistently links proper nutrition to better healthy development and learning outcomes.⁵ Universal free school meals would ensure that every student in Hawai'i has access to the nutrients necessary for optimal learning, helping to close achievement gaps. One public school teacher put it this way:

"We put a great deal of emphasis on student outcomes such as test scores. However, if we want to improve student output we must address student input such as access to qualified teachers and healthy meals... Providing students with universal free lunch may also be an important tool to help decrease the chronic absenteeism that has plagued schools ever since the Covid-19 Pandemic."

Finally, UFSM would ultimately support Hawai'i's local farmers, through the DOE's other school meal initiatives, notably Farm-to-School. This not only provides students with healthier, more sustainable food options but also strengthens Hawai'i's economy. Reducing the state's reliance on imported food fosters a more resilient and self-sufficient community.

Thank you for the opportunity to provide testimony in support of HB 757. As shown in the attached page, there are multiple revenue options that would cost the DOE only 1% of its annual budget. Across the country, UFSM has been implemented successfully through the intentional blending of policies and funding mechanisms at the federal, state, and local levels. We are pleased that the Hawai'i legislature is paying attention to this important issue because hungry keiki cannot learn. Thank you for your consideration of this bill.

It amazes me greatly that with all of the evidence, research and examples from other states who have initiated providing free breakfast and lunch to all students successfully that we are once again debating this issue. As a retired elementary teacher, my personal experiences with students over 40 years, I can repeat the reasons why we need this bill but it comes down to doing the right, pono thing for our keiki. The argument that our keiki "waste" food does not address the real issues which from my experience are the real issue. A possible lawsuit by someone, some day is not a reason to deprive keiki from food. In most schools, due to the enrollment and scheduling, some keiki are asked to eat lunch at 10 am or as late as 1 pm. They are also put in situations of waiting in line, being late to lunch, safety drills, cafeteria use by others which limits their actual eating time. When I first started working in the DOE in the 1990's, the children, teachers and even some community members ate lunch from the cafeteria. It was cooked there and the workers knew how to provide for the community they worked. We have lost this with the "institutionalism" of current lunch paths. In my last years of teaching in the DOE, lunch time became hard for everyone. Many of my students needed and wanted to eat their lunch but time constraints at breakfast and lunch made it a challenge. What happens then? We find ways to get them the food. We are NOT feeding institutions, we are feeding children. As I was told by one principal, you know you are risking your job by doing that? My answer; what is my job worth if I am not able to help my students? Our children should not be hungry, nor should our families have to pay monies for these foods. It is the very least we can do for our community keiki. The DOE should be the biggest advocate for this bill and finding ways to make sure all our keiki are fed for free.

Not only were all children assured they would have daily food, but schools that implemented free school meals saw their Math and English test scores increase at a rate equivalent to attending six additional weeks of school. While six additional weeks of school would cost Hawai'i \$300 million annually, universal free school meals would cost Hawai'i only \$25 million annually. As a parent, former President of the Holualoa Parent-Teacher Organization, active participant in the School Community Councils of Holualoa Elementary and Kealakehe Intermediate School, and volunteer organizer for afterschool programs addressing food insecurity, I am writing to express my strong support for HB757, which seeks to implement universal free breakfast and lunch for our keiki.

The Urgent Need to Address Food Insecurity

In Hawai'i, food insecurity is a pressing issue, with one in three households reporting challenges in accessing sufficient food. Alarmingly, nearly half (46%) of ALICE (Asset Limited, Income Constrained, Employed) households experience food insecurity. Despite these numbers, two out of three financially vulnerable families in our state do not qualify for free school meals, leaving many children without reliable access to nutritious food during the school day.

Impact on Houseless Keiki

Our state faces a significant homelessness crisis, with a total of 6,389 individuals experiencing homelessness in Hawai'i as of 2024. Families with children make up nearly 30% of this population, meaning approximately 1,917 individuals are children without stable housing. These houseless keiki are particularly vulnerable to food insecurity, and for many, school meals may be their only consistent source of nutrition.

Title I Schools in Kona

In the Kona area, several schools are designated as Title I due to high percentages of students from low-income families. These include Kona Pacific Public Charter School, with 60.96% of its students eligible, Innovations Public Charter School, with 48.75% eligibility, and Holualoa Elementary School, with 51.52%. Other schools we know are also Title 1, but due to lack of annual applications, there is no data for Kealakehe Elementary, Intermediate and Highschool, Kahakai Elementary, Ho'okena Elementary, and Honaunau Elementary Schools. Despite these designations, many students still fall through the cracks, not qualifying for free meals yet struggling with food insecurity.

The Imperative for Universal Free Meals

Implementing universal free breakfast and lunch ensures that no child goes hungry during the school day. Access to healthy meals is directly linked to better learning outcomes, improved concentration, and overall well-being. By providing free meals to all students, we eliminate the stigma associated with free or reduced-price lunches and ensure that every child, regardless of their economic background, has the nourishment they need to succeed.

The Housing Crisis and Its Impact

The volatile luxury housing market, exacerbated by the COVID-19 pandemic, has intensified our housing crisis, leading to increased displacement and financial strain on local families. As housing costs soar, more families find themselves on the brink of homelessness or forced to make difficult choices between housing and food. Universal school meals provide a safety net for these families, ensuring that their children receive essential nutrition even as they navigate housing instability.

As someone deeply invested in the well-being and education of our keiki, I urge you to support HB757. Universal free breakfast and lunch are not merely about feeding children; they are about nurturing the future of our community, ensuring that every child has the opportunity to learn, grow, and thrive without the burden of hunger.

Aloha Chair Woodson, Vice Chair La Chica, Maui Rep. Amato, and Members of the Committee,

My name is Christine Andrews and I am from Wailuku, Maui. I submit this testimony today in SUPPORT of H.B. 757, relating to education, which would, beginning with the 2025-2026 school year, require the Department of Education to provide free breakfast and lunch to all students enrolled in department schools.

My children were born and raised on Maui, but we spent ten years in Saint Paul, Minnesota where they attended Saint Paul Senior High School, a large urban high school of over 2,000 students. The Saint Paul Public School system provides free school breakfast and lunch for all students. Even though our family was not income eligible, I saw the benefits of this program for my own children.

My kids, like most high schoolers I know, would leave for school late or forget to eat breakfast. Fortunately for them, at all entrances to their school, there were carts that had little containers of milk, containers of yogurt, and fresh fruit. I had the opportunity when volunteering at the school to watch students walking into the school, almost all of them grabbing a milk and, my eyes did not deceive, a fruit on the way to class. As a parent who would nag my kids to eat before school or to eat their fruit, and be responded to with an eye-roll, there was something supremely comforting in feeling like my kids' school had their back. That they might not stop for breakfast if I reminded them, but that they would grab something from the cart under the warm gaze of the school cafeteria workers. My daughters both had very bad social anxiety, and also had almost daily after school activities. I am very certain that they would not have felt comfortable bringing a packed lunch to school. They never would or did. I do feel like the free lunch, the communal experience that all students shared in equally at the cafeteria, made it possible for my girls to eat at school when they otherwise would not have. So, even as a family that would not have qualified for free school meals, I know that having free school meals made a significant difference in my kids' lives.

You don't have to take my word for it. I know that the cost of these meals, especially if provided to children who would not otherwise qualify, seems like a big investment. Yet, the benefits of these programs have been well documented. Heck, the benefits of them in Minnesota were so substantial that Gov. Tim Walz was tapped as a candidate for Vice President and spent a good

part of last summer and fall boasting about them. According to the Rockerfeller Foundation's <u>True Cost of Food: School Meals Case Study</u>, "Research and practice suggest that providing this benefit without the burden of income eligibility to all students would: enable students that may hover at or slightly above the income threshold to receive the financial and health benefits of free, healthy meals; mitigate problems of stigmatization; eliminate the administrative burdens of meal applications and lunch debt on students, families, and administrators; and translate into better academic performance and lasting improved health outcomes. Additionally, an increase in economies of scale for school meals may allow many schools to provide better food at the reimbursement rate, and have an even greater beneficial impact on local economies and the environment".

The foreword of the <u>Case Study</u> notes, "This case study shows that school meals are essential for the health and economic stability of communities. We learned that while school meal programs cost \$18.7 billion per year to run, they provide nearly \$40 billion in human health and economic benefits, providing at least \$21 billion in net benefit to society even when we measure only their benefits to human health and economic equity. Enhancements to school meal programs can increase their net value even more as they expand their benefits to additional impact areas. We analyze investments to maximize student participation, improve dietary composition, and optimize food purchasing policies, which together would produce an additional \$10 billion worth of net-positive health, equity, environmental, and economic impacts." [emphasize added].

I encourage the members of the Committee to read the report, (available for download at <u>https://www.rockefellerfoundation.org/reports/true-cost-of-food-school-meals-case-study/</u>) in its entirety so that they can fully appreciate that, while the costs of providing free school meals (breakfast and lunch) to ALL Hawai`i students, without regard to income eligibility, has a net benefit to health, academic performance, local food producers, and the economy, that makes the investment in our children a wise one.

Thank you for the opportunity to testify. As a concerned citizen, I stand in **support** of HB757.

According to a report from the University of Hawai'i at Mānoa from 2021, 48% of Hawai'i families with children are experiencing food insecurity. Even if one could argue that figure was due to the pandemic, a recent report from the Hawai'i Appleseed Center for Law & Economic Justice has stated that 46% of Hawai'i public school students qualify for reduced cost or free school lunches. Considering that studies (such as one from the journal Public Health Nutrition from the University of Cambridge) have found that food insecurity can have an effect on academic performance, even indirectly, guaranteeing access to school breakfast and lunch for Hawai'i public students could go a long way to helping boost stagnating test scores.

Even if it weren't for the potential boost to academic performance, I would still be arguing in favor of HB757. I was a beneficiary of the school breakfast and lunch programs, and to have had access to at least two filling lunches each day was certainly a privilege. I strongly believe that every Hawai'i student enrolled in public schools should have that privilege as well.
