Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports this bill.

This bill amends Hawaii Revised Statutes ("HRS") §11-381 by repealing paragraph 6 of subsection (a), so that candidates would no longer be allowed to use campaign funds to purchase two tickets for another candidate's event. This measure is in alignment with HRS §11-382(1), which prohibits the use of campaign funds to support the campaign of another candidate.

The Commission requests that this committee pass this measure.

Dear Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

HAPA strongly supports HB772, which prohibits the use of campaign funds to purchase up to two tickets for an event or fundraiser held by another candidate or committee.

The current law can lead to a cycle of mutual financial support among candidates, creating opportunities for undue influence and favoritism. This bill reduces that potential quid pro quo arrangement and guarantees that campaign funds are used solely to support that specific candidate's own campaign efforts.

This change would also align with recent efforts to improve campaign finance regulations. Two years ago, Act 128 went into effect. This Act prohibits lobbyist contributions and expenditures during legislative sessions shortly before and after. This bill would complement this law since it would further restrict the flow of campaign funds between candidates.

It is worth noting that we have been taking steps to increase transparency in our political financing, such as the new requirements of legislation requiring disclosure of certain lobbyist relationships in their public financial interest disclosures. HB772 builds on this trend of increasing accountability for our people.

We urge you to support the passage of HB772 to make voting accessible and simple for everyone.

Dear Chair Tarnas, Vice Chair Poepoe and Members of the Committee,

The Chamber of Sustainable Commerce strongly supports HB772, which would remove a loophole in the campaign finance laws that allow candidates to donate to other campaigns in the form of purchasing up to two tickets to another candidate's event.

As small business owners who believe we can strengthen Hawaii's economy without hurting workers, consumers, communities or the environment, we urge this committee to vote in favor of passing HB772, because this bill brings us another step closer toward a democracy that protects small business owners, workers, consumers and the environment, not just large corporate campaign donors who can afford to pay to play.

Campaign donations are meant for a candidate to run their own campaign. Removing the ability for one candidate's campaign to purchase tickets to another candidate's event ensures that campaign funds aren't quietly funneled to other election campaigns. This also prevents potential conflicts of interest and "pay to play" circumstances in which candidates feel pressured to support or attend another candidate's fundraiser in exchange for political favors. This bill is an important step in reducing the influence of big money in our election process by requiring that campaign donation remain focused on the candidate to whom the original donation was given, and not a way to indirectly support other campaigns.

# **Testimony in Support of HB772**

Submitted to the House Judiciary and Hawaiian Affairs Committee by Evan Weber, Managing Director, Our Hawai'i, 1/28/2025

Chair Tarnas, Vice Chair Poepoe, and all Committee members,

On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, we write in in strong support of House Bill 772, relating to campaign finance. Our members and supporters are local people — kama'āina and kānaka 'oiwi, keiki and kūpuna, from Kaua'i to Kohala, Kailua to Kapolei and every place in between. They have joined our movement to fight for a Hawai'i that puts local people — not big money interests — first, because they are worried about the direction of our islands and believe now is the time for change.

Our supporters are not alone. Our corruption and public trust in government crisis has reached a tipping point. After years of the FBI putting our officials in handcuffs, resignations, and scandals, Hawai'i voters as a whole in 2022 ranked government corruption as their number 3 top issue, only behind inflation and affordable housing. In 2024 polling, 2 in 3 (66%) voters said they believe elected officials care more about "wealthy donors" than the "needs of their communities. With public trust at or near all time lows, now is the time for action. While some progress has been made in recent years through the Commission to Improve Standards of Conduct, there is more opportunity to take action in removing the influence of money in politics.

House Bill 772 seeks to close the loophole allowing candidates to donate to each other's campaigns through the purchase of fundraising tickets. This legislation is a crucial step toward fostering fairness and transparency in Hawai'i's electoral process.

By addressing this loophole, HB 772 ensures that campaign funds are used solely for their intended purpose—engaging and communicating with voters—rather than creating a system of mutual financial support among candidates. This change will help prevent the appearance of impropriety and maintain public trust in our democratic system.

Closing this loophole reinforces the principle that elections should be won through merit and the ability to connect with constituents, not through connections to other candidates, especially well established or sometimes entrenched elected officials. This helps level the playing field, particularly for grassroots candidates who may not benefit from connections with elected politicians.

In conclusion, I strongly urge you to support HB 772. Mahalo for the opportunity to testify.



# HOUSE BILL 772, RELATING TO CAMPAIGN FINANCE

# JANUARY 28, 2025 · JHA HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 772, relating to campaign contributions, which disallows the use of campaign funds to purchase up to two tickets for an event or fundraiser held by another candidate or committee.

Our democracy belongs to we, the people. At a time when our nation is experiencing extreme political turmoil and basic civil liberties are under assault, we must take steps in Hawai'i to safeguard democratic participation. In the 2024 primary election, for example, our state experienced its lowest turnout in 65 years, with only 32.1 percent of registered voters filling out a ballot. This is, in part, a reflection of the public's deep cynicism with our electoral processes.

Hawai'i continues to be embroiled in public corruption scandals, following the bribery allegations that were levied against former Senate Majority Leader Kalani English and former State Representative Ty Cullen. Other public officials, such as employees at local permitting offices, have also recently been ensnared in bribery scandals, in some cases with connections to Milton Choy, the lobbyist who was responsible for coordinating the bribery scheme that Sen. English and Rep. Cullen became a part of. These cases show that we have a moral crisis in our public institutions and must do all we can to restore integrity to government.

With that in mind, we should act quickly to end the longstanding practice of campaign money laundering. When people make campaign donations, they generally expect that those contributions will be used to help the candidate receiving the funds run their own campaign. Removing the ability to buy tickets for another candidate's event ensures that campaign funds are not funneled to other campaigns, thereby preventing candidates from exerting pressure on their political peers to support their preferred campaigns in exchange for legislative favors.

Additionally, ending this practice will erode the tendency toward "buying factions" through campaign contributions, which undermines the integrity of our campaign system by redirecting it toward the accumulation of power, rather than the preservation of the public trust. Finally, passing this measure will strengthen transparency in our campaign system, since the original funding that is used to make candidate-to-candidate donations is not publicly reported.

We believe our government should work for the public interest, not special interests. It is in that spirit that we support this and other reforms to restore integrity to our state's electoral and governmental processes.
