In consideration of HOUSE BILL 868 RELATING TO DISABILITIES

House Bill 868 proposes to require the Department of Land and Natural Resources (Department) to evaluate its facilities for compliance with the Americans with Disability Act (ADA) and compile a list of non-compliant facilities. Further, this bill requires a report to the Legislature. **The Department acknowledges the intent of this measure and provides the following comments.**

The Department has already implemented and completed an ADA self-evaluation and transition plan.

The self-evaluation included an evaluation of the Department's facilities for compliance with the ADA Standards for Accessible Design. Based on the self-evaluation, the Department developed a transition plan that detailed structural changes to Department facilities to achieve program access and specified a time frame to for their completion. Since completing its transition plan, the Department continues to submit plans and specifications for new construction and facility improvements to the Disability and Communication Access Board (DCAB) for review. These reviews ensure ongoing compliance with the ADA Accessibility Guidelines as adopted and amended by DCAB.

The Department appreciates the intent of this bill and is committed to ensuring Department programs, services, and activities are compliant with the ADA.

Comments:

We believe this is an important bill. While there are federal and state laws in place that require accessibility for individuals with disabilities, we do have questions about whether all facilities are in compliance. In particular we raised at the Legislature years ago that many parks and beaches failed to provide proper access. It is far from clear that DLNR has made sufficient efforts to address that. For that reason, the actions proposed in this measure would be a very good next step to getting this issue back on the radar and getting the department back on track.
