Chair Woodson and Members of the Committee:

The Department of the Attorney General (Department) provides the following comments.

The bill requires the Department of Education to establish and administer a three-year student athlete travel pilot program (Program) to provide funding for intracounty travel expenses for student athletes of Maui county, and it appropriates funds.

Any sports-related travel for student athletes must comply with title IX of the Education Amendments of 1972 (20 U.S.C. sections 1681-1688), and section 302A-461, Hawaii Revised Statutes. The Department recommends amending the bill to explicitly require compliance with all applicable state and federal laws. Additionally, the bill should require reporting on the number of male and female student-athletes who participated in the pilot program, the amount of private donations received, both monetary and service-related, and the allocation of money (both private and public) and services provided to each male and female athletic team.

Bill Title: HB 0088 RELATING TO STUDENT ATHLETES.

Purpose of Bill: Requires the Department of Education to establish and administer a three-year student athlete travel pilot program to provide funding intra-county travel expenses for student athletes of Maui county. Appropriates funds. Repeals 6/30/28.

Department's Position:

The Hawaii State Department of Education (Department) appreciates the opportunity to testify in support of the intent HB 88, which establishes a three-year student athlete travel pilot program.

Travel is a challenge across all Department athletic programs. These challenges are even greater for schools that need to travel to other islands for intra-island games and face additional lodging issues. While there is special funding for athletic travel for Lanai and Molokai teams due to their unique geographic challenge to participate in athletic events, these funds are limited. The three-year pilot would be a welcome support for student athletes who also face lodging challenges in addition to other travel expenses. The Department respectfully suggests the pilot allow funding to also be used for an athletic clerk if needed, who would assist with travel procurement and implementation of the pilot.

While the Department appreciates the appropriation in this measure, we ask that it does not adversely affect the priorities identified in the Department's Governor-approved budget.

My name is Briann Starkey and I am submitting testimony as an individual. I am writing this in favor and support of HB 88, in relation to Students Athletes. I am a current Elementary teacher at Kualapuu School on the island of Moloka'i. I am also a mom of four children, two who have graduated and 2 who currently attend Moloka'i High School and are involved in athletics.

Sports on Moloka'i as you may know are a driving force for our youth of today. Exercise and health are important factors. However, students are also driven & committed to make the traveling team to get off the island, represent our island community as well as their families. Many of the above mentioned students have multi-children in their families and are involved in different sports. And like every off-island trip, it involves money. Money for food for at least 4 or 5 meals. (Dinner, Breakfast, lunch, dinner) which usually range at \$20. That is about \$100 a trip, for EACH sport for EACH child which may deem costly over the sports season of 3 months.

Qualifications; other than money for food. Our schools need money for travel and participation in school representation. A sports season for one sport lasts a couple months. The opportunity for competitions to be held on Maui are high which leaves Moloka'i students traveling the most. Out of 7 Maui County Competitions and the school funding, Moloka'i schools can only afford to participate in 3 of the 7 which makes their qualifying time for MIL's and States lessen. Teams can only take a certain amount of students, leaving some home and not participating. Maui schools only travel one time to Moloka'i

and one time to Lana'i..Moloka'i students travel the most and in need of more participation in competition and more funds.

Traveling costs, Mokulele is the only way off of the island for Moloka'i residents. It would help if you would support travel and funding by boat for when the plane transportations are ceased. This can cause unfairness in the Sports qualifications as well. My son and his Paddling Team had to disqualify themselves from a canoe race because Mokulele planes were not flying yet the Competition still went on. Where is the fairness in that?

Your support with the passing of this Bill HB 88 will help all of our families here on Moloka'i and our student athletes ease our minds. Thank you for your consideration.
