



**TESTIMONY IN SUPPORT TO HOUSE BILL 89 HD1
RELATING TO TEACHER EDUCATION**

Aloha e Chair Woodson, Vice Chair Chica, and Members of the Committee on Education,

The Office of Hawaiian Affairs (OHA) **SUPPORTS HB 89 HD1**, which establishes a Teacher Housing Assistance Program aimed at improving teacher recruitment and retention, particularly in hard-to-staff schools. OHA commends the introduction of this bill and acknowledges the amendments made in HB 89 HD1 that strengthen its intent and implementation, especially for public charter schools and enhanced eligibility criteria for teachers in hard-to-fill positions. These adjustments will have a more significant impact on Native Hawaiian educators and the communities they serve.

OHA appreciates the amendments made to HB89 HD1, particularly those that outline clear criteria for eligibility and ensure that the program can effectively serve teachers in need. These adjustments ensure that the bill can be successfully implemented and reach those teachers who will benefit most from this support.

Hawai'i continues to face a chronic teacher shortage, with approximately 10% of teachers leaving the profession annually¹, and over 60,000 students lacking a certified teacher.² One of the leading factors behind teacher turnover is the high cost of living, particularly in relation to housing. The lack of affordable housing options disproportionately impacts underserved communities, including rural areas where many Native Hawaiian students live and attend school.³

Native Hawaiian students are particularly affected by teacher shortages, and their academic success is closely tied to the stability of their educators. The ability to retain

quality teachers in these communities is essential for the success of these students⁴. Providing housing assistance directly supports Native Hawaiian educators by easing their financial burden and helping them remain in their communities to serve the students who need them most.

Moreover, HB 89 HD1 aligns with OHA's Mana i Maui Ola framework, which includes goals and strategies for education and housing that directly benefit Native Hawaiian communities. The program's potential to provide housing assistance will contribute to OHA's broader efforts to create economic self-sufficiency for Native Hawaiian educators, many of whom face significant barriers in securing affordable housing in one of the most expensive places to live in the nation. Housing assistance will not only improve their quality of life but also sustain their careers and their ability to support the academic success of the students they teach.

This bill is a critical step toward creating a supportive learning environment for students by ensuring their teachers are able to remain in the communities they serve, reducing turnover, and enhancing the overall quality of education. By stabilizing teachers' financial situations, HB 89 HD1 strengthens the well-being of Native Hawaiian communities and promotes positive educational outcomes for Native Hawaiian students.

OHA appreciates the amendments made in HB 89 HD1 and is grateful for the committee's attention to the needs of Native Hawaiian educators. **We strongly urge the Committee to pass HB 89 HD1**, as it is a vital measure for retaining educators and ensuring equitable and quality education for Native Hawaiian students. Mahalo for the opportunity to submit testimony in support of HB 89 HD1.

Bill Title: HB 0089, HD1 RELATING TO TEACHER HOUSING.

Purpose of Bill: Establishes the Teacher Home Assistance Program to provide housing vouchers to certain eligible teachers. Appropriates funds out of the Teachers' Housing Revolving Fund. Effective 7/1/3000. (HD1)

Department's Position:

The Hawai'i State Department of Education (Department) appreciates the opportunity to provide comments regarding HB 89, HD 1, relating to teacher housing assistance.

The Department supports efforts to address Hawai'i's teacher recruitment and retention challenges. Our state's high cost of living and a shortage of affordable housing impact our ability to attract and retain qualified educators throughout our school system.

We recommend the following clarifications to strengthen the bill's implementation. In Section (g) (2), we recommend amending it to: "Has taught at a public school or public charter school" to ensure that public charter schools are specifically mentioned.

The Department also recommends that the requirement of "one year of teaching prior to the application date" should refer to the year immediately preceding the application.

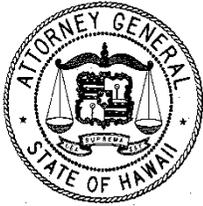
The Department also has concerns about repayment for "eligible teachers" that do not fulfill the criteria. For example, a teacher that does not stay for five consecutive years.

While the Department supports the intent of this measure, successful implementation would require dedicated staff and financial resources to verify eligibility, process applications, administer the housing voucher program, and manage contracts to collect repayments for teachers that no longer meet the "eligible teacher" criteria. The Department appreciates the inclusion of funding in this

proposal but asks that any additional funding or positions not affect the Department's request in its Governor-approved budget.

The Department remains committed to working with the Legislature to develop comprehensive solutions to our educator workforce challenges.

Chair Woodson and Members of the Committee:

The Department of the Attorney General (Department) provides the following comments.

The purpose of this bill is to alleviate the financial burden on teachers and improve teacher recruitment and retention by establishing a Teacher Housing Assistance Program to provide housing vouchers to certain eligible teachers. It appropriates funds out of the Teachers' Housing Revolving Fund.

The bill sets forth eligibility criteria for receiving these housing vouchers. See page 4, line 19, through page 5, line 14. One of the eligibility requirements is to "[c]ommit[] to teach at a hard-to-fill school, as determined by the department, or a public charter school for no less than five consecutive years[.]" Page 5, lines 5-7. However, the bill does not specify the consequences if a teacher fails to fulfill this commitment. For clarity, the Department recommends amending the bill to include provisions addressing the repayment of vouchers in such cases. We suggest inserting the following new subsections (f) through (h) in the new section to be added to chapter 302A, starting on page 4, line 17:

(f) If a voucher recipient fails to satisfy the work requirements in accordance with subsection (j)(4), the recipient shall repay the total amount of voucher funds received as a loan repayable to the department. The repayment shall be subject to the terms and conditions set by the department, including circumstances under which recipients may be eligible for deferment or forgiveness due to hardship or inability to secure

employment, as well as potential for fees for the collection of delinquent repayment.

(g) Voucher funds repaid by the voucher recipient pursuant to subsection (f) shall be deposited into the teachers' housing revolving fund established pursuant to section 302A-833.

(h) In accordance with chapter 103D, the department may enter into written contracts with collection agencies to collect delinquent repayment of vouchers owed to the department pursuant to subsection (f). A collection agency that enters into a written contract with the department to collect delinquent voucher repayments pursuant to this section may collect a fee from the debtor in accordance with the terms of, and up to the amounts authorized in, the written contract.

The current subsections (f) and (g) should be redesignated as (i) and (j), respectively, and the reference to subsection (e)¹ on page 3, line 15, should be changed to refer to subsection (j).

H.B. 89, H.D. 1 – RELATING TO TEACHER HOUSING

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO wishes to provide comments on H.B. 89, H.D. 1, which proposes to establish a Teacher Housing Assistance Program to provide housing vouchers to certain eligible teachers and appropriates funds out of the Teachers' Housing Revolving Fund.

Under Act 172, SLH 2023, the legislature identified affordable housing as a key strategy for recruiting and retaining the education workforce; not just teachers. Similarly, the legislature should consider providing a "workforce home assistance program" to make other government employees eligible since they face the same low salaries and high cost of living.

The HGEA represents thousands of employees who work for the DOE and public charter schools who make less than a starting Hawaii teacher's salary. Some of these employees also work in hard-to-staff locations with high turnover. They, too, should benefit from a housing assistance program being administered by the department for which they work. They, too, deserve to be eligible for a housing voucher to assist with rent, mortgage, or a down payment for their primary residence.

The Hawai'i State Teachers Association (HSTA) **supports** HB 89, which would establish the Teacher Home Assistance Program to provide housing vouchers to certain eligible teachers and appropriates funds out of the Teachers' Housing Revolving Fund.

Hawai'i's high cost of living, with homes costing 2.7 times the national average, poses a significant challenge to attracting and retaining qualified teachers, especially in rural and underserved communities. The ALICE (Asset Limited, Income Constrained, Employed) initiative reports that a family of four in Hawai'i needs to earn \$107,796 annually to afford basic necessities, a threshold many teachers and their families do not meet. This financial strain forces many educators to seek second jobs or leave the profession altogether, leading to high turnover rates and a reliance on emergency hires.

The Teacher Home Assistance Program proposed in HB HB 89 would provide crucial financial assistance to help teachers afford housing costs. This would not only alleviate some of the

economic burden on educators but also serve as a powerful recruitment and retention tool. By enabling teachers to live closer to their schools and communities, we can foster stronger relationships, improve teacher morale, and ultimately enhance the quality of education for our keiki.

We urge the committee to pass HB 89 and invest in the well-being of our teachers. This program is a vital step towards ensuring that all students in Hawai'i have access to a quality education.
