1 **Fiscal Implications:** Undetermined.

2 **Department Position:** The Department of Health offers comments.

3 **Department Testimony:** The Disease Outbreak Control Division (DOCD) provides the following  
4 testimony on behalf of the Department.

5 Between 2014 and 2023, Hawaii reported 92 cases of Rat lungworm disease (RLWD), with the  
6 majority of cases occurring on the Big Island (71 cases, 77%). RLWD is a disease that causes  
7 substantial impairment to quality of life, is difficult to diagnose, and for which we are still  
8 lacking strong evidence to guide treatment recommendations. There is critical need for ongoing  
9 research into RLWD, and we are supportive of measures that promote and advance high quality  
10 research to improve diagnosis, treatment, and/or prevention of RLWD.
