Chair Tarnas and Members of the Committee:

The Department of the Attorney General (Department) strongly supports this bill and offers the following comments.

This bill amends section 134-9.6, Hawaii Revised Statutes (HRS), to amend the annual reporting requirements for the Department and the chief of police of each county concerning licenses to carry firearms.

The bill removes the deadline of April 1 for the Department to publish its annual report, which will allow the Department time to complete the required aggregation of the data it receives from the county police departments. The report is still due annually.

The bill extends the date that the county police departments provide the data to the Department from February 1 to March 31 of each year for the prior calendar year, allowing the county police departments additional time to provide the data to the Department.

The amendments in the bill will give the county police departments more time to provide reportable data and will give the Department sufficient time to complete the annual report with its existing resources.

We respectfully ask your Committee to pass this bill. Thank you for the opportunity to provide testimony.

Comments:

I oppose HB995 and the proposed changes to Section 134-9.6, Hawaii Revised Statutes, for several reasons.

First, deadlines are essential for ensuring tasks are completed on time. This is why deadlines are set by this committee to move measures such as HB 995 through the Hawaii State Legislature.

Second, extending the reporting deadline for police chiefs by 60 days will only postpone the completion of a task that, with proper planning and organization, could have been finished and submitted to the Attorney General by February 1. To help meet this deadline, county police departments can adopt various strategies for gathering the necessary information. For example, they can break the task into smaller, more manageable parts and summarize data monthly or quarterly.

Third, and most importantly, eliminating the deadline for the Attorney General to publish the annual report will likely result in indefinite delays in sharing this important information, causing unnecessary hold-ups.

In summary, without deadlines, tasks frequently remain unfinished. Extending deadlines can be equally problematic as having none at all; when a task is granted an extension, it often gets postponed again.

Additionally, the **Annual Report on Licenses to Carry** provides the public with essential statewide and county firearm registration statistics, which are crucial for an informed citizenry.

I would like to express my gratitude to the Committee members for reviewing my testimony and taking my concerns about the impact of HB995 on the citizens of Hawaii into consideration.
