Chair Elefante and Members of the Committee:

The Department of the Attorney General (Department) strongly supports this bill and offers the following comments.

This bill amends section 134-9.6, Hawaii Revised Statutes (HRS), to amend the annual reporting requirements for the Department and the chief of police of each county concerning licenses to carry firearms.

The bill removes the deadline of April 1 for the Department to publish its annual report, which will allow the Department time to complete the required aggregation of the data it receives from the county police departments. The report is still due annually.

The bill extends the date that the county police departments provide the data to the Department from February 1 to March 31 of each year for the prior calendar year, allowing the county police departments additional time to provide the data to the Department.

The amendments in the bill will give the county police departments more time to provide reportable data and will give the Department sufficient time to complete the annual report with its existing resources.

We respectfully ask your Committee to pass this bill. Thank you for the opportunity to provide testimony.

Chair Elefante, Vice Chair Wakai, and members of the Committee:

The Department of Law Enforcement (DLE) supports House Bill 995, relating to firearms reporting requirements. This bill amends the annual reporting requirements imposed on the Department of the Attorney General and the county police chiefs regarding licenses to carry firearms. Specifically, the bill extends the data submission deadline from February 1 to March 31, removes the existing publication deadline, and maintains comprehensive reporting standards for firearms licensing data.

This extended timeline ensures that the annual report will contain more comprehensive data categorized by age, gender, race, and county, including detailed information on license denials and revocations.

Accurate and timely reporting on firearms licensing is critical for public safety planning and policy development. The proposed changes maintain the necessary transparency and accountability in firearms licensing while providing a more realistic timeframe for data collection and reporting.

Written Testimony in Opposition to H.B. No. 995 Submitted to the Senate Committee on Judiciary & Hawaiian Affairs March 16, 2025

Aloha Members of the Committee,

I strongly urge you to vote NO on H.B. No. 995, a bill amending annual reporting requirements for licenses to carry firearms under the Department of the Attorney General and county police departments. While it claims to streamline data collection, this legislation is a deceptive step toward overregulation, threatens the privacy of law-abiding gun owners, and risks alienating Hawaii from the Trump administration's agenda—potentially to the detriment of our people. As a concerned citizen rooted in limited government and personal freedom—values that can unite us across party lines—I present the following objections to demonstrate why this bill must be rejected.

### **1.** Overreach That Burdens Law Enforcement and Taxpayers

H.B. 995 expands an already intrusive reporting system, demanding detailed data on carry licenses by age, gender, race, and reasons for denials or revocations. This piles unnecessary administrative work onto county police and the Attorney General's office, diverting resources from real crime-fighting. Democrats value efficient government—why bog down our law enforcement with paperwork that serves no clear public safety purpose?

In <u>California, a similar firearms reporting mandate</u> under the Armed Prohibited Persons System ballooned costs and strained police budgets, with little evidence of reduced violence. Hawaii's taxpayers and officers deserve focus on actual threats, not bureaucratic busywork.

### 2. Threatening Privacy and Chilling Second Amendment Rights

The bill's requirement to categorize and analyze license data by demographics risks profiling law-abiding gun owners, eroding their privacy and discouraging lawful carry. Democrats who champion individual rights should see the danger—why create a system that could intimidate citizens exercising a constitutional freedom?

<u>New York's SAFE Act reporting requirements</u>, enacted in 2013, led to widespread backlash after personal data leaks exposed gun owners to harassment, chilling applications and trust in government. Hawaii's gun owners—hunters, sport shooters, and self-defenders—could face the same fate, undermining community confidence.

### 3. Defying Trump's Pro-Gun Agenda Harms Hawaii

The Trump administration, led by figures like Attorney General nominee Pam Bondi and Vice President JD Vance, fiercely defends Second Amendment rights. Bondi has stated, "Law-abiding Americans shouldn't face government overreach on their constitutional freedoms," while Vance has argued, "Gun control schemes waste resources and punish the innocent" (paraphrased from campaign remarks). H.B. 995's expanded reporting clashes with this agenda, risking federal pushback—think reduced DOJ funding or legal challenges—that could hurt Hawaii's people. Democrats who value pragmatic governance should ask: why defy an administration poised to prioritize enforcement over regulation, potentially costing us vital support?

<u>Washington State's enhanced gun reporting</u> lost federal grants in 2021 under Trump's first term for clashing with DOJ priorities. With Bondi and Vance in power, Hawaii could face worse—why gamble with our state's resources?

### 4. No Evidence of Public Safety Gains

H.B. 995 justifies itself as a tool for policymakers and researchers, but it offers no proof that more reporting reduces gun violence. The bill's vague promise to "remedy disparities" in denials lacks data showing current disparities harm safety. Democrats demand evidence-based policy—where's the proof this works?

<u>Illinois' Firearm Owner's Identification reporting</u> expanded in 2021, yet a 2023 audit found no link to lower crime rates, just higher costs and delays in processing. Hawaii risks the same empty outcome—data for data's sake, not results.

### 5. Eroding Trust Between Communities and Government

Mandating detailed annual reports—especially with demographic breakdowns—could fuel perceptions of bias or targeting, fracturing trust between Hawaii's diverse communities and law enforcement. Democrats who prioritize equity and unity should see the red flag—why risk alienating residents over a report with no proven benefit?

<u>Philadelphia's gun permit reporting efforts</u>, tied to broader violence initiatives, sparked community pushback in 2023 when residents feared profiling, undermining cooperation with police. Hawaii's harmony is too valuable to jeopardize with this divisive overreach.

### **Conclusion: A Principled NO Vote Protects Hawaii's People**

Members of the Committee, H.B. 995 masquerades as a minor tweak but delivers overregulation, privacy risks, and defiance of Trump's agenda—hurting Hawaii's taxpayers, gun owners, and federal standing. It burdens police, lacks evidence of safety gains, and threatens community trust. From California to Illinois, similar measures have wasted resources and divided residents, not saved lives.

Vote NO on H.B. 995 to safeguard our finances, freedoms, and unity. Let's reject this unnecessary intrusion and align with practical, proven priorities—before defying Bondi and Vance costs us more than we can bear.

### Comments:

I am writing to respectfully submit my testimony and strong opposition to HB995, which seeks to track gun wonders and expose their private data. As a concerned resident of Hawaii, I believe this measure represents a significant overreach of government authority, violates fundamental privacy and second amendment rights, and threatens the freedoms of law-abiding citizens without providing a clear and effective solution to gun related issues. I urge you to reject this bill for the following reasons:

HB 995's proposal to track gun wonders and collect their private data raises serious concerns about the erosion of personal privacy. The creation of a database to monitor law abiding citizens who legally own firearms feels akin to a surveillance state, where the government assumes guilt rather than innocence. As an individual who values my right to privacy, I am deeply troubled by the potential for this data to be misused whether through government overreach, unauthorized access or data breaches. In an era where cybersecurity threats are increasingly commonevidenced by incidents like the 2023 breach of Hawaii DOH systems which exposed sensitive information. I am not confident that such data could or would be adequately protected.

Moreover, this bill fails to demonstrate a compelling need for such invasive measures, particularly considering the low rate of gun violence in the state. Law abiding gun ownders should not be subjected to such unwarranted scrutiny for simply exercising their constitutional rights. The second amendment guarantees the right to bear arms, and the fourth amendment protects against unreasonable searches and seizures, which includes the right to privacy. By mandating the collection and potential exposure of private data, HN995 undermines both of these foundational principles.

The establishment of a gun owner database also creates significant potential for misuse. History has shown that government registries can be weaponized against specific groups, leading to discrimination or targeted enforcement. For example, during the 20th century, firearm registries in other jurisdictions were used to confiscate weapons from law abiding citizens, often during times of political unrest. While I do not suggest that this is the immediate intent of HB995, the precedent set by such a database opens the door to future abuses of power, particularly if political climates shift or if the data fell into the wrong hands.

Additionally the exposure of private data could disproportionately affect certain communities, such as those in rural Hawaii, where gun ownership is often a practical necessity for hunting, farming, and self defense. These individuals may already face systemic challenges and the added

burden of government tracking could exacerbate feelings of mistrust and alienation. I worry that this bill will create a chilling effect, discouraging responsible citizens from exercising their second amendment rights or failing to comply with such measures, for fear of being monitored and targeted.

Proponents of HB995 may argue that tracking gun owners enhances public safety, but I respectfully disagree. The root causes of gun violence, such as socioeconomic disparities, mental health challenges and illegal firearms - are not addressed by this bill. Instead it places an undue burden on law abiding citizens while doing little to deter criminals, who by definition, do not comply with legal requirements.

According to the FBI's 2022 uniform crime report, a significant portion of gun crimes involve weapons obtained through illegal means, such as theft or straw purchases. Targeting legal gun ownders with invasive tracking measures diverts resources from more effective strategies such as cracking down on black market gun sales or investing in community based violence prevention programs

Rather than resorting to intrusive overreach, I urge the legislature to consider alternative approaches that respect both public safety and individual rights. For example, enhancing background checks, increasing mental health services, or supporting community outreach programs could address the underlying causes of violence without compromising privacy or individual liberties and constitutional freedoms. These measures would target actual threats while still preserving freedoms of law abiding citizens.

I respectfully urge you to reject HB995, in its current form. This bills proposal to track gun wonder and expose private data is an invasive an unnecessary measure that violates privacy rights, risks misuses and fails to address the root causes of gun violatence.

As a resident of Hawaii, who values both safety and liberty, I am deeply concerned about the prescedent this legislation sets.

To the Honorable Members of the Hawaii State Legislature,

I am Tiare Smith, a Native Hawaiian resident of Kahalu'u, O'ahu, where I have lived for 45 years. As a kama'āina deeply rooted in this community, I write to express my resolute opposition to HB 995, a bill that ostensibly amends firearms reporting requirements under Section 134-9.6, Hawaii Revised Statutes, but in practice precipitates an alarming overreach into the privacy and rights of law-abiding citizens. While I acknowledge the bill's intent to refine administrative processes, its implications are antithetical to the principles of equity, personal liberty, and fiscal responsibility that should guide legislative action in our state. Below, I outline the pros and cons of HB 995, followed by detailed solutions to address its deficiencies without compromising the rights of Hawaii's people.

### Pros of HB 995

The bill presents a veneer of administrative efficiency that warrants consideration:

1. \*\*Extended Data Collection Timeline\*\*: By shifting the deadline for county police chiefs to submit data from February 1 to March 31, the bill ostensibly affords law enforcement additional time to compile accurate statistics on licenses to carry.

2. \*\*Removal of Fixed Reporting Deadline\*\*: Eliminating the April 1 publication deadline for the Department of the Attorney General's annual report could, in theory, allow for more thorough data aggregation and vetting.

3. \*\*Public Policy Insight\*\*: The justification sheet claims the report may benefit policymakers and researchers by providing data on firearm ownership trends, potentially informing future legislation.

These points, however, are overshadowed by the bill's profound shortcomings, which I address next.

### Cons of HB 995

HB 995 constitutes an intrusive overreach that threatens privacy, equity, and constitutional rights:

1. \*\*Tracking Gun Owners and Exposing Private Data\*\*: The bill mandates the collection and public dissemination of detailed personal information—age, gender, race, and county of residence—for every applicant or licensee. This granular tracking not only risks exposing private data to misuse but also disproportionately burdens Native Hawaiians and rural residents like myself, who may face stigmatization or retaliation in tight-knit communities.

2. \*\*Fuels an Anti-Second Amendment Agenda\*\*: By cataloging denials, revocations, and appeals with an eye toward "remedying disparities," HB 995 lays the groundwork for policies that could disenfranchise law-abiding gun owners, particularly those exercising their constitutional rights under the Second Amendment. This veiled agenda undermines the sovereignty of individuals to protect themselves—a right acutely felt in areas like Kahalu'u, where self-reliance is often a necessity.

3. \*\*Inequitable Application and Cost Inefficiency\*\*: The bill's broad data requirements impose an unfunded mandate on county police departments, diverting resources from public safety to bureaucratic compliance. Smaller counties, such as Hawaii or Kauai, may struggle to meet these demands, exacerbating disparities in enforcement and eroding equity across the state.

### Detailed Solutions to Address the Cons

Rather than acquiesce to this ill-conceived measure, I propose the following solutions, which prioritize safety, efficacy, cost-effectiveness, and equity while rejecting the bill's intrusive framework:

1. \*\*Protect Privacy with Aggregate Reporting\*\*:

- \*\*Solution\*\*: Replace individual-level data collection with anonymized, aggregate statistics (e.g., total licenses issued or denied per county). This preserves public insight into firearm trends without compromising personal privacy.

- \*\*Cost Savings\*\*: Eliminates the need for extensive data security measures to protect sensitive records, reducing annual compliance costs by an estimated 20-30% (based on national averages for similar reporting systems).

- \*\*Equity\*\*: Prevents disproportionate exposure of Native Hawaiian or rural populations, fostering trust in governance.

2. \*\*Enhance Safety Without Tracking\*\*:

- \*\*Solution\*\*: Redirect resources to community-based safety initiatives, such as free firearm training and storage education programs offered through local organizations like the Hawaiian Civic Clubs.

- \*\*Efficacy\*\*: Studies (e.g., RAND Corporation, 2022) show training reduces accidental discharges by up to 40%, a more direct safety benefit than passive data collection.

- \*\*Cost-Effectiveness\*\*: At \$50 per participant, a statewide program for 5,000 gun owners costs \$250,000 annually—far less than the millions spent on administrative tracking (e.g., California's \$24 million firearm database budget in 2023).

3. \*\*Counter Anti-2A Bias with Transparency\*\*:

- \*\*Solution\*\*: Require the Attorney General to publish a biennial audit of its reporting methodology, ensuring data is not manipulated to justify restrictive firearm policies.

- \*\*Efficacy\*\*: Deters agenda-driven interpretations, safeguarding Second Amendment rights.

- \*\*Cost Savings\*\*: A biennial audit, costing approximately \$100,000 every two years, is more economical than annual overhauls of a flawed reporting system.

4. \*\*Fund Equity Through Reallocation\*\*:

- \*\*Solution\*\*: Reallocate funds from HB 995's bureaucratic expansion to bolster underresourced police departments in rural counties, ensuring uniform safety standards without punitive oversight.

- \*\*Equity\*\*: Levels the playing field for smaller jurisdictions, preventing urban-centric policy bias.

- \*\*Cost-Effectiveness\*\*: A one-time \$500,000 investment in staffing and technology yields long-term savings by reducing reliance on redundant reporting.

### ### Conclusion

HB 995 represents a precipitous step toward governmental overreach, cloaked as administrative reform. As a Native Hawaiian who has called Kahalu'u home for nearly half a century, I implore you to reject this bill and its insidious implications. The right to privacy, the sanctity of self-defense, and the equitable distribution of resources are not negotiable. Adopt instead the solutions I have outlined—practical, cost-effective measures that uphold safety and liberty without disenfranchising Hawaii's people. Let us not trade our aloha for surveillance.
