STRENGTHEN FARM-TO-SCHOOL INITIATIVES

Chair Kahaloa, Vice Chair Kusch, and Members of the Committee:

Thank you for the opportunity to provide testimony in support of the intent of HCR 104/  
HR 100 urging the Department of Education to strengthen farm-to-school initiatives. We  
support the intent of this measure and offer the following comments.

The University of Hawai'i at Mānoa College of Tropical Agriculture and Human  
Resilience (CTAHR) supports the efforts of the Department of Education (DOE) to  
strengthen local farm-to-school initiatives by offering our expertise in food science,  
human nutrition and Cooperative Extension technical assistance to DOE and our  
agricultural producers to meet the mandate of Act 175, Session Laws of Hawai'i 2021,  
for at least thirty percent of school meal ingredients to be sourced locally by 2030.  
CTAHR acknowledges that a robust local farm-to-school program would provide  
increased food and nutritional security for keiki, increased institutional markets for local  
food and farming entrepreneurs, and more sustainable local food systems.

**Department's Position:**

The Hawaii State Department of Education (Department) is submitting testimony with comments on HCR 104.

The School Food Services Branch (SFSB) is currently tasked with the goal of sourcing 30% of school meal ingredients locally by 2030.

The Department is responsible for establishing guidelines for procuring locally sourced products in accordance with the United States Department of Agriculture's National School Lunch Program and state procurement laws, including the necessity of gathering competitive bids.

The Department is working closely with produce vendors to include additional local farmer offerings to be available to SFSB to procure and be distributed to schools.

The Department requests assistance and collaboration with other state agencies to reach the 30% by 2030 goal.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HCR 104 / HR 100**, which urges the Department of Education to strengthen farm-to-school initiatives.

HFB strongly supports the increased use of locally grown agricultural products, fruits, vegetables, meats, dairy, poultry, and value-added products in our schools and state facilities. We support the State's Farm-to-School goal of 30% by 2030, in accordance with Act 175, SLH 2021 as well as the Farm-to-State goals established in Act 176, SLH 2021.

My name is Vivienne Hill, and I am a high school senior and member of the Hawai'i Youth Food Council. I am writing in strong support of HCR104 / HR100 because farm-to-school programs can make a real difference in the lives of students.
