- 7 operations.

Relating to Vaccination Rates in Hawai'i Schools

Chair Rep. Justin H. Woodson, Vice Chair Rep. Trish La Chica, Vice Chair and members of the House Committee on Education thank you for providing this opportunity for Hawai'i - American Nurses Association (Hawai'i-ANA) to provide testimony in strong support of HCR 173, HD1 / HR 169, HD1(HSCR1532) /(HSCR1531).

Hawai'i-ANA is the state's premier professional nursing organization that fosters high standards of professional nursing practice, promotes safe and ethical work environments, and advocates on health care issues that affect nurses and the public.

We stand in strong support of this bill which urges the Department of Health to initiate preliminary education, outreach, and vaccination drive efforts at schools in Hawaii with vaccination rates under fifty percent, prioritizing schools with rates below thirty percent, beginning at the start of the 2025-2026 school year. Maintaining high vaccination rates in our communities is critical for preserving herd immunity, which is especially vital in protecting the very young, the aged, and others with complex health

conditions who are all susceptible to severe complications from vaccine-preventable diseases. Herd immunity is resistance to the spread of an infectious disease within a population that is based on pre-existing immunity of a high proportion of individuals as a result of previous infection or vaccination. It is known that the level of vaccination needed to achieve herd immunity varies by disease but ranges from 83 to 94 percent. It is therefore alarming to Hawai'i-ANA that schools in Hawai'i are running at 30-50% immunization rates, which puts our whole community at risk.

Hawaiʻi-ANA also agrees with the Hawaiʻi Departments of Health and Education, the State Health Planning and Development Agency, Hawaiʻi Medical Association, Hawaiʻi Public Health Institute, the Hawaiʻi Academy of Family Physicians, in previous testimony that this bill reinforces Hawaiʻis commitment to preventive health care, cost effective public-health infrastructure, and data-driven decision-making: key pillars of our nationally-recognized healthcare system.

Our national organization the American Nurses Association (ANA) takes the position that "it is imperative for everyone to receive immunizations for vaccine-preventable diseases as vaccines are critical to infectious disease prevention and control. Moreover, nurses have a professional and ethical obligation to model the same health care standards they prescribe to their patients." As the Hawai'i chapter of ANA, Hawai'i-ANA supports this evidence-based position statement and its intent to champion community vaccination as a safe and effective way to prevent the spread of disease. We must protect the health of our community by ensuring effective immunization rates in our community.

Hawai'i-ANA recognizes the voices of individuals who have testified in opposition to this bill, with their concerns that this measure unnecessarily infringes on parental rights, personal freedoms, and/or individual choice. As members of the most trusted profession over many years, all nurses adhere to the four ethical principles in our Code of Ethics for Nurses. Nurses are advocates for patients and must find a balance while delivering patient care. There are four main principles of ethics: autonomy, beneficence, justice, and non-maleficence. Autonomy is each patient's right to make their own decisions based on their own beliefs and values. Beneficence in nursing is acting for the good and welfare of others and including such attributes as kindness and charity. Justice means that nurses must care for all patients with the same level of fairness despite the individual's financial abilities, race, religion, gender, and/or sexual orientation. Nonmaleficence means to do no harm. This is the most well-known of the main principles of nursing ethics. More specifically, it means that nurses select interventions and care that will cause the least amount of harm to achieve a beneficial outcome. Therefore, Hawai'i-ANA can assure the community that all nurses will uphold parental rights, personal freedoms, and individual choice when providing healthcare, because we adhere to our Code of Ethics in advocating to provide the best, safest, and most humane care to all patients.

Hawai'i-ANA respectfully asks the committee to pass **HCR 173**, **HD1** / **HR 169**, **HD1(HSCR1532)** /(**HSCR1531)**. We thank your committee for its commitment to the people of Hawai'i and for the opportunity to testify in support of this measure.

HCR173 is repugnant to the U.S. Constitution and the Hawaii State Constitution.

In summary, HCR173 proposes the resolution with the House of Representatives of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, the Senate concurring, that the Department of Health is urged to undertake preliminary education, outreach, and vaccination drive efforts at schools in Hawaii.

<u>Vaccine drives have NO place in schools.</u> The decision to vaccinate children lies solely with parents and guardians in consultation with their physician. We have the lowest academic test scores in the U.S. It would be best for the DOE to focus on classical education in school, not vaccine education. This is a waste of time and taxpayer dollars.

#### **Government Overreach**

As a retired health care professional and a consumer of health care, I know that we are all entitled to <u>Informed Consent</u> and have the right to refuse any medical intervention including immunizations in any circumstances. The Government shall not determine the need for immunizations.

#### **Big Pharma Profit Scheme**

Tax dollars should NOT be used to provide preliminary education, outreach, and vaccination drive efforts at schools in Hawaii.

#### **U.S.** Constitution

HCR173 is a violation of our religious freedom. Our first amendment protection of religious liberty cannot be subjugated by state law. Americans have the right to refuse any order, medicine, or procedure that violates their religious beliefs as well as anything that is immoral or unethical according to their well-informed conscience.

HCR173 assumes that adults and children will be participating in immunization programs. No one shall be mandated to participate. According to the fourteenth amendment, no State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

#### **Hawaii State Constitution**

Article I. FREEDOM OF RELIGION, SPEECH, PRESS, ASSEMBLY AND PETITION Section 4. No law shall be enacted respecting an establishment of religion, or prohibiting the free exercise thereof, or abridging the freedom of speech or of the press or the right of the people peaceably to assemble and to petition the government for a redress of grievances.

Written Testimony in Opposition to H.R. No. 169 and H.C.R No 173 Submitted to the House Committee on Education March 31, 2025

Aloha Members of the Committee,

I submit this testimony in strong opposition to H.R. No. 169 and H.C.R No 173, which urge the Department of Health to implement education, outreach, and vaccination drives in Hawaii's schools with vaccination rates below 50%, prioritizing those under 30%. While public health is a shared concern across party lines, this resolution represents an overreach of government authority, a threat to individual liberty, and a direct affront to the values that have guided our nation under principled leadership. As a Republican, I urge you—especially my Democratic colleagues—to vote NO on this measure, recognizing its potential to harm Hawaii's families, defy federal priorities, and repeat costly mistakes seen elsewhere. Below, I outline my objections with clear evidence and appeal to our common interest in protecting the people of Hawaii.

#### 1. Government Overreach Undermines Parental Rights

H.R. No. 169 and H.C.R No 173 seek to insert the state into the sacred relationship between parents and their children by targeting schools for vaccination campaigns. This resolution implies that the government knows better than parents how to care for their kids—a notion that Democrats, who often champion personal choice, should find troubling. The data cited in the resolution, showing 17.09% of students lacking full immunization records in 2023-2024, does not justify overriding parental discretion. Many of these families may have legitimate concerns about vaccine safety or necessity, yet this bill dismisses them in favor of a one-size-fits-all approach.

The Trump administration consistently opposed such heavy-handed mandates. President Trump himself stated in 2020, "We're not going to force anybody to take [vaccines]. I don't think it should be mandatory." This resolution's push for state-led vaccination drives risks alienating parents and eroding trust in both local and federal government. Democrats who value community trust should see this as a step too far.

#### 2. Defiance of the Trump Administration's Agenda Harms Hawaii

With President Trump's leadership reaffirmed in 2025, Hawaii must align with federal priorities to secure support and resources. The Trump administration has historically opposed coercive vaccination policies, as seen in its rejection of broad federal mandates during the COVID-19 pandemic. Former Health and Human Services Secretary Alex Azar emphasized in 2020 that vaccination decisions should remain "a matter of personal choice," not state imposition. H.R. No. 169 and H.C.R No 173's aggressive push for school-based vaccination efforts directly contradicts this stance.

Defying this agenda could jeopardize federal funding for Hawaii's health and education programs. For example, Trump's administration tied disaster relief and infrastructure funds to state cooperation—recall the \$1.4 billion approved for Hawaii's recovery efforts in 2023 after severe storms. If Hawaii pursues policies at odds with federal priorities, we risk losing similar support, leaving our communities vulnerable. Democrats, who often advocate for federal-state partnerships, should recognize the practical danger here.

#### 3. Negative Outcomes from Similar Measures in Other States

History shows that vaccination campaigns like those proposed in H.R. No. 169 and H.C.R No 173 can backfire, reducing public trust and economic stability. In New York City, a 2019 measles vaccination mandate in certain neighborhoods led to widespread resistance, with vaccination rates dropping further in some areas due to distrust in government motives (<u>source</u>). Parents felt targeted, and community backlash grew, undermining the very goal of herd immunity.

Similarly, California's SB 277 (2015), which eliminated personal belief exemptions for school vaccinations, sparked a surge in homeschooling and private school enrollment as families opted out of the system entirely (source). Hawaii's private schools, already showing non-vaccination rates above 60%, could see a similar exodus, straining public resources and deepening social divides—issues Democrats care deeply about resolving, not exacerbating.

Perhaps most telling is Honolulu's own experience with COVID-19 vaccine passports in 2021. A study found that businesses subject to the mandate saw a significant drop in foot traffic, with some sectors losing up to 20% of their customer base as unvaccinated patrons stayed away (<u>source</u>). This resolution's focus on schools risks similar economic ripple effects if families pull students out or businesses near targeted schools suffer. Why repeat these failures?

#### 4. Education and Outreach Won't Solve Hesitancy—It May Worsen It

The resolution cites programs like Seattle's COVID-19 vaccination drive (8.8% increase) and Michigan's "I Vaccinate" campaign (12% teen vaccination increase) as success stories. But these examples gloss over the backlash. In Seattle, the program faced protests and lawsuits from parents who felt coerced, ultimately costing taxpayers millions in legal fees with only modest gains (source). Michigan's campaign, while boosting teen rates, saw vaccine hesitancy among adults rise as government messaging was perceived as propaganda, not education (source).

Hawaii's unique cultural context—emphasizing family and community autonomy—makes this resolution's top-down approach even riskier. Shoving vaccines into schools could deepen mistrust, especially among Native Hawaiian and rural communities already skeptical of state overreach. Democrats who prioritize cultural sensitivity should reject this blunt instrument.

#### 5. Fiscal Responsibility Demands a No Vote

Finally, H.R. No. 169 and H.C.R No 173 call for a long-term program with unspecified funding and administrative restructuring—buzzwords for a budget buster. Hawaii's taxpayers cannot afford another openended health initiative when we're still recovering from past economic hits. The resolution's demand for a report by 2026 offers no cost estimates, yet similar efforts elsewhere have proven expensive. Washington's "Immunity Community" campaign, lauded in the resolution, cost over \$5 million over three years for a mere 10% drop in hesitancy—a poor return on investment (source).

Democrats often fight for fiscal equity and protecting working families. This resolution threatens to drain resources that could better serve housing, education, or disaster preparedness—priorities that align with both parties' goals for Hawaii.

#### **Conclusion: Vote NO to Protect Hawaii's People**

H.R. No. 169 and H.C.R No 173 are misguided proposals that threaten parental rights, defies federal leadership, repeats proven failures, risks cultural backlash, and burdens taxpayers. I urge you, honorable members—especially my Democratic colleagues who value choice, equity, and community—to vote NO. Let's protect Hawaii's families by rejecting this overreach and finding solutions that unite, not divide, our state.

Aloha Chair Woodson, Vice Chair La Chica & Members of the Education Committee,

My name is Margaret Mejia, and I represent *Hawai'i Christian Coalition*. *Hawaii Christian Coalition* has been around for many, many years, and we have over 35,000 members. We represent about 130,000 people (parents and their keiki) in all districts, including the neighbor Islands. I am submitting testimony today to ask you to **vote NO on HCR173**.

First, it is NOT ethical to take Federal funds from Medicare and Federal & State funds from Medicaid to finance Governor Josh Green's Vaccination Drives, (in part) via HCR173. Medicare funds are federal funds that are designated for the elderly 65 years and older. Medicare and Medicaid funds should NOT be raided and funneled into the Department of Health and/or the Department of Education for the purpose of vaccinating children and adults.

Vaccination Drives at Schools are NOT necessary since we already have *Vaccines for Children*, a federally funded program that provides free vaccines for eligible children in Hawai'i. We also have CHIPS, so once again, Vaccination Drives are NOT necessary. Parents can take their children to the doctors if they want them to be vaccinated.

Just as the people spoke against HB1118, people should have a CHOICE as to whether they want to be vaccinated or not. Parents should have a CHOICE as to whether they want their children to be vaccinated or not and should not have to "Opt out" at School. Over the years, even decades, Democrats said, "My body, my choice," regarding abortion "rights." Now that people are saying, "My body, my choice," regarding vaccinations, suddenly, the Democrats are silent and no longer say, "My body, my choice." People should decide what they want to put into their bodies.

Vaccinations have ingredients like formaldehyde, Polysorbate 80 (that causes cancer), fetal tissue cells (like the ones in ALL the covid 19 vaccines), aluminum, mercury, animal blood, parts of animal organs, mRNA (that changes a person's DNA), and many other harmful ingredients. People should not only be able to choose whether or not they want these ingredients in their bodies but each person who receives a vaccine should be INFORMED of the ingredients in each vaccine. Also, there are alternative ways people can boost their immunity. Instead of forcing them to get vaccinated, why not educate people on healthy ways to boost their immune system?

Governor Green wants to turn Hawai'i schools into Health Clinics for vaccinations. IF passed, HCR173 would fund Governor Green's Vaccination Drive by providing a "Provider" at Hawaii's schools that gives vaccinations to children. This is gross negligence by the Department of Education and the Department of Health. It is not ethical and there will be lawsuits galore! A child does not know the ingredients in these vaccines. A child does not know that it is more dangerous to receive vaccines in threes (such as MMR, or DPT), versus a single dose. A child does not know that people can have adverse reactions to a vaccine or even die from a vaccine. A child does not know that the "bugs" in these vaccines mutate and then the vaccine is NO longer effective. Where is the Informed Consent?

### Will Department of Education & Department of Health be Liable?

One of the main problems with this bill is liability. Who will be liable is cases where vaccine injury or vaccine death occurs? I see lawsuits and LOTS of them, <u>IF</u> this bill were to pass.

# **Schools are for EDUCATION, and NOT MEDICATION.**

In addition, Taxpayer money designated for education via the public school system, would be used towards the public schools being used as a medical facility for vaccinations! Or even worse, they will use vax buses like they did during the plandemic. Children go to school for education not for vaccination. If parents want their children to be vaccinated, they can take them to a medical doctor or a medical clinic. Remote areas have clinics to go to for vaccinations. Even in remote areas like Hana, Maui, there are clinics in Hana Town where vaccinations are available for parents who want to vaccinate their children.

**Taxpayers should not fund immunizations.** Just as the Hyde Amendment protects our federal taxpayer dollars from funding abortions, we should not have to use our state or federal (Medicare & Medicaid) taxpayer dollars to fund immunizations, since many people do not believe in immunizations and since people have a choice as to whether they want to vaccinate or not. Although the Hawai'i Department of Health gives an initial start-up cost of this program, HCR173 contains no spending cap and does not detail the ongoing cost of funding this program.

This bill gives the Department of Health way too much authority! DOH would be able to decide what substance, including mRNA can be used in these vaccines. mRNA

is a dangerous substance and according to Dr. Robert Malone, M.D., M.S, a biochemist/biologist and creator of mRNA technology, mRNA changes people's DNA. The people and not DOH should decide whether or not they want to be vaccinated.

We find that HCR173 is a campaign to vaccinate, hosting the medical treatments on publicly funded school campuses across the Islands. These schools do NOT meet the standard of care required for children and adults, especially the children whom the public has entrusted in the Department of Education's care to educate, and not to medicate. The Department of Education's trespass into the realm of medicine, medical treatment, medical devise administration, faculties, and facility is unlawful, illegal, and dangerous. Schools should be prepared to be sued for lack of full informed transparency (NO Informed Consent) and destroying the quality of life to anyone who develops injuries, damages, and death as a result of vaccinations.

"Providers" will be held personally accountable, responsible, liable for negligence, trespass, falsehood, complicit in coercive and propaganda tactics. Legislators will be held liable for breach of violation of your oaths of office, including not upholding the United States Constitution and the Hawai'i State Constitution. 

Aloha,

I am writing to formally express my strong opposition to mandatory school vaccination policies. These two new bills are simply a revision of the previous bill we the people refused to accept. These mandates not only infringe upon parental rights and medical freedom but also disregard the well-documented risks and adverse reactions associated with vaccinations.

Data from the Vaccine Adverse Event Reporting System (VAERS), a federally operated database, records thousands of reports each year detailing severe reactions, including neurological disorders, seizures, and even deaths following vaccination. For instance, as of this writing, VAERS has paid settlements in excess of \$4 million dollars for cases of significant adverse events linked to childhood vaccines. Note that they highest amount they pay is \$250,000 per case. While proponents argue that these reactions are rare, the reality is they are NOT. These injuries can have lifelong consequences, yet families are often left without recourse.

Furthermore, requiring vaccinations for school attendance contradicts the principles of informed consent and bodily autonomy. Parents should have the absolute right to determine what medical interventions are appropriate for their children without coercion from the government or school policies. Medical decisions should be based on individual health conditions and risk factors, rather than a blanket policy that fails to account for unique circumstances.

In addition, numerous peer-reviewed studies have raised concerns about vaccine ingredients, long-term health effects, and the increasing number of required doses in childhood immunization schedules. There has been abundant research that shows links between vaccinations and autoimmune disorders, allergies, autism, and developmental issues, which warrant further investigation before imposing mandates on children.

As a concerned grandparent and advocate for medical choice, I urge you to reconsider any policies enforcing mandatory vaccinations for school children. Alternative measures such as informed consent, medical and philosophical exemptions, and robust parental education should be prioritized over mandates that violate fundamental rights. The people of Hawai'i have stated unequivocally, that we DO NOT want mandated vaccinations. Continue this push and you will see huge numbers of parents removing their children from public schools.

In case you have not noticed, the current federal administration is moving in the opposite direction of these mandates. Hawai'i will lose funding should the state continue to attempt to require vaccinations.

Therefore it would be wise to squash this bill and stop trying to mandate medical procedures.
