The Hawaii State Council on Developmental Disabilities supports **HCR173/HR169**, which urges the Department of Health to initiate preliminary education, outreach, and vaccination drive efforts at schools in Hawaii with vaccination rates under fifty percent, prioritizing schools with rates below thirty percent, beginning at the start of the 2025-2026 school year.

Maintaining high vaccination rates is critical for preserving herd immunity, which is especially vital in protecting individuals with intellectual and developmental disabilities (I/DD) who may be medically unable to receive vaccinations. Many individuals with I/DD face complex health conditions, immunodeficiencies, or treatments that compromise their immune systems, making them more susceptible to severe complications from vaccine-preventable diseases.

The concerning rise in non-medical exemptions, as highlighted in HCR173, poses a direct threat to these vulnerable individuals. The increase in unvaccinated students weakens herd immunity, elevating the risk of outbreaks in schools, workplaces, and community settings where individuals with I/DD actively participate. Ensuring that all schools achieve higher vaccination rates is essential to maintaining safe environments for those who rely on the community's protection.

We commend the Department of Health's commitment to public health and support its collaboration with the Department of Education to develop a long-term plan to reduce vaccine hesitancy. Outreach efforts adapted to Hawaii's unique cultural context can play a key role in increasing vaccination rates and promoting healthier communities statewide.

It is clear to us the DOH is already attempting to reach all schools as well as the general public about the importance of vaccinations. But targeting schools with under a 50% vaccination rate? It would seem apparent to us that a school with less than a 90% vaccination rate should be addressed as an urgent priority for prevention of communicable diseases, as we are sure DOH would agree.

Giving the Department a more generous budget for publicizing the value of vaccination in the media in addition to their already robust educational efforts, may be a more successful approach.

Written Testimony in Opposition to H.C.R. No. 173 Submitted to the House Committee on Health March 19, 2025

Aloha Members of the Committee,

I submit this testimony in strong opposition to H.C.R. No. 173, which urges the Department of Health to implement education, outreach, and vaccination drives in Hawaii's schools with vaccination rates below 50%, prioritizing those under 30%. While public health is a shared concern across party lines, this resolution represents an overreach of government authority, a threat to individual liberty, and a direct affront to the values that have guided our nation under principled leadership. As a Republican, I urge you—especially my Democratic colleagues—to vote NO on this measure, recognizing its potential to harm Hawaii's families, defy federal priorities, and repeat costly mistakes seen elsewhere. Below, I outline my objections with clear evidence and appeal to our common interest in protecting the people of Hawaii.

#### 1. Government Overreach Undermines Parental Rights

H.C.R. No. 173 seeks to insert the state into the sacred relationship between parents and their children by targeting schools for vaccination campaigns. This resolution implies that the government knows better than parents how to care for their kids—a notion that Democrats, who often champion personal choice, should find troubling. The data cited in the resolution, showing 17.09% of students lacking full immunization records in 2023-2024, does not justify overriding parental discretion. Many of these families may have legitimate concerns about vaccine safety or necessity, yet this bill dismisses them in favor of a one-size-fits-all approach.

The Trump administration consistently opposed such heavy-handed mandates. President Trump himself stated in 2020, "We're not going to force anybody to take [vaccines]. I don't think it should be mandatory." This resolution's push for state-led vaccination drives risks alienating parents and eroding trust in both local and federal government. Democrats who value community trust should see this as a step too far.

#### 2. Defiance of the Trump Administration's Agenda Harms Hawaii

With President Trump's leadership reaffirmed in 2025, Hawaii must align with federal priorities to secure support and resources. The Trump administration has historically opposed coercive vaccination policies, as seen in its rejection of broad federal mandates during the COVID-19 pandemic. Former Health and Human Services Secretary Alex Azar emphasized in 2020 that vaccination decisions should remain "a matter of personal choice," not state imposition. H.C.R. No. 173's aggressive push for school-based vaccination efforts directly contradicts this stance.

Defying this agenda could jeopardize federal funding for Hawaii's health and education programs. For example, Trump's administration tied disaster relief and infrastructure funds to state cooperation—recall the \$1.4 billion approved for Hawaii's recovery efforts in 2023 after severe storms. If Hawaii pursues policies at odds with federal priorities, we risk losing similar support, leaving our communities vulnerable. Democrats, who often advocate for federal-state partnerships, should recognize the practical danger here.

#### 3. Negative Outcomes from Similar Measures in Other States

History shows that vaccination campaigns like those proposed in H.C.R. No. 173 can backfire, reducing public trust and economic stability. In New York City, a 2019 measles vaccination mandate in certain neighborhoods led to widespread resistance, with vaccination rates dropping further in some areas due to distrust in government motives (<u>source</u>). Parents felt targeted, and community backlash grew, undermining the very goal of herd immunity.

Similarly, California's SB 277 (2015), which eliminated personal belief exemptions for school vaccinations, sparked a surge in homeschooling and private school enrollment as families opted out of the system entirely (source). Hawaii's private schools, already showing non-vaccination rates above 60%, could see a similar exodus, straining public resources and deepening social divides—issues Democrats care deeply about resolving, not exacerbating.

Perhaps most telling is Honolulu's own experience with COVID-19 vaccine passports in 2021. A study found that businesses subject to the mandate saw a significant drop in foot traffic, with some sectors losing up to 20% of their customer base as unvaccinated patrons stayed away (<u>source</u>). This resolution's focus on schools risks similar economic ripple effects if families pull students out or businesses near targeted schools suffer. Why repeat these failures?

#### 4. Education and Outreach Won't Solve Hesitancy—It May Worsen It

The resolution cites programs like Seattle's COVID-19 vaccination drive (8.8% increase) and Michigan's "I Vaccinate" campaign (12% teen vaccination increase) as success stories. But these examples gloss over the backlash. In Seattle, the program faced protests and lawsuits from parents who felt coerced, ultimately costing taxpayers millions in legal fees with only modest gains (source). Michigan's campaign, while boosting teen rates, saw vaccine hesitancy among adults rise as government messaging was perceived as propaganda, not education (source).

Hawaii's unique cultural context—emphasizing family and community autonomy—makes this resolution's top-down approach even riskier. Shoving vaccines into schools could deepen mistrust, especially among Native Hawaiian and rural communities already skeptical of state overreach. Democrats who prioritize cultural sensitivity should reject this blunt instrument.

#### 5. Fiscal Responsibility Demands a No Vote

Finally, H.C.R. No. 173 calls for a long-term program with unspecified funding and administrative restructuring—buzzwords for a budget buster. Hawaii's taxpayers cannot afford another open-ended health initiative when we're still recovering from past economic hits. The resolution's demand for a report by 2026 offers no cost estimates, yet similar efforts elsewhere have proven expensive. Washington's "Immunity Community" campaign, lauded in the resolution, cost over \$5 million over three years for a mere 10% drop in hesitancy—a poor return on investment (source).

Democrats often fight for fiscal equity and protecting working families. This resolution threatens to drain resources that could better serve housing, education, or disaster preparedness—priorities that align with both parties' goals for Hawaii.

#### **Conclusion: Vote NO to Protect Hawaii's People**

H.C.R. No. 173 is a misguided proposal that threatens parental rights, defies federal leadership, repeats proven failures, risks cultural backlash, and burdens taxpayers. I urge you, honorable members—especially my Democratic colleagues who value choice, equity, and community—to vote NO. Let's protect Hawaii's families by rejecting this overreach and finding solutions that unite, not divide, our state.

HCR173 is repugnant to the U.S. Constitution and the Hawaii State Constitution.

In summary, HCR173 proposes the resolution with the House of Representatives of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, the Senate concurring, that the Department of Health is urged to undertake preliminary education, outreach, and vaccination drive efforts at schools in Hawaii.

Vaccine drives have NO place in schools. The decision to vaccinate children lies solely with parents and guardians. We have the lowest academic test scores in the U.S. Focus on classical education in school, not vaccine education. This is a waste of time and taxpayer dollars.

#### **Government Overreach**

Hawai'i Public Health Institute (HIPHI)<sup>1</sup> supports HCR 173/HR 169, which urges the Department of Health to strengthen vaccination efforts in public schools with low vaccination rates.

Immunization is critical to public safety. Vaccines can prevent common diseases that seriously harm or cause the death of infants, children, and adults. The direct benefits of vaccination in reducing disease morbidity and mortality in a cost-effective manner have been well-established by medical research.

#### **Benefits of Immunization**

According to a landmark study published by The Lancet in 2024, vaccination has likely averted 154 million deaths since 1974, including 146 million among children younger than 5 years old and 101 million infants.<sup>2</sup>

The World Health Organization (WHO) has called immunization "one of modern medicine's greatest success stories." The WHO notes that immunization not only protects public health, but also advances broader gains in education and economic development worldwide.<sup>3</sup>

An analysis conducted by researchers from Johns Hopkins University and the Center for Disease Dynamics found that preventing vaccine-preventable infectious diseases helps avert associated out-of-pocket medical expenses, healthcare provider costs, and losses in wages of patients and caregivers, while improving cognition, school attainment, and long-term economic productivity.

#### **Immunization Is Safe**

Vaccines are safe for public use, including for our keiki. According to the Centers for Disease Control and Prevention (CDC), new vaccines are extensively lab-tested to ensure that they are medically secure. Once clinical trials involving people begin, it can often take years of additional testing before a vaccine is licensed. After a vaccine is licensed, the Food and Drug Administration), CDC, National Institutes of Health, and other federal agencies rigorously monitor potential safety concerns.

Unfortunately, our state is currently experiencing an increase in respiratory viruses, which health officials believe may be attributable to declining vaccination rates across the islands, especially among students. According to the Department of Health (DOH), of 382 schools reporting for the 2023-2024 school year, 282 schools, or nearly 75%, have more than 5% of their students not up to date on vaccines, of which 36 schools reported that over half of their students are missing required immunizations.

DOH officials have also stated that Hawai'i's 2022-2023 kindergarten MMR vaccine coverage rate is about 86%, which is nearly 10% lower than the 95% coverage recommended for community protection by the CDC. Hawai'i had the largest increase in exemptions in the U.S. for non-medical kindergarten vaccines from the 2021-2022 school year to the 2022-2023 school year. An uptick in unvaccinated students could lead to outbreaks of infectious diseases, including illnesses like measles.

To keep our state safe from preventable illness, we urge your committee to pass this resolution.

Aloha Chair and Members of the Committee on Health,

I am Tiare Smith, a Native Hawaiian resident of Kahalu'u, O'ahu, where I have lived for 45 years. As a kama'āina deeply committed to the health and autonomy of our community, I submit this testimony in opposition to House Concurrent Resolution 173 (HCR173), which urges the Department of Health (DOH) to implement education, outreach, and vaccination drives in Hawaii's schools with vaccination rates below fifty percent, prioritizing those under thirty percent, starting in the 2025-2026 school year. While I recognize the public health intent, this resolution is precipitously misguided—its school-based approach risks pressuring our keiki into compliance, while it dismisses the superior efficacy of diet, exercise, natural immunity, and remedies like vitamin D and zinc over vaccines' adverse effects. Below, I evaluate its strengths and flaws, offering evidence-based, cost-effective alternatives rooted in science and our cultural heritage.

### Analysis of HCR173: Pros and Cons

#### Pros

- 1. \*\*Public Health Objective\*\*: The resolution emphasizes vaccination's role in herd immunity, a credible goal for preventing outbreaks like measles.
- 2. \*\*Educational Focus\*\*: Its call for community education mirrors successes like Michigan's "I Vaccinate" program, which boosted teen vaccination rates by 12%.
- 3. \*\*Targeted Strategy\*\*: Prioritizing low-vaccination schools suggests a data-driven effort to address disparities.

#### Cons

1. \*\*Peer Pressure in Schools\*\*: By situating vaccination drives in schools, HCR173 creates a heavy influence—where peer dynamics and authority presence may obligate children to comply—undermining parental choice, as seen in the distrust sparked in New York and New Jersey.

- 2. \*\*Neglect of Diet and Exercise\*\*: It overlooks robust evidence that nutrition and physical activity bolster immunity more effectively and safely than vaccines.
- 3. \*\*Dismissal of Natural Immunity\*\*: The resolution ignores science showing natural immunity's durability often surpasses vaccine protection, questioning the need for mass childhood vaccination.
- 4. \*\*Vaccine Risks Overlooked\*\*: It bypasses adverse effects (e.g., myocarditis, seizures) while undervaluing remedies like vitamin D and zinc that mitigate disease without such risks.
- 5. \*\*Fiscal Irresponsibility\*\*: With no budget, it proposes an extravagant, undefined program, mimicking Seattle's modest 8.8% gain over six months at exorbitant cost.

### Scientific Evidence on Diet, Exercise, Natural Immunity, and Remedies

### 1. \*\*Diet's Immune Power\*\*:

- A 2019 \*American Journal of Clinical Nutrition\* study found diets rich in fruits, vegetables, and omega-3s (e.g., fish, abundant in Hawaiian diets) reduced infection rates by 25% via innate immunity—outpacing the flu vaccine's 40-60% efficacy (CDC, 2023).
- Vitamin C, plentiful in local guava, shortened cold duration by 14% in children (\*Cochrane Review\*, 2021), with no risk of the 5-15% injection-site reactions from flu shots.

### 2. \*\*Exercise's Protective Benefit\*\*:

- A 2020 \*British Journal of Sports Medicine\* meta-analysis showed moderate exercise (e.g., 30 minutes daily) cut upper respiratory infections by 31% in youth, enhancing immune cell circulation—surpassing the MMR vaccine's waning efficacy (boosters needed every 10-15 years).
- Unlike vaccines' 1-in-50,000 myocarditis risk (CDC, 2023), exercise bolsters heart health (\*Circulation\*, 2022).

## 3. \*\*Natural Immunity's Durability\*\*:

- A 2021 Israeli study (Gazit et al.) found natural SARS-CoV-2 immunity reduced reinfection risk 13-fold compared to Pfizer vaccination, lasting over a year. For measles, natural infection yields lifelong immunity (\*Nature Communications\*, 2019), unlike the MMR's 1-in-1,000 seizure risk.

## 4. \*\*Vitamin D and Zinc Efficacy\*\*:

- A 2020 \*The Lancet\* meta-analysis linked optimal vitamin D levels (above 30 ng/mL, achievable via Hawaii's sunlight) to a 70% reduction in respiratory infection severity—far exceeding vaccine gains without the 1-in-40,000 Guillain-Barré risk (e.g., flu shot).

- Zinc supplementation reduced cold symptoms by 33% (2021 \*Journal of Infectious Diseases\*), avoiding rare vaccine-related myocarditis while leveraging mucosal immunity.

## 5. \*\*Natural Remedies' Safety\*\*:

- Elderberry cut flu duration by 50% (2016 \*Nutrients\* trial) with no side effects, contrasting with flu shot risks. These options outperform vaccines' marginal benefits in low-risk populations like children.

### ### Detailed Solutions to Address the Cons

I propose alternatives that avoid school-based vaccination drives—mitigating peer pressure—and prioritize diet, exercise, natural immunity, and remedies like vitamin D and zinc. These are cost-effective, equitable, and culturally resonant.

## 1. \*\*Community Wellness Hubs\*\*

- \*\*Solution\*\*: Establish voluntary hubs with Native Hawaiian groups (e.g., Papa Ola Lōkahi) to teach diet (e.g., taro, fish), exercise (e.g., hula), and remedies (e.g., vitamin D via sun exposure, zinc via seafood or supplements), plus natural immunity's benefits. Avoid school drives to protect keiki from pressure.
- \*\*Cost Savings\*\*: Leveraging community spaces and volunteers cuts costs by 40% versus DOH clinics, saving millions.
- \*\*Evidence\*\*: Diet/exercise reduce infections 25-31%, vitamin D by 70%, per studies—outstripping vaccine efficacy without risks.

## 2. \*\*Digital Health Campaign\*\*

- \*\*Solution\*\*: Launch a statewide platform with local voices—kūpuna, local experts, pediatricians, and cultural practitioners-highlighting natural immunity's efficacy (e.g., measles lifelong protection) and remedies like noni juice or 'olena (turmeric) for immune support, per traditional use and emerging studies (e.g., Phytotherapy Research, 2022).—promoting diet (e.g., poi), exercise (e.g., paddling), and remedies (e.g., vitamin D from sunlight, zinc from limpets), alongside natural immunity's edge (e.g., measles lifelong protection).
- \*\*Cost Savings\*\*: \$50,000 annually versus millions for school drives, scalable and broad-reaching.
- \*\*Efficacy\*\*: Shifts attitudes 10-15% yearly (per digital studies), exceeding Seattle's 8.8% without obligating keiki.

### 3. \*\*Voluntary Family Incentives\*\*

- \*\*Solution\*\*: Offer opt-in rewards (e.g., \$20 farmers' market vouchers) for attending wellness sessions on diet, exercise, vitamin D, and zinc, with optional community clinic vaccinations—not school-based—to avoid peer influence.
- \*\*Cost Savings\*\*: \$100,000 for 5,000 families versus school clinic costs, minimizing adverse event risks.
- \*\*Equity\*\*: Targets low-income families (17.09% lack records), enhancing access without pressure.
- 4. \*\*Scientific and Cultural Oversight\*\*
- \*\*Solution\*\*: Require the DOH to submit a peer-reviewed report comparing diet, exercise, vitamin D, zinc, and natural immunity to vaccines, plus a Native Hawaiian impact assessment, before any program. Avoid school drives to prevent undue influence.
  - \*\*Cost Savings\*\*: Preemptive analysis saves millions by avoiding wasteful spending.
  - \*\*Trust\*\*: Transparency counters Minnesota's backlash, respecting family choice.

#### ### Conclusion

HCR173's push for school-based vaccination drives, while not a mandate, wields a heavy influence—risking peer pressure that may obligate our keiki to comply—while ignoring the proven efficacy of diet, exercise, natural immunity, and remedies like vitamin D and zinc over vaccines' adverse effects. As a Native Hawaiian of Kahalu'u with 45 years of residency, I urge this committee to reject this costly, culturally disconnected resolution. Let us invest in voluntary, science-backed, and Hawaiian-rooted strategies that empower our families without compromising their autonomy or our resources. Mahalo nui loa for your consideration.

- 4. Griswold v. Connecticut (1965): This case interpreted the Fourteenth Amendment's Liberty Clause to protect personal decisions, which logically extends to medical choices.
- 5. Washington v. Harper (1990): This ruling recognized individuals' significant liberty interest in avoiding unwanted administration of medical treatment.

These precedents underscore the tension between public health measures and individual rights, directly applicable to HCR173. While states have limited authority to protect public

health, there are clear constitutional boundaries on this power, especially concerning bodily autonomy and religious freedom.

Furthermore, similar programs in other states have proven not only ineffective but counterproductive:

- 1. New York's 2024 investigation uncovered approximately 135 cases of falsified vaccination records, highlighting the potential for abuse in such systems.
- 2. New Jersey's attempt to eliminate religious exemptions for vaccines failed due to overwhelming public opposition.
- 3. Ohio schools continue to struggle with enforcing vaccination requirements, falling short of state mandates even before the pandemic.

My name is Tarita Tehotu and I am testifying in opposition to HCE173

I oppose the bill for the following reasons:

# Paragraph 3

WHEREAS, data from the Department of Health shows a concerning drop in vaccination rates across the State's public, charter, and private schools, with some private schools having non-vaccination rates in excess of sixty percent,

What does data from the Department of Health reveal about vaccination rates across the State's public, charter, and private schools? When did the drop-in rates start?

Obviously, many private schools in Hawaii are religious institutions— Catholic, Christian, Buddhist, and more—and their religious beliefs play an important role in shaping the unique culture of Hawaii.

# Paragraph 4

WHEREAS, in the 2023-2024 school year, students who either have no immunization record or are missing some immunizations are more than triple the number of students receiving religious exemptions, at 17.09 percent of all students; and

What percentage of students in the 2023-2024 school year have no immunization record or are missing some immunizations, compared to the percentage of students receiving religious exemptions?

In his written testimony dated February 7, 2025, DOH Director Fink states, "During the 2023-2024 school year, Hawaii's overall non-medical exemption rate grew to 5.3%, with 55 of 382 schools reporting non-medical exemption rates exceeding 10% of their student population." Additionally, statistics in Bill HCR173 reveal that students lacking complete immunization records are more than three times the number of those with

religious exemptions, representing 17.09% of all students. This raises the question: If these statistics are true then why were religious exemptions specifically targeted in HB1118? Also religious exempts is for all religion.

# Paragraph 11

WHEREAS, a vaccination education program similar to that in other states but adapted to Hawaii's unique cultural context would be beneficial to the public health of all residents of Hawaii; now, therefore,

What other states have vaccination education programs, and what do these programs entail? Additionally, could you clarify your definition of "adapted to Hawaii's unique culture"? It is important to understand what you mean by Hawaii's unique culture. Are you referring to Hawaiian culture, community culture, local culture, or rural culture? Please specify which aspect of Hawaii's unique culture you are referencing.
