HR 88 / HCR 92 - REQUESTING THE GOVERNOR'S COORDINATOR ON HOMELESSNESS AND THE CITY AND COUNTY OF HONOLULU TO ESTABLISH A TWO-YEAR HOMELESSNESS SANTUARY PILOT PROGRAM.

Aloha Chair Marten, Vice Chair Olds, and Members:

The Statewide Office on Homelessness and Housing Solutions (SOHHS) would like to provide comments to HR 88 / HCR 92.

The purpose of HR 88 and HCR 92 is to request the Governor's Coordinator on Homelessness and the City and County of Honolulu to establish a two-year homelessness sanctuary pilot program.

While the issue of homelessness remains, Hawaii has made significant strides. Under Governor Green's leadership and within the administration's first term, SOHHS set new priorities which include the ambitious goal of halving unsheltered homelessness (by November 2026). This means helping to shelter and house nearly 2,000 unsheltered people. Several of SOHHS's priorities focus on expanding the deeply affordable housing inventory for individuals experiencing homelessness as well as affordable rental units for individuals, couples, and families who are at risk of homelessness due to the high costs of living in Hawaii.

As the Governor's Coordinator on Homelessness, I am honored to further the important work of this office and the administration to reduce and prevent homelessness across the state. Our goal is to further expand deeply affordable housing inventory and supportive services for individuals experiencing homelessness through the state's Kauhale Initiative.

I FULLY SUPPORT THIS BILL! As a resident of O'ahu who experienced houslessness 10 years ago with my disabled husband and 2 children who were 3 and 1 years old at the time, a simple safe space to park a car and sleep and access to a bathroom is the VERY LEAST the City and County could have been providing to houseless residents, ESPECIALLY considering how many times a "state of emergency" has been declared over houseleness. "Ohana zones" were discussed when Ige was governor, but for some reason, the leftover Big 5 like Castle & Cooke decided that it was more important to use their "nonprofit" affilition with HomeAid Hawaii to push "tiny homes" - toolsheds that Josh Green has decided to try to brand as "kauhale."We don't need toolsheds! We don't need tax write-off "charities" for real estate developers getting in the way and trying to mooch off federal funding for houselessness. WE NEED EMERGENCY SAFE SPACES FOR HOUSELESS PEOPLE. Finland was able to address their houseless crisis with Housing FIRST. Not "clean and sober first," not "employed first." HOUSING FIRST. This emergency safe space is the first step to realizing this. Shelter people FIRST, address wraparound service needs SECOND. And for God's sake, STOP LETTING LANDLORDS DICTATE THE RULES ON HOUSING! More and more people will end up houseless as long as landlords can continue to increase rents WHILE WAGES STAY STAGNANT, you will continue to have a houseless crisis! No, states aren't "shipping their homeless here." Houselessness is a HAWAII-GROWN problem. Was 10 years ago, still is today. The number of homeless non-locals who find a way to get here (including buying a 1-way ticket) is MINISCULE compared to the number of HOUSELESS LOCALS. Every time you all look into this, the "it's a mainland problem" always gets debunked. Stop kicking the can! And the 1 thing I would change about this bill is I would add a requirement that any contractor that has anything to do with this safe space is audited continuously! I've watched the biggest names in the "nonprofit" sector literally squander OUR TAXPAYER DOLLARS AND DONATIONS on "administrative costs" over the past 10 years. And I first witnessed this after being houseless myself. DO NOT let "nonprofits" have carte blanche with our money. Hold them accountable to actually abide by their mission statements and HELP SOLVE THIS HOUSELESS CRISIS WHILE TREATING PEOPLE WITH DIGNITY.
