Chair Kila, Vice Chair Grandinetti, and Members of the Committee:

The Hawaii Military Affairs Council ("MAC") supports HR43.

The MAC was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

The Military Affairs Council has been working with the Hawaii Department of Transportation, Army Garrison Hawaii and Navy Region Hawaii to provide safe passage along Kolekole Pass in time of emergency, whether natural or man-made. There was a practice run with Hawaii Emergency Management Agency and partners in February. We are grateful to HDOT for making early investments in road improvements. The Army and Navy are committed to do their part and are requesting funds as a part of this partnership. The Hawaii Congressional Delegation is also a most supportive partner in this collective commitment to ensure that Oahu's westside community members will have an alternative road to get to safety in time of emergency.

I stand in SUPPORT of this resolution. I am a lifelong resident of the Waianae coast, I've grown up here and have noticed traffic always getting worse. I remember when a hostage situation lasting more than 12 hours shut down the entire Waianae coast. The response to that was to build an 'access road' less than 10 yards from where the hostage situation took place, and if the exact same situation had occurred, would have shut down the bypass road for safety reasons as well.

While projects like the widening of Farrington Highway and adding turn lanes along most of it (for some strange reason stopping sort of one of the worst choke points on this side of the island) and increasing public transit has helped in small amounts to help alleviate traffic, it is not enough. The Bypass Roads put in help slightly in situations when they are authorized to be open but they are not a solution and only help in certain situations.

A proper bypass road is long overdue for Waianae, however I would urge that this bypass road be constructed with the intention of being permanently open and not locked behind a gate or past a military checkpoint. While repairing Kolekole Pass would be excellent for use by the military and in Emergencies, other options must also be considered, including the building of tunnels or passes over/through the mountains.
