The Department of Corrections and Rehabilitation (DCR) **supports the intent** of House Resolution (HR) 70, which requests the DCR expand its personal and professional development programs to include community service programs to fix potholes, trim trees, pickup litter, and perform other services for the State or counties.

DCR appreciates the legislature's interest in this area and would like the legislature to know the DCR already operates community service worklines at the Hawaii Community Correctional Center (HCCC) and Kulani Correctional Facility (KCF - specific to the pothole repairs and tree trimming along portions of Stainback highway), on the Island of Hawaii. DCR also operates community service worklines at the Women's Community Correctional Center (WCCC), and at the Waiawa Correctional Facility (WCF), here on Oahu.
