I followed that case until her child was finally returned to her after the most egregious incidents occurred to that child. The removal of her child was a violation of the 4th amendment search and seizure protections and that was only the beginning of the outrageous actions by the department.

The DAG for this case was Sonja Toma whose responsibility was to provide accurate and complete information to the court "under penalty of perjury". Sonja was in noncompliance with her duties as DAG and therefore cannot be trusted to the duties of family court judge.

Dear Chair Rhoads, Vice Chair Gabbard, and Committee Members,

I am submitting testimony in strong opposition to the confirmation of Sonya H. Toma to the District Family Court of the Second Circuit.

Ms. Toma's previous role as a Deputy Attorney General in the Family Law Division on Maui presents a clear and disqualifying conflict of interest. In that role, she represented the Department of Human Services, particularly Child Protective Services (CPS), in legal matters involving family court proceedings.

In effect, CPS was her client — she argued in favor of the agency's positions, including the removal of children, supervision orders, and other highly sensitive matters. If confirmed to the bench, Ms. Toma would now be tasked with ruling on the same types of cases — often involving CPS — from a judicial seat rather than an advocacy role.

The appearance of impartiality is essential to public trust. Families must believe their case will be evaluated fairly and without bias. But it is difficult, if not impossible, for families to feel that confidence when the judge assigned to their case previously advocated for the very agency they are now opposing.

For this reason, I respectfully urge the Committee to vote no on the confirmation of Ms. Toma. Maui families deserve a Family Court judge who is not only experienced, but also neutral and independent in every sense.

Aloha, I am writing an opposition to the appointment of Sonya Toma becoming a family court. Judge in Maui County.

I am one of the 81% of families in this state who had a child removed that was never harmed prior to entering the family court system. My child was removed from my home while I was changing naked in my bedroom without a court order, without a warrant. When I located at the agent, I was tricked into believing that he was going to transport my son to a treatment center. I had arranged for prior. In fact, the agent drove away with my son. I watched him drive away, and when I left, thinking, he was safe on his way to treatment. The agent drove back to my parking lot and met the police claiming that I drove off and that I was a danger to my son. Without ever seeing me, without ever seeing my son, within 2 1/2 minutes according to the body cam footage the police officer took the word of the agent and signed away my custody destroying my family forever. Sonya Toma was the Attorney General during the entire case that dragged on for almost two years.

During the case, Sonya Toma repeatedly signed under penalty of perjury that my son was safe under Hawaii supervision. I believe this is ground for her, not being appointed.

During my son's captivity under the state of Hawaii, he was starved for three weeks in foster care. He lost 21lbs those first 3 weeks. Then Rushed to the hospital after my many, pleas of begging for them to weigh my son as he was telling me about the abuse. I had recordings where my son shared with me that the agent told him it was OK to lie and that if he said he didn't feel safe with me living at home that he would be allowed to smoke cannabis and the foster home. And then he told me that they let him. My son's neglect, and abuse in the system only escalated. To make things worse they also had him read pre-written statements in court. It reminded me of hostage situations in countries that you United States claims are terrorists.

Within a couple of months of being in the system, my child ran away and was on the streets. When he was found, he tested positive for meth and declared he had tried to hang himself and slit his own wrists.

Despite having court orders in Colorado for my ex-husband to not even have unsupervised phone calls, let alone visits. Despite the fact that he owed over \$130,000 in back child support, Without ever meeting my ex-husband in person, without ever inspecting his home and ignoring the court orders of Colorado for reunification that I presented to the courts under Sonya Toma's supervision they purchased my ex-husband a plane ticket and took my son to Colorado without following Federal ICPC protocols.

My ex very quickly abused my son verbally, and berated him for his sexual orientation. Again, I made pleas in the court that fell on deaf ears by Sonya Toma. Within six weeks, my son had been arrested for Cannabis at school and ran away. Despite him becoming homeless and missing no amber alert or missing persons report was filed. Sonya Toma continued declaring the false narrative and drafting multiple orders, granted under penalty of perjury declaring that he was safe under Hawaii's supervision with my ex-husband in Colorado and receiving services.

He did not receive any services. He was declared a dropout of high school. After a few weeks, the terrifying phone calls in the middle of the night began escalating. He called telling me he was freezing on the side of the highway in a tent too week to stand. I plead with him to get up and to get on a public bus so at least he could have heat because the temperatures were below freezing. He then called me and told me he was going to be leaving the country with a transsexual Russian that he met on the streets. A week later he called me and told me he was robbed with a gun on a train after they rode it to Texas and back in a freight cart. The following week he told me he fell on a cactus running down a hill as he was hearing a woman get murdered. He slept in an elevator with homeless smoking fentanyl. A week later he told me he witnessed murder and then I was contacted and told he was working in a circus in Alabama. All of this was declared to the courts yet under penalty of perjury the orders were signed as Sonya Toma consistently declared under penalty of perjury that he was safe under Hawaii supervision receiving services in Colorado. After he was located at the circus, he fled in the middle of the night and ended up with my family in Florida. He slipped deeper into drugs, despite my plea in and out of court, declaring that he was self dosing DMT, psilocybin, LSD and cannabis. I was completely ignored, and he was consistently still declared as Safe under Hawaii supervision in Colorado. I believe this to be perjury and in my opinion, it sounds like financial fraud of Medicaid or title IV or some sort of government funding.

I believe if DOGE where to examine case FCS2110052 and watch the DVD's (specifically November 2,2021 for the ICPC / Colorado court violations), January 2022-March 2022 (declaring he was safe while missing) and October 31-November 2022 details of circus and drugs)(Nov2022- April 2023 repeated declarations of LSD, Psilocybin, and DMT use) that in my opinion Sonya Toma likely would be investigated for the false claims / perjury / that he was safe

during all of these times, which are documented on DVDs and on transcripts. I emailed Govornor Josh Green, Cathy Betts, Elladine Olivao and many others throughout the case the details of horror we endured. I'm happy to provide those emails.

My son return to me two years later after I located him in the ghetto of South Carolina, where their child welfare services took him from police that I called to save him. They flew him to the airport and dumped with me at the airport without checking an ID or any sort of verification that I was his parent.

He was and still is heavily addicted to drugs and traumatized in and out of hospitals, and homelessness as I try to bring him back home and into treatment. I have no options as he no longer trusts anyone associated with the Department of health and human services for medical care or mental health care.

The evil that I witnessed in that courtroom and the suffering, my family has endured at the hands of Sonya Toma under penalty of perjury are what I believe is grounds to not appoint Sonya Toma as a judge.

Whatever decision you make, remember God is watching, God sees all, Our children of Hawaii deserve protection from evil, And your choice to place a judge that will affect thousands of family in Hawaii is also on your soul.

RE: JC 28: CONFIRMATION OF SONYA TOMA TO THE MAUI FAMILY COURT

Dear Senator Rhodes and Committee Members:

The purpose of this letter is to acquaint you with Attorney Sonya Toma who is scheduled to meet with you later this week as she seeks confirmation to the Second Circuit Family Court on Maui.

I have had the opportunity and pleasure of being acquainted with Sonya for twenty plus years. She is an extremely talented individual who possesses many of the qualities which will make her an outstanding addition to the Second Circuit Bench.

As an attorney she is highly respected by the members of the Maui County Bar. Her ethics are above reproach, and her work ethic is exemplary. If she has an ego it is a heathy component of her personality that will never be on display in a negative manner which is not always true of folks wearing black robes.

In addition to her strong intellect, she is experienced in several areas of the law which will be relevant to her service on the Family Court. The designation "Family Court" does not truly convey the many areas of the law which are present in the constellation of issues presented as Family Law cases. It is not just divorce, support, custody and visitation or Child Welfare issues. Examples of these ancillary matters include, but are not limited to:

1. DOE truancy matters which may stem from absent parents or parents who are active criminals, physically and/or emotionally abusive, substance abusers,

- neglectful individuals which results in a lack of parental participation and responsibility, incarcerated, etc., etc.
- 2. DOH cases involving hospitalization of individuals who are believed to be a danger to themselves or others.
- 3. DOH cases with children who are the subject of active CPS cases who are in need of mental health services which DOH is reluctant to provide.
- 4. DHS Elder Abuse Cases which are self-explanatory. In these situations the Deputy Attorney Generals (DAGs) in the Family Law Section are required to represent the Public Guardian in Guardianship Proceedings.
- 5. Teenage CPS children are often simultaneously on the Juvenile Calendar and the Family Law DAGs are called upon for information and/or assistance in finding a suitable resolution in these cases.
- 6. CPS parents are frequently also involved in the Criminal Justice system and Sonya's experience and knowledge in both the prosecution and defense bar is a true benefit as the outcome of the criminal matters have a definite impact on the direction and outcome of CPS and non-CPS cases.

While she was a Deputy Attorney General (DAG) in the Maui Family Law Division we interacted on a regular basis as I have a Judiciary Contract to provide legal services to families involved with the Child Welfare System. This area of the law is highly emotionally charged as parents are alleged to be abusers, neglectful, perpetrators of despicable physical and/or emotional harm to their own children. They enter the Court confused, angry and hostile in most cases. Sonya consistently treated parents with respect. Her calm but firm composure is very effective in de-escalating extremely volatile situations.

As opposing counsel, she was always respectful, non-judgmental and open to discussion when we had opposing views in a case. Unlike so many members of the legal profession Sonya does not allow ego to cloud her judgment or conduct which is refreshing and somewhat rare in litigators. She is always prepared including an assessment of her opponents' position. This thorough preparation combined with her extensive legal knowledge resulted in cases being disposed of in a timely manner not having to be continued when an opposing party raises an issue she has not contemplated. She also prepares the CPS workers when they are going to testify so they hopefully had all the documents and relevant information necessary for the hearing to proceed; again avoiding the need to repeatedly continue cases.

Sonya is articulate in both her oral and written communications. When dealing with parties her calm demeanor combined with her ability to translate legalese into lay language which parents can understand and appreciate is exceptional. These characteristics are a requisite to an appropriate judicial temperament. When combined

with her effective communication skills I believe parties will leave her Court knowing they heard and given a fair hearing.

It is also important you are aware of the well rounded and valuable member of society that is Sonya Toma. Her C.V. sets forth her numerous contributions to the legal community. In addition, she is actively engaged in the Okinawan Society of Maui County, the AAUW; a very active parent in both in school and extracurricular activities of her sons. They attend local public middle and high schools. She is involved in fund raising, a great member of the car wash teams, travels as a chaperone, leader, first aid provider, etc. to her sons' various sports teams and the Special Olympics with her eldest son.

Thank you for the opportunity to share the Hawaii State Bar Association (HSBA) Board of Directors' comments on JC 28, Nomination of Sonya H. Toma for District Family Court of the Second Circuit.

After a rigorous process, described below, the HSBA Board of Directors concluded that Ms. Toma is **QUALIFIED**. Ms. Toma has extensive experience in family law, and has worked as a deputy prosecutor, deputy public defender, deputy attorney general, deputy corporation counsel, and as a legal aid attorney. She has experience in both civil and criminal litigation. Ms. Toma is well respected in and out of the courtroom, and will continue to bring her strong work ethic, leadership skills, dedication to public service, and respect for the law to the District Family Court of the Second Circuit.

The HSBA Board of Directors followed its multi-step process to arrive at its conclusion, which included:
